#### Missionary Rally, January 16, 2016 Winfield Free Will Baptist Church

The session began at 6:00 PM with Bro. Danny Williams, moderator opening the meeting. He made opening comments and then led the opening prayer.

Host Pastor, Bro. Kent Nelson was recognized next. He welcomed everyone to the Winfield Church. After making opening comments he recognized the churches of our association present for the meeting. They were Free Water, Hamilton, Liberty, New Liberty, Union Chapel, and the host church Winfield. He also recognized the Piney Grove church visiting form the Vernon association. Bro. Dick Williams led the congregation in singing *The Regions Beyond*. The Winfield church choir blessed the congregation next with special music.

Bro. Tyler Penn, missionary with the International Students was the first mission speaker. He shared his and his wife's work with International Students in Champaign Illinois. At the University of Illinois there are over 12,000 International students from almost 120 different countries, and they have no idea who Jesus is. They are from countries where you cannot go in and share the Gospel. At the university the gospel is shared with them. Some students are there only about six month others about six years. He thanked everyone and asks for prayer before going up to the Youth service.

Bro. Matt Turnbough, missionary to Spain spoke next. He has been in Spain for 12 years and has been back in the States since July on a state side assignment. He shared Romans 1:16 on how powerful the gospel is and how he has seen lives changed by it. For the last few years they have been helping the churches in Spain teaching classes, helping pass out food & clothing. The last few months they have been preaching to around 160 families a month from over 30 nationalities sharing Christ. He made other comments concerning the work and thanked everyone for their support.

Bro. Eddie and Sis. Amanda Simmons, missionaries to Kenya spoke next. For the last two years they have been making short trips to Kenya from out of the church he is pastoring just outside of Charlotte, NC. While ministering there they have had 500 new believers being discipled by the people they disciple while they were there. They thanked everyone for their support.

Bro. Terry and Sis. Tammy Miller, missionaries to Ft. Collins, Colorado spoke next. He stated they were part of a Home Missions church revitalization program in Ft. Collins working to bring the church back to self supporting. Sister Tammy gave her testimony, and they thanked everyone for their support.

**Bro. Bud and Sis. Ruth Bivens**, missionaries to Mexico spoke next. Bro. Bud stated they used to spend 75% of their time at the Bible College and 25% at the orphanage, but now they are not needed as much at the college so they spend more time at the orphanage. He shared about the shoe box ministry they have each year at the orphanage. They have about 16 teen children at the orphanage now. He said they had been in Mexico for 20 years. During this time they have seen many people come to Christ. Sister Ruth made comments about some of the children at the orphanage and thanked everyone for their support.

Bro. Dick Williams led the congregation in singing Send the Light. The Trio from the Winfield church Danny, Karen, and Dick Williams blessed the congregation with special music next.

Bro. Randall Wright, Missionary to Texas gave the evening message. He thanked everyone for allowing him to be there. He shared about the work in McKinney. This is their fifth year there and they have seen many people come to Christ. He also shared some stories about the work there. He spoke from Matthew 25:31-46. He brought a powerful message on *Finding Significant Ministry*.

The offering was received with Bro. Bud Bevins praying the offertory prayer. As the World Missions offering will be in April, a short video on World Missions was shown during the offering. Bro. Danny reminded the Pastors about the World

Missions packets, and thanked everyone for their offertory gifts

**Bro. Donald Smith** presented the mission project for this summer next. The mission project will be Bro. Barry & Jessica Long serving in Aurora, Colorado. The funds raised will go to the Long account to support the work there. There will be a special fund raiser on August 13<sup>th</sup> with Ventriloquist Allen Jones and also a singing group to be announced later. This will be at the Hamilton church. Our goal is \$2500 and the project will run from January 16<sup>th</sup> to September 17<sup>th</sup>. Mission packets will be sent out in early June. He thanked everyone for their support.

There was one item of business that needed attention. The constitutional change was put on the table at the annual meeting in September to be taken off the table at the January meeting. The deletes agreed to take it off the table in September at the annual meeting. Announcements were given next. Refreshments would be served in the fellowship hall. Bro. Danny Williams thank everyone for coming and then closed in prayer.

NOTE, There was a separate meeting held in the gymnasium for Grades 6 to 12 during this meeting. Bro. Lazaro Coralles gave his testimony, and Bro. Tyler Penn

gave the evening Message.

The session opened at 9:00AM with Bro. Ray Selman leading the congregation in singing 'Tis So Sweet To Trust in Jesus. Bro. Adam Smith, host pastor, welcomed everyone to the session and gave instructions regarding their facilities. Bro. Dwayne Hammontree led the opening prayer. Bro. Ray Selman led the congregation in singing Standing on the Promises.

**Bro. Danny Williams,** moderator called the meeting to order. Bro. Donald Smith, clerk, gave the roll call of the delegates. The standing delegates voted to seat

**Bro.** Adam and Apryl Smith blessed the congregation with special music singing *Help is on the Way*. Bro. Danny Williams led in prayer.

**Bro. Jerry Williams,** from the Winfield church brought the first message of the day from Matthew 8:1-7 on the *Power of Christ*. His Message was very inspiring and encouraging. He closed with prayer.

The meeting was adjourned for break at 10:00 AM. Bro. Ashley Culp led the prayer.

The meeting reconvened at 10:20 AM.

Bro. Ashley Culp, Trinity Youth Camp Director gave the first State report. Bro. Ashley said there were 51 salvation decisions, 4 answered the call to preach and 2 answered the call to missions. They had 10 weeks of camp with the largest week being 186. This year they have installed new LED lights in both dorm bathrooms and the kitchen area, a new roof on the dining hall, new interior ceiling in the Prophet chamber, installed two new exterior doors on the boys dorm, new exterior door on director's home, replaced wall material and ceiling around fireplace due to water damage. The projects for 2016 are to replace the gym roof and sidewalls at a cost of \$28,000 and are presently \$6000 short. The goal is for the contractor to return within two weeks to continue work on the gym. He thanked everyone for their prayers and support.

Bro. Danny Williams, Alabama State Executive Director spoke next. He gave the Children's Home report first. Bro. Danny said they have 19 children at the home right now, 3 graduated from high school this year. During the past few weeks they have added 3 brothers, twin 10 years old and a 12 year old. There has been one saved in the last two months. They have had a good year financially primarily because of two estate gifts, repairs and improvements have been made on the campus without borrowing money. The board will be meeting October 1<sup>st</sup> and the Annual Toy Run will be held the first Saturday in December at the home.

Bro. Danny Williams gave the state report next. Bro. Tim Riggs in Mobile is averaging in the 70's on Sunday mornings. There big project was paving the parking lot and it has been completed with about 70 parking spaces. They are hoping to go self-supporting soon. They have had 7 saved since the first of the year and just baptized six. Bro. Billy Biven at the Eastside church in Dothan is part of a revitalization program. The church has been under mission care for about a year and a half. A year ago they were averaging about 20-26 on Sunday morning and about 10 on Sunday night. Now they are averaging about 50 on Sunday morning and 45 on Sunday night. Five have been saved during the year.

**Bro. Danny Williams** gave the Acts 1:8 report next. Through August they have received \$371,000. Last year at this time they had received \$335,000 which is 35,000 more than last year. The budget is \$60,000 more than last year and right now

we are about \$6200 behind budget. The Jasper Association has given almost \$48,000 to Acts 1:8 which is about \$2500 less than last year.

October 17<sup>th</sup> – 18<sup>th</sup> is the Ministers Retreat at Lake Guntersville. The State Association meeting will be November 9<sup>th</sup> 10<sup>th</sup> & 11<sup>th</sup> at The First Church in Dothan. Bro. Rob Morgan and Bro. Tim Campbell will be the guest speakers. M/S/C to accept these reports as information.

**Bro. Donald Smith** gave the Mission Board report next. Our Mission project this summer was Bro. Barry Long in Aurora, Colorado. We had a special fund raiser on August 13<sup>th</sup> at the Winfield church with Allen Jones and a singing group from Mexico. That night \$1,315.00 was raised. To date we have raised \$2,565.00 which is \$65.00 over our goal. He thanked everyone for their support. M /S/C

The Resolution and Appreciation Committee Report was given next by Bro. Kip Madison .We, the Resolution and Appreciation Committee of the Jasper Association; wish to express our appreciation to the following churches for hosting the meetings of the Jasper Association in 2016. 



# CONSTITUTION OF THE JASPER ASSOCIATION OF FREE WILL BAPTIST

# ARTICLE 1

This body shall be known as the Jasper Association of Free Will Baptist of Alabama.

# ARTICLE II MEMBERSHIP

SECTION I. The membership of the Jasper Association shall consist of all churches that, upon the approval of this body, shall become members.

SECTION II. A local church that wishes to become a member of this Association must adopt the National Treatise and make formal written request. A two –thirds vote of the delegates present must be recorded for acceptance into this Association.

# ARTICLE III REPRESENTATION

Each church holding membership in this Association shall be entitled to three (3) delegates. Ordained ministers, deacons and General Board members who are in good standing with this Association, shall be standing delegates.

# ARTICLE IV

The Officers of the Jasper Association shall be a moderator, an assistant moderator, a Clerk/Treasurer, and assistant Clerk/Treasurer, each of whom shall be elected every two (2) years with the election coming on even years.

#### ARTICLE V BOARDS

SECTION I. General Board (a) Composition. The General Board shall be composed of the moderator, assistant moderator, clerk/treasurer, assistant clerk/treasurer, the pastor and one member from each local church that is a part of this body. Each member from a local church shall serve a two year term with one-half of the members being elected each year. (b) Executive committee. An Executive Committee shall consist of the moderator, assistant moderator, clerk/treasurer and five (5) members from the General Board. These five members shall be elected annually by the General Board. This committee shall function as the General Board when said Board is not in session. (c) Duties. The General Board shall formulate all

items of general business during the annual session of the Association, as well as other responsibilities so delegated by the body. When this Association is not in session, this Board shall have power to act as the body.

SECTION II. Board of Directors of the Trinity Free Will Baptist Camp. The Jasper Association shall be represented to the Board of Directors of the Trinity Free Will Baptist Youth Camp by three (3) members. Each member shall serve a term of three (3) years with one term expiring each year.

SECTION III. Mission Board. The Mission Board shall consist of five (5) members. Each member shall serve for a five (5) year term with one term expiring each year. The Mission Board's responsibilities will be to help set up mission conferences and to promote Foreign and Home Missions in the Jasper Association.

SECTION IV. State Board Member. The Jasper Association Moderator shall represent this Association to the General Board of the Alabama State Association. In his absence, the Assistant Moderator will serve as his proxy.

SECTION V. Childrens Home Trustee. This person shall represent the Jasper Association on the Childrens Home Board of Trustees. This member shall serve a term of Two (2) Years and give a report to each annual session of the Jasper Association.

#### ARTICLE VI STANDINGCOMMITTEES.

SECTION I. Credentials Committee. The Credentials Committee shall consist of five (5) persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from the churches and other associations, as well as, all ministerial reports. This committee shall also examine all ministers who become a part of this body whether by ordination or by letter. It is expected that all ministers coming from other associations will present letters of recommendation; however, in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of business pertaining to ministers or conduct of ministers should be presented first to this committee. Business matters handled by this committee may be referred to the Association or to the General Board.

SECTION II. Nominating Committee. Shall consist of Five (5) members, elected for period of Five years, with the senior member in point of service expiring each year. It shall be responsibility of this Committee to make nominations for Associational Officers and submit such nominations to the General Board.

SECTION III. Finance Committee. The Finance Committee shall consist of three (3) members elected for a period of three years, with the senior member in point of service expiring each year. It shall be the responsibility of this committee to

examine the financial report and bank statements of the Association, verify their accuracy, and report to the Association at the Annual Session.

SECTION IV. The moderator of this Association shall be an ex-officio member of all boards and committees.

#### ARTICLE VII MEETINGS

SECTION I. This Association shall meet annually on the third Saturday in September at location determined at the previous annual session.

SECTION II. The Nomination Committee shall meet on the first Tuesday night of August at a location and time to be determined by the General Board. The General board shall convene annually on the second Monday night of August at a time and location to be determined by the General Board.

SECTION III. The associational year shall end on August 31<sup>st</sup> and all letters to the Association should be mailed to the clerk no later than the 10<sup>th</sup> day of September of each year.

SECTION IV. There shall be one other district meeting during the associational year. The meeting will be held in January at locations determined at the annual session.

SECTION V. The officers of the Jasper Association shall serve as the officers of the District Meeting.

# ARTICLE VIII MINISTERS AND DEACONS

SECTION I. Any man who becomes convinced that the Lord has called him to preach the gospel shall be licensed by the church of which he is a member. (The church should contact the Credentials Committee for a copy of "Guidelines for Licensed Ministers").

If, after a period on one (1) full year, he has been called to an approved work such as pastor, assistant pastor, youth minister, full-time evangelism, or missionary work, he may then be examined by the responsible ones of this body to determine his worthiness for ordination. The local church, of which he is a member, must be able to show proof of his worthiness as to his character, doctrine, ability, sincerity, and desire. If, after having been examined, he then be found worthy, he shall be ordained by this Association. All ordinations to the ministry must be approved at the annual session or at a quarterly meeting of the Jasper Association. If, after the period of one (1) full year has expired, the licensee has not been called to an approved work, his license may then be renewed each year or until he has been called to an approved work. No one may be ordained who has not been called to an approved work.

SECTION II. Candidates for ordination to the ministry shall present their request for ordination to the Credentials Committee, (using forms prepared and approved by this body), at least by the time of the last regular meeting prior to the ordination date requested.

SECTION III. Preachers coming to us from other Free Will Baptist Associations shall present their request for membership to the Credentials Committee at any quarterly meeting or annual session and said request may be acted upon at that session.

SECTION IV. Preachers coming to us from other denominations shall present their requests to the Credentials Committee at any quarterly meeting or annual session. Such request shall be acted upon at the time of the following regular meeting be it quarterly meeting or annual session.

SECTION V. All ministers having been previously approved by this Association, shall receive a Card of good standing annually upon receipt of Church Letter listing all approved ministers of that Church.

SECTION VI. Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ordained ministers and at least one deacon, or one ordained minister and at least two deacons.

# ARTICLE IX DISCIPLINE

SECTION I. This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith or from the National Treatise. Whenever conditions warrant it, this Association shall have power to withdraw fellowship from any local church.

SECTION II. Any church being dealt with because of a disciplinary problem shall represent to the quarterly meeting and annual session by letter and fees, but shall not have the right to vote by delegates, standing or otherwise, until the matter is settled. Exception: Any minister who is a member of such church but is ministering to another church that is in good standing with the Association shall not be so penalized.

SECTION III. All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-third vote of this Association.

SECTION IV. No minister whose conduct is being questioned by this Association shall have the right to vote in either the quarterly meeting or annual session.

SECTION V. The pastor who preaches the word of God, ministers to the needs of the members, and exercises general leadership within the congregation is expected to unite with the local church if he is not a member when called..."

When the minister becomes pastor to a given local church, it is his responsibility to obtain good standing in the association of which that church is a member if he is

not already in good standing therein." (A Treatise of the Faith and Practices of the Original Free Will Baptist, 1973, 50 A: Page 59B.)

SECTION VI. No church shall accept as members those who have not been baptized by an ordained minister.

# ARTICLE X AMENDMENTS

This Constitution may be amended at any session of this association by twothirds vote of voting body present, provided proposed amendment is presented in writing, read, placed on the table during morning session, and acted upon during afternoon session.

#### RULES OF DECORUM

- 1. This Association shall be called to order by the moderator and presided over by officers elected at the previous annual session.
- 2. The association shall be opened and closed by singing and prayer.
- 3. The names of delegates shall be noted and referred to as often as is necessary.
- 4. The moderator shall not be entitled to a vote except in case of a tie and then he shall give a deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as moderator while he speaks.
- 5. Only one person shall speak at a time and he shall arise and address the moderator, and after recognition by the moderator, he shall proceed.
- 6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.
- 7. No person will be allowed to speak more than twice on the same subject without permission from the moderator nor more that five (5) minutes at a time.
- 8. No person shall laugh or talk in a disturbing manner while discussion is going on.
- 9. No delegate shall absent himself from the association without leave of the moderator.
- 10. Any minister absent from the annual session of this association for two years in succession shall be dropped from the roll of ministers. Exception: Full-time evangelists or Missionaries serving in the other states or countries, students who are attending college, those serving in the armed forces.
- 11. These Rules of Decorum may be amended at any session of this association by the two-thirds vote of body present, provided proposed amendment is presented in writing, read, placed on the table during morning session, and acted upon during afternoon session

#### GUIDELINES FOR RETIRED MINISTERS FUND

#### I. Qualifications

- A. The minister/missionary must be at least 65 years old or totally disabled.
- B. He must have served in the Jasper Association for at least 10 years as pastor of affiliated churches or in full time missionary work, sanctioned by the National Association of Free Will Baptist and meet all other qualifications.
- C. He must not be in the pastorate or missionary at the present.
- D. He must maintain membership in a local church affiliated with the Jasper Association.

#### II. Procedure for Participation

- A. The local church, of which the retired minister/missionary is a member, must make a <u>WRITTEN REQUEST</u> to the Jasper Association <u>ANNUALLY</u> recommending the minister/missionary and stating his qualifications to participate in the Jasper Association Retired Ministers Fund. No funds will be given any retired minister/missionary without this written request.
- B. Each retired minister/missionary, which meets the qualifications, will receive \$600 annually as the funds are available.

#### III. Funding of the Account

A. We recommend that each church in the Jasper Association send at least \$100 annually for the Retired Ministers Fund to provide funding for the account.

#### GUIDELINES FOR LICENSED MINISTERS IN THE JASPER ASSOCIATION

#### I.RULES PERTAINING TO THE LICENSED MINISTER

- A. Qualifications for the Licensee
  - 1. He must be a member of a church which belongs to the Jasper Association.
- 2. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. His present and prospective educational qualifications should also be considered. Upon completion of such an examination, the local church shall determine whether or not to grant license. The ministerial license shall be valid for a period of one year but is renewable annually.

- 3. He must have his license renewed annually by said church and kept in force until ordination.
- B. The Activities of the Licensee
- 1. According to the general practices of Free Will Baptist, a licensed minister is urged to afford himself of every opportunity to preach the word. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of officiating at the observances of the ordinances and weddings.
- 2. The licensee should consider the period between his receiving license and being ordained as a time of study and training in preparation for his calling.
- C. His Relationship to the Association
- 1. The clerk of the church should report the names of licensed ministers to the clerk of the Association who will forward a copy of these guidelines to each licensee.
- 2. Licensed ministers are expected to attend regular meeting of the Jasper Association and the Quarterly Meetings.

#### II. SUGGESTIONS FOR PREPARATION FOR ORDINATION

- A. Attend Free Will Baptist Colleges or Bible Institutes if possible.
- B. Seek the counsel of experienced pastors.
- C. Make as thorough a study as possible of the following:
  - 1. The Holy Bible
  - 2. Free Will Baptist Doctrine
  - 3. Systematic Theology
  - 4. Homiletics
  - 5. Pastoral theology and church administration
  - 6. Evangelism
  - 7. Church History (especially FWB history)

#### III.SUGGESTED SCHEDULE OF WORK LEADING TO ORDINATION

- A. As soon as licensee feels that he is qualified to become a candidate for ordination, he should request a list of study questions from the Credentials Committee of the Association. We would strongly encourage him to proceed with his examination before entertaining a definite call to a church. However, no one may be ordained who has not been called to an approved work. (See ARTICLE VIII SECTIONI).
- B. At least two months before the Credentials Committee meets, he should secure the examination. He should make five copies of the completed examination (one for each member of the Committee), and send them to the Credentials Committee no later than two months before its meeting.
- C. The candidate is required to pass an oral examination administered by the Committee.

- D. The Committee will report to the candidate on whether he passed or what areas he may need additional study in.
- E When the approved candidate has passed the examination, the Committee will recommend his ordination to the Association. This recommendation will be made only after the candidate has been licensed for one full year. The candidate should have definite prospects of a church pastorate or another approved work that would justify his being ordained.


