Missionary Rally, January 21, 2017

Winfield Free Will Baptist Church

The session began at 6:00 PM with Bro. Danny Williams, moderator opening the meeting. He stated 65 churches are participating in the mission conference with 24 different speakers. He made other opening comments.

Host Pastor, Bro. Kent Nelson was recognized next. He welcomed everyone to the Winfield Church. After making opening comments he led the opening prayer. Bro. Danny Williams led the congregation in singing *Bring in the Sheaves*. Bro. Danny asks each missionary to give a praise item and a prayer request.

Bro. Tim Awtrey, missionary to Bulgaria spoke next. His praise item was that they had just started the third church in Bulgaria. He asked everyone to pray for the first church that had been started ten years ago in Bulgaria that God would raise up a Bulgaria pastor to led that church.

Bro. Jamie Lee, missionary to Illinois spoke next. His praise items was stepping back and walking on faith in God; answering the call to go to Champaign and seeing God do more than he could ever thought. His prayer request was that they would find favor with the people in Champaign. He thanked everyone.

Bro. Lazaro Riesgo, missionary to Cuba spoke next. He is from Cuba. He is here working with FWB International missions as an educational specialist to Hispanic people. One of the blessings in his life is he and his wife have been in Cuba and Peru during the year and are thankful God gave them the opportunity to invest their life there with those people. His prayer request is to pray for Hispanic countries in Latin America and Spain that they can reach people for Christ. And right now there is an open door in many of those countries. He thanked everyone.

Bro. Bud and Sis. Ruth Bivens, missionaries to Mexico spoke next. He stated Bro. Rick Carol sent about 3000 shoe boxes and back packs, over a 1000 pairs of shoes and about 1000 stuffed animals to give out after Christmas. It took sixteen trips to get them into Mexico. They had a service on Wednesday night at a church they started in 1995 and had 450 people with 31 churches that took shoe boxes back to other churches in Mexico. Alabama supports 7 pastors each month and supports the Bible Institute. He asks prayer for the Children's home. They just started a home school program and need house parents, and then they could house 20 to 25 more children. He thanked everyone for their support.

Bro. Doug Bishop, missionary to Japan spoke next. His praise item was they went to a small town in Japan and began by teaching English to draw people into the church that otherwise would not come. Through that they were able to teach the Bible study in English, teaching the Bible and English at the same time. After two years they were able to turn the church over to another missionary, and are thankful God continued to work with the seeds they planted. His prayer request was to help them raise funds to return to Japan.

Bro. Carl Spruill, missionary to Hawaii spoke next. He is the team leader for Team Hawaii. His praise item was that he and his family have been approved to leave in April. They have been on the road raising fund for the last year and three

months. His prayer request was that Chris and Magi Davenport will be able to come to Hawaii by July. He thanked everyone.

Bro. Ken Eagleton, missionary to Brazil spoke next He lives in Brazil and is the regional director for Latin America and Africa and has responsibilities with International Missions in several countries. His praise item is being able to see the fruits of their labor serving in the Ivory Coast for so many years, and seeing what God is doing in that country. For example, having 10% more churches than they had the year before and 15% more in attendance and more churches being planted. He asks to pray for all missionaries.

The offering was received with Bro. Dwayne Hammontree praying the offertory prayer. The Winfield choir blessed the congregation with special music.

Bro. Clint Morgan, General Director of Free Will Baptist International Missions gave a report on International Missions and thanked everyone for their support of missions. He also gave the evening message. He spoke from 2 Corinthians 10:1-6. He brought a very informative message on *Spiritual Warfare*. He closed in prayer and Bro. Danny Williams gave the invitation.

Bro. Danny reminded the Pastors to pickup there World Missions packets, before leaving. Announcements were given next. Refreshments would be served in the fellowship hall. Bro. Danny Williams thank everyone for coming and Bro. Mark Riggs closed in prayer.

There was a separate meeting held in the gymnasium for the youth during this meeting with Bro. Chris Davenport and Bro. Tim York.

The meeting was adjourned for break at 10:00 AM. Bro. Charles Lynn led the prayer.

The meeting reconvened at 10:20 AM.

Bro. Bryan Silas gave the Trinity Youth Camp report in the absent of Bro. Ashley Culp, Director of the camp. Bro. Silas serves on the camp board. He stated Bro. Ashley sends greeting from the camp and thanked everyone for another great year. This year they replaced the roofs on both the girl's and boy's dorms without borrowing any money. They changed out several of the light fixtures to LED lights and plan on changing the gym lights to LED in the off season. He also would like to change out the dorm area to LED and a family has committed to pay for this upgrade, which he believes will be a great saving to the camp in the years to come. They are in the process of selecting their 2018 speakers. He is thankful for the salvation and ministry decisions that were made this summer and thankful for the prayers and financial support and for all the campers that attended the camp this year. He stated Bro. Ashley wanted to thank everyone for allowing him to serve the last eighteen years as the camp director. M/S/C

Bro. Danny Williams, Alabama State Executive Director spoke next. He gave the Children's Home report first. Bro. Danny stated they have 23 children at the home right now, and they are back in school at Winfield and Carbon Hill school systems. They are looking for a couple to serve as house parents, please pray for this need. October is Harvest month. Please note the list in the latest newsletter of the supplies needed. December 2nd will be the annual Toy Run and Benefit Ride. Last year the Toy Run raised a little over \$100,000.

Bro. Danny Williams gave the state report next. Bro. Tim Riggs and family in Semmes at the Bay City FWB Church went self-supporting on April 1st. About 100 people have come to know Christ since they started ten years ago. Bro. Daltan Malloy is serving as the interim pastor at Eastside in Dothan while a search for a new pastor takes place. Hopefully we will have someone in place in the near future. The church is averaging in the fifties on Sunday morning and forties on Sunday night. Six teenagers have been saved this summer and one young man has answered the call to preach. The newest addition to the state work is the Athens Alabama project. Bro. Joel Franks and B.J. Eaton have begun the process planting a church there. The Athens project will be funded by the Acts 1:8 plan.

Bro. Joel Franks, church planter to Athens AL. gave a presentation about the work in Athens. A slide presentation was shown while he shared about the Athens work. He asks to please pray for the Athens work.

Bro. Danny Williams gave the Acts 1:8 report next. This year's budget is \$570,000. This is about \$35,000 more than 2016 donations. Thank you for your help this year. It takes \$1600 each day to fund the Acts 1:8 budget. Everyone is encouraged to fund at least one day. We need everyone to match 2016 giving and

increase it some. As of August 31, 2017, across the state, giving is down about \$5,600 compared to 2016. This puts us behind budget by about \$14,000. The Jasper Association churches have given \$53,243.39 in 2017. Thank you for your support.

Bro. Donald Smith gave the Mission Board report next. Our Mission project this summer was Bro. Randall Wright serving in McKinney, TX. The funds raised will go toward his operating fund. Our goal this year was \$2500. To date we have \$ 1,620 with moiré expected to come in. Thank you so much for your prayers and financial support. M/S/C

The Resolution and Appreciation Committee Report was given next by Bro. Jerry Williams. 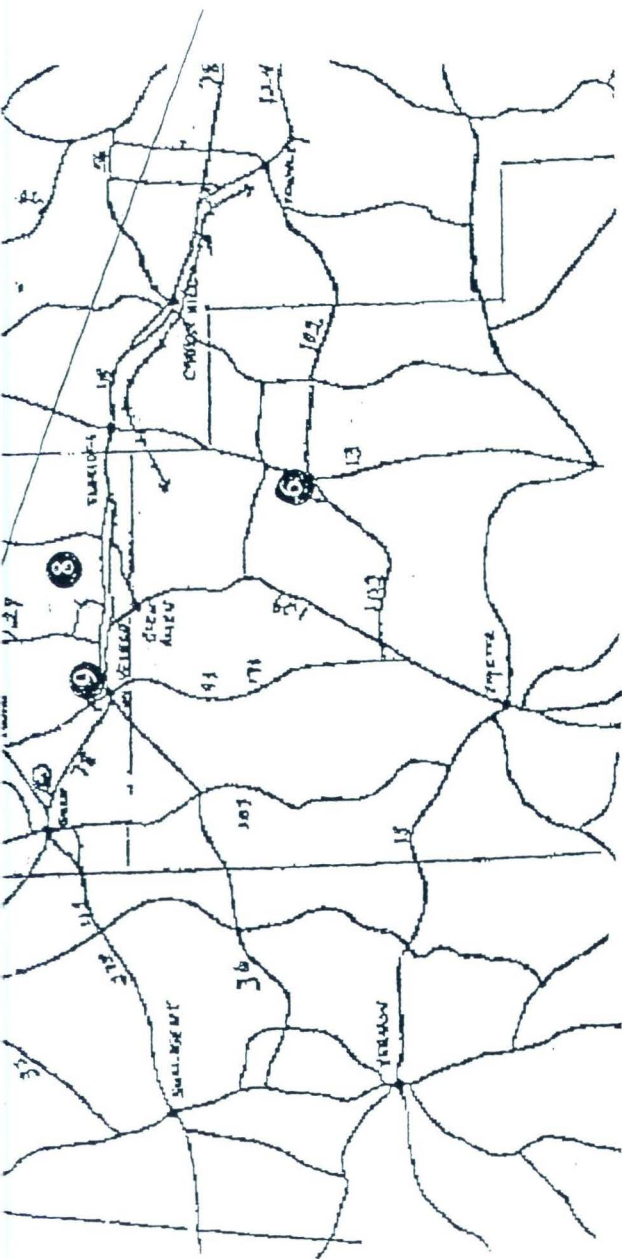

To be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, and the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

1. The Bible. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

6. The sinfulness of Man. Man was Created innocent, but by disobedience fell into a state of sin and condemnation. His prosperity, therefore, inherits a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. (3) Continuance in faith and obedience until death.

11. **Salvation Free.** God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. **Perseverance.** All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. **Gospel Ordinances.** Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.

14. **Tithing.** God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matthew 23:23), and the apostle Paul said, "Upon the first day of the week let everyone of you lay by him in store, as God hath prospered him"

15. **The Christian Sabbath.** The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

CONSTITUTION OF THE JASPER ASSOCIATION OF FREE WILL BAPTIST

ARTICLE 1

NAME

This body shall be known as the Jasper Association of Free Will Baptist of Alabama.

ARTICLE II

MEMBERSHIP

SECTION I. The membership of the Jasper Association shall consist of all churches that, upon the approval of this body, shall become members.

SECTION II. A local church that wishes to become a member of this Association must adopt the National Treatise and make formal written request. A two-thirds vote of the delegates present must be recorded for acceptance into this Association.

ARTICLE III

REPRESENTATION

Each church holding membership in this Association shall be entitled to three (3) delegates. Ordained ministers, deacons and General Board members who are in good standing with this Association, shall be standing delegates.

ARTICLE IV

OFFICERS

The Officers of the Jasper Association shall be a moderator, an assistant moderator, a Clerk/Treasurer, and assistant Clerk/Treasurer, each of whom shall be elected every two (2) years with the election coming on even years.

ARTICLE V

BOARDS

SECTION I. General Board (a) Composition. The General Board shall be composed of the moderator, assistant moderator, clerk/treasurer, assistant clerk/treasurer, the pastor and one member from each local church that is a part of this body. Each member from a local church shall serve a two year term with one-half of the members being elected each year. (b) Executive committee. An Executive Committee shall consist of the moderator, assistant moderator, clerk/treasurer and five (5) members from the General Board. These five members shall be elected annually by the General Board. This committee shall function as the General Board when said Board is not in session. (c) Duties. The General Board shall formulate all

items of general business during the annual session of the Association, as well as other responsibilities so delegated by the body. When this Association is not in session, this Board shall have power to act as the body.

SECTION II. Board of Directors of the Trinity Free Will Baptist Camp. The Jasper Association shall be represented to the Board of Directors of the Trinity Free Will Baptist Youth Camp by three (3) members. Each member shall serve a term of three (3) years with one term expiring each year.

SECTION III. Mission Board. The Mission Board shall consist of five (5) members. Each member shall serve for a five (5) year term with one term expiring each year. The Mission Board's responsibilities will be to help set up mission conferences and to promote Foreign and Home Missions in the Jasper Association.

SECTION IV. State Board Member. The Jasper Association Moderator shall represent this Association to the General Board of the Alabama State Association. In his absence, the Assistant Moderator will serve as his proxy.

SECTION V. Childrens Home Trustee. This person shall represent the Jasper Association on the Childrens Home Board of Trustees. This member shall serve a term of Two (2) Years and give a report to each annual session of the Jasper Association.

ARTICLE VI

STANDING COMMITTEES.

SECTION I. Credentials Committee. The Credentials Committee shall consist of five (5) persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from the churches and other associations, as well as, all ministerial reports. This committee shall also examine all ministers who become a part of this body whether by ordination or by letter. It is expected that all ministers coming from other associations will present letters of recommendation; however, in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of business pertaining to ministers or conduct of ministers should be presented first to this committee. Business matters handled by this committee may be referred to the Association or to the General Board.

SECTION II. Nominating Committee. Shall consist of Five (5) members, elected for period of Five years, with the senior member in point of service expiring each year. It shall be responsibility of this Committee to make nominations for Associational Officers and submit such nominations to the General Board.

SECTION III. Finance Committee. The Finance Committee shall consist of three (3) members elected for a period of three years, with the senior member in point of service expiring each year. It shall be the responsibility of this committee to

examine the financial report and bank statements of the Association, verify their accuracy, and report to the Association at the Annual Session.

SECTION IV. The moderator of this Association shall be an ex-officio member of all boards and committees.

ARTICLE VII MEETINGS

SECTION I. This Association shall meet annually on the third Saturday in September at location determined at the previous annual session.

SECTION II. The Nomination Committee shall meet on the first Tuesday night of August at a location and time to be determined by the General Board. The General board shall convene annually on the second Monday night of August at a time and location to be determined by the General Board.

SECTION III. The associational year shall end on August 31st and all letters to the Association should be mailed to the clerk no later than the 10th day of September of each year.

SECTION IV. There shall be one other district meeting during the associational year. The meeting will be held in January at locations determined at the annual session.

SECTION V. The officers of the Jasper Association shall serve as the officers of the District Meeting.

ARTICLE VIII MINISTERS AND DEACONS

SECTION I. Any man who becomes convinced that the Lord has called him to preach the gospel shall be licensed by the church of which he is a member. (The church should contact the Credentials Committee for a copy of "Guidelines for Licensed Ministers").

If, after a period on one (1) full year, he has been called to an approved work such as pastor, assistant pastor, youth minister, full-time evangelism, or missionary work, he may then be examined by the responsible ones of this body to determine his worthiness for ordination. The local church, of which he is a member, must be able to show proof of his worthiness as to his character, doctrine, ability, sincerity, and desire. If, after having been examined, he then be found worthy, he shall be ordained by this Association. All ordinations to the ministry must be approved at the annual session or at a quarterly meeting of the Jasper Association. If, after the period of one (1) full year has expired, the licensee has not been called to an approved work, his license may then be renewed each year or until he has been called to an approved work. No one may be ordained who has not been called to an approved work.

SECTION II. Candidates for ordination to the ministry shall present their request for ordination to the Credentials Committee, (using forms prepared and approved by this body), at least by the time of the last regular meeting prior to the ordination date requested.

SECTION III. Preachers coming to us from other Free Will Baptist Associations shall present their request for membership to the Credentials Committee at any quarterly meeting or annual session and said request may be acted upon at that session.

SECTION IV. Preachers coming to us from other denominations shall present their requests to the Credentials Committee at any quarterly meeting or annual session. Such request shall be acted upon at the time of the following regular meeting be it quarterly meeting or annual session.

SECTION V. All ministers having been previously approved by this Association, shall receive a Card of good standing annually upon receipt of Church Letter listing all approved ministers of that Church.

SECTION VI. Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ordained ministers and at least one deacon, or one ordained minister and at least two deacons.

ARTICLE IX DISCIPLINE

SECTION I. This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith or from the National Treatise. Whenever conditions warrant it, this Association shall have power to withdraw fellowship from any local church.

SECTION II. Any church being dealt with because of a disciplinary problem shall represent to the quarterly meeting and annual session by letter and fees, but shall not have the right to vote by delegates, standing or otherwise, until the matter is settled. Exception: Any minister who is a member of such church but is ministering to another church that is in good standing with the Association shall not be so penalized.

SECTION III. All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-third vote of this Association.

SECTION IV. No minister whose conduct is being questioned by this Association shall have the right to vote in either the quarterly meeting or annual session.

SECTION V. The pastor who preaches the word of God, ministers to the needs of the members, and exercises general leadership within the congregation is expected to unite with the local church if he is not a member when called..."

When the minister becomes pastor to a given local church, it is his responsibility to obtain good standing in the association of which that church is a member if he is

not already in good standing therein." (A Treatise of the Faith and Practices of the Original Free Will Baptist, 1973, 50 A: Page 59B.)

SECTION VI. No church shall accept as members those who have not been baptized by an ordained deacon or minister.

ARTICLE X AMENDMENTS

This Constitution may be amended at any session of this association by two-thirds vote of voting body present, provided proposed amendment is presented in writing, read, placed on the table during morning session, and acted upon during afternoon session.

RULES OF DECORUM

1. This Association shall be called to order by the moderator and presided over by officers elected at the previous annual session.
2. The association shall be opened and closed by singing and prayer.
3. The names of delegates shall be noted and referred to as often as is necessary.
4. The moderator shall not be entitled to a vote except in case of a tie and then he shall give a deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as moderator while he speaks.
5. Only one person shall speak at a time and he shall arise and address the moderator, and after recognition by the moderator, he shall proceed.
6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.
7. No person will be allowed to speak more than twice on the same subject without permission from the moderator nor more than five (5) minutes at a time.
8. No person shall laugh or talk in a disturbing manner while discussion is going on.
9. No delegate shall absent himself from the association without leave of the moderator.
10. Any minister absent from the annual session of this association for two years in succession shall be dropped from the roll of ministers. Exception: Full-time evangelists or Missionaries serving in the other states or countries, students who are attending college, those serving in the armed forces.
11. These Rules of Decorum may be amended at any session of this association by the two-thirds vote of body present, provided proposed amendment is presented in writing, read, placed on the table during morning session, and acted upon during afternoon session

GUIDELINES FOR RETIRED MINISTERS FUND

I. Qualifications

- A. The minister/missionary must be at least 65 years old or totally disabled.
- B. He must have served in the Jasper Association for at least 10 years as pastor of affiliated churches or in full time missionary work, sanctioned by the National Association of Free Will Baptist and meet all other qualifications.
- C. He must not be in the pastorate or missionary at the present.
- D. He must maintain membership in a local church affiliated with the Jasper Association.

II. Procedure for Participation

- A. The local church, of which the retired minister/missionary is a member, must make a WRITTEN REQUEST to the Jasper Association ANNUALLY recommending the minister/missionary and stating his qualifications to participate in the Jasper Association Retired Ministers Fund. No funds will be given any retired minister/missionary without this written request.
- B. Each retired minister/missionary, which meets the qualifications, will receive \$600 annually as the funds are available.

III. Funding of the Account

- A. We recommend that each church in the Jasper Association send at least \$100 annually for the Retired Ministers Fund to provide funding for the account.

GUIDELINES FOR LICENSED MINISTERS IN THE JASPER ASSOCIATION

I. RULES PERTAINING TO THE LICENSED MINISTER

A. Qualifications for the Licensee

- 1. He must be a member of a church which belongs to the Jasper Association.
- 2. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. His present and prospective educational qualifications should also be considered. Upon completion of such an examination, the local church shall determine whether or not to grant license. The ministerial license shall be valid for a period of one year but is renewable annually.

3. He must have his license renewed annually by said church and kept in force until ordination.

B. The Activities of the Licensee

1. According to the general practices of Free Will Baptist, a licensed minister is urged to afford himself of every opportunity to preach the word. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of officiating at the observances of the ordinances and weddings.

2. The licensee should consider the period between his receiving license and being ordained as a time of study and training in preparation for his calling.

C. His Relationship to the Association

1. The clerk of the church should report the names of licensed ministers to the clerk of the Association who will forward a copy of these guidelines to each licensee.

2. Licensed ministers are expected to attend regular meeting of the Jasper Association and the Quarterly Meetings.

II. SUGGESTIONS FOR PREPARATION FOR ORDINATION

A. Attend Free Will Baptist Colleges or Bible Institutes if possible.

B. Seek the counsel of experienced pastors.

C. Make as thorough a study as possible of the following:

1. The Holy Bible

2. Free Will Baptist Doctrine

3. Systematic Theology

4. Homiletics

5. Pastoral theology and church administration

6. Evangelism

7. Church History (especially FWB history)

III. SUGGESTED SCHEDULE OF WORK LEADING TO ORDINATION

A. As soon as licensee feels that he is qualified to become a candidate for ordination, he should request a list of study questions from the Credentials Committee of the Association. We would strongly encourage him to proceed with his examination before entertaining a definite call to a church. However, no one may be ordained who has not been called to an approved work. (See ARTICLE VIII SECTION I).

B. At least two months before the Credentials Committee meets, he should secure the examination. He should make five copies of the completed examination (one for each member of the Committee), and send them to the Credentials Committee no later than two months before its meeting.

C. The candidate is required to pass an oral examination administered by the Committee.

D. The Committee will report to the candidate on whether he passed or what areas he may need additional study in.

E. When the approved candidate has passed the examination, the Committee will recommend his ordination to the Association. This recommendation will be made only after the candidate has been licensed for one full year. The candidate should have definite prospects of a church pastorate or another approved work that would justify his being ordained.
