- 2. We must understand the source of success.





Psalm 1:1-2

I am sure that we have all heard the words of this children's song and have sang them probably numerous times. However, like many a song we too often sing the lyrics of the song without embracing the biblical truth behind the song. This song seems like it was inspired by the very passage of Scripture we just read, a great warning to be careful. A warning the church of today seems to be ignoring much to its detriment.

O be careful little eyes what you see

The opening line of this song is a great reminder to keep our eyes on the righteousness of God. Where we let our eyes wonder is where our soul will dwell. There are a vast array of sins our eyes entice us too. There is a nationwide and churchwide epidemic of pornography. Jesus teaches us that if

we look upon another with lust we have sinned. In spite of this dire warning there are countless church goers who let the destructive sin of pornography wreck their relationship with God, their relationship with their families and their effectiveness to minister. The most frightening aspect is that many Christians are allowing this to infiltrate their home under the guise of a harmless movie or tv show. We need to stand up and sound the warning that there is nothing harmless about fragrant and flippant nudity and that it will lead to the destruction of the family and ultimately the church. We need to be careful what we let our eyes gaze upon.

O be careful little ears what you hear

We must heed the warning of this lyric. We need to be careful what we hear. Over the ages the church has become lethargic about the sanctity and holiness of God. We have allowed His name to become a mockery. We have supported music and movies that takes His name in vain. We have allowed our minds to become numb to vulgarity and profanity. We need to be careful what we allow our ears to hear. When we fill our minds with the constant hate and filth of the world, that is what we become. We should guard our minds with the truth and love of God. We should fill our minds with the words of Scripture. We should listen to the edifying of His majesty. We should be careful what we allow our ears to hear.

O be careful little feet where you go

This verse most aptly embodies the Psalmist warning. We need to be careful where we allow our feet to carry us. There has been many a Christian who has fallen based on where his feet carried him. Weather it was to ungodly counsel or ungodly activity we need to be careful where we allow our feet to take us. There is a progressive action behind the warning of the Psalmist. If we allow our feet to continually take us into sinful situations, we will eventually fall into sin. We need to guard against this and be careful where we allow our feet to take us.

O be careful little mouth what we say

We need to have a mouth that is uplifting and fully of Godly grace. We need to be people who are identified by our love and not hate. The church as a whole has a reputation of hate, and much of it is warranted. We have become so judgmental of people that we forget the words of Jesus, "Love your neighbor as yourself." We need to get rid of the hateful and ungodly speech, and be people who speak Love. We need to let the Holy Scriptures be our voice. We need to speak God to people. We need to be careful what we allow our mouth to say.

In conclusion let us look to Proverbs 4:23 which reads, "Keep your heart with all

vigilance, for from it flow the springs of life." We need to be actively guarding our heart and only allowing in the things from God. What we allow ourselves to be exposed to, will become part of us. Like mentioned in our key text, Psalm 1, let us meditate and expose ourselves to God's Law. We need to allow God's Word to become part of us.

ARK CITY FWB CHURCH REPORT

To the Kansas State Association of Free Will Baptist;

At this time last year, we were in the training stage to begin facilitating a Christian based depression support group. In September, we launched the support group and have been blessed to minister to a diverse age range of people who are struggling with depression and have considered or attempted suicide. We have had one person attend because the group was recommended by their counselor and we remain amazed their counselor even knew the group existed. God has used the group to minister His restorative love to hurting, desperate people. We are in the planning stages of starting an addiction support group but at this moment do not have a launch date in mind and we wait upon the Lord to lead and guide in that endeavor.

The last year obviously held its struggles and challenges but we rejoice in the victories. Our oldest daughter, Kaitlin, spent 6 months in Thailand working with victims of sex trafficking through a Christian mission group. She has returned to the states to pursue her studies. Our youngest daughter, Gabrielle, has answered her call to vocational missions and is planning to attend Welch after graduating high school to study psychology and missions. She is returning to Rampart, Alaska on a mission trip this summer and will also be traveling to Uganda. While she has not met her entire fund raising goal yet but God has greatly blessed her finances thus far. She also continues to be active in various local ministries.

The last few months at church has seen a person we have been ministering to for 4 plus years reach 10 months of sobriety. My wife and I have often despaired of ever seeing this person live clean and sober and we have been overjoyed at their deliverance and success. It has been an important reminder to us, and will hopefully serve as a reminder to others, that you work where God plants you and He will bring a harvest. In my younger days in ministry I dreamed of being involved in these historical, great revival type of moves of God. As time has gone on I have been incredibly humbled by the fact that God would take a single broken life and trust us to minister to that person. I also want to express my thanks to my wife who, like most pastor's wives, labors tirelessly for God, the church, and our family with little recognition or appreciation.

We are currently still working on forming a collective vision for the future of our congregation. The goal is to have written visions from all members of the church and then form them into one collective vision. While I had hoped that process would be completed by now it is still something we are working on and something we will continue to challenge the members to constantly consider over the years. I have also challenged every family in our church to plan and execute a community outreach so I can better see how God is speaking to them and so they can see how God is using them and also recognize that it is their efforts that God uses grow the Kingdom and the church. We continue to be active in our support for various missionaries and mission groups and are proud to be supporting efforts to raise awareness of the plight of persecuted Christians around the world.

We were approached in September by the pastor of a displaced Spanish speaking church looking for a location to hold services. 17% of the population of Ark City is Hispanic and we have long felt the need to work with a Hispanic ministry. After doing our due diligence in prayer and reference checking Iglesias Del Nazareno moved into our building and have services on Sunday afternoon at 1:00 and on Tuesday evenings. It has been a wonderful relationship that has benefited both congregations and we look forward to having joint services and outreaches in the future.

Our greatest need continues to be laborers for the harvest. We desperately need someone to work with and teach our children and to help disciple new converts. I would ask you to join us in prayer that God will send us one or two mature Christian families to work alongside us in the ministry.

PRAIRIE MEADOWS FWB CHURCH REPORT TO KANSAS STATE MEETING APRIL 27 – 29, 2017

This past year has been a very productive year for Prairie Meadows Free Will Baptist Church. It has been a year filled with joy, sorrow, highs and lows. A year of change and a year of strengthening. This past year we have had to lean on the Lord as never before and join together to accomplish His will.

The biggest news bulletin of the year would be our change of location. As many of you know, our landlord at our old location put the building for sale a couple of years ago. Well, the building finally sold. The purchaser of the building gave us the opportunity to continue to meet there if we signed a three year lease. We prayerfully considered this and decided that it was time to find a new meeting place. The reason for this is many. First, the building was not large and we were already closing in on capacity. Second, there was no room for any additional Sunday School classrooms. Finally, the majority of our people were coming from towns further to our north. We looked for a different place to meet and found Happenings Event Space. This location was about 15 minutes to our north and put us near the center of where our people were actually coming from. The building is twice as large as our previous building and the rent is a little cheaper. The drawback is we do not have exclusive access to the building. It is still an event rental hall and we rent it every week for our church services. This presents some obstacles, but none too big. We do have to set up every week for service and tear down afterwards. Sometimes we will get there on Sunday Morning and have to do some cleaning from the event the night before, but we know that we are were God wants us. The positives far outweigh the negative. However. please pray that we will find a permanent home in God's timing.

Moving has presented a few struggles with our attenders. The majority are still faithful, but it is easy to get out of the habit of church when something changes. Anything Satan can use to pull someone away from church He will. We do have some families that we are working to get faithful again. Although the church is closer for them now, it is still different. Please pray as we reach out to them through visitation, letters, calls and events.

We have seen growth in some of our "new" to church families. They are stepping up and helping the church and suggesting events. It is exciting to see the growth of God in their lives. We have seen the altar full several Sundays this past year. It is a helpful reminder of why we planted this church, to see God move in people's lives. It is what sustains us when the going gets tough.

We had a tremendous Easter Service. We had some new faces there and many tear filled eyes. We had several babies there and 10 kids from 2-7 in our children's church. The seats were packed with one of our largest crowds ever. Most importantly, the Risen and Living Savior was glorified. Services like this show me that it is evident that God is moving at Prairie Meadows church. We have seen many lives changed. We know that this is where God wants us to be.

We do, still, have the need for financial support. I have talked to the church about working towards a self-sustaining level, but we are not yet there. It is evident that God is moving at Prairie Meadows Church, but it is also evident that Satan is attacking our support. He know that when the finances are struggling, it is hard to trust in God. I prayerful ask for your continued support. Even if it is just for another year. I full believe that self-sustaining is in sight, but we need support for a little longer. We run this church much cheaper than most mission plants. We only require \$1,000 per month in support. This is not a large amount of money in the grand scope of things, but it is what makes the difference in us being able to meet our bills. Please continue to pray.

KANSAS STATE ASSOCIATION OF FREE WILL BAPTISTS

CONSTITUTION AND BY-LAWS (updated 06/11/16)

PREAMBLE

From long experience, we the members of the Free Will Baptist denomination, being regularly baptized upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of unity and fellowship among us as a church and to preserve and maintain correspondence and coordination within us, do therefore ordain this constitution for a better denominational government.

ARTICLE I - NAME

This Association shall be called the Kansas State Association of Free Will Baptists, and shall be composed of such regularly organized and disciplined Free Will Baptist Quarterly Conferences, conveniently located, as may embody themselves under this constitution.

ARTICLE II - MEMBERSHIP

This Association shall consist of elected delegates from the several Quarterly Conferences and Churches of which they are composed. Each Quarterly Conference is entitled to five (5) delegates and every Church is entitled to one (1) delegate, providing said Quarterly Conferences and Churches are in good standing. Ordained ministers and ordained deacons, who are serving on local church deacon boards, and all elected officers of the State Association shall be standing delegates.

ARTICLE III - OFFICERS

The officers of this association shall be moderator, assistant moderator, clerk, assistant clerk, treasurer, and assistant treasurer. The executive board shall consist of three (3) men who are ordained ministers or deacons, elected for a one (1), two (2), and three (3) year term, with one term to expire each year.

ARTICLE IV - REPRESENTATION

Any well organized and well regulated Free Will Baptist Quarterly Conference, composed of such churches as conform with the practice and adopt the doctrines of the Free Will Baptist denomination as published in the Treatise of the National Association, may at any time, on application and by vote of this body, become of member thereof.

- 1. Providing they adopt and adhere to State questionnaire number 1, 2, and the one for ministers and deacons.
- 2. Failure to comply with this ruling concerning licensing and ordination of ministers and deacons will result in withdrawal of fellowship.

ARTICLE V - DISCIPLINE

This Association shall have power to discipline the Quarterly Conferences of which it is composed, and to exclude them for disorderly walk if labor proves unsuccessful, but in no case reverse their decisions, nor to interfere with any of their internal regulations.

ARTICLE VI - DELEGATES AND FEES

It shall be the duty of the Quarterly Conferences of this Association to represent themselves by letter, delegates, and a fee of \$150.00 per church, and report their standings and statistics, at which time the Association shall act upon such questions and topics as may be referred to it by its respective Quarterly Conferences and transact such other business not repugnant to this constitution. Each local church is entitled to one (1) delegate to this Association, provided a letter of recommendation is presented to the clerk of this Association, from the local church, signed by the local church clerk or its pastor.

ARTICLE VII - BY-LAWS

This Association shall have power to adopt any regulations or by-laws not inconsistent with this constitution, which may be deemed essential to the further regulation of its session.

ARTICLE VIII - AMENDMENTS

This constitution may be amended or changed at any regular session of this Association by two-thirds vote present, provided the proposed amendment or change be laid on the table for at least eight (8) hours.

ARTICLE IX – ASSOCIATIONAL YEAR

The reporting period for this Association will begin April 1 and end March 31.

BY-LAWS

SECTION 1 - OFFICERS

All officers and board members shall be members in good standing of a local church affiliated with the Kansas Sate Association. They shall be elected at the discretion of this Association.

SECTION 2 - OFFICERS DUTIES

- Moderator: The Moderator shall be the principle executive of the Association. He shall preside at the 1. meetings of the State Association. He shall be an ex-officio member of all boards and committees.
- 2. Assistant Moderator: In the absence of the Moderator, or in the event of his death, inability, or refusal to act, the Assistant Moderator shall perform the duties of the Moderator, and when so acting, shall have all the powers of and be subject to all the restrictions upon the Moderator. The Assistant Moderator shall perform such duties as from time to time may be assigned to him by the Moderator or by the Association.
- 3. <u>Clerk</u>: To be custodian of the Association records, in general, perform all duties incidental to the office of Clerk and such duties as from time to time may be assigned to him by the Moderator or Association.
- 4. Assistant Clerk: In the absence of the Clerk, or in the event of his death, inability, or refusal to act, the Assistant Clerk shall perform the duties of the Clerk and when so acting, shall have all the power of and be subject to all the restrictions upon the Clerk. The Assistant Clerk shall perform such duties as from time to time may be assigned to him by the Clerk or the Association.

- 5. <u>Treasurer</u>: The treasurer shall be a person with some bookkeeping ability. It shall be his duty to receive and promptly deposit to the bank account of the State Association all checks and monies. He shall pay all fixed expenditures, and miscellaneous expenditures incurred in the normal operation of his office. He shall keep accurate records of all receipts and disbursements with proper vouchers. He shall balance his books monthly. He shall give an itemized written report to each annual Associational meeting. He shall give a written monthly report to the editor of the State publication to be printed. He is the custodian of all records (financial), legal papers, and Associational documents.
- 6. <u>Assistant Treasurer</u>: In the absence of the Treasurer, or in the event of his death, inability, or refusal to act, the Assistant Treasurer shall perform the duties of the Treasurer and when acting, shall have all the power of and be subjected to all the restrictions upon the Treasurer. The Assistant Treasurer shall perform such duties as from time to time may be assigned to him by the Treasurer or the Association.
- 7. <u>Parliamentarian</u>: He shall have a good working knowledge of parliamentary law. He is to advise the Moderator or any member of the proper procedure, according to Roberts' Rules of Order.

SECTION 3 - BOARDS AND THEIR DUTIES

Each state board shall provide a proposed plan for the coming year with their vision statement and proposed budget, so that the state body of Free will Baptists will be apprised of the growth and expansion of the state work.

1. <u>Executive Board</u>: It shall be the duty of this board to act in behalf of the Association in an emergency situation when the Association is not in session, provided there is not sufficient time to call the Association into special session. The declaration of emergency shall be unanimous by all three board

members. It shall be bound to carry out the directions of the Association and shall hold itself bound by every consideration of morality and honor to carry out the wishes of this Association and to act under its instructions in whatever technical rights, civil laws, and the decisions that the courts may give it in certain emergencies.

It shall be the duty of this board to sign their signatures to any and all papers concerning property, indebtedness, bonds, or other legal documents pertaining to the execution of the will of this Association.

The members shall assist and direct such work for the general promotion of this Association as is deemed needful or necessary as the means available shall permit.

All decisions of this board shall be governed by the general tenets of this Association and shall not violate this constitution. This Board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, and work done and shall make a report in writing at each annual session of the Association. All records shall be available to this Association at its request.

Whereas, this board represents the Association, when not in session as provided above, it or a majority of the active local churches who are members of this State Association shall have the power to call the Association into special conference provided each affiliated Quarterly Conference shall be given notice at least ten (10) days prior to the meeting of such special conference.

2. <u>Mission Board</u>: It shall be the duty of this board to labor to further the Gospel of Jesus Christ into the uttermost parts of the earth. In accomplishing this, they are to endeavor to establish missions and churches in communities within the bounds of this Association with whatever moral and financial

assistance that may be theirs. In cases of small churches failing to function, whatever assistance deemed appropriate shall be rendered to maintain the effective witness of that church by either direct labor with the church or with a Quarterly Conference board in instances where the affiliated Quarterly Conference has a functional board or agency.

This board shall be empowered to receive and convey title to real property in the area of its labors.

The promotion of missionary endeavor from a local, state, or national level shall come within the scope of endeavor of this board. This board shall assist in maintaining prayer and financial support of missionary enterprises through whatever channels available.

Whereas missionary and evangelistic labors are so intimately related, this board shall assist through participation or assistance in maintaining a strong evangelistic thrust in the life of affiliated Quarterly Conferences.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors. This board shall keep an accurate record of all meetings, decisions, work done, funds received and disbursed, and shall make a report in writing at each annual session of this Association. All records shall be available to this Association at its request.

3. <u>Christian Education Board</u>: The duties of this board shall be to plan and assist in organizing and sustaining strong Sunday School, Church Training Services, and any educational endeavor such as conferences, in every church in each Quarterly Conference affiliated with the State Association with every means of promotion and assistance available to them. This board shall plan, promote, coordinate, and conduct statewide youth activities, camp(s), etc. It shall approve all state competitors to the National Youth Conference.

This board shall organize itself and elect such officers as necessary to the orderly conduct of its affairs and labors.

This board shall keep an accurate record of all meetings, decisions, work done, funds received, and funds disbursed. It shall make a report in writing at each annual session of this Association. All records shall be available to this Association at its request.

SECTION 4 - ASSOCIATIONAL REPRESENTATIVES

1. <u>General Board Member to the National Association</u>: He shall be elected for a three (3) year term. He shall meet with the General Board of the National Association of Free Will Baptists, and shall take to it the desires of this Association.

SECTION 5 - ORGANIZATION OF NEW CHURCHES

- 1. When a church is a member of a Quarterly Conference within the State and desires to change membership to another Quarterly Conference, it will:
 - A. Request a dismissal to unite with another Quarterly Conference. A letter of dismissal and recommendation is given, if said church is in good standing.

- 1) All members of said church holding State office or board membership will continue their duty if church follows outlined procedure.
- 2) If church desires not to follow with the outlined procedures, all members holding State office or board membership positions will be declared vacant and replaced by the Executive Board.
- Any church or minister desiring to start a mission in an area where there is an organized Free **B**. Will Baptist church that is a member of the Kansas State Association will first seek the cooperation of said church. No minister should help organize a group into a church that is out of fellowship with an established Free Will Baptist church that is a member of the Kansas State Association.

SECTION 6 - THE PRACTICE OF ACCEPTING MINISTERS INTO THE STATE OF KANSAS

- 1. No minister shall be examined or accepted into the local Kansas Quarterly unless it has been requested by a local church of that Quarterly. The minister must be a member of that church.
- 2. A minister transferring from one Quarterly to another within the Denomination shall undergo the following:
 - He is examined by the local Quarterly's examining council. A.
 - He is required to present a letter of good standing by the Quarterly of which he was last a **B**. member.
 - С. His Ordination Credentials may then be "ratified" by the Quarterly upon recommendation of the examining council.
- 3. A minister from another denomination wishing to unite with the Free Will Baptist Denomination must first unite with a local Free Will Baptist Church and will then be subject similar to that in Item 2. Upon a vote of acceptance he shall be issued Free Will Baptist credentials.
- 4. A minister from an independent Free Will Baptist Church wishing to unite with the Free Will Baptist Denomination must first unite with a local Free Will Baptist Church.

The following procedure shall take place:

- A. His local Free Will Baptist Church shall request he be examined by the Quarterly.
- B. He will then be set aside for 12 months of probation by the Quarterly upon recommendation of the examining council.
- С. During that 12 months of probation he shall:
 - 1) Have the status of a licensed minister with the Quarterly and State Association.
 - 2) Have the status of an ordained minister in the local church.
- D. After 12 months the local church may request his credentials be "ratified".

- E. His ordination credentials may then be "ratified" by the Quarterly upon re-examination and recommendation of the examining council.
- 5. A minister from another independent church or denomination wishing to unite with the Free Will Baptist Denomination must first unite with a local Free Will Baptist Church and then be subject to the same procedure as that in Item 4. Upon a vote of acceptance he shall be issued Free Will Baptist credentials.

STANDING RULES OF ORDER

- 1. All business meetings shall be opened by singing, reading of a portion of God's Word, and prayer and shall be closed with prayer.
- 2. All business, except routine, shall be brought before the body by committees, but should any committee refuse or fail to present to this body any business given it by any member of the Association, then such business may be presented to the body by any member.
- 3. No one shall speak more than five minutes or more than twice on the same subject without the consent of the Moderator.
- 4. Any member of this body can appeal the decision of the chair to the Association and by a two-thirds majority vote thereon, the objection shall be sustained or rejected.
- 5. No one shall leave the Association when in a business session without the consent of the Moderator.
- 6. Anyone desiring to speak shall arise and say "Brother Moderator," but shall speak no further until he or she is recognized by the Moderator.
- 7. The Moderator shall stop discussions when not carried on in a Christian spirit or when it is likely to lead to discord or division.
- 8. The Officers of this body shall submit, at every annual session, a written report of the work done for this Association.
- 9. This Association may correspond by messenger or otherwise with other religious bodies.
- 10. All resolutions and reports shall bear the names of all the members of the committee who favor them; and if the names be not a majority of such committee, the Clerk shall not read the resolution or report. A minority report may be received however.
- 11. All committees shall be appointed by the Moderator which shall be assisted by a Committee on Committees. This Committee on Committees shall be appointed by the Moderator.
- 12. A majority of votes shall be final upon all subjects except to amend the constitution and by-laws, receive Quarterly Conferences, the changing of the members of the committees appointed by the Moderator and overruling the Moderator, then it shall require a two-thirds majority.
- 13. The sessions of this Association shall convene the last Thursday night, Friday, Friday night, and Saturday until noon of April.
- 14. These by-laws may be amended or changed at any regular session of this Association by two-thirds vote present.
- 15. This Association shall adopt "Roberts' Rules of Order."

- PREVIOUSLY APPROVED MOTIONS -

<u>1975</u>

All Quarterly Conference projects must be approved by the Executive Boards of the various Quarterly Conferences, and the chairman of the respective boards must contact the State Christian Education Board before sponsorship or funds will be approved.

<u>1977</u>

Association Treasurers (includes Board Treasurers)

- 1. The treasurers should require written support for all disbursements.
 - A. For mileage, a signed statement should be presented which tells the purpose for the trip, the destination, and the total miles driven.
 - B. For other expenditures an invoice or statement should support all disbursements.
 - C. All Statements should be itemized.
- 2. All voided checks should be retained.
- 3. Treasurers should reconcile their bank accounts monthly or as often as the bank supplies statements. Checks that do not clear the bank in a reasonable amount of time should be investigated.
- 4. The Association should reimburse only the expenses of those members duly elected or appointed by the Association.
- 5. Members of official business should be more thrifty with God's money.

<u>1981</u>

The Standing Boards of the State Association shall be allowed to pay their duly elected members 20 cents per mile for travel to and from board meetings.

<u>1988</u>

Motion that the clerk instruct future nominating committees to maintain representatives from both Quarterly Meetings on all boards and committees if at all possible.

<u>1990</u>

The following guidelines are to be used in preparation of financial records.

- The check, check register, and ledger (if used) should document the reason for the 1) expenditure.
- Expenditures should be documented by purpose for the expenditure and should be 2) signed and dated.
- Records should show the year in addition to the month and day. 3)
- Each treasurer should read and follow the "Previously Approved Motions" in the 4) State Minutes.
- 5) Bank statements should be reconciled, dated, and initialed.
- Reports from each treasurer that are to be presented at the State Meeting should be 6) prepared early enough for use by the Auditing Committee.

- Separate accounts should have a separate ledger. 7)
- More stability in length of service and experience is desirable in selection of 8) treasurers.

The Moderator is authorized to appoint, from volunteers, an editor for a State newsletter. The newsletter should be informative in nature regarding scheduled events of Churches across the State and should be approximately one page in length. Printing and postage costs necessary will be paid for from the State Treasury.

<u>1991</u>

The Public Morals Committee is to be elected one year in advance of their reporting time.

<u>1992</u>

The Moderator will not serve on any standing board, whereas he is an ex-officiate member of all boards (this applies to the Asst. Moderator when he becomes Moderator), and that those members chosen to serve on the Executive Board not serve on any other standing boards.

As guidelines, no one person will hold more than one office, except for those performing the duties of Clerk and Treasurer.

<u>1994</u>

The following is to be used concerning the State Home Missions Board:

- 1. Any church and/or pastor receiving financial aid participate in all State and Quarterly activities.
- 2. Give accountability of work that is being done.
- 3. Keep records of all visits that are made.
- 4. Give monthly report to whatever department you are receiving funds from.
- 5. If unable to abide by these guidelines financial aid would be nullified and all funds paid back to the department from which received.

<u>1995</u>

Any person serving as a State officer or as a member of a State board or committee who does not take an active part (does not attend meetings or participate in phone communications) be removed from such board (committee) and be replaced by the State Executive Board until the next state meeting. The respective boards or committees will make this determination and notify the State Executive Board for further action.

No missionary or interim missionary shall be hired into such an important leadership position that cannot pass Guidelines for Ordination set by any Quarterly or Association in the State of Kansas.

<u>1996</u>

The location of the Kansas State Association meeting will be determined two years in advance.

<u>1997</u>

The Kansas State Home Mission Board will cease financial support to churches unless the church place themselves under the authority of the Kansas State Home Mission Board.

<u>1998</u>

Reduced Mission Board size from five to three members.

2000

Associational year will run from May 1 to April 30.

<u>2001</u>

The *Arrow* editor will be paid \$40.00 per bimonthly issue for expenses.

The General Board Member to the National Association will be elected to a three-year term.

2002

Guidelines for the office of State Promotional Director:

- 1. To see to the needs of the local church by filling empty pulpits, when asked by the local church.
- 2. To see that the neighboring states receive copies of the state newsletter, the *Arrow*.

- 3. To promote only those things that the state body of Free Will Baptists approved by vote.
- 4. Work in cooperation with the state boards.

2003

- 1. Everyone elected to handle the financial affairs of this Association must have some knowledge of proper bookkeeping/accounting procedures.
- 2. Each person elected to handle the financial affairs of this Association read and follow the previously approved motions shown in the State minutes regarding their duties and the Associational year.
- 3. The State Home Missions Board recover missing records such as bank statements, and to the extent possible, source of receipts and expenditures. Since there was none found among the records, the State Home Missions Board will recover or develop a repayment agreement and schedule for the \$13,000.00 loaned to Living Hope Free Will Baptist Ministries in 2001. These documents will become a permanent part of the Board's records.

<u>2004</u>

Adopted a program to be called "The A.J. Project" (patterned after our current program of a Kansas ministerial student in college) for future years to be used for a yet unidentified participant.

<u>2006</u>

Clarify the program as follows:

"The A. J. Project" be available to Kansas Free Will Baptist ministerial students attending a Free Will Baptist College.

If a Kansas Ministerial student is not available or interested, then any Free Will Baptist ministerial student who will work in Kansas and who is attending a Free Will Baptist college will be considered.

The recruiting, selecting, and fundraising of the candidate(s), along with their scheduling, supervision, and job duties be the responsibility of the State Executive Board.

The program purpose is to visit and assist the churches of the State Association during

the student's stay.

<u>2010</u>

The allocation for State Cooperative giving is:

35% - State Home Missions
10% - National CO-OP
25% - Christian Education Board
24% - State Treasurer
3% - Free Will Baptist Bible College
3% - Hillsdale Free Will Baptist College

<u>2011</u>

Increased delegate fee to \$150.00 per church.
