The committees all being appointed the body adjourns to 230 p m afternnon session, after singing by the congregation, prayer was led by CA Dean and the body is called to order and the call for church letters is renewed and two is read and the state of same noted and a motion prevails that Rev. J J Thomlev preach a doctrinal sermon Saturday at 9 o'clock a m.

Rev. R T Coleman, miles traveled 500, sermons preached 70, mem-

bers received 14, baptised 5, money received \$27 00,

Rev, J A Slay, miles traveled 1145, sermons preached 101, members received 3, baptised 1, money received \$11.07, railroad fare \$1.80 and on a motion we adjourn to 8.30 Saturday morning.

Saturday morning session after singing by the congregation praver was offered by Warren Renfroe and the body is called to order and the moderator extends the right hand of fellowship to those arriving since the last session and on a motion brother C C Hanks name is added to the roll of ministers with the understanding that Brother Hanks will meet his church in conference and get in proper standing with the church and a recess is taken for 10 minutes, after which Rev. Com. on suggestions, we suggest and recommend that the pastors and preachers and churches adhere to the resolutions past heretofore by the association we also recommend that the next session of this association meet with Pine Grove Church at Perdido Station Ala at the regular time, we suggest that we hold one fifth Sunday meeting to be held with New Home church at Lottie, Ala,, commencing on Thursday night before the fifth Sunday in July 1917 and we further recommend that the preachers get together on the other two fifth Sundays and run revival meetings with some of the weak churches, we further suggest that the association get down to business and quit childrens play, and adhere to the rules and regulations as passed by the association.

The reports all being in we take up miscellanious business and the subject of the woman preacher having been sprung by Rev J J Thomley in preaching the doctrinal sermon with a suggestion that she be not allowed to preach in our churches, is again introduced by R M Chambless and after considerable discussion Pro and Con by the members of the body, a vote is taken will the woman be allowed to preach in our churches the majority voting votes no those voting yes were R M Chambless, T J Phillips, C A Dean, D E Dean and W M Williams 5, Rev. R T Coleman and Thomas Coleman not voting, while others were very much confused and admitted that they did not exactly understand the proposition.

On motion Rev. W R Thompson of liberty No. 2 is seated with the body, and a vote of thanks is extended to the brethren and sisters and community at large for their kindness and hospitality shown the body while here assembled, Rev. J J Thomley is re-elected evangilist of the association: and Rev. Warren Renfroe is elected to write the circular letter, and Rev. R T Coleman to preach the introductory sermon in 1917.

A motion prevails that the Deacons of the church is impowered and instructed to administer Baptism to candidates in the absence of the pastor or other preacher if the candidate is ready.

Resolutions and Querries, brought from the fifth Sunday meeting,

1st Shall we adopt the rule the second fellowship in receiving members after Baptism as is now practiced by some of our churches it is so carried.

2nd. Does any church have a right to lay aside the old rool book and make a new list of names, leaving off some of the members, the body votes no and the churches is instructed to comply with the rules and regulations of the church covenant, as laid down therein.

On motion we adjourn to meet with Pine Grove church at Perdido Station, Ala., on Thursday before the fourth Sunday in October 1917 at 10 o'clock a m.

# . CHURCH COVENANT

In order to have a more perfect and free christian love and fellow-ship for each other, and to advance the cause of our Lord and Master, we do hereby agree and covenant by the help of God our Father and aided by the Holy Spirit, to keep the ord; ances precepts and examine as laid down in the new testament of our Lord and Saviour Jesus Christ.

## AS TO RULES ARTICLE I

- Sec. 1. When a sufficient number of members are ready for organization the articles of faith and church covenant shall be read and if adopted the right hand of fellowship shall be extended and after prayer they shall proceed to the election of officers, after which they shall be declared organized and ready for business.
- Sec. 2. No church shall be organized with less than three male members.
- Sec. 3. The officers of a church shall be a pastor, one or more deacons and a clerk and a treasury and not less than three trustees.
- Sec. 4. The church shall call their pastor at the next preceeding the last regular conference, in the associational year, unless in case of a vacancy, in such case they may call a conference for that purpose.
- Sec. 5. Any church in case of necessity may call a conference and elect one of their members or a visiting minister as moderator.
- Sec. 6. The church may hold a conference as often as it deems it necessary.
- Sec. 7. It is suggested that the church commune and wash the saints feet four times a year if convenient, and it shall not be postponed on acount of disobedient members, and they may commune oftener if they so desire.
- Sec. 8. The church shall not try a member without a hearing unless said member refuses to attend the conference, when notified to do
- Sec. 9, The church may grant a license to any member in good standing to preach the gospel if it deems him worthy and competent, and said license shall be good as long as he is an advantage to the cause, but he shall not be ordained only by the recommendation or order of the church.
- Sec. 10. When ministers or deacons are to be ordained the church shall call a presbytery or instruct their pastor to do so for that purpose, and said presbytery shall be composed of two ministers or one minister and two deacons.
- Sec. 11. Deacons shall not be ordained until they have been tried.

  Sec. 12 Each minister shall be a member of some live church and
- Sec. 12 Each minister shall be a member of some five that and in good standing with his church.
- Sec. 13. It shall be the duty of every member male and female to attend each conference meeting if they can, for on that day the pastor

is expected to instruct the church in a spiritual manner by giving plain and pointed lessons on doctrine and discipline, and the rule of holy living and the church members duties.

- Sec. 14. No member shall give or attend card parties or attend other places of worldly amusement, or allow such things to be given in their homes, and drunkness is strictly forbidden.
- Sec. 15. Members dismissed from the 'church by letter who becomes disorderly or continues to hold their letters out of a church an unreasonably length of time without a reasonable excuse shall be cited to the church in conference to answer for their conduct,

#### ARTICLE 2

- Sec. 1. The pastor shall attend his church monthly unless providentially hindred, and shall sit as moderator and see that justice is done, but he may appoint some suitable brother to sit in his stead, when he thinks proper for cause, he shall also hold a protracted meeting with his churches once a year.
- Sec. 2 The deacons shall be elected by the church and shall hold office at the discretion of the church, they shall watch over the flock advise the unruly members and report such to the church in conference when necessary, and may administer the ordinance of Baptism, they shall make all necessary arrangements for the communion, look into the needs of the church, and the support of the pastor, they shall take notice of such members as refuse or neglect to partake of the Lord's supper and wash each others feet, and endeavor to ascertain the cause, that the same may be laid before the church in conference if necessary.
- Sec. 3. The clerk shall be elected by the church and shall hold office at the discretion of the church, he shall keep a record of the members and a minute of the business transactions of the church and shall read same at the conference as often as the church may demand, and shall turn over all books and papers to his successor in office.
- Sec. 4. The treasury shall be elected by the church, shall hold office at the will of the church, shall hold all moneys paid into the church for general expenses, and pay out same only on an order from the church, in conference and shall turn over all money and papers to his successor.
- Sec. 5. The trustees shall be elected by the church, and shall hold office for two years and until their successor are elected, unless removed for cause, they shall have charge of the deeds and all other

church property and shall look after the repairs of the church, but they can not sell or otherwise dispose of the church property without an order from the church in conference.

Sec. 6. No one shall be received in the church unless scripturely baptised and members shall not miss three conferences in succession without a good excuse,

Sec. 8. Members must pay all debts contracted by them or make satisfactory arrangements with their creditors, and they shall help pay their pastors.
