### **PROCEEDINGS**

#### FRIDAY MORNING, OCTOBER 8, 1976

The Eighty-Seventh Session of the Liberty No. 1 Association of Free Will Baptists opened with Bro. Jesse Odom directing the song service with Deborah Findley at the piano.

Rev. Willis Murphy welcomed everyone.

Bro. Ivan Stewart brought the Morning Devotional from Psalms 133:1 and Matthews 5:23-24 on "Unity". Also using Luke 13:11-13. Prayer by speaker.

The clerk called the session to order and introduced the officers.

Rev. P. L. Findley, moderator, brought the Moderator's Message from 2 Chronicles and 2 Corinthians 6:17-18. Prayer by speaker.

Visiting brethren were invited to seat with us.

Associational Deacons, Bro. Ted Fretwell and Bro. Herbert Cardwell, were appointed by the moderator.

Church letter statistical reports were given out by reading clerks, Rev. C. B. Baggett and Bro. Ivan Stewart.

The moderator asked Bro. Jesse James Odom to stand and read the replacements on the Executive Committee and Ordaining Council, which was voted on at the 3rd Quarterly Meeting, held July 10, 1976 at Union Grove FWB Church to have ready for association in effect of Article 2, page 9 in the 1975 minutes. On the Executive Committee replacements were Bro. Rodger Presley, Bro. Bernice Gray and Bro. Lloyd Saucer. On the Ordaining Council replacements were Rev. Tony Downey and Rev. Paul Bailey. Rev. W. G. Palmer stood and made a motion that this item be tabled until Saturday's session, seconded by Rev. Clyde Bruley. Delegates were read from church letters and seated. A vote on this issue to be tabled was voted on, 23-16.

All stood and took the Right Hand of Christian Fellowship while singing "Amaging Grace."

#### WORSHIP HOUR

The 11 o'clock service opened with Bro. Elmer Gray directing the song service.

An offering of \$29.96 was received.

The Semirah Springs group sang two specials "Is My Lord Satisfied With Me" and "Little Is Much If God Is In It". Prayer by Rev. Tony Downey.

Rev. Clyde Bruley brought the Morning Message on "The Creation" from Genesis 1:1 and John 1:10. Prayer by speaker.

Dismissed for lunch and giving of "Thanks" by Rev. E. F. Sanford.

#### FRIDAY AFTERNOON, OCTOBER 8, 1976

Assembled back at 1:30 with Rev. Clyde Bruley directing the singing with Mrs. Ivan Stewart at the piano.

Bro. Garry Winsett brought the afternoon devotional from Matthew 6:23 and Matthew 5:14-16. All stood in prayer led by Rev. J. T. Long.

The moderator opened the business session by recognizing visitors and corresponding delegates.

Committee reports were given oral: Sis. Barbara Baker requested special prayer for Rev. Thigpen (Bible College). Sis. Morencia Palmer requested special prayer for Rev. Walter Jones' wife and family, who passed away in June (Retirement & Ins.) Liberty No. 1 Home Mission and Alabama State Home Mission Reports forms were passed out by reading clerks. Bro. Ivan Stewart and Rev. W. G. Palmer commended on these and how well our churches had responded to the \$2.50 per member, which \$437.15 was given over its amount per member.

Requests from associational church letters were read, approved and adopted. (1) Range Church requested that Bro. Lloyd Saucer be ordained as a Deacon during this session. (2) Union Grove church requested that Bro. Bernice Gray be ordained as a Deacon on Saturday, Oct. 9, 1976. (3) Appleton church had two letters attached, stating that Bro. Roy Cain and Bro. M. D. Casey resigned as Deacons. (4) Pine Grove Church (a) Requested that Bro. Garry Winsett be ordained as a minister of the Gospel on Sunday afternoon, Oct. 17, at 4 p.m. at his church, Pine Grove FWB, Perdido; (b) Request that Bro. Horace Chafin meet with the Ordaining Council for transferrer of Deacon's papers; (c) We ask for a loan of \$4,000.00 from Liberty No. 1 Home Mission money for building an educational building, installment note attached; and (d) Request that Bro. Ken Reiter be ordained as a minister of the Gospel on Saturday night, Nov. 6, at his church, Mobile Mission. Motion made by Rev. W. G. Palmer and seconded by Bro. Guy Milstid.

# CONSTITUTION OF THE LIBERTY NO. 1 ASSOCIATION OF FREE WILL BAPTIST

#### **PREAMBLE**

From experience we, the members of Liberty Number 1 Association of Free Will Baptist, being regularly baptised upon the profession of our faith in Jesus Christ and members of Churches in this Liberty Number 1 Association and realizing the necessity of a bond of union and fellowship among us; to preserve and maintain correspondence and coordination with us; to unify the work of the various Churches composing the Liberty Number 1 Association; and to devise and executer measures for the extension of the Kingdom of God in cooperation with the various Churches of the Association, or that may be hereafter represented therein, do therefore ordain this Constitution for our better Associational Government.

# Article I

This Association shall be known as the, "Liberty Number 1 Association of Free Will Baptist."

# Article II MEMBERSHIP

Section 1. Membership in Liberty Number 1 Association shall be based upon Churches who after examination as to their faith and practice are found to believe in the doctrine of the Bible as outlined in our National Treatise of Faith and Practice of the Original Free Will Baptist, and who make written request to this Association for membership.

**Section 2.** The Officers of Liberty Number 1 Association shall be a moderator, asst. moderator, clerk, asst. clerk, and treasurer. And shall be elected by the Association at regular session. All boards and committees shall be elected by the Association and shall serve as directed by Association.

#### Article III

The Libery Number 1 Association adopt the National Treatise of Free Will Baptist as our rule of faith and practice.

#### **Artice IV**

Section 1. When a sufficient number of members are ready for organization the articles of faith and church covenant shall be read and if adopted, the right hand of fellowship shall be extended, and after prayer they shall proceed to the election of officers, after which they shall be declared organized and ready for business.

Section 2. No church shall be organized with less than 3 male members, nor within 6 miles of another church of the same faith, unless in towns or cities.

**Section 3.** The officers of a church shall be a pastor, one or more deacons, and a clerk and treasurer, and not less than 3 trustees.

Section 4. The church may hold a conference as often as it deems it necessary.

**Section 5.** It shall be the duty of each church to commune and wash the Saints feet at least each quarter.

Section 6. The church shall not try a member without a hearing unless said member refuses to attend the conference, when notified to do so.

Section 7. When an Associational Church desires that one of its members should be licensed or ordained to preach the Gospel, it requests the Quarterly Meeting or Association to examine by council, such member. And upon approval of council, the Association shall grant the proper papers to the candidate.

Section 8. The Ordaining Council shall consist of 5 ordained Ministers in good standing in this Association to be elected by the body. Anyone to be ordained to the office of Minister or Deacon shall upon recommendation of his church appear before this council for ordination.

Section 9. Every Minister of Liberty Number 1 Association shall be a member of an active church, and in good standing with the church in this Association.

Section 10. The Officers and their duties in the local church shall be as outlines in National Treatise Page 47, Chapter 1. "The Local Church."

#### Article V

Section 1. Ministers' Cards will be dated to expire on October 31 of each year. The Executive Committee will examine cards. At their approval, ministers will receive a new card.

Section 2. Each Church send a Sunday School report to Clerk of Sunday School Convention in May and bring a program.

Section 3. Suggest that old and disabled Ministers be placed on Honor Roll and receive life time identification card.

Section 4. Each Church send a maximum of 3 elected delegates to represent their church.

Section 5. The host church for any meeting of Liberty Number 1 Association, shall have a program outline and send one to associational clerk 3 weeks in advance of meeting. Associational Clerk shall send a program outline to all churches and all persons on the program.

Section 6. No church shall use a Minister or Deacon with more than one living wife and whose wife has more than one living husband and be in good standing with this Association.

Section 7. No Minister belonging to Liberty Number 1 Association shall pastor a church of another denomination.

Section 8. We recommend the church to support their Pastor to such a degree that he may devote himself to full time ministry of the Gospel when financially possible.

Section 9. The Executive Committee will examine all church letters and upon their approval letters will be read and delegates seated. For traveling Executive Committee will be paid 10c per mile by the Association.

Section 10. (A) The Liberty Number 1 Home Missions money can be loaned to churches at no interest. Proper paper work will be done by Church requesting the loan and paid for by the church. (B) Two Board Members must sign for money to be withdrawn from bank. (C) Loans and paper work must be approved by Liberty Number 1 Association or Quarterly Meeting before money is let out.

Section 11. The Moderator to be paid \$30.00, Clerk paid \$50.00 and Asst. Clerk paid \$10.00.

Section 12. We recommend each church to encourage their pastor to attend the State Association if possible and pay his expenses.

Section 13. The Associational offering will go to the host church for associational expenses.

Section 14. No Boards or Committees shall meet during the Business Session of this Association.

Section 15. Each church to tithe 10% of its income to the Association Treasury to be distributed from the Associational Treasury to the different phases of work: CHILDREN'S HOME 15%; BIBLE COLLEGE 10%; RETIREMENT & INSURANCE 10%; FOREIGN MISSION 10%; NAT'L HOME MISSION 10%; ALABAMA FWB MISSION 20%; and LIBERTY NO. 1 ASSOCIATION HOME MISSION 25%.

Section 16. In time of bereavement, church clerks will call associational clerk, in turn the associational clerk will call all ministers. Telephone cost will be paid out of the Associational Treasury.

Section 17. Board of Christian Education. This Board shall be composed of three members elected by the Association serving a three year term. One member shall be elected each year. The duties of this Board shall be: 1. To plan and promote Christian Education in the Association such as: (A) Ministers and Deacons Retreat. (B) Laymans Institutes. (C) Bible Conferences.
