

### **PREAMBLE**

FROM EXPERIENCE WE, THE MEMBERS OF LIBERTY NO. 1 ASSOCIATION OF FREE WILL BAPTIST, BEING REGULARLY BAPTIZED UPON THE PROFESSION OF OUR FAITH IN JESUS CHRIST AND MEMBERS OF CHURCHES IN THIS LIBERTY NO.1 ASSOCIATION AND REALIZING THE NECESSITY OF A BOND OF UNION AND FELLOWSHIP AMONG US; TO PRESERVE AND MAINTAIN CORRESPONDENCE AND COORDINATION WITH US; TO UNIFY THE WORK OF THE VARIOUS CHURCHES COMPOSING THE LIBERTY NO.1 ASSOCIATION; AND TO DEVISE AND EXECUTE MEASURES FOR THE EXTENTION OF THE KINGDOM OF GOD IN COOPERATION WITH THE VARIOUS CHURCHES OF THE ASSOCIATION OR THAT MAY BE HEREAFTER REPRESENTED THEREIN, DO THEREFORE ORDAIN THIS CONSTITUTION FOR OUR BETTER ASSOCIATION GOVERNMENT.

#### **ARTICLE I**

NAME

THIS ASSOCIATION SHALL BE KNOWN AS THE, "LIBERTY NO.1 ASSOCIATION OF FREE WILL BAPTIST"

#### **ARTICLE II**

**MEMBERSHIP** 

SECTION 1: MEMBERSHIP IN LIBERTY NO.1 ASSOCIATION SHALL BE BASED UPON CHURCHES WHO AFTER EXAMINATION AS TO THEIR FAITH AND PRACTICE ARE FOUND TO BELIEVE IN THE DOCTRINE OF THE BIBLE AS OUTLINED IN OUR NATIONAL TREATISE OF FAITH AND PRACTICE OF THE ORIGINAL FREE WILL BAPTISTS, AND WHO MAKE WRITTEN REQUEST TO THIS ASSOCIATION FOR MEMBERSHIP.

<u>SECTION2:</u> THE OFFICERS OF LIBERTY NO.1 ASSOCIATION SHALL BE A MODERATOR, ASSIST. MODERATOR, CLERK AND TREASURER, AND SHALL BE ELECTED BY THE ASSOCIATION AT REGULAR SESSION. ALL BOARDS AND COMMITTEES SHALL BE ELECTED BY THE ASSOCIATION AND SHALL SERVE AS DIRECTED BY ASSOCIATION.

#### ARTICLE III

THE LIBERTY NO.1 ASSOCIATION ADOPTED THE NATIONAL TREATISE OF FREE WILL BAPTIST AS OUR RULE OF FAITH AND PRACTICE.

#### **ARTICLE IV**

<u>SECTION 1:</u> WHEN A SUFFICIENT NUMBER OF MEMBERS ARE READY FOR ORGANIZATION THE ARTICLES OF FAITH AND CHURCH COVENANT SHALL BE READ AND IF ADOPTED, THE RIGHT HAND OF FELLOWSHIP SHALL BE EXTENDED, AND AFTER WHICH THEY SHALL BE DECLARED ORGANIZED AND READY FOR BUSINESS.

<u>SECTION 2:</u> NO CHURCH SHALL BE ORGANIZED WITH LESS THAN 3 MALE MEMBERS, NOR WITHIN 6 MILES OF ANOTHER CHURCH OF THE SAME FAITH, UNLESS IN TOWNS OR CITIES.

<u>SECTION 3:</u> THE OFFICERS OF A CHURCH SHALL BE A PASTOR, ONE OR MORE DEACONS, AND A CLERK AND TREASURER, AND NOT LESS THAN 3 TRUSTEES.

SECTION 4: THE CHURCH MAY HOLD A CONFERENCE AS OFTEN AS IT DEEMS NECESSARY.

<u>SECTION 5:</u> IT SHALL BE THE DUTY OF EACH CHURCH TO COMMUNE AND WASH THE SAINTS FEET AT LEAST EACH QUARTER.

<u>SECTION 6:</u> THE CHURCH SHALL NOT TRY A MEMBER WITHOUT A HEARING UNLESS SAID MEMBER REFUSES TO ATTEND THE CONFERENCE, WHEN NOTIFIED TO DO SO.

SECTION 7: WHEN AN ASSOCIATION CHURCH DESIRES THAT ONE OF ITS MEMBERS SHOULD BE LICENSED OR ORDAINED TO PREACH THE GOSPEL, IT REGUESTS THE QUARTERLY MEETING OR ASSOCIATION TO EXAMINE BY COUNCIL, SUCH MEMBER. AND UPON APPROVAL OF COUNCIL, THE ASSOCIATION SHALL GRANT THE PROPER PAPERS TO THE CANDIDATE.

<u>SECTION 8:</u> THE ORDAINING COUNCIL SHALL CONSIST OF 5 ORDAINED MINISTERS IN GOOD STANDING IN THIS ASSOCIATION, TO BE ELECTED BY THE BODY. ANYONE TO BE ORDAINED TO THE OFFICE OF MINISTER OR DEACON SHALL UPON RECOMMENDATION OF HIS CHURCH APPEAR BEFORE THIS COUNCIL FOR ORDINATION.

SECTION 9: EVERY MINISTER OF LIBERTY NO.1 ASSOCIATION SHALL BE A MEMBER OF AN ACTIVE CHURCH, AND IN GOOD STANDING WITH THE CHURCH IN THIS ASSOCIATION.

SECTION 10: THE OFFICERS AND THEIR DUTIES IN THE LOCAL CHURCH SHALL BE AS OUTLINED IN THE NATIONAL TREATISE, DATED 1981, PAGE 51, CHAPTER I "THE LOCAL CHURCH".

#### **ARTICLE V**

SECTION 1: MINISTERS' CARDS WILL BE DATED TO EXPIRE ON OCTOBER 31 OF EACH YEAR. THE EXECUTIVE COMMITTEE WILL EXAMINE CARDS. AT THEIR APPROVAL, MINISTERS WILL RECEIVE A NEW CARD.

SECTION 2: EACH CHURCH SEND A SUNDAY SCHOOL REPORT TO CLERK OF SUNDAY SCHOOL CONVENTION IN MAY AND BRING A PROGRAM.

SECTION 3: SUGGEST THAT OLD AND DISABLED MINISTERS BE PLACED ON HONOR ROLL AND RECEIVE LIFE TIME IDENTIFICATION CARD.

SECTION 4: EACH CHURCH SEND A MAXIMUM OF 3 ELECTED DELEGATES TO REPRESENT THEIR CHURCH.

<u>SECTION 5:</u> THE HOST CHURCH FOR ANY MEETING OF LIBERTY NO.1 ASSOCIATION, SHALL HAVE A PROGRAM OUTLINE AND SEND ONE TO ASSOCIATION CLERK 3 WEEKS IN ADVANCE OF MEETING. ASSOCIATION CLERK SHALL SEND A PROGRAM OUTLINE TO ALL CHURCHES AND ALL PERSONS ON THE PROGRAM.

SECTION 6: NO CHURCH SHALL USE A MINISTER OR DEACON WITH MORE THAN ONE LIVING WIFE OR WHOSE WIFE HAS MORE THAN ONE LIVING HUSBAND OR USE A MINISTER FROM ANOTHER DENOMINATION AS PASTOR AND BE IN GOOD STANGING WITH THIS ASSOCIATION.

SECTION 7: NO MINISTER BELONGING TO LIBERTY NO.1 ASSOCIATION SHALL PASTOR A CHURCH OF ANOTHER DENOMINATION.

<u>SECTION 8:</u> WE RECOMMEND THE CHURCH TO SUPPORT THEIR PASTOR TO SUCH A DEGREE THAT HE DEVOTE HIMSELF TO FULL TIME MINISTRY OF THE GOSPEL WHEN FINANCIALLY POSSIBLE.

<u>SECTION 9:</u> THE EXECUTIVE COMMITTEE WILL EXAMINE ALL CHURCH LETTERS AND UPON THEIR APPROVAL LETTERS WILL BE READ AND DELEGATES SEATED. FOR TRAVELING, EXECUTIVE COMMITTEE WILL BE PAID 10 CENTS PER MILE BY THE ASSOCIATION.

SECTION 10: (A) THE LIBERTY NO.1 HOME MISSION'S MONEY CAN BE LOANED TO CHURCHES AT NO INTEREST FOR CHURCH RELATED PROJECTS OR CAN BE USED FOR ASSOCIATION EXPENSES IF BODY AGREES BY A MAJORITY VOTE. CHURCH REQUESTING LOAN SHOULD PREPARE THE PROPER PAPER WORK, STATING WHAT MONEY IS TO BE USED FOR. (B) BOARD TO MEET WITH APPLICANT AND MAKE RECOMMENDATION TO BODY. (C) FINAL DECISION TO BE MADE BY THE BODY. (D) UPON SIGNATURE OF TWO (2) BOARD MEMBERS, MONEY MUST BE WITHDRAWN OR RELEASED BEFORE NEXT MEETING OR LOAN IS CANCELLED. (E) A BALANCE OF \$27,500.00 IS TO BE MAINTAINED FOR EMERGENCY PURPOSES, AUTHORITY BEING GIVEN TO EXECUTIVE COMMITTEE AND HOME MISSION BOARD TO MEET BETWEEN REGULAR MEETINGS TO APPROVE LOAN FOR THIS EMERGENCY. (F) MAXIMUM TIME FOR REPAYMENT IS FOUR YEARS FOR \$5,000 AND UP, TWO YEARS FOR \$2,500 AND DOWN WITH A MINIMUM MONTHLY PAYMENT OF \$50.00. (G) WHEN A NEW CHURCH IS RECEIVED INTO THE ASSOCIATION, THAT CHURCH MUST BE IN "GOOD STANDING" FOR THREE (3) YEARS BEFORE THAT CHURCH IS ELIGIBLE TO APPLY FOR A LOAN. (H) NO CHURCH MAY APPLY FOR A LOAN UNLESS IT IS IN "GOOD STANDING" WITH THE ASSOCIATION.

SECTION 11: (A) TAKE 7% PERCENT OFF THE TOTAL 10% PERCENT MONEY TO PAY STATE FEES FOR EACH CHURCH (REPLACES A & B), (C) THE CLERK SHALL BE PAID \$250.00, ASSISTANT CLERK \$25.00 AND MODERATOR \$50.00, (D) DISTRICT ASSOCIATION TO PAY \$200.00 PER CHURCH FOR STATE FEES.

SECTION 12: WE RECOMMEND EACH CHURCH TO ENCOURAGE THEIR PASTOR TO ATTEND THE STATE ASSOCIATION IF POSSIBLE AND PAY HIS EXPENSES.

SECTION 13: THE ASSOCIATIONAL OFFERING WILL GO TO THE HOST CHURCH FOR ASSOCIATIONAL EXPENSE.

SECTION 14: NO BOARDS OR COMMITTEE SHALL MEET DURING THE BUSINESS SESSION OF THIS ASSOCIATION.

SECTION 15: EACH CHURCH TO TITHE 10% OF ITS INCOME TO THE ASSOCIATION TREASURY TO BE DISTRIBUTED FROM THE ASSOCIATION TREASURY TO THE DIFFERENT PHASES OF WORK: CHILDREN'S HOME – 10%; BIBLE COLLEGE – 3%; RETIREMENT – 56%; INTERNATIONAL MISSIONS – 7%; NATIONAL HOME MISSIONS – 7%; ALABAMA HOME MISSIONS – 7%; LIBERTY NO.1 HOME MISSIONS – 3%; AND PROMOTIONAL DIRECTOR – 7%; (AMENDED 10/13/84 – ALL 10% MONEY FOR INTERNATIONAL AND HOME MISSIONS SHALL BE DESIGNATED EACH QUARTER TO ALABAMA MISSIONARIES.)(AMENDED 10/13/12)

SECTION 16: IN THE TIME OF BEREAVEMENT, CHURCH CLERKS WILL CALL ASSOCIATION CLERK, IN TURN THE ASSOCIATION CLERK WILL CALL ALL MINISTERS. TELEPHONE COST WILL BE PAID OUT OF ASSOCIATION TREASURY.

SECTION 17: "RETIREMENT"- (A) TO QUALIFY A MINSTER MUST BE IN GOOD STANDING WITH ASSOCIATION FOR AT LEAST 5 YEARS AND BE 65 YEARS OF AGE. (B) IF A MINISTER DIES WHILE ON THE PROGRAM, HIS WIFE WILL CONTINUE TO RECEIVE FROM THE PROGRAM AS LONG AS SHE REMAINS UNMARRIED AND IN GOOD STANDING WITH THE ASSOCIATION. (C) IF A MINISTER DIES BEFORE THE AGE OF 65 THE MINISTER'S WIDOW WOULD BEGIN TO RECEIVE AT THE AGE OF 65 AS LONG AS SHE REMAINS UNMARRIED AND IN GOOD STANDING WITH THE ASSOCIATION. (D) CLERK HAS PERMISSION TO ISSUE RETIREMENT CHECK, FIRST MONTH AFTER THE 65<sup>TH</sup> BIRTHDAY OF MINISTER. (E) FINAL DECISION TO BE MADE BY THE BODY.

SECTION 18: "AMENDMENTS"- MAY BE AMENDED AT ANY REGULAR SESSION BY A TWO-THIRDS VOTE OF MEMBERS PRESENT; PROVIDED PROPOSED AMENDMENT BE PRESENTED IN WRITING TO THE BODY AND SHALL LIE ON THE TABLE AT LEAST FROM MORNING SESSION TIL EVENING SESSION, OR FROM EVENING SESSION TIL SESSION PRIOR TO ADOPTION AND SHALL DURNING THAT TIME BE READ AT LEAST TWICE IN OPEN SESSION.

#### **ARTICLE VI**

SECTION 1: POLICY ON MARRIAGE AND HUMAN SEXUALITY, LIBERTY NUMBER 1 ASSOCIATION OF FREE WILL BAPTIST. ADOPTED JULY 12, 2015:

#### INTRODUCTION

THIS STATEMENT EXPRESSES THE BELIEFS OF LIBERTY NUMBER 1 ASSOCIATION OF FREE WILL BAPTIST REGARDING MARRIAGE AND HUMAN SEXUALITY. IT IS BASED ON THE APPLICATION OF BIBLICAL PRINCIPLES TO OUR FAITH, OUR LIFE, AND OUR PRACTICE, AND IS IN INTENTIONAL ACCORD WITH THE TREATISE OF THE FAITH AND PRACTICES OF FREE WILL BAPTISTS, ESPECIALLY AS EXPRESSED IN THE APPENDIX TO CHAPTER IV, SECTION 1, ADOPTED BY THE NATIONAL ASSOCIATION OF FREE WILL BAPTIST, OF WHICH THIS ASSOCIATION IS A MEMBER, IN JULY 2008.

#### WHAT WE BELIEVE ABOUT MARRIAGE AND HUMAN SEXUALITY

BOTH SCRIPTURE AND NATURE AS DESIGNED BY GOD AFFIRM THE LIFE-LONG, CONVENANTAL UNION OF ONE MAN, BEING MALE AS CREATED BY GOD, AND ONE WOMAN, BEING FEMALE AS CREATED BY GOD, IN A ONE-FLESH RELATIONSHIP. THIS ONE-FLESH RELATIONSHIP IS EMBLEMATIC OF THE UNION OF CHRIST AND HIS CHURCH. IT IS THE SOLE AND BEAUTIFUL CONTEXT OF THE DIVINE PLAN FOR THE MARITAL RELATIONSHIP OF MAN AND WOMAN AS IMAGEBEARERS OF GOD, AS WELL AS THE FOUNDATION FOR THE FAMILY AS THE BASIC, DIVINELY ORDAINED UNIT OF HUMAN SOCIETY. VIOLATIONS OF THIS ONE-FLESH UNION, WHEATHER HETEROSEXUAL OR HOMOSEXUAL, PREMARITAL OR EXTRAMARITAL, CONTRAVENE THE DIVINE PLAN FOR THE FAMILY AND FOR THE FAMILY AND FOR THE CONCEPTION AND REARING OF CHILDREN, BRINGING SPIRITUAL DESPAIR, GUILT, AND DEATH TO INDIVIDUALS AND CULTURES.

THE SCRIPTURE REFERENCES LISTED ARE EXAMPLES OF WHAT THE SCRIPTURE TEACHES CONCERNING MARRIAGE AND HUMAN SEXUALITY. GENESIS 1:26-28; 2:18,20-25; EXODUS 20:14; DEUTERONOMY 5:18; MATTHEW 19:4-6; ROMANS 1:18-32; 1CORINTHIANS 7:1-5; EPHESIANS 5:21-33; 1THESSALONIANS 4:3-5; HEBREWS 13:4.

#### **HUMAN SEXUALITY**

FIRST CORTNTHIANS 6:9-11 CONDEMNS A VARIETY OF LIFESTYLES INCLUDING THOSE ASSOCIATED WITH ADULTERY, PROSTITUTION, AND HOMOSEXUALITY. INDEED, THE BIBLE CONDEMNS AS SEXUAL IMMORALITY—-"FORNICATION" IN THE AUTHORIZED VERSION—ALL SEXUAL INTERCOURSE OUTSIDE MARRIAGE AS DEFINED ABOVE. IT ALSO COMMANDS CHRISTIANS TO FLEE FROM SEXUAL IMMORALITY BECAUSE OF ITS DESTRUCTIVE EFFECTS AND BECAUSE THE BODY OF THE CHRISTIAN IS THE TEMPLE OF THE HOLY SPIRIT (1CORINTHIANS 3:16: 6:12-20).

ROMANS 1:18-32 MAKES CLEAR THAT IT IS NOT ONLY SINFUL TO ENGAGE IN HOMOSEXUAL UNIONS, BUT ALSO TO APPROVE OF SUCH SINS IN OTHERS OR TO ENCOURAGE THEIR PRACTICE. AS A RESULT, IN ORDER TO MAINTAIN OUR CONSISTENT CHRISTIAN WITNESS, WE CANNOT SANCTION, APPROVE, OR PROMOTE IN ANY WAY ADULTERY OR ANY OTHER FORM OF SEXUAL IMMORALITY---INCLUDING, BUT NOT LIMITED TO, PORNOGRAPHY, PEDOPHILIA, POLYGAMY, BESTIALITY, OR HOMOSEXUAL UNIONS. THIS IS MADE CLEAR IN MANY PASSAGES OF THE OLD AND NEW TESTAMENTS.

OUR ASSOCIATION FOLLOWS WHAT THE BIBLE REVEALS AS THE "SURE FOUNDATION" OF THE TEACHINGS OF JESUS CHRIST AND HIS APOSTLES (MATTHEW 7:24-29; 1CORINTHIANS 14:37). IF OUR ASSOCIATION IS TO BEAR THE NAME CHRISTIAN AUTHENTICALLY, WE CALLED TO TEACH AND PRACTICE THESE TEACHINGS AND ARE NOT AT LIBERTY TO DEPART FROM THEM FOR A DIFFERENT AUTHORITY. THOUGH WE STRIVE TO LIVE PEACEABLY WITH ALL PEOPLE AND TO OBEY LEGITIMATE GOVERNMENT AUTHORITY, IF THE TWO COME INTO CONFLICT ABOUT MATTERS AS FOUNDATIONAL AS MARRIAGE, WE MUST ULTIMATELY OBEY GOD RATHER THAN MAN (ACTS 4:18-21).

SEXUAL ACTIVITIES OUTSIDE OF MARRIAGE, INCLUDING BUT NOT LIMITED TO THOSE NAMED ABOVE, ARE INCONSISTENT WITH THE TEACHINGS OF THE BIBLE AND THE ASSOCIATION. LEWD CONDUCT; TRANSGENDER BEHAVIOR; AND THE CREATION, DISTRIBUTION, OR VIEWING OF PORNOGRAPHY ARE INCOMPATIBLE WITH GOD'S PURPOSE FOR HUMAN SEXUALITY.

A CIVIL GOVERNMENT'S SANCTION OF A UNION WILL BE RECOGNIZED AS A LEGITIMATE MARRIAGE BY THIS ASSOCIATION ONLY TO THE EXTENT THAT IT IS CONSISTENT WITH THE BIBLICAL DEFINITION OF MARRIAGE EXPRESSED IN THIS POLICY STATEMENT.

#### **ASSOCIATION PRACTICES DERIVED FROM THIS POLICY**

#### FOR MEMBERSHIP IN OUR ASSOCIATION

ANY CHURCH REQUESTING MEMBERSHIP IN LIBERTY NUMBER 1 ASSOCIATION MUST BE IN AGREEMENT WITH ASSOCIATION POLICY ON MARRIAGE AND HUMAN SEXUALITY.

#### MINISTERS EMPLOYED BY MEMBER CHURCHES OF THE ASSOCIATION

MINISTERS EMPLOYED BY MEMBER CHURCHES SHALL BE SUBJECT TO DISMISSAL AND/OR LOSS OF ORDINATION FOR VIOLATING THIS STATEMENT OF FAITH ON MARRIAGE AND HUMAN SEXUALITY OR BY OFFICIATING AT A MARRIAGE CEREMONY THAT VIOLATES THE LETTER OR SPIRIT OF THIS POLICY.

#### **USE OF MEMBERS CHURCHES' FACILITIES**

IT IS THE ASSOCIATION POLICY THAT THE FACILITIES OF MEMBER CHURCHES MAY NOT BE USED FOR ANY CEREMONY THAT IN ANY WAY APPROVES OF, SOLEMNIZES, SUPPORTS, OR ALLOWS A SAME-SEX UNION, A POLYGAMOUS UNION, OR ANY UNION THAT CONSTITUTES CHILD ABUSE. VIOLATIONS OF THIS POLICY MAY RESULT IN THE DISMISSAL OF MEMBER CHURCH BY ASSOCIATION.

### **OFFICERS' DUTIES**

OFFICERS OF LIBERTY NO.1 ASSOCIATION SHALL BE AS LISTED IN ARTICLE II, SECTION II OF THE CONSTITUTION:

#### 1. MODERATOR

- A. IT SHALL BE THE DUTY OF THE MODERATOR TO PRESIDE AT EACH SESSION OF THE ASSOCIATION AND QUARTERLY MEETING.
- B. THE MODERATOR SHALL CALL THE BODY TO ORDER AT THE BEGINNING OF EACH BUSINESS SESSION.
- C. THE MODERATOR SHALL SEAT THE DELEGATES IN A DESIGNATED AREA AT THE BEGINNING OF EACH SESSION.
- D. THE MODERATOR SHALL NOT ALLOW DISCUSSIONS WHEN NOT CARRIED ON IN A CHRISTIAN SPIRIT.
- E. THE MODERATOR SHALL HAVE ANYONE DESIRING TO SPEAK TO ARISE TO HIS FEET AND ADDRESS HIM AS "BRO. MODERATOR", BUT SHALL NOT SPEAK FURTHER UNTIL RECOGNIZED BY THE MODERATOR.
- F. THE MODERATOR SHALL BE CHAIRMAN OF THE EXECUTIVE COMMITTEE AND ORDAINING COUNCIL.

#### 2. ASSISTANT MORERATOR

A. THE DUTY OF THE ASSISTANT MODERATOR SHALL INCLUDE PERSIDING AT THE REQUEST OF, OR IN THE ABSENCE OF, THE MODERATOR AND ASSISTING HIM IN SUCH WAYS AS MAY BE NECESSARY.

### 3. CLERK-TREASURER

A. IT SHALL BE THE DUTY OF THE CLERK TO PREPARE THE MINUTES OF THE PROCEEDINGS OF ALL MEETINGS OF THE ASSOCIATION, AND THE HANDLING OF SUCH OFFICIAL CORRESPONDENCE FOR THE ASSOCIATION AS DIRECTED BY THE BODY.

B. THE CLERK SHALL RECEIVE AND DISBURSE ALL ASSOCIATIONAL MONIES AS DIRECTED BY THE ASSOCIATION.

#### 4. ASSISTANT CLERK

A. THE ASSISTANT CLERK SHALL ACT FOR THE CLERK IN THE ABSENCE OF THE CLERK OR AT THE REQUEST OF THE CLERK AND TO ASSIST IN WHATEVER WAYS MAY BE NECESSARY.

### **BOARDS**

### 1. LIBERTY NO.1 HOME MISSION BOARD

**A.** THE LIBERTY NO.1 HOME MISSIONS BOARD SHALL RECEIVE AND DISBURSE MONIES OF THE LIBERTY NO.1 HOME MISSION AS DIRECTED BY THE ASSOCIATION.

### **COMMITTEES**

### 1. EXECUTIVE COMMITTEE

**A.** THE EXECUTIVE COMMITTEE'S DUTIES SHALL BE OUTLINED IN THE CONSTITUTION OF LIBERTY NO.1 ASSOCIATION; ARTICLE 2, SECTION 2-ARTICLE 5, SECTION 1-ARTICLE 5, SECTION 9.

**B.** THE NATURE OF THE WORK OF THE EXECUTIVE COMMITTEE SHALL BE EXECUTIVE AND PROMOTIONAL AND NOT LEGISLATIVE.

### 2. CTS DIRECTOR

A. IT SHALL BE THE DUTY OF THE CTS DIRECTOR TO PRESIDE AT THE ANNUAL CTS CONVENTION AND GENERAL PROMOTION OF CTS WORK OF LIBERTY NO.1 ASSOCIATION.

**B.** THE CHURCH WHERE CTS RALLY IS TO BE HELD IS IN CHARGE OF MAIN PROGRAM. EACH CHURCH IS ENCOURAGED TO BRING A SKIT OR PROGRAM AT RALLY IN ADDITION TO MAIN PROGRAM.

#### 3. SUNDAY SCHOOL DIRECTOR

**A.** IT SHALL BE THE DUTY OF THE SUNDAY SCHOOL DIRECTOR TO PRESIDE AT THE ANNUAL SUNDAY SCHOOL CONVENTION AND GENERAL PROMOTION OF THE SUNDAY SCHOOL WORK OF LIBERTY NO.1 ASSOCIATION.

AND TO WATCH OVER ONE ANOTHER IN LOVE, ENDEVORING TO "KEEP THE UNITY OF THE SPIRIT" IN THE BONDS OF PEACE, TO BE CAREFUL OF ONE ANOTHER'S HAPPINESS AND REPUTATION, AND SEEK TO STRENGTHEN THE WEAK, ENCOURAGE THE AFFLICTED, ADMONISH THE ERRING, AND AS FAR AS WE ARE ABLE PROMOTE THE SUCCESS OF THE CHURCH AND OF GOSPEL.
