Motion carried to elect Field Evangelist when Rev. R. P. Ritch was elected. Motion carried that the pastors of each church raise funds to purchase an $8x11\frac{1}{2}$ in. Duplicator for Clerk's use. Motion carried that each pastor select a committee from his church to raise funds to purchase a tent for Field Work. Recessed by motion until 1:30 p.m.

Associational Rulings

- 1. Each Minister, ordained or licensed, shall make written report of his years work at each session of this Body No certificates of standing will be issued to any minister not complying. No license will be extended to any licensed minister not complying.
- 2. Each minister, ordained or licensed, of churches belonging to this Association is expected to affiliate with the Ministers Conference, and cannot be recognized as a minister, nor pastor churches of this Association except they comply with this ruling.
- 3. Each ordained minister must bear yearly Certificates of Standing to be eligible to pastor churches of this Association. License of all licensed ministers must be renewed.
- 4. Ministers coming to us from another denomination, must hold membership in some church in this Association for one (1) year before being eligible to pastor churches of this Association.
- 5. Licensed ministers must bear license for one (1) year before being eligible for ordination.
- 6. Churches must use the letter form sent them each year by the Clerk to be recognized by this Association.

- 1. THE BIBLE.— The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death

- 9. ELECTION.—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect

1 Tim. 2:4.

- 10. FREEDOM OF WILL.— The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

 Joshua 24:15.
- 11. SALVATION FREE.—God desires the calvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely. Rev. 22:17.
- 12. PERSEVERANCE.— All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.

13. GOSPEL ORDINANCES — Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel: Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.
