J. O'Donnell took charge of the devotional service reading Mk. 2:1-7 with some good comments. Many testimonies rendered then the services turned to Rev. W. C. Patterson for the Message. Bro. Patterson used the scriptures Gen. 43:21-25 and St. John 14:6. A message about the cup. After the message the services were turned to the Pastor Rev. J. W. Burnham to have charge of the Supper. There were 44 taking part in the supper and a goodly number in the feet washing.

The Liberty No. 2 Association of Free Will Baptist was organized on Friday before the 4th Sunday in September in the year of our Lord A. D. 1934. Organizing Councilmen: Rev. E. J. Carlisle, Reev. W. BY LAWS----

1. Each session shall be opened by singing, scripture reading, and prayer, and shall be closed with prayer.

2. Each Sunday School shall send one delegate for the organization and one additional delegate for every twenty-five (25) members or major fraction thereof. These delegates, along with all ordained ministers in good standing with the Association shall constitute the official board and shall transact all business properly coming before said body.

3. Visiting Brethren and Corresponding Messengers shall be recognized by the presiding officer and invited to a seat in council. They shall not, however have the power to vote on any question.

4. Members from five (5) different Sunday Schools and Leagues shall constitute a quorum to transact business, but a smaller number may adjourn from time to time.

5. The president or vice-president shall preside at all meetings, and in their absence the body may choose one to preside.

6. Anyone wishing to speak shall arise and address the presiding officer as "Bro. President" or "Sis. President" and be recognized before speaking.

7. No subject shall be discussed without a motion and a second, and the question stated by the president.

8. No report shall be adopted except by a motion and a second and a vote taken.

9. The president shall appoint all committees unless otherwise directed by the body.

10. Each Church send \$5.00 Entrance Fee. Each Sunday School with more than fifty (50) members, \$5.00. Each Sunday School with more than twenty-five (25) members and less than fifty, \$2.50. Each Sunday School with less than twenty-five (25) members, \$1.00. Each League, \$2.00.

11. Delegates may be sent to represent at once both the Sunday School and the League but must be so authorized and must come equipped with the proper credentials.

12. These By-Laws may be temporarily suspended or permanently altered by a two-thirds vote of all members present at any regular business meeting of the Convention.

CONSTITUTION—

PREAMBLE: In order to strengthen and unify our Christian word and the building of Christian character among the members of the Liberty Association of Free Will Baptists, and to promote and maintain a correspondence with each other in an association-wide organization, we propose to band ourselves together in an organic union to keep the rules of such an organization according to the following plan:

Article 1. This organization shall be composed and known as the Sunday School and League Convention of Liberty No. 2 Association of Free Will Baptists.

Article II. This Convention shall be composed of regularly organized Sunday Schools and Leagues within the bounds of said Association and shall meet on the second fifth Sunday of each year. The place of meeting will be decided at each previous session.

Article III. Any Sunday School or League desiring to become a member of this Convention shall send two (2) or more delegated representatives with a petitionary letter, stating the desire of their particular organization to become a member of this Body. They shall be received by a majority vote of all members present.

Article IV. The officers of this Convention shall be President, who shall preside at all meetings; a Vice-President, who shall preside over meetings in the absence of the President; a secretary and treasurer who shall keep a true and accurate record of every meeting and every business transaction, and to have, hold and convey or convoy any and all funds entrusted to him or her by the Convention. Other officers may be elected as deemed necessary by this Body.

Article V. An Executive Committee, composed of three (3) members, to be elected so that their terms expire alternately thus: one to be elected for one year; one to be elected for two years; and one to be elected for three years. They shall be elected by the body and shall attend to all business matters between regular annual sessions and also shall arrange the program for the Annual Session. One of these members shall be chosen from the Sunday School, one from the League ,and one shall be elected at large.

Article VI. All officers, including Executive Committee members, must be Christians and Free Will Baptists.

Article VII. This Constitution may be altered or amended by a two-thirds vote of all members present at any regular business meeting, but notice of such intended change must be given at least twenty-four hours in advance of the proposed amendment or alteration. Any amendment or alteration voted by this body shall be final.

ASSOCIATIONAL RULINGS—— liawd

- 1. Each Minister, Ordained or Licensed must report in person or by letter to each session of this Association to receive proper credentials for the coming year.
- 2. Each minister, ordained or licensed of churches belonging to this Association is expected to affiliate with the minister's conference and cannot be recognized as a minister nor pastor churches of this Association except they comply with this ruling.
- 3. Each ordained minister must bear yearly certificates of standing to be eligible to pastor churches of this association. License of all licensed ministers must be renewed.
- 4. Ministers coming to us from another denomination must hold membership in some church of this association for one (1) year before being eligible to pastor churches of this association.
- 5. Licensed ministers must bear license for one (1) year before being eligible for ordination.
- 6. Churches must use letter form sent them each year by the Clerk to be recognized by this Association.
- 7. That this body elect officers in the beginning of each session and not in the closing for one (1) year ahead as heretofore practiced.
 - 8. That this body adopt a unified program.
- 9. This body rules that any minister of this Association has a right to use the tent when not being used by regularly elected evangelist, by inviting the evangelist to assist in the revival.
- 10. That each church pay an entrance fee of \$5.00 same to be used for the expense of the association.
- 11. That the ministers' conference convene on Friday night instead of Friday evening as heretofore practiced.
 - 12. That the Clerk be paid \$10.00 each term for his services.

- 4. THE HOLY SPIRIT. The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. St. John 16:7, 8; Acts 2:4; Eph. 4:4-6.
- 5. THE GOVERNMENT OF GOD. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of men requires. Ps. 22:28; 97:2.
- 6. THE SINFULNESS OF MAN. Man was created innocent, but by disobedience fel into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; 3:19.
- 7. THE WORK OF CHRIST. The Son of God by His incarnation, life, suffering, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith. I John 2:2.
- 8. THE TERMS OF SALVATION. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. nI the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death. II Cor. 7:10; Pro. 28:13.
- 9. ELECTION. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect. I Tim. 2:4.
