Rev. J. T. Windsor preached at the 11 o'clock hour, reading Gen. 35:1. Prayer by Sister Hattie Owens. Text — "Let us arise and go to Bethel". Dismissed for lunch by Rev. W .H. Ryland.

After a good lunch served by the ladies of the Church, we assembled back in the Church at 1:15 P. M. Rev. J. W. Burnham leading the singing. Scripture reading, Isa. 55:1-3. Prayer by Rev. W. C. Patterson.

REPORTS OF COMMITTEES

Credential - All letters in order, adopted.

Devotional — Rev. J. T. Windsor to preach Friday morning at eleven o'clock, Rev. Charlie Carlisle Friday night, Rev. H. A. O'Donnell Saturday morning at eleven o'clock. Rev. F. C. Barber to preach Saturday night with Bro. Sam Kimberly leading the devotional. Adopted.

Business — Moved, carried to receive report and take up the business item by item.

We your business committee present the following items for your consideration:

- 1. Hubert Ledlow be questioned and if found worthy ordain him a deacon for Wattsville Church, Adopted.
- 2. Clarence (Buddy) Magouyrk be questioned and if found worthy ordain him to the full Gospel ministry, Talladega Church. Adopted.
- 3. M. J. Naler be called in question and if found worthy ordain him to the full Gospel ministry. Adopted.
- 4. That we commend the Quarterly meeting for their good report, with the exception of preventing the ordained personal from being standing delegates. Adopted.
- 5. That the 1956 session meet with the Ragland Church, as they ask for it. Adopted.
- 6. That we give the good sisters of this Church and this community a rising vote of thanks and appreciation for preparing and serving the good meals. Adopted.
- 7. That we grant the Printing Co. to print their ad as requested in our minutes for the sum of \$5.00. Adopted.
- 8. That the Moderator appoint all standing committee, and other committee. Adopted.
- 9. That we either make proper provision for the support and care for the field Evangelist, or not elect one.

Amended. That we elect a field Evangelist and make proper provision, Adopted.

10. That each Church pay into the home mission treasure immediately following the close of this session the sum of \$10.00 to be held in reserve for the care and expenses of the field Evangelist, and pay \$10.00 per week during the progress of a revival conducted by him (where there is no church). Adopted.

- 11. That the Association pay \$20.00 to the home mission treasurer and each Church send \$10.00 to each session of the Quarterly Meeting and Association. This will amount to about \$400.00 a year for the Evangelist work. Rejected.
- 12. That this body pay one-half of expenses of revival conducted by Rev. F. C. Barber, and Rev. S. W. McDonough, and the Sunday School Convention be called on to pay the other half. Adopted.
- 13. That we pay D. J. O'Donnell \$30,00 expenses to National Association, Adopted.
- 14. That a committee of three (3) ministers be appointed by the Moderator to deal with the five (5) ministers who failed to report to the ministers conference. Adopted Committee Rev. C. L. Carlisle, H. A. O'Donnell, M. J. Naler.

Family Religion — We recommend that all homes teach the Bible to their children, and that God is real. Reprint of 1952 report: "To teach prayer, its worth and aim, always with Bible reading and family prayer. Giving God thanks always, for every good gift cometh from God. To honor and respect His service everywhere and at all times holding Him supreme above all the earth." Adopted.

Temperance — Be temperate in all things. Luke 21:34, "And take heed to yourselves, lest at any time your hearts be overcharged with surfeiting, and drunkenness, and cares of this life, and so that day come upon you unawares." James 1:26, "If any man among you seem to be religious, and bridleth not his tongue, but deceiveth his own heart, this man's religion is vain." Eph. 5:18, "And be not drunk with wine, where in is excess; but be filled with the Spirit." Adopted.

Organizing - No report.

That we strive faithfully to get our Ministers to work where we have no churches. 4. That we work together in one mind and one accord. Adopted.

Literature — We recommend that literature on religion that is not in accord with the Bible be kept out of homes. We should encourage our children to read a portion of the Bible every day. Adopted.

Education — We, the committee, recommend that the parent teach their children to say Grace before each meal, and teach them all the commandments of God, and all that are old enough to read, to read a portion of God's Word daily. Adopted.

Sabbath School — We recommend a reprint of the 1954 report. "We should devote more time and study to the work of the Lord's Day, to keep it Holy. For we know that He is the creator of all things, and on the seventh day did rest from all His labours. The Sunday School is the most important School that was ever taught, so let us teach our children from the fireside in our home, in the Church, don't just send them, but bring them, also teach them to reverence the Lord." Adopted.

CONSTITUTION

Preamble: In order to strengthen and unify our Christian work and the building of Christian character among the members of the Liberty No. 2 Sunday School Convention of Free Will Baptist, and to promote and maintain a correspondence with each other in a convention wide organization, we propose to band ourselves together in an organic union to keep the rules of such an organization according to the following plan:

Article I, This organization shall be composed and known as the Sunday School and League Convention of Liberty No. 2 Association of Free Will Baptist.

Article II. This Convention shall be composed of said Association and shall meet at 2 p. m. Saturday before the 4th Sunday in April of each year and continue through Sunday. The place of meeting will be decided at each previous session.

Article III. Any Sunday School or League desiring to become a member of this Convention shall send two (2) or more delegated representatives with a petitionary letter, stating the desire of their particular organization to become a member of this body. They shall be received by a majority vote of all members present.

Article IV. The officers of this Convention shall be President, who shall preside at all meetings; a Vice-President, who shall preside over meetings in the absence of the President; a Secretary and Treasurer who shall keep a true and accurate record of every meeting and every business transaction, and to have, hold and convoy any and all funds entrusted to him or her by the convention. Other officers may be elected as deemed necessary by this body.

Article V. An Executive Committee, composed of three (3) members, to be elected so that their terms expire alternately thus: one to be elected for one year; one to be elected for two years; and one to be elected for three years. They shall be elected by the body and shall attend to all business matters between regular and annual Session. One of these members shall be chosen from the Sunday School, one from the League, and one shall be elected at large.

Article VI. All officers, including Executive Committee members, must be Christians and Free Will Baptist.

Article VII. This Constitution may be altered or amended by a twothirds vote of all members present at any regular business meeting, but notice of such intended change must be given at least twenty-four hours in advance of the proposed amendment or alteration. Any amendment or alteration voted by this body shall be final.

ASSOCIATIONAL RULINGS

- 1. Each Minister, Ordained or Licensed, must report in person or by letter to each session of this Association to receive proper credentials for the coming year. Unless he is too old, or too feeble to attend then he, as a Free Will Baptist Minister, receives a life time certificate of standing.
- 2. Each Minister, Ordained or Licensed, of churches belonging to this Association is expected to affiliate with the Minister's Conference and cannot be recognized as a minister nor pastor churches of this Association except they comply with this ruling.
- 3. Each ordained minister must bear yearly certificates of standing to be eligible to pastor churches of this Association. License of all licensed ministers must be renewed.
- 4. Ministers coming to us from another denomination must hold in some church of this Association for one (1) year before being eligible to pastor churches of this Association.
- 5. Licensed Ministers must bear license for one (1) year before being eligible for ordination.
- 6. Churches must use letter form sent them each year by the Clerk to be recognized by this Association.
- 7. That this body elect officers in the beginning of each session and not in the closing for one (1) year ahead as heretofore practiced.
 - 8. That this body adopt a unified program.
- 9. This body rules that any minister of this Association has a right to use the tent when not being used by regularly elected evangelist by inviting the evangelist to assist in the revival.
- 10. That each church pay an entrance fee of \$5.00. Same to be used for the expense of the Association.
- 11. That the Minister's Conference convene on Friday night instead of Friday evening as heretofore practiced.
 - 12. That the Clerk be paid \$10.00 each term for his services.
- 13. That the Moderator appoint all standing committees and any other committee.

BY-LAWS

- 1. Each session shall be opened by singing, scripture reading, and prayer and shall be closed with prayer.
- 2. Each Sunday School shall send one delegate for the organization and one additional delegate for every twenty-five (25) members or major fraction thereof. These delegates, along with all ordained ministers and deacons with the superintendent in good standing with the association shall constitute the official board and shall transact all business properly coming before said body.
- 3. Visiting Brethren and corresponding Messengers shall be recognized by the presiding officer and invited to a seat in council. They shall not, however, have the power to vote on any question.
- 4. Members from five (5) different Sunday Schools and Leagues shall constitute a quorum to transact business, but a smaller number may adjourn from time to time.
- 5. The president or vice-president shall preside at all meetings, and in their absence the body may choose one to preside.
- 6. Anyone wishing to speak shall arise and address the presiding officer as "Bro. President" or "Sister President" and be recognized before speaking.
- 7. No subject shall be discussed without a motion and a second and the question stated by the president.
- 8. No report shall be adopted except by a motion and a second and a vote taken.
- 9. The president shall appoint all committees unless otherwise directed by the body.
 - 10. Each Sunday School shall send \$5.00 entrance fee. League \$2.00.
- 11. Delegates may be sent to represent at once both the Sunday School and the League but must be so authorized and must come equipped with the proper credentials.
- 12. These By-Laws may be temporarily suspended or permanently altered by a two-thirds vote of all members present at any regular business meeting of the convention.

FREE WILL BAPTISTS ARTICLES OF FAITH

- 1. The Bible. The Scriptures of the Old and New Testaments were given by the inspiration of God, and are our infallible rule of faith and practice. I Tim. 3:16.
- 2. God. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor, of the universe; and in the Scriptures as Father, Son, and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey. I Cor. 8:6; Matt. 28:19.
- 3. Christ. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Savior and Lord. St. John 1:1-12.

- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. St. John 16:7, 8; Acts 2:4; Eph. 4:4-6.
- 5. The Government of God, God exercises a wise and benovelent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of men requires. Psalm 22:28; 97:2.
- 6. The Sinfulness of Man. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; 3:19.
- 7. The Work of Christ. The Son of God by His incarnation, life, suffering, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith. I John 2:2.
- 8. The Terms of Salvation. The conditions of salvation are: I. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuation in faith and obedience until death. II Cor. 7:10; Prov. 28:13.
- 9. Election, God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect. I Tim. 2:4.
- 10. Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish. Joshua 24:17.
- 11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely. Rev. 22:17.
- 12. Preserverance. All believers in Christ, who through grace perservere in holiness to the end of life, have promise of eternal salvation. St. John 15:6; II Peter 2:20-22.
- 13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; Feet washing, an ordinance teaching humility, of universal obligation, and to be ministered to all true believers, Mark 16: 15; II Cor. 4:5; John 13:14.
- 14. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works and activities, and for personal communion with God. Gen. 2:3; Exodus 20:8-11.
- 15. Resurrection, Judgement and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life." John 5:29; Matt. 25:46.

FREE WILL BAPTIST CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "prove things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and knowledge of our Lord and Saviour Jesus Christ.

We will not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of souls, and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
