Motion made, second and carried to ask the Ministers Conference to stay open till Saturday. Singing led by Rev. C. L. Carlisle, No. 338, "Blest Be The Tie".

Report of Business Committee - Read and received to take it Item by Item by proper move and second.

We the Business Committee report the following for your consideration. Item 1. Carried - Call in Question Bro. Levernon Davis and if found worthy license him to preach the Gospel for one year.

Item 2. Carried - Rev. Curtis L. Davis be called in Question and if

found worthy ordain him to preach the Gospel.

Item 3. Carried — Rev. Maxwell Gallups be called in question and if found worthy ordain him to preach the Gospel.

Item 4. Carried — Bro. P. D. Warlick be called in question and if found worthy reissue him Deacon paper.

Item 5. Adopted — That the various Committees hold office for the coming year; giving a report this session and then be ready with a written report as to the needs as they have found them at the next session..

Item 18. Adopted — That the Field Evangelist be paid \$50.00 a week plus 5 cents a mile traveling expenses, all his offering to be given to Home Mission Board Treasure.

Rev. Floyd C. Barber offered his resignation as a member of the trustee board of the Children's Home from this Association effective the 12th of Nov. 1960. Accepted.

Singing led by Rev. E. R. Mayo No. 5, "Look For Me At The Gate", 86, "Talk It Over With Jesus" led by Rev. C. L. Carlisle. A short recess.

No. 328 led by Rev. C. L. Carlisle.

Report of Literature Committee — read and adopted — We your Literature Committee recommend for your reading pleasure and for information of Free Will Baptist and the Gospel of the Lord.

3rd, The Free Will Baptist-Weekly - \$2.00 a year.

The Bible in every home, and at least one of the Free Will Baptist publications in every home, or at least in every minister and deacon home.

We urge everyone to carefully examine all literature brought into the home and firmly stand against false doctrine so widely spread. We read in Eph. 4:14, "That we henceforth be no more children, tossed to and fro, and carried about with every wind of doctrine, by the sleight of men, and cunning craftiness, whereby they lie in wait to deceive"; Pro. 22:6, Train up a child in the way he should go: and when he is old, he will not depart from it.

- 2. Each Minister, Ordained or Licensed, of churches belonging to this Association is expected to affiliate with Minister's Conference and cannot be recognized as a minister nor pastor churches of this association except they comply with this ruling.
- 3. Each ordained minister must bear yearly certificates of standing to be eligible to pastor churches of this Association, License of all Licensed ministers must be renewed.
- 4. Ministers coming to us from another denomination must hold membership in some church of this Association for one (1) year before being eligible to pastor churches of this Association.
- 5. Licensed Ministers must bear license for one (1) year before being eligible for ordination unless called to pastor a church then he can be ordained before a year is finished.
- 6. Churches must use letter form sent them each year by the Clerk to be recognized by this Association.
- 7. That this body elect officers in the beginning of each session and not in the closing for one (1) year ahead as heretofore practiced. Clerk be elected for two (2) years beginning in 1961.
  - 8. That this body adopt a unified program.
- 9. This body rules that any ministers of this Association has right to use the tent when not being used by regular elected evangelist by inviting the evangelist to assist in the revival.
