

MS&C to accept the report and paused for a moment of silence.

Education and Family Religion Committee: We the Education and Family Religion Committee recommend daily Bible reading and studying from the King James Version, also daily family devotions. We believe and recommend II Tim. 2:15. "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." MS&C

Temperance and Resolution Committee: We the Temperance and Resolution Committee believe the King James Version of the Bible to be the true word of God. We believe that we should be dedicated Christians, attend church services whenever we are physically able, and live our lives so others will see Christ in us. We should abstain from all alcoholic beverages and evils of the world. We will teach our children while they are young the ways of the Lord. We will do all we can to lead our children to the Lord and oppose those who may lead them astray. MS&C

Literature and Sunday School Committee: We the Literature and Sunday School Committee recommend we continue to use the Randall House Publishing literature for Sunday School and Church Training, Daily devotions, and continued use of the King James Version of the Bible. We suggest teaching and saying the Pledge of Allegiance to our Christian Flag, to the Bible, and the American Flag in an attempt to teach younger people where our heritage came from. MS&C

Children's Home Report: Top priority at this time is to find a couple to serve as house parents. Please make this a top item of prayer. We have 21 children, 13 boys and 8 girls. The time has come for us to start replacing our vans. We voted to start with 2-12 passenger vans. Please start now on getting Wal-Mart gift cards for the children's gifts at Christmas. THE CONSTITUTION OF THE LIBERTY #2 ASSOCIATION OF FREE WILL BAPTIST

ARTICLE I. NAME-This Association shall be known as The Liberty #2 Association of Free Will Baptist.

ARTICLE II. OFFICERS-The officers of this Association shall be a moderator, and an assistant, a clerk and a treasurer and an assistant. The offices of clerk and treasurer may be combined. This Association shall elect the moderator and assistant at the close of the annual session and he shall serve two years for both the Quarterly and Annual sessions. This election will come on the odd year. The clerk-treasurer and assistant shall be elected at the close of the annual session and he shall serve two years. The election will come on the even year. They shall take office on the first Quarterly session.

ARTICLE III. MEMBERSHIP-This Association shall be composed of churches in good standing according to Faith and Practices of the Treatise of the National Association of Free Will Baptist. All ministers and churches wishing to become members of this body must willingly submit to the articles of the constitution and all rules of same.

Section 1. Churches desiring membership in this Association shall send delegates bearing a petitionary letter. If the church(es) upon examination by the Credentials Examining Committee are found to be in order and properly organized as specified in the Treatise, they shall by vote of this body be received into full fellowship.

Section 2. Acceptance of Ministers into the Association. No minister shall hold any office or have the right to vote until one of the following applies:

Ministers coming from another association of Free Will Baptist must bring a written recommendation from the association from which he comes in good standing and then be questioned by the Examining Committee. The Examining Committee will then make their recommendation to the body for vote.

Ministers coming from and independent church or another denomination must first unite with one of the churches of this Association for not less than one year. Then be examined by the Credentials-Examining Committee according to the Holy Scriptures and the Faith and Practices of the Treatise of the Free Will Baptists. This committee will then make their recommendation for a vote of the delegation.

ARTICLE IV. REPRESENTATION - Each church is expected to be represented at the quarterly and annual associational sessions.

Section 1. Each church shall be represented at the quarterly and annual associational sessions by delegation. Each church being entitled to ten delegates.

Section 2. Ordained ministers and deacons and licensed ministers are standing delegates. All standing delegates are encouraged to attend at least three sessions a year including the annual associational session.

Section 3. Each church shall pay an entrance fee of \$60.00 for each quarterly session to help with the printing of the minutes. Whenever the state raises their dues, we automatically raise ours to meet the necessary fees. (May 2001-Annual session dues increased to \$85.00)

ARTICLE V. MEETINGS - The quarterly meetings of churches shall meet on the Saturday before the 3rd Sunday in November, February, and May. Any business of these meetings is subject to approval of the annual session of The Liberty #2 Association which meets the Saturday before the 3rd Sunday in August.

Section 1. Roberts Rule of Order shall be used as a guide in all business transactions and parliamentary usages.

ARTICLE VI. DISBURSEMENT OF FUNDS - The moderator shall be paid \$10.00 for the annual session. The clerk shall be paid \$30.00 each session and \$0.35 per mile for business expenses other than coming to quarterly and annual sessions. The treasurer shall pay for the normal expenses incurred, such as; the printing of the minutes and \$0.20 per mile shall be paid to the trustee to and from The Children's Home. All other disbursements must be by vote and approval of the Association.

ARTICLE VII. COMMITTEES - The moderator shall appoint all temporary committees and appoint a nominating committee to make nominations to fill vacancies on all standing committees and councils. The nominating committee shall consist of three (3) members. Any other nominations may come from the floor of delegates.

Section 1. Temporary committees only function during the session appointed. The first five (5) committees shall be composed of three (3) members each, and the remainder as specified. (1) Devotional (2) Temperance and Resolution (3) Literature and Sunday School (4) Education and Family Religion (5) Deceased Committee (6) Ministerial Committee consisting of three ordained men in good standing with the Association (7) Business and Auditing Committee consisting of five men of the Association.

Section 2. Standing committees are:

- (1) Organizing Committee There shall be an Organizing Committee consisting of five ordained men elected to terms of one for five years, one for four years, one for three years, one for two years, and one for one year. The duties are: To organize churches within the Association or to act as an advisory council to advise any organizing church to follow the National Free Will Baptist Treatise, chapter one (1) section three (3) 1980 edition of Practices of FWB.
- (2) Ordaining and Credentials Committee of the Ministry. There shall be an Ordaining and Credentials Committee consisting of five ordained men elected to terms of one for five years, one for four years, one for three years, one for two years and one for one year. The duties are **a.** To question candidates for licenses and ordination. **b.** To license and ordain approved candidates. **c.** To check on any minister who is in question of character or standing. **d.** To have the authority to request the credentials of the individual in question.

(3)Executive Committee - There shall be an Executive Committee consisting of the moderator, the assistant moderator, the clerk of the Association, and two men elected by the Association for terms of one year each. The duties are to act as the Association when the Association is not in session.

ARTICLE VIII. REPORTS - Each church is requested to send Quarterly and Annual reports of progress on forms furnished by the Association one week before meetings.

ARTICLE IX. CHURCH ORGANIZATION - There shall be no church organized without seven charter members.

ARTICLE X. CERTIFICATE OF STANDING

Section 1. Each minister, ordained or licensed shall report in person or by letter to the Annual Session of The Association to receive a certificate of standing.

Section 2. Churches of this Association desiring certificates of standing for their deacons, must make the request known in the annual report, giving the name of each deacon which is in good standing.

ARTICLE XI. ORDINATION OF MINISTERS

Section 1. Licensed ministers must bear licenses for one year, and then be called to a specific work before being eligible for ordination. Licenses must be renewed each year by the request of the residing church.

ARTICLE XII. THE MINISTER'S & DEACONS CONFERENCE

Section1. Each minister ordained or licensed of churches of the Association is expected to affiliate with The Ministers & Deacons Conference.

Section 2. This Association recommends that each deacon join and support The Ministers & Deacons Conference.

ARTICLE XIII. RESTRICTION OF MINISTERS

Section 1. A minister in this Association is not to perform a marriage ceremony if a man or woman has another living husband or wife.

ARTICLE XIV. AMENDMENTS - This Constitution and these bylaws shall not be changed or altered except and only by a two-thirds vote of delegates present from member churches of the annual session of the Association.

BY-LAWS OF MINISTERS AND DEACONS CONFERENCE OF LIBERTY #2 ASSOCIATION

- 1. This Conference shall elect a moderator and assistant moderator each year at the August session and he must have attended at least one conference before being elected. Clerk & assistant also are elected.
- 2. This Conference shall meet four times a year, Friday night before each session.

- 3. Any minister or deacon, being a member of any church of the Liberty #2 Association will be given the opportunity to join this conference.
- 4. Any minister or deacon not belonging to this Conference will be recognized as a minister or deacon, but will not have a right to vote.
- 5. Each minister and deacon shall pay \$1.00 to the clerk of the Ministers & Deacons Conference for expenses.

RULES OF DECORUM

When the quarterly and annual sessions convene, they shall be opened and closed by singing and prayer.

Only one person shall speak at one time, and shall rise to his feet and address the moderator.

Each person speaking shall not be interrupted in speech until he gets through, (exception, if he breaks order).

The person speaking shall adhere to the question and shall in no way cast reflections on any person who may have spoken before him.

No person shall speak more that two times on the same subject without permission of the moderator.

Members shall address each other by Brother or Brethren, or Sisters.

No member shall speak longer than ten minutes at any one time without permission of the moderator.

No member of this Association shall absent themselves from the meeting without leave of the moderator.

GUIDE LINES FOR ORDINATION WITHIN THE LIBERTY #2 ASSOCIATION

This Association ordains no man that has more than one living wife, nor a man whose wife has more than one living husband.

This Association ordains no one that doesn't believe fully the Faith and Practice of the Free Will Baptist Treatise.

This Association ordains no one that doesn't believe in the verbal inspiration of the Word of God.

This Association ordains no one that doesn't believe and practice tithing to their church.

This Association ordains no one with a bad character with them that are without.

This Association will not ordain anyone that is affiliated with The World Council of Churches.

This Association will not ordain, or license a woman to preach the Gospel or deacon churches.

This Association will not ordain anyone that does not believe and practice the ordinances of the Gospel: A)Baptism by Immersion B)Communion C)Feet Washing

This Association will not ordain anyone that doesn't believe a person can apostatize and be lost.

This Association will not ordain anyone that is affiliated with the charismatic movement.

FREEWILL BAPTIST ARTICLES OF FAITH

THE BIBLE: The Scriptures of the Old and New Testaments were given by Inspiration of God, and are infallible rules of faith and practice. I Tim. 3:16.

GOD: There is one living and true God. Revealed in nature as the Creator, Preserver, and Righteous Governor of the Universe; and in the Scriptures as Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adhere and obey. I Cor. 8:6, Matt. 28:19.

CHRIST: Christ is God manifest in the flesh in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Savior and Lord. St. John 1:1-12.

THE HOLY SPIRIT: The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. St. John 16:7-8, Acts 2:2-4, Eph.4:46.

THE GOVERNMENT OF GOD: God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of men requires. Psalms 22:17, 97:2.

And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
