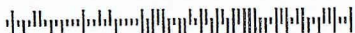

I understand that: (1) I am entitled to a single vote on each matter that is subject to a vote of policyholders, regardless of the number of policies that I have in force or the amount of insurance or premium associated with such policies; (2) All proxy votes will be cast together by the Secretary as a single block vote; and (3) This proxy shall remain in effect for the period of time that my policy or policies remain in force, unless sooner revoked by me.
