MINUTES OF THE LITTLE BROWN CHURCH ASSOCIATION SIXTY-NINTH ANNUAL SESSION OF THE FREE WILL BAPTIST PROCEEDING

ARTICLES OF FAITH

- 1. THE BIBLE—The scripture of the Old and New Testiment were given by inspiration of God, and are our infallable rule of faith and practice.
- 2. GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Rightous Governor of the universe; and in the Scripture as Father, Son and Holy Ghost, yet as one God, infintely wise and good, whom all intelligent creatures are supremely to love, adore and obey.
- 3. CHRIST—Christ is God manefested in flesh; His divine nature truly God, in His human nature truly man. The mediator between God and glorified. He is now risen and glorified, and is our ever present Saviour and Lord.
- 4. THE HOLY SPIRIT—The scripture assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sancifier of men.
- 5. THE GOVERNMENT OF GOD—God exercises a wise and benevelent providance over all beings and all things by maintaining the constitution and law of nature. He also performs special acts of grace not otherwise provided for, as the highest welefare of man requires.
- 6. THE SINFULNESS OF MAN—Man was created innocent, but by disobedience into a state of sin and condemnation. His posterity

therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

- 7. THE WORK OF CHRIST—The Son of God be His incarnation life sufferings, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 8. THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance or sincere sorrow of sin and hearty renucation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit free from soul diminion of sin and becomes a child of God. 3. Continuence in faith and obedience until death.
- 9. ELECTION—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become is elect.
- 10. FREEDOM OF THE WILL—The human will is free and self-controlled having power to yield to the influence of the truth and the Spirit, or to resist them and perish.
- 11. SALVATION FREE—God desires the salvation of all, The Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water freely.
- 12. PRESERVANCE—All believers in Christ, who, through grace preservance in holiness to the end of life have promise of eternal salvation.
- 13. GOSPEL ORDINANCES—Baptism, or the immersion of believers in water and the Lord's Supper, are ordinaces to be perpetuated under the Gospel; Feet Washing, an ordinace teaching humility of universal obligation, and to be administered to all believers.
- 14. THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, wroship, holy works and activities, and for personal communications with God.
- 15. RESURRECTION, JUDGEMENT AND FINAL RETRIBUT-ION—The Scripture teaches the resurrection of tll men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

CHURCH COVENANT

Having been brought, as we humbly trust by Divine Grace to embrace the Lord Jesus as our Saviour and having obtained justification by faith in His Name, as members of the Free Will Baptist Church at ______ agree:

1. To watch over each other in love, and to pray for each other as members of a common faith ever striving to keep the unity of the spirit in the bonds of peace.

- 2. We will not speak evil of another nor will we prosecute or expose the faults of the weak members of our church, but we will endeaver to be governed by Paul's instruction to Timothy: "That we will reprove, rebuke and exhort each other as members of a common brotherhood."
- 3. We are commanded to do good unto all men, especially to those who are of the household of faith. But we should remember that our relations to each other are closer and the obligations more blinding that we become as a family and assume in a Christian sense the care and responsibility that members of a family should feel for each other.
- 4. We will attend that stated meeting of our church unless we are providentially hindered or uncontrollable circumstances prevent us. And we will contribute of our means as the Lord has prospered us for the support of our pastor and other necessary expenses of our church. And we- will prefer the- services of our church to that of any other, and will pray for our pastor while he is preaching the Word to us.
- 5. We will not injure our influence in the house of our Lord by accepting seats among the ungodly and sinners, but will occupy seats near the pulpit and use the natural powers which the Lord has given us to praise His Holy Name. We will sing with those who sing and pray with those who pray.
- 6. We will not be guilty of the sin of Sabbath breaking by making Sunday visits to our neighbors which is double sin against the law of God, for in doing so, we fail to attend the house of the Lord and hinder others who might wish to do so. Let us remember the laws of Moses which condems Sabbath breaking and the words of the inspired Apostle which says, "Forsake not the assembling of yourselves together as the manner of some is".
- 7. We will not neglect secret and public prayer, and those of who are heads of families will strive to dedicate our household to the service of God by teaching our children the great necessity of the Christian religion as the only hope of happiness after death. We will adopt the Covenant of Joshua, the servant of the Lord and say: "But as for me and my house, we will serve the Lord".

CONSTITUTION

Be it known that we, the Free Will Baptist Church, being in Alcorn, Tishomingo, and Prentiss Counties, in Mississippi, do believe in the doctrines of the General Atonemen. we have been baptized upon profession of faith in Christ, we are desirous of bringing about a reciprocal union. We propose therefore, to maintain the order and rule of our Association according to the the following plan.

We believe the Churches of Christ are mutually independent each other; that congregational form of government should be invariably preserved; yet we are being convinced of the unity of friendly intercourse and pious council on the principal of union advantages, and Christian love, we hold it a duty of the churches to pay respect to these principals with regard to the duty of the Association.

ARTICLE 1. The Association shall be composed of members chosen by the different churches of our union, who on producing letterss from their respective churches certifying their appointment shall be entitled to seats.

- 2. The letter so produced shall express the condition of these churches respectively; that is, the members in the fellowship, the members received, and died since the last meeting.
- 3. The body shall have no conceived power to word it over God's heritage, or infringe on any of the internal privileges or rights of the churches in our union, but shall be considered an advisory council in all things pertaining to the internal concern of the churches.
- 4. The Association is to give the best advise it can on all matters of difficulty. If the union should be broken between any of the churches, the Association shall inquire into the cause of the breach and use its endeavers to remove the difficulty; if the breach cannot be removed to withdraw from the church which they look upon as unsound in principals, and disorderly conduct or practice, until they be reclaimed.
- 5. To take up no case of any kind in the union without the consent of the majority of the churches, and then only to give advise.
- 6. All newly constituted churches may be received into the union by their representatives presenting a letter from their respective churches if found orderly and orthodox; such a reception shall be manifested by the right hand of fellowship.
