



# FIRST QUARTERLY MEETING December 5, 1987 ANTIOCH FREE WILL BAPTIST CHURCH

Rev. Leonard Ball opened our meeting with congregational singing, with Bro. Kenneth Conaway accompanying at the piano. Rev. Luther Gibson led in the opening prayer. Rev. Glen Jones welcomed the Association to Antioch.

Rev. Malcolm Garrett brought the morning devotion taken from Hebrews 4:12. He spoke of God's word being sharper than a two-edged sword and how it reaches into the hearts of Christians. The word and the Holy Spirit helps us to realize when we are reverting back to old habits.

Rev. Gerald Taylor then called the meeting to order and recognized the standing delegates. Then the church delegates were recognized and seated. MSC to seat the delegates. The Minutes were read and accepted.

Suggested revisions to the Constitution were presented to the body. Each resolution was read by the Moderator as recommended by the Executive Committee to be incorporated into the Constitution. Each resolution was discussed and voted on seperately and approved as read. MSC to delete resolution one, two and three from the Minutes. MSC to add resolution four to article six as section one. MSC to delete resolution five and six. MSC to incorporate resolution seven into article ten as section five. MSC to delete resolution eight. MSC to add resolution nine to article six as section two. MSC to delete resolution ten. MSC to add resolution eleven to article two as section three. MSC to add resolution twelve to article six as section four. MSC to delete resolutions thirteen and fourteen. MSC to incorporate resolution fifteen into article five as section three. MSC to delete resolutions sixteen and seventeen.

Rev. Glen Jones moved to table the remainder of the revisions until the next quarterly meeting. MSC.

We were dismissed in prayer for a short recess. At this time the Credentials Committee met with Rev. Larry Ball.

Following recess Rev. Ivan Asbury led the congregation in "There Is Power In The Blood." He also blessed the congregation with a solo titled "Born Again." Rev. Taylor introduced our guest speaker for the morning, Rev. Ray Lewis. Rev. Lewis brought a message from Nehemiah chapter one. He gave us Nehemiah's outline for prayer. (1) concerned, (2) right concept, (3) continued, (4) confessed, (5) claimed God's promise, (6) had a desire. Following this message Rev. Taylor asked for special prayer requests. The prayer was led by Rev. Russell Wright and closed by Rev. Danny Ballard. Rev. Lewis then presented the National Retirement Program to the Association. There was a short period of question and answer time. The congregation voted to give Rev. Lewis an honorarium of \$100.00.

The attendance for this meeting was 51 and the offering was \$42.25.

Rev. Larry Ball of Community was recommended to be accepted into the Association. The meeting closed by the congregation giving Rev. Ball the right hand shake of Christian fellowship and acceptance into our Association.

Rev. Clouse recognized the standing delegates. The church delegates were recognized and seated. MSC to seat delegates.

Rev. Wayne Yarbrough welcomed the Association to Jones Chapel. Rev. Terry Booker led in the singing of "Soul Winners for Jesus."

Our first message was brought by Rev. Larry Ball. His message was taken from Psalm 126:5-6. He spoke of sowing and reaping and putting forth an effort to being a soul winning church. He gave us four necessities for a soul winning church: (1) He, meaning you and I, must work through Christ. (2) He must go forth everyday. (3) He must go with concern. (4) He must bear precious seed. Rev. Ball closed with James 5:20 and prayer.

Rev. Glenn Jones made a motion to send \$1,000.00 to March for Missions out of the Little Brown Creek Associational Treasury. MSC.

The Credentials Committee recommended that Bro. Donnie Johnson and Bro. Johnny Johnson be accepted into full fellowship of the Little Brown Creek Association as licensed ministers.

Rev. Malcolm Garrett resigned from the Credentials Committee because of his new pastorate outside the Association. MSC to accept resignation. The body gave Rev. Clouse the authority to appoint Rev. Tommy Wright and Rev. Russell Wright to finish out the term for Rev. Garrett and Rev. Gerald Taylor on the Credentals Committee until this year expires.

Mid-Way wavered their acceptance of the annual session to Martin Hill. MSC that Rev. Clouse continue as Moderator and appoint an Assistant Moderator. Rev. Clouse then appointed Rev. Tommy Wright to fill this position. MSC to close the business session and adjourn for a five-minute recess. The session closed in prayer led by Rev. Ivan Asbury.

After recess Rev. Danny Short led the congregation in singing "I'm Finding New Joy." A love offering was taken for Rev. Wayne Yarbrough for medical expenses. A report of attendance of 47 was given.

The host church then blessed the congregation with a special entitled "That Heavenly Home." Rev. Glenn Jones brought the final message "Building Up The Saints," taken from Ephesians 4:11-16. This message on edification encouraged us to not only go but to teach and instruct Christians in baptism, prayer, Bible study, tithing, and witnessing. He brought out three inspiring points: (1) What people should be involved in edifying, (2) What people need to be edified, and (3) What purpose will edification serve in our churches. He closed his message in prayer.

Glenn Jones led the congregation in "To God Be The Glory" with Sis. Joyce Booker at the piano. Rev. Russell Clouse made announcements, reminding the churches to furnish the Saturday lunch and gave information concerning the Saturday session. Rev. Terry Booker welcomed everyone to Martin Hill Church and to the Annual Session.

The Board of Christian Education is happy to report that all of our churches continue to operate Sunday Schools and our average attendance has increased from 775 in 1986-87 to 809 this year.

#### **RULES AND DECORUM**

The Little Brown Creek Association year ends on August 1 with all church clerks having their letter to the Association no later than August 15. The Association shall open by song and prayer. Only one person may speak at a time. All addresses by the members shall be made to the Moderator, and the person thus speaking shall confine himself to the subject of the debate. The speaker should not cast a personal reflection toward any member of this body who has spoken previously.

No person should speak more than three times on any one subject without the permission of a majority of the Association.

No delegate should absent himself without permission of the Moderator.

No member should speak longer than (15) fifteen minutes at any one time without permission of the Moderator.

Every motion made and seconded shall come under the consideration of the Association except when withdrawn by consent.

The Association shall furnish each church with Minutes of their proceedings, in proportion to the membership of the church.

All questions coming before the Association shall be determined by majority vote, except exclusion of churches, which shall require a two-thirds (2/3) majority.

The Minutes of the Association shall be read before the body just prior to the close of the Association, corrected if need be, and signed by the Moderator and the clerk.

The body shall have no conceived power to lord it over God's heritage, or infringe on any of the internal privileges or rights of the churches in our union, but shall be considered an advisory council in all things pertaining to the internal concern of the churches.

The Association is to give the best advice it can on all matters of difficulty. If the union should be broken between any of the churches, the Association shall inquire into the cause of the break and use its endeavors to remove the difficulty. If the break cannot be removed, the Association is to withdraw from the church which they look upon as unsound in principles, and disorderly conduct of practice, until they be reclaimed.

The Association is not to take a case of any kind, within the union, without the consent of the majority of the churches, and then only to give advice.

## GOVERNMENT AND CONSTITUTION OF THE LITTLE BROWN CREEK ASSOCIATION OF FREE WILL BAPTISTS

Be it known that we, the Free Will Baptist Churches, being in Alcorn, Tishomingo, and Prentiss Counties, in Mississippi, do believe in the doctrines of the general atonement. We have been baptized upon profession of faith in Christ. We are desirous of bringing about reciprocal union. We propose, therefore, to maintain the order and rule of our Association according to the following plan.

We believe the churches of Christ are mutually independent, that congregational forms of government should be invariably preserved, yet, we are being convinced of the unity of friendly intercourse and pious council on the principal of union advantages and Christian love, we hold it a duty of the churches to pay respect to these principals with regard to the duty of the Association.

ARTICLE I. The name of the organization shall be called The Little Brown Creek Association of Free Will Baptists.

ARTICLE II. Membership

Section 1. Newly organized Free Will Baptist Churches petition the Association for membership, which shall be granted by a majority vote of the Association.

Section 2. The Association shall be composed of members chosen by the different churches of our union, who, on producing letters from their respective churches certifying their appointment, shall be entitled to seats.

Section 3. A church that fails to report at two consecutive Annual Associations will be automatically removed from the rolls of this Association.

ARTICLE III. Representatives

Section 1. Each church should have not more than four (4) delegates.

Section 2. All ordained members of the Association shall be standing delegates. Each delegate shall be entitled to one vote on all business transactions. ARTICLE IV. Officers

Section 1. The officers of this organization shall be moderator, assistant moderator, clerk and treasurer.

Section 2. Their duties shall be those usually involving such officers, and they shall serve until their successors are elected except the assistant moderator. The assistant moderator shall become the moderator for the following year.

ARTICLE V. Boards and Committees

Section 1. The general officers and one elected member from the body will compose the Executive Board to see to such items that may arise during the year. The moderator shall be Chairman of the Board.

Section 2. The Home Mission Board shall consist of two (2) ministers and three lay members elected from the body. The ministers shall be elected for terms of one (1) and two (2) years. The members shall be elected for terms of one (1), two (2) and three (3) years. One minister and one lay member shall be elected each year when the Association is in regular session. It shall be the duty of the Board to help in the organization of new churches and to promote the work of Free Will Baptist in general. An evangelist shall be elected from the body to serve with his board.

Section 3. The following committees shall be appointed at the start of each Association: Nomination, Finance, Obituary, Resolution, and Educational. These committees shall be dismissed by the Association.

Section 4. Each board and committee shall make a report to the Association before the close of the Association.

Section 5. Temporary committees may be appointed by the moderator if the body sees need of such committees.

ARTICLE VI. Meetings. The time and place of the meetings of this organization shall be determined at each preceding regular meeting. On the occasion of no meeting place being provided at the regular preceding meeting, the matter will fall into the hands of the Executive Board.

Section 1. The introductory speaker for the Association is to be left to the moderator and the assistant moderator.

Section 2. A free will offering will be taken on Saturday morning of each Association to support the general fund.

Section 3. The host church will be responsible for special music during Saturday morning services.

Section 4. Association quarterly meetings will be from 9:30 til 12:00 noon on Saturday before the first Sunday in December, March, and June; and Friday night and Saturday before the first Sunday in September. Each church is asked to send delegates to each meeting so they may be represented.

ARTICLE VII. Finances. Each church holding membership in this Association shall be asked to send the following monies in this manner: \$50.00 to each quarterly meeting, \$50.00 to each annual meeting.

ARTICLE VIII. Report of churches. Each church holding membership in this organization shall send a written report to each regular meeting. This report is to include such information as indicated by form letter provided.

ARTICLE IX. Quorum. Representatives from five (5) churches shall constitute a quorum for the transaction of business.

ARTICLE X. The Minister

Section 1. For the purpose of ordaining ministers of the gospel and for trying all ordained members for unChristian conduct, there shall be a council, which shall convene at a stated time during the Association and at a time during the Associational year, if called by the moderator or his assistant or any five (5) members of said council, who deem it necessary to make such a call. This council shall consist of all ordained members present who are in good standing. They shall elect a moderator and clerk from among themselves who shall hold office until their successors are elected. It shall be the duty of this council to examine for ordination and if found competent to ordain and set them apart for the work of the ministry by laying on of hands. This council will examine ministers who wish to come into this Association from other associations or denominations and will ordain those who are sound in faith and practice according to Articles of Faith of Free Will Baptists. This council shall have full power to try all ordained ministers for unChristian conduct, and on testimony, their decisions shall be final.

Section 2. This Association may exclude from its body any minister who teaches heresey, or any church who follows him in said teaching, or who is disloyal to the Faith as held by the Association and expressed in our Articles of Faith.

Section 3. This Association having watch-care over all the churches, within its bounds, shall withdraw fellowship from any church which calls a minister for a pastor who has been excluded by the Ordaining Council for unChristian conduct or false teachings according to Free Will Baptist Articles of Faith.

Section 4. It shall be the duty of each member who shall organize a church to obtain deacons for the same who have been duly elected by the church body. It is his duty, also, to obtain deacons where a vacancy occurs within his church or churches. It shall be the duty of each pastor to encourage the organization and support of a Sunday School in the church or churches where he is pastor, as with other organizations which may have proved helpful to the work of the church.

Section 5. The Little Brown Creek Association shall prepare and present to each ordained and accepted minister an annual ministerial certificate denoting good standings to be presented during the Association of each year.

Section 6. And we require Ministers holding cards of good standing in this Association, who fail to report to this annual meeting for two (2) consecutive years, either by his presence or a letter, be examined by the "Credentials Committee," as to their eligibility of credentials.

#### **DOCTRINE**

THE BIBLE. The Scriptures of the Old and New Testaments were given by inspiration of God, and our infallible rule of faith and practice. (Il Peter 1:18-21; Il Timothy 3:16-17.)

GOD. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in Scriptures as Father, Son, and Holy Ghost; yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey. (Deut. 6:4; I Cor. 8:4; Jer. 10:10; John 4:24; Eph. 4:6.)

CHRIST. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour and Lord. (I Tim. 3:16; John 1:1-2; Matt. 1:23; Rom. 3:25-26; Matt. 26:28; Matt. 28:5-6.)

THE HOLY SPIRIT. The Scriptures assign to the Holy Spirit all the attributes of God. (I John 16:13; John 16:8; II Peter 1:21.)

THE GOVERNMENT OF GOD. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for as the high west welfare of men requires. (Acts 17:28; Matt. 10:30; Job 14:5; Isa. 9:6.)

THE SINFULLNESS OF MAN. Man was created innocent, but by disobedience fell into a state of condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God. (John 3:3; Rom. 3:23; Isa. 64:6.)

THE WORK OF CHRIST. The Son of God by His incarnation, life, sufferings, death, and ressurection, effected for all redemption from sin that is full and free, and is the ground of salvation by faith. (Heb. 2:9; Rom. 5:18; Rom. 8:1; Rom. 4:25.)

THE TERMS OF SALVATION. The conditions of salvation are: (a) Repentance or sincere sorrow for sin and hearty renunciation of it. (b) Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. (c) Continuance in faith and obedience until death. (Acts 17:20; Luke 13:3; Acts 16:31; Eph. 2:8-9; Rev. 2:10.)

ELECTION. God determined from the beginning to save all who should comply with the conditions of salvation. Hence, by faith in Christ, men become His elect. (Rom. 8:28-30; Rom. 10:9, I Peter 1:2.)

FREEDOM OF WILL. The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish. (Rev. 22:17; II Chro. 7:14; Rev. 3:20.)

SALVATION FREE. God desires the salvation of all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely. (Mark 16:15; Isa. 55:1; Gal. 2:20.)

PERSERVERANCE. All believers in Christ, who through grace perserve in holiness to the end of life, have promise of eternal salvation. (II Peter 1:10; Heb. 6:4-6; Rev. 2:10.)

GOSPEL ORDINANCES. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance, teaching humility of universal obligation, and to be ministered to all true believers. (Matt. 28:19-20; Col. 2:12; Rom. 6:4; I Cor. 11:23-29; John 13:4-14.)

TITHING. God commanded tithes and offerings in the Old Testament, Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store, as God hath prospered him." (I Cor. 16:2; Gen. 14:20; Mal. 3:8-10.)

THE CHRISTIAN SABBATH. The divine law requires that one day in seven is to be set apart from secular employments and amusements for rest, worship, holy works and activities, and for personal communication with God. (Gen. 2:3; Ex. 20:8-11; Luke 24:1-6.)

RESURRECTION, JUDGMENT AND FINAL RETRIBUTION. The Scriptures teach the resurrection of all men on the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life." (I Cor. 15:1-58; Acts 17:31; Heb. 9:27; II Cor. 5:10; Matt. 25:46.)

#### **CHURCH COVENANT**

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.



To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
