MINUTES OF THE SIXTY-EIGHTH ANNUAL SESSION OF THE LITTLE RIVER ASSOCIATION OF GEORGIA

The Sixty-Eighth Annual Session of the Little River Association of Free Will Baptists met on Saturday, October 19,1974 with the Cool Springs Free Will Baptist Church. Norman Park, Georgia. Host Pastor for the Association was the Rev. Jerry Wisham.

SATURDAY MORNING SESSION

Registration of Minister, Deacons and delegates began at 9:10 A, M. At 9:30 the Association participated in song and praise time followed by devotion by the Rev. R.S. Hayes.

At 10:05 the Association was called to order by the Moderator, followed by report from the Credentials Committee and seating of delegates. (See Report)

Visitors were recognized by the President. Then he appointed the following committees.

OBITUARY: Mrs. Verda Rice, Chairman, Mrs. L. D. Wynn, and Mrs. Carlton Brown.

FINANCE: Mr. F.O. Nelson, Chairman, Mr. William Cooper and Mr. Robert Hendricks.

Following the appointment of Committees the Moderator called for reports from the following:

ORDAINING COUNCIL: A partial report for the ordaining council was given Riley Gid-dens. (See Report)

BOARD OF TRUSTEES: No business being conducted by the Board of Trustees, a Negative Report was given.

EXECUTIVE COMMITTEE: With no business being brought before the committee, a negative report was given.

BIBLE INSTITUTE: The Little River Bible Institute Report was given by the Rev. Leslie Carney. The motion carried to accept the report. (See Report) The Rev. Damon C. Dodd submitted his resignation as Trustee of the Bible Institute. The motion carried to accept the resignation of Bro. Dodd and to extend to him and his wife a rising vote of appreciation for their good work and devotion to the Association during their stay with us.

MORNING WORSHIP SERVICE

The host church led the Association in singing and prayer. After which the Rev. Billy Sumner presented the morning message with the subject being Because He Lives.

There was a break for Lunch with the Moderator announcing that the afternoon session would commence at 1:30.

SATURDAY AFTERNOON SESSION

The afternoon session began at 1:15 p.m. with a song and praise time being led by the host church. Devotion was given by Rev. Amos McMillan, Minister at Ozias Church.

ORDAINING COUNCIL met on January 19, 1974 to act upon business that might be brought before it. The following items of business were conducted.

BIBLE INSTITUTE REPORT

The Little River Association Bible Institute opened for the Fall Session Tuesday, September 17, 1974, in two locations; Bemiss Free Will Baptist Church for the Western area of the Association and White Hall Church, Waycross, for the Eastern area. The Bemiss area enrolled 14 students and the Waycross area 12, for a total enrollment of 26. Rev. Leslie Carney and Mr. William Cooper are serving as Instruc-

tors in the Bemiss school. Rev. Damon C. Dodd opened the session in Waycross and continued until he moved from Homerville. Rev. Ronald Wallace, Pastor of Okefenokee Free Will Baptist Church, Waycross, took over the teaching duties after Rev. Dodd left. He attended Free Will Baptist College, Nashville, Tennessee and is a candidate for the B.A. degree soon. He is thoroughly fundamental and is a good, thorough teacher. The pupils in the class have responded most favorably to Bro. Wallace's teaching ministry.

Financially, it will be about a breakeven experience this session. At the present time we show a balance in the treasury of \$324.80, plus a credit memo from the National Free Will Baptist Sunday School Department of \$25.34, making a total balance of \$380.14. Accounts receivable of \$35.11 raise this amount to \$415.25.

The projected budget for the remainder of this session is:

Teaching Services\$225.00 Outstanding Accounts p. 150.00 Total \$375.00

Hopefully we will not run into any emergancies during this session and will be able to get by on the present balance.

We have appreciated the support of each Church and individual over the Association during the past year. Two Churches have contributed on a regular monthly basis: Pine Level Church gave \$10.00 per month for a total of \$120.00. Bemiss Church gave \$5.00 per month which amounted to \$60.00 for the year.

If the Institute program is to continue, it will require the prayers, giving, and cooperation of everyone in the Little River Association. There is no doubt about it, this is a worthwhile program -- one which rightly deserves the support of every Free Will Baptist Church and member in

the Association. Make this a matter of prayer and follow the leadership of the Holy Spirit.

REPORT OF THE BOARD OF TRUSTEES OF THE LITTLE RIVER ASSOCIATION BIBLE INSTITUTE JULY 27, 1974

The Little River Association Bible Institute will begin its Fall Session on Tuesday evening, September 17, 1974 at 7:30, and continue through Tuesday evening, December 10. Instructors will be Rev. Leslie Carney, Rev. Damon C. Dodd, and William Cooper. Rev. Carney is Institute Director.

Courses have been changed slightly to allow us to place more emphasis on direct Bible study. We will continue to offer ETTA courses to those who want them. In the Advanced Diploma course, the offering will be "Evangelize Through Christian Education" to be taught by Rev. Carney. The Preliminary Diploma course to be taught by William Cooper will be "Teaching Techniques."

Two completely new courses will be offered this session: The Book of Acts and The Book of Revelation. Course materials for the Book of Acts will be adapted from available Free Will Baptist authors. The textbook for the Book of Revelation will be "A Study Guide for the Book of Revelation", by Rev. Damon C. Dodd.

There will again be two centers for the Institute sessions. The Western Division

will meet at Bemiss and the Eastern Division will hold classes at White Hall Church, Waycross.

Institute fees will remain unchanged: Matriculation-\$2.50; Instructional fee-\$12.50. ETTA textbooks have increased in price from \$2.25 to \$2.60. The textbook for the Revelation course is \$1.25 and a fee of \$2.00 will be charged for the mimeographed materials for the Book of Acts. Cost of books would thus vary from \$3.60 to \$5.20, depending on the courses taken.

The projected budget for this session is a follows:

Balance in the Bible Institute Treasury as of July 9, 1974, was \$313.37. This, together with the anticipated income between now and September 17 should push this figure up to at least \$350.00, leaving a total of \$250.00 to be raised through student fees. This means that we must have a minimum of 17 students in order to break even for this session.

We would like very much to enroll all of these here today. We are prepared to do so if you are ready to respond. You may contact anyone of the following brethren here today and complete your enrollment form before you leave this meeting. The men to see are: William Cooper, John Cook, Rev. Billy Sumner, Rev. Riley Giddens, or Rev. Leslie Carney.

We would like to make special mention of Pine Level Church and Bemiss Church. THESE ARE THE ONLY TWO CHURCHES IN THE ENTIRE ASSOCIATION WHO HAVE SUPPORTED THE INSTITUTE ON A REGULAR MONTHLY BASIS. Pine Level has given \$120.00 over the past year and Bemiss has contributed

\$60.00. Our thanks go to each and every Church and individual who has made any contributions toward the Institute, as well as all those who have prayed for this cause. Please continue in prayer. And please take advantage of this opportunity to learn more about the Bible and your Church by enrolling today in the Bible Institute as a student.

BIBLE INSTITUTE REPORT - APRIL 20, 1974

Dear Christian Brethren:

We have reached a critical point in our Bible Institute program. In the words of one of the characters in a Shakespeare drama, "To be or not to be, that is the question." The problem is not financial in as much as will show a balance in excess of \$200.00 at the close of the present session. The problem is students.

There has been a steady decline in enrollment and attendance over the past year.
We have sought to analyze this declining
interest to find the cause. Frankly, we
haven't satisfied ourselves as yet. We
want you to help us.

Ther are three areas of the Bible Institute program that might be the cause of the illness. First, is YOUR personal interest in continuing the Institute. Do you as an association want it? Do you feel that the good it has done and will do justifies its existence? Would you vote to keep it going and back up that vote by your personal attendance if the classes were held in your locality?

The second concern is curriculum. We have used the ETTA study course books and

given ETTA certificates and diplomas. Some may object to this material. Suppose we were to write our own materials based on a study of the Bible books and doctrines? How would a course on the book of Acts, the Gospel of John, the Book of Revelation or Daniel appeal to you? If this is your desire, let us know and we will begin to phase out the ETTA courses and replace them with good, sound, practical Bible courses.

The third area if instructors. As teachers, we are vitally interested that we carry on a relevant and meaningful teaching ministry. Are we being too hard and overly demanding? Have we failed to simplify our teaching so that it can be easily understood? Your suggestions in this area are needed, encouraged, and welcomed.

Finally, there is the matter of money. Are the fees too high? It is the feeling of the Board that the Institute should be self-supporting. Fees have been determined accordingly. However, since Institute operating costs are pretty well fixed and do not fluctuate, the cost per student could be lowered if there were more students enrolled. It costs about \$450.00 to carry on a 13 weeks program with two instructors. This means we must have at least 30 students at \$15.00 each to pay our way. If we had 60 students enrolled, this cost could be reduced to \$8.00 per student.

Without your active participation as a student or a regular donor to the Institute we simply cannot continue this program. We must know here today what your wishes are in regards to this program. We would like to see it continue. But we are just your servants and must be governed by your actions. Pray and search your hearts well and then, under the leadership of the Holy Spirit, tell us what to do.

BIBLE INSTITUTE REPORT - JANUARY 19, 1974

Little River Association Bible Institute closed out a successful and profitable Fall session December 11, 1973. Classes were held in Cool Springs Church where Rev Leslie Carney and Rev. William Cooper served as instructors and White Hall Church, Waycross, with Rev. Damon C. Dodd as teacher. Rev. Leslie Carney is the Bible Institute Director.

This session was unique in that it marked the completion of the first full cycle of the ETTA courses in the Preliminary Diploma curricula. In the very beginning of the Institute separate courses were offered ministerial students. 10 students completing all the requirements for the Preliminary Teacher's Diploma. We had hoped to present these diplomas here today but due to a delay in Wheaton, Illimois, where the diplomas are hand-lettered for each individual, we were unable to receive them in time. However, these people will be publicly recognized by the Institute Director when he presents his report.

The Board met in Valdosta Friday, January 11, and finalized plans for the Winter-Spring session of the Institute. Classes will begin on Tuesday evening, February 5, at 7:30. The session will

close on Tuesday evening April 30. The Western Section will again meet at Cool Springs Church. Rev. Carney will teach the Advanced class and the courses will be Biblical Beliefs and The Missionary Enterprise. Rev. Cooper will be the instructor for the Preliminary courses which will consit of Old Testament Law and History and Understanding People. Plans have not been perfected as yet for the Eastern section but will be announced soon. Rev. Dodd will be the instructor for this division. Fees will remain the same: \$2.50 matriculation and \$12.50 instructional. Textbooks will cost \$2.25 each.

Financially we fared better this session than in any previous session. After all expenses were met, we showed a balance in the treasury of \$385.17. The projected budget for the coming session will be approximately \$600.00. This means that we must have a minimum of 15 students to break even financially. We feel confident that there will be more than the minimum number of our people who will want to avail themselves of this privilege of good, sound Biblical training.
