

THEME: "Revival for Survival"

Scripture: II Chronicles 7:14

MORNING PRELIMINARIES

Congregation singing was led by song leader, Roger Spivey, and pianist Wanda Cooper. Bill Barksdale led in prayer. Morning devotions were by William Sumner, Hahira Pastor. Welcome was by Roy Cooper and response was by Jerry Wishum.

MORNING BUSINESS MEETING

The session was called to order by the Moderator, Bill Cooper. Credentials Committee Chairman, Louise Ivey, reported: 13 churches reported; attending were 11 pastors, 2 other ministers, 15 deacons and 53 church delegates totaling 81 voting members for the day. The delegates were seated by vote. A Finance Committee for the day was appointed by the Chair: Earl Ridley, Chairman; Roger Spivey and Daniel Eason.

Motion that churches be allowed to substitute delegates without written authority from church was carried.

An Obituary Committee was appointed by the Chair: Latrelle Barksdale, Nancy Lee and Charlene Neuenschwander. Jerry Wishum was appointed to serve on the Nominating Committee.

Coy Miller dismissed the Morning Business Meeting with prayer.

MORNING WORSHIP SERVICE

(1) A letter of recommendation from the Union Association on behalf of Brother Jerry Wisham and we recommend that the Moderator extend the hand of fellowship to Brother Wisham. (2) A letter of recommendation from the Cumberland Association, Nashville, TN on behalf of Brother Roger Spivey and we recommend the Moderator extend the hand of fellowship to Brother Spivey. (3) Having received a letter from the Ozias Church to examine their pastor, Brother Victor Neuenschwander for membership in the Little River Association, and having complied with that request, recommend that Brother be received into the fellowship of the Association upon the receipt of a letter of recommendation from the North Florida Association. (4) We recommend that the Clerk write a letter to Rev. Carl Taylor, asking Brother Taylor to meet with the Ordaining Council at the next session July 31, 1982, at the Homerville Church. (5) We further recommend that the petition relative to Rev. Taylor Merritt by Ozias Church be tabled.

State Mission report was given by Board Member, William Sumner: Atlanta Mission sold surplus land and applied the money to existing loan. Plans are now being made for the first building on the front property. The work in Dublin seems to be progressing. Brother Hedrick has found work to supplement his income. The Perry Mission is in the process of moving an existing building onto some new property. The Gainesville Mission is having full time services in Brother McKinney's home at present. Brother McKinney is without a job at present.

After a motion to adjourn was carried, C. D. Rentz led in the prayer of Benediction.
