Little River Association of Free Will Baptists Minutes of the Annual District Meeting

Convening at: Zion Hill FWB Church, Millwood

Date: January 15, 2005, 9:30 am

PRELIMINARIES:

The meeting began with the congregational songs "Down at the Cross" and "At Calvary". Rev. Billy Sumner, pastor of the Corinth church led in prayer. Rev. Keith Lloyd, pastor of the Zion Hill church, brought the morning devotion from Mark 7:1-8 on the subject of "Vain Traditions".

Moderator Jeff Goodman called the meeting to order. The Credentials Committee Report was given as follows: 12 churches reported with 10 pastors, 3 other ministers, 10 deacons, and 41 delegates present. All elected delegates were seated by a vote from the standing delegates. The total voting delegation was 64.

The State Coop Offering was received and totaled \$148.00. Sis. Faye Ogletree was appointed to serve as a temporary member of the Finance Committee.

The minutes of the last meeting were read, and Clerk Keith Lloyd gave the Treasurer's Report. A motion was made, seconded and carried to receive each report as given.

REPORTS OF BOARDS AND COMMITTEES:

A LRA Executive Board:

Moderator Jeff Goodman reported that the Executive Board had met just prior to the Annual Session, and had reached a consensus that some of the boards and committees of the association have been inactive and/or unnecessary for years. Therefore, the Executive Board recommends to the Association that the following boards and committees be disbanded: Credentials Committee, Resolutions Committee, Trustee Board, and Christian Education Board. A motion was made and seconded to approve this recommendation. After discussion, the motion carried. The Moderator informed the other Boards and Committees that their first meeting should be held immediately following the Annual Session, and that they should then appoint a Chairman and plan the first meeting thereafter.

* LRA Camp Board:

- Camp Board Interim Treasurer Keith Lloyd submitted a financial report. A motion was made, seconded and carried to accept the report. This financial report becomes an integral part of the minutes.
- The date for Jr. Camp has not been officially set, but is tentatively scheduled for June 12th 17th, 2005. Other groups have expressed an interest in renting the facilities for camp sessions as well.

* LRA Mission Board:

Sis. Melonie Brown gave the Mission Board report. This year's Annual Mission Rally will be held on February 19th, 2005, beginning at 6:00 pm, at the Open Door Fellowship (formerly Valdosta 1st FWB Church). Sis. Debbie Griffin, Rev. Billy Hanna, and Rev. William Smith will be giving reports on International and Georgia mission works. Pastors and churches are encouraged to support the rally with their presence and prayers. Each church is also asked to bring a gift of at least \$300 to the Rally, for a Mission Offering that will be equally divided between the Debbie Griffin account and the Georgia Missions program.

* LRA CE Board:

The Moderator informed the Association that since the CE Board had been disbanded, the money in its account needed to be redistributed. A motion was made and seconded to divide the CE Board account between the Camp Board and the Mission Board, and to divide all future Association fees equally between the General Fund, the Camp Board, and the Mission Board. The motion carried.

Finance Committee:

Clerk Keith Lloyd gave the report from the Finance Committee as follows: Balance Brought Forward: \$1764.69; Total Receipts: \$1863.44; Balance On Hand: \$3628.13. A motion was made, seconded and carried to receive the report.

Nominating Committee:

Moderator Jeff Goodman began reading and acting upon the individual officers of the Nominating Committee report. A motion was made, seconded and carried that the Moderator read the entire report, and that the association vote on the report by acclamation. After the report was read, a motion was made, seconded and carried to elect all officers by acclamation. The slate of 2005 Officers and Board and Committee members will be attached to the opening pages of the Annual Minutes.

❖ GAFWB Camp Board:

➤ Rev. Jeff Goodman gave the GAFWB Camp Board report. The Winter Retreat at Epworth By The Sea was a big success. State Teen Camp is scheduled for May 29th thru June 3rd, 2005, and will be held again at Camp Echeconnee in Lizella. The report was received as information.

GAFWB Mission Board:

Sis. Melonie Brown gave the GAFWB Mission Board report. The State Mission Board is set to meet on Thursday, January 20th, 2005, to discuss where to begin another Georgia mission work. A candidate to pastor this new work has been found and will be announced soon. Rev. Bill Lewis is the new missionary pastor to the Open Door Fellowship, formerly the Valdosta 1st Free Will Baptist Church in Valdosta, Georgia. The report was received as information.

OLD BUSINESS: (none)

NEW BUSINESS:

- ➤ GAFWB Executive Secretary William Smith reported on various retreats and activities that were scheduled, the financial status of the State Association, and the contributions of the LRA to the GAFWB. Bro. William also informed the LRA that a denominational fund had been established to help with the relief efforts associated with the recent tsunami. All contributions can be sent through the State Office, and should simply be designated "tsunami".
- A motion was made, seconded and carried that Sis. Heather Goodman and Sis. Joyce Johnson be elected as delegates to the GAFWB State Meeting on March 17th thru 19th, 2005, at the Shallowford FWB Church in Marietta, Georgia; and, that Moderator Jeff Goodman and Clerk Keith Lloyd be given the authority to appoint other delegates as needed.
- ➤ Rev. Ron Burger, the pastor of the Cool Springs Church, introduced his son, Darrell, to the Association. Darrel and another member of the Cool Springs Church, Charity Kline, have been selected to be a part of this year's E-Team. Darrell will be traveling to Brazil and Charity to Panama to be involved in NAFWB mission efforts during the summer. Bro. Darrell spoke briefly to the Association and asked for their prayers and support, and made himself available to come to Association churches to speak concerning these mission efforts.
- Having received a request from the Open Door Fellowship, the Ordaining Council recommends that Rev. Bill Lewis' credentials as a Minister of the Gospel be received and held by the LRA, pending a Letter of Good Standing from the Midway Association. A motion was made, seconded and carried to accept this recommendation. The Moderator gave Rev. Lewis the right hand of Association fellowship and welcomed him to the LRA.
- ➤ Having examined Bro. Carl Morrison, a licensed minister from the Forest Hill Church, the Ordaining Council recommends that he be ordained as a Minister of the Gospel at a time and place to be determined by him. A motion was made, seconded and carried to accept this recommendation.
- Clerk Keith Lloyd read the 2004 Obituary Report. After standing for a moment of silence in honor and memory of the deceased, Rev. Mitchell Deems led the Association in prayer. The Obituary Report will be attached to the opening pages of the Annual Minutes.

CLOSING ITEMS:

- Announcements, prayer requests, and praise reports were given from pastors and members of Association churches.
- A rising vote of thanks was given to the Zion Hill Church for their hospitality in hosting the Annual Session of the LRA.
- Moderator Jeff Goodman thanked the Association for the privilege of serving, and then turned the meeting over to newly elected Moderator, Rev. Teddy Burch.
- > A motion was made, seconded and carried to adjourn from the business session.

MORNING WORSHIP AND FELLOWSHIP:

- The congregation sang the hymn "Joy Unspeakable", and Sis. Christy Hurst ministered to the Association with a special song entitled "I Exalt Thee". Following the praise and worship song, "Shout to the Lord", Clerk Keith Lloyd introduced the morning speaker, Rev. Bill Lewis, who is serving as the missionary pastor of the Open Door Fellowship in Valdosta, Georgia. Bro. Lewis brought the morning message from the first chapter of the Gospel of John on the subject of: "How Do You Respond To The Light?" After the message, the congregation sang together, "Turn Your Eyes Upon Jesus", as an opportunity to respond to the Word was given.
- Rev. Arthur Knight, pastor of the Hahira 1st FWB Church dismissed the meeting with a benediction prayer and giving of thanks. Following the meeting, the Association joined together for a wonderful and bountiful meal prepared and provided by the members of the Zion Hill FWB Church. All enjoyed the meal and the fellowship.

A copy of the insurance certificate will be required and attached to this signed contract.

Indian Mound Baptist Church and its affiliates will not hold the Little River Association and/or its members responsible or liable for any accidents or injuries to staff or camp participants while on the Camp Ozias facilities.
