



1973 - FIRST QUARTERLY SESSION

The First Quarterly Session of Free Will Baptist Association convened at Martin Youth Camp Saturday morning, January 20, 1973. Bro. Clint Ard led the song service. Prayer—Rev. James Rathel; Welcome—Bro. Howard Roberts; Response—Bro. Bobby Richardson; Devotional—Bro. Wayne Sheffield. (II. Chron. 2nd Chap. 13th v.) There were four ministers present.

The Credential Committee made a partial report, Motion was seconded and carried to accept this report and seat the delegates. Due to the absence of all Credential Committee except Bro. David Clements, the Moderator approved Bro. Harry Haire and Bro. David Richardson to help with the report.

Minutes of the last meeting were read and adopted.

The Credential Committee made a final report. M.S.C. to accept the Credential Committee Report.

III.

The Resolution Committee Report. M.S.C. to adopt report and voted on each item separately. Motions seconded and carried to adopt items I, II, III, and IV. Items V and VI were discussed and tabled until the next session. That each church be sent a letter concerning Items V and VI and vote to accept or reject these items. M.S.C. for Moderator to appoint a committee to study Church Decorum and report on next Quarterly Session. The committee members are as follows: Bro. Louie Grimes, Bro. Kenneth Kirby, Bro. Danny Keen, Bro. James Rathel and Bro. Herbert Boyd.

Bro. Wayne Sheffield asked that the association give the churches a chance to fix rooms at camp. M.S.C. that also the Youth Camp Board be in charge of assigning rooms.

M.S.C. to give New Home I a rising vote of thanks for hosting the Association. Dismissed — Bro. Danny Keen.

- II. BE IT RESOLVED that we print program of each session and send copy to each church with a letter encouraging support.
- III. BE IT RESOLVED that this Association send a questionaire to all churches requesting evaluation and ideals that we may see a renewed interest in our attendance to sessions of our Associations.
- IV. BE IT RESOLVED that each church be encouraged to organize a chapter of "Master's Men" and "Women's Auxiliary" if they have neither.
- V. BE IT RESOLVED that we discontinue printing our constitution and by-laws in the minutes due to the costs and lack of changes made from year to year, and that they be mimeographed and a copy provided to each member of every church in our association.
- VI. BE IT RESOLVED that the Church Decorum be discontinued due to the fact that it is out-dated, un-needed and basically unconstitutional.

STANDING RULES OF MARTIN QUARTERLY MEETINGS

- 1. Recommend that each church close their books on September 1 and mail their annual and quarterly reports to the clerk two weeks before each session.
- 2. The pastoral year will begin on September 1st.
- 3. Each church that entertains Quarterly Meetings will prepare a program for that day and be responsible for preacher and speakers and let the moderator and clerk know in advance of the meeting.
- 4. The Sunday School and C.T.S., Ministers and Deacons Conference, Ladies Auxiliary and any other auxiliary give an annual report to the Quarterly Meetings.
- 5. The Obituaries of each church will give name, date of birth and date of death of members in an annual report to the Quarterly Meetings. This information will be given to the Resolution Committee.
- 6. Our standing resolutions will be printed in the minutes each year.
- 7. Our Quarterly Meeting fee will be 25ϕ per capita member at each session, or \$1.00 at the Annual Session.
- 8. A Digest Committee of at least three will be elected by the body or appointed by the moderator to examine church letters and make a report of their findings.
- 9. Our Quarterly Meetings will be Saturday before the third Sunday in January, April, July and October at 10:00 A.M. The Annual Session will be held in October beginning at 9:30 A.M. and continuing until all business is finished.
- 10. That no person may serve more than one elected office in the Martin Quarterly at the same time.
- 11. That the Second and the Annual Session of the Quarterly Meeting will be held at the Youth Camp with all churches acting as hosts. The first and third sessions will be held in the local churches by request with this church acting as host.

- 12. DISBURSEMENTS: (a) Retain in treasury \$50 after each session (b) State Association \$5 each session (c) retain for printing minutes \$80 each session (d) National Association \$2.50 each session (e) Moderator \$5 per session, Clerk \$5 each session per one, two, three sessions, and \$20 for fourth session. (f) the remaining funds left will be allocated as follows: (a) State Cooperative Board 25%, (b) local mission board 15%.
- 13. Superannuation Board: 25% of funds will be allocated to the State Superannuation Board and the remaining funds to the retired ministers of the Martin Quarterly Meeting or their widows which to be eligible have to be recommended by the local church and approved by the Quarterly Meeting
- 14. The Moderator and Clerk will not serve more that three years in succession.
