ORDAINING COUNCIL REPORT

The Ordaining Council has had three meetings, including the one held during the April session of the Martin Association. James Rathel was called before the council at that meeting to be questioned concerning his preaching, teaching and practicing the doctrine of speaking in unknown tongues and interpreting unknown tongues in a Free Will Baptist Church and encouraging this doctrine and practice among members of a Free Will Baptist Church. He admitted under questioning that he was guilty as reported but would not agree to any adjustment on his part.

Two weeks later he requested a meeting with the council. This session was held at New Home Church, Miller County, near Colquitt, Georgia. Mr. Rathel admitted his error to the council and promised to correct it in his preaching and teaching and to make a public confession to the church of which he was pastor and to cease and desist the preaching and teaching of this doctrine and practice.

However, instead of fulfilling this promise, he began a tirade against the council on his daily radio broadcasts over Radio Station WSEM, Donalsonville, Georgia. When all efforts had been exhausted to labor with him and help him get back in line had failed, the council requested a meeting with the Executive Board of the Association for the purpose of their hearing the matter from both sides. Mr. Rathel was notified of the meeting and requested to be present with witnesses to defend his position. On the night before the scheduled meeting, in a telephone conversation with two members of the council, he informed us that he would not be present, and he did not attend the meeting, which was held at the Martin Association Youth Camp.

The result of that meeting will be given by the Executive Board of Martin Association in a report to be presented at this session.

As a result of this experience, the Ordaining Council has found that the procedures for ordaining ministers in Martin Association are totally inadequate and leave too many loopholes. Also, there are no procedures clearly defined for dealing with ordained ministers who get out of line doctrinally or morally.

The Ordaining Council requests of this association that it be, and hereby is, authorized to draw up a well-defined set of procedures for the ordination of ministers, together with a step-by-step method of dealing with ordained ministers when such dealings become necessary.

We recommend that Rev. Whitaker be received into the membership of Martin Association pending receipt of a letter or recommendation from Union Association.

Rev. J. M. Goode, pastor of New Salem Church, appeared before the Council desiring to take membership in Martin Association. We recommend that he be received into the membership of Martin Association pending receipt of a letter of recommendation from South Georgia Association.

STANDING RULES FOR MARTIN QUARTERLY MEETINGS

1. Recommend that each church close their books on September 1 and mail their annual and quarterly reports to the clerk two weeks before each session.
2. The pastoral year will begin on September 1st.
3. Each church that entertains Quarterly Meetings will prepare a program for that day and be responsible for preacher and speakers, and let the moderator and clerk know in advance for the meeting.
4. The Sunday School and C.T.S., Ministers and Deacons Conference, Ladies Auxiliary and any other auxiliary give an annual report to the Quarterly Meetings.
5. Obituaries of each church will give name, date of birth and date of death of members in an annual report to the Quarterly Meetings. This information will be given to the Resolutions Committee.
6. Our standing resolutions will be printed in the minutes each year.
7. Our Quarterly Meeting fee will be 25¢ per capita member at each session, or \$1.00 at the Annual Conference.

8. A Digest Committee of at least three will be elected by the body or appointed by the moderator to examine church letters and make a report of their findings.
9. Our Quarterly Meetings will be Saturday before the third Sunday in January, April, July and October at 10:00 A.M. The Annual Session will be held in October beginning at 9:30 A.M. and continuing until all business is finished.
10. That no person may serve more than one elected office in the Martin Quarterly at the same time.
11. That the Second and Annual Session of the Quarterly Meetings will be held at the Youth Camp with all churches acting as hosts.
12. DISBURSEMENTS: (A) Retain in treasury \$50 after each session (B) State Association \$5 each session (C) Retain for printing minutes \$80 each session (D) National Association \$2.50 each session (E) Moderator \$5 per session, Clerk \$5 each session per one, two, three sessions and \$20 for fourth session. (F) The remaining funds left will be allocated as follows: (a) State Co-operative Board, 15% (b) Local Mission Board, 10% (c) State Superannuation Board, 75%.
13. The moderator and clerk will not serve more than three years in succession.

ORDAINING COUNCIL REPORT

The Ordaining Council of the Martin Association of Free Will Baptists respectfully submits the following report to the Association in its annual session October 16, 1976:

Our last official meeting was held during the quarterly meeting of the association this past July. You heard and adopted our report at that meeting and witnessed the ordination of Rev. Cecil Mock to the Gospel Ministry.

At that meeting you authorized the Council to draw up some suggested procedures for the ordination of ministers in our association. While we do not claim to have worked up a perfect set of procedures, we do have prepared for your consideration and action here today a complete order worked out and are ready to submit the same here today.

Also, it has been called to our attention that James Rathel is oper-

ating as an ordained minister on the strength of the Free Will Baptist credentials which he was ordered to surrender by this association. We recommend, therefore, that the association instruct its clerk to have published in the State Promotional Bulletin a notice that Mr. Rathel is no longer an officially recognized Free Will Baptist minister and that we also inform the proper authorities in Seminole and Miller Counties of this fact. Further, if this body deem it necessary, that we ask the clerk to have the same notice published in the Seminole and Miller County newspapers.

We have received letters of recommendation for the following ministers who have applied for membership in our association: Rev. Bobby Whitaker, Rev. W. C. Combs, Rev. W. A. Addison. A letter of recommendation for Rev. J. M. Goode is pending the action and attention of the clerk of the South Georgia Association and will be in our hands at a later date.

PROCEDURES FOR ORDAINING MINISTERS

The Ordaining Council of the Martin Association of Free Will Baptists hereby submits to the Association in its annual session, October 16, 1976, the following suggested procedures for the ordination of ministers.

1. Request for ordination must come from the church with which the candidate holds membership and may be submitted through the Association at any of its regular meetings or directly to any member of the Ordaining Council.
2. The Ordaining Council will arrange a meeting with the candidate for a brief interview at which time he will be given an application form for ordination which he shall fill out and file with the Ordaining Council at his earliest convenience.
3. Upon receipt of the application, the Ordaining Council will set a time and place for the examination to be taken. In each case the examination must be completed before the Council can proceed with plans for the ordination of the candidate. Passing grade on the examination is 70 out of a possible 100.

4. When the examination has been sucessfully completed, the Or-
daining Council shall submit an appropriate recommendation to
the next session of the Association for final action regarding the
odration of the candidate. The candidate shall be given the
privilege of selecting the time and place for the ordination
service.
5. A candidate failing to make a passing grade on the examination
must wait at least two (2) weeks before taking it again.
6. Pursuant to the ruling by the National Association in its 1976 ses-
sion, no person will be ordained to the Free Will Baptist ministry
in the Martin Association who has been divorced and has more
than one living companion.

These procedures shall be numbered as follows in the Associational
Decorum: 15. A through F. (Pp. 30, 31 in the 1972 minutes)

The remaining provisions as stated in the Associational Decorum
shall remain as they are with the exception of Number 20, which shall
be deleted in its entirety.
