The State Trustee Board report was given by Brother Bobby Roberts. A motion was approved to receive the report as information.

The Woman's Auxiliary report was given by Sister Martha Everson. A motion was accepted to receive the report as information.

Due to the fact that Rev. Herbert Waid is to speak at our April session, but will be unable to do so; and that Rev. Rick Cason is to speak at our August session, but will be leaving our area, it is agreed for the Executive Committee to secure speakers for the April and the August sessions.

EXECUTIVE COMMITTEE REPORT

The Executive Committee of the Martin Association met September 21, 1987 at New Home (Miller County) Church. Jerry McNease, Terry McVey, and Ken Faison were present.

The meeting opened with prayer by Ken Faison. The minutes and financial report from August session were read and received. From this meeting the following recommendations were formulated to present to the Association in October.

1. We recommend that the Association send a love offering (amount to be decided) on behalf of the medical expenses of Rev. James Roland.
2. Due to the fact that our minutes cost is increasing each year, we recommend that we increase our withholding for that purpose. We recommend that our constitution be amended thusly:

The meeting was recessed until October 17, 1987 at the Colquitt Church with other members Duane Hunt and Abbie Calhoun also present. The above recommendations were adopted by the full committee, along with the following recommendations.

3. We recommend that we take care of the expenses of the Life Quest seminar with Jonathan Thigpen for our Association in the amount of \$300.00
4. We recommend that the April session be designated as "Youth Day" for the competitive activities, and that Bud Hill be invited to bring a devotion at that session.

We were dismissed in prayer by Jerry McNease.
