

# Preface

Another year has quietly slipped into eternity. It's gone. We can discuss what we should have done and what we could have done to advance the cause of Christ; but, 1999 is on the eternal books. We need to ask ourselves this question at the end of each year, "how pleased is God with our effort?" Three of our 13 Sunday Schools showed gains in attendance from 1997 to 1998. One church recorded S. S. gain during 1999. (For more information on S. S. comparisions see the graph and narrative after the statistical page.) Of the eight churches that reported tithes and offerings two years in a row the total was up less than half of 1%. Of the churches reporting, collectively we gained one member over the number lost. Most of our churches lost membership during 1999. We had 41% less baptisms last year. One bright note, a church gained 41% in total membership in 1999. Praise the Lord!

This commentary is almost all negative, sorry to say, but this should not discourage us, it should challenge us to do better in the year 2000. How can we do better? What do we need to do? First, let's pray. Ask God to show us where we have not worked very efficiently. Satan would have us spin our wheels on many activities that have very little eternal value. Let's include God in every aspect of our church planning. Plans made within ourselves usually amount to wasted effort. Let's ask Him to help us mobilize our churches to include all of our members in an outreach to our friends, neighbors, co-work'ers and others. The Great Commission applies to more than just our Pastors. One of our most productive efforts might be in following up on our members who have quietly slipped out of our midst. Don't we need to be reminded of our responsibility to our Christian brothers and sisters?

Let us resolve to ask God to guide us into greater service in the coming year. He has been so good to us in providing the ultimate sacrifice, His Son Jesus Christ. How much have we sacrificed for Him?

# MARTIN ASSOCIATION OF FREE WILL BAPTISTS – Minutes – Fourth Quarterly Session October 9, 1999

Martin Association of Free Will Baptists convened at the New Home (Decatur County) Church at 9:30 a.m. The opening activity was the singing of a congregational hymn led by Brother Howard Scarborough and accompanied by Sister Cumbie at the piano. After prayer by Rev. Jamie Florence, Brother Steve Allen extended the welcome to those in attendance. Brother Earl Daniels responded to the welcome. Brother Randall Forrest presented the devotional.

**Business Session:** After the devotion, the meeting was called to order by Moderator Daniels. Standing delegates were recognized. Elected delegates were asked to stand and were officially seated. Each minister and his wife were recognized. Each deacon and his wife were also recognized. Minutes of the third session of 1999 were read and approved with corrections. Financial report for the third session was also read and approved without changes. Roll call of association churches was made and the number of members attending from each church was recorded.

**Committee Appointments:** Moderator Daniels appointed Program and Nominating Committees as follows: Billy Adams, Herbert Boyd, and Claude Newsome were appointed to serve on the Credentials Committee. Sisters Jean Tully, Scarborough Scott and Regina Sauls were appointed to serve on the Resolutions Committee.

**State Board and Woman's Auxiliary Reports:** Three reports were given by elected State Board Members. Brother Jerry McNease reported on Camp Board progress. The advantages and disadvantages of purchasing a campsite were discussed. The Association voted to go on record opposing the purchase of a campsite at this time. Rev. Roger Russell reported Mission Board progress and Dr. Frazier reported on Christian Education Board's progress. He indicated the Board has established a committee to look into the possibility of establishing several Bible Institutes across the State. Sister Melinda Pinson reported Martin Woman's Auxiliary progress. She announced the officers for the coming year. (See the September 11, 1999 minutes of the Woman's Auxiliary report for the slate of officers for 2000.)

**Credentials Committee Report:** Brother Boyd related the following statistics: Standing delegates (30); Ministers (8); Ministers' Wives (9); Deacons (11); Deacons' Wives (6); Visitors (0); Churches reporting (11); Churches with delegates (10); Total present (90); Martin Church Membership reported (645); Quarterly fees total (S346.00); Benevolent Fund totaled (\$1244.00); and the General Offering was (S86.45). Attendance banners were awarded to the Highway Church for the highest percent present and to the New Home (D.C.) Church for highest number present. **Recess:** Moderator Daniels called for a 20 minute recess so the Committees could complete their work.

**Completion of Business:** Moderator Daniels called the meeting back to order. Brother Howard Scarborough opened this session with a congregational hymn accompanied by Sister Cumbie on the piano. Moderator Daniels called for the Resolutions Committee Report.

**Resolution Committee Report:** Sister Sauls read the following resolutions for consideration by the body. Be it resolved:

A. That we continue to support our Georgia Missionaries and other Missionaries.

B. That we faithfully minister to our elderly and shut-ins through visitation, prayer and assistance.

C. That we continue to use II Chronicles 7:14 as our theme verse: "If my people which are called by my name, shall humble themselves, and pray and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and heal their land."

D. We give a rising vote of thanks to the New Home (D.C.) Church congregation for their hospitality in hosting the Martin Association Quarterly Meeting.

These resolutions were adopted as a whole, then voted on as separate entities. The body approved all four resolutions. Moderator Daniels asked for a rising vote of thanks to the New Home (D.C.) church for their hospitality.

**General Information:** Rev. Matt Pinson reviewed the advantages and disadvantages of changing the name of the Free Will Baptist Bible College. After discussing this issue, the Association voted to recommend the name be changed to Palmer College. The Association asked the clerk to draft a letter indicating our vote and forward this to each FWB Bible College Trustee Board member. A second request of clerk was that he draft a letter and send it to the churches that were not represented at this Quarterly Meeting, encouraging them to attend the next meeting in January. Rev. Pinson indicated that Sis. Elise Williams had been added as a recipient of the benevolent fund. Rev. Roger Russell said the Association had enough surplus to give a love offering of \$250.00 to Rev. Ursrey. This suggestion was translated to a motion which was seconded and carried unanimously.

**Worship Service:** The business part of the meeting was adjourned and the worship service began. Bro. Scarborough led a congregational hymn accompanied by Sis. Cumbie on the piano. After New Home's special music "The Lord Is My Life" sung by Bro. and Sis. Gerald Cumbie and Rev. Pinson's hymn "Each Step I Take", Rev. Cumbie preached on the subject "God's Elisha".

Matt Pinson at the piano. After prayer by Rev. Willie Dawson, Rev. Bill Robinson extended the welcome to those in attendance. Rev. Roger Russell responded to the welcome. Bro. Herbert Boyd presented a devotional from Proverbs 18:4 reminding us of "The Friend That Sticks Closer Than a Brother".

**Business Session:** After the devotion, the meeting was called to order by Moderator Daniels. Standing delegates were recognized. Elected delegates were asked to stand and were officially seated. Each minister and his wife were recognized. Each deacon and his wife were also recognized. Minutes of the first and second sessions of 1998 were read and approved without corrections. Financial report for the second session was also read and approved without changes. Roll call of Association churches was made and the number of members attending from each church was recorded. Bro. Boyd suggested the Association consider increasing the church fee for the Benevolent Fund by \$1.00 during the fourth quarter of 1999, to help the retired ministers and minister's widows during the Christmas holiday. # MARTIN DISTRICT WOMEN'S AUXILIARY CONVENTION

# September 11, 1999



Figure 1 illustrates Sunday School data for three years - 1997, 1998, and 1999. Three churches, 2, 11, and 12 recorded gain in S.S. attendance from 1997 to 1998, with a percent increase of 53%, 23%, and 26% respectively. Only one church showed a gain in S.S. attendance from 1998 to 1999 which was 52%. The names of specific churches was not recorded, because the purpose of the graph is to help us get an overview of our progress rather than embarrass specific churches. Some are holding their own, others lost membership. We do not collect information on the different age groups enrolled in our church Sunday Schools. Consequently, our Quarterly Association does not know whether we are gaining or losing our youth, young adults, or our older adult members. We may want to consider collecting more detailed S.S. information. Accurate information is always needed to make good decisions in improving our effectiveness in service to our Lord and Savior Jesus Christ. Will we be held accountable for the way we conduct His work?

# CONSTITUTION MARTIN ASSOCIATION OF FREE WILL BAPTISTS

# PREAMBLE

We, the Martin Association of Free Will Baptists of Georgia, do establish and ordain this Constitution for the purpose of advocating, promoting, and increasing our fellowship with one another as fellow members of the Church of Jesus Christ, and for the extension of the Kingdom of God through the preaching of the Gospel of the divine Son of God.

#### **ARTICLE I**

#### NAME:

This Association shall be called the Martin Association of Free Will Baptist, and shall be composed of such regularly organized and well disciplined churches as may embody themselves under this constitution.

### **ARTICLE II**

#### COMPOSITION AND DELEGATES:

Section 1. This Martin Association shall be composed of its general officers, all ordained and licensed ministers of Gospel, all ordained deacons who are in good standing with the churches of which they are members, duly elected delegates from the local churches comprising the Association, and all Home and Foreign Missionaries who are members in good standing with a church belonging to this Association.

Section 2. Local churches shall be allowed two (2) delegates for the first fifty members or fraction thereof, and one (1) delegate for each additional twenty-five (25) members or fraction thereof.

#### **ARTICLE III**

#### MEETINGS:

The sessions of this Association shall be held quarterly in January, April, July, and October on Saturday following the first Sunday of these months. The place of meeting to be determined by vote of the Association. It shall be the duty of the member churches to represent by letter and delegates at these meetings and report their condition and statistics on forms provided by the Association. The October session shall be considered the annual session of this Association.

#### ARTICLE IV

# INDEPENDENCE OF THE LOCAL CHURCHES:

Every church in this Association shall be considered an independent body and shall control its own internal affairs, having unrestricted right to administer its own government without interference from any higher body, being under Christ free and independent.

# ARTICLE V

# ASSOCIATIONAL RELATIONSHIP TO THE LOCAL CHURCHES:

The Martin Association shall be considered an advisory board whose function is to meet quarterly at such places as may be determined according to Article III of this Constitution, and not to adjourn formally until all pertinent matters are disposed of. While in session its duty shall be to examine all questions of interest to this Association and to use its best influence to promote Christian, denominational, and benevolent programs and institutions, such as Sunday Schools, Church Training Service, Woman's Auxiliary, Masters Men, Home and Foreign Missions, and childcare institutions. The only punitive power this Association has in relation to the member churches is the right to withdraw fellowship from such churches who are in open violation of the rules and regulations of said Association or who become unsound in the doctrines and practices of the Free Will Baptist Denomination.

#### **ARTICLE VI**

#### **OFFICERS:**

Section 1. The officers of this Association shall be Moderator, Assistant Moderator, Treasurer, Assistant Treasurer, Clerk and Assistant Clerk, each of whom shall be elected at the close of the October session and assume the duties of their offices the next day following their election.

Section 2. No individual shall be elected to more than one office at a time.

Section 3. The Moderator may not serve more than (3) terms in succession. The Clerk and Treasurer may serve for an indefinite period of time.

#### **ARTICLE VII**

#### PROCEDURES FOR JOINING THE ASSOCIATION:

A church desiring to become a member of Martin Association shall submit a petitionary letter to the Association at any of its regular quarterly sessions, stating the date and place of organization, the Pastor's name and address, list of all elected officers, number of members, and time and place of regular meetings. The church must conform to the doctrines, and practices of the Free Will Baptist Denomination as set forth in the Treatise of Faith and Practice of the National Association of Free Will Baptists.

This Association reserves the right to send its Executive Committee to investigate any applicant for membership in this Association if it deems necessary and to subsequently act on the report of said Executive Committee before approval for membership becomes final.

### ARTICLE VIII

#### FINANCE:

Section 1. It is suggested that each church comprising this Association send to the Association on a quarterly basis fifty cents (.50) per member to be determined on a total membership basis. However, at the discretion of the churches, inactive members need not be in the per-capita figure, but it is hoped that the churches will elect to include all members, active and inactive, in determining their total fee.

Section 2. Regular funds to the Associational treasury shall be disbursed on a quarterly basis as follows:

A. Retain in the treasury fifty (50) dollars.

B. State Association, fifteen (15) dollars.

C. For printing minutes, one hundred fifty (150) dollars.

D. Moderator's honorarium, five (5) dollars; Clerk's honorarium, twenty-five (25) dollars for three sessions and fifty (50) dollars for the annual session.

E. The remaining funds will be allocated as follows: State Cooperative Program, 70% - Benevolent Fund, 30%.

### ARTICLE IX

# COMMITTEES, BOARD, COUNCIL:

1. Committees may be chosen for any particular function at any session of the Association as the need arises. Unless otherwise specified, the Moderator shall appoint these committees.

Section 2. Standing Committees may be set up by the Association as the need arises and unless otherwise specified, the Moderator shall appoint these committees.

Section 3. The Standing Committees of this Association shall be the Executive Committee and the Investigating Committee. The Executive Committee shall consist of the Moderator, Clerk, Treasurer, and three (3) members to be elected annually by the Association. The Executive Committee shall act for and in behalf of the Martin Association on matters pertaining to its interests which may arise between sessions and which by their nature require immediate action. Such actions shall however, be subject to final approval by this Association at its next regular session and consequently must be reported in full to the Association at its regular meeting.

The Investigating Committee shall consist of three (3) members who shall be elected as follows: one for a three (3) year term; one for a two (2) year term; and one for a one (1) year term. Election thereafter shall be for the three (3) year term. This committee shall act on instruction from the Association in investigating any irregularities among the churches which threaten the harmony and well being of the Association. It shall have no legislative or jurisdictional powers within itself, but must report all its findings to the Association for official action.

Section 4. There shall be an Ordaining Council consisting of three (3) ordained ministers in good standing with Martin Association. They shall be elected as follows: one for a three (3) year term; one for a two (2) year term; and one for a one (1) year term. Election thereafter shall be for the three (3) year term.

The Ordaining Council shall examine candidates for ordination to the Gospel ministry under the procedures adopted by this Association. \* (Guidelines adopted by the State Association.)

#### ARTICLE X

ALTERATIONS OR AMENDMENTS:

This Constitution may be altered or amended by the Martin Association at any of its regular sessions by a two-thirds (2/3) vote of the members present and voting, provided that notice of the proposed alteration or amendment be presented in writing, filed with the Clerk of the Association, and read publicly before the Body at least two (2) times at a previous regular meeting.

# **BY-LAWS**

# MARTIN ASSOCIATION OF FREE WILL BAPTISTS

1. It is recommended that each church close its books on September 1st and mail the quarterly and annual reports to the clerk two weeks before each session of the Association.

2. It is suggested that the Pastoral year begin September first.

3. All business of this Body shall be conducted according to established parliamentary procedures as set forth in Robert's Rules of Order.

4. No member shall absent himself from the house without leave from the Moderator, and no member shall leave the Association without the consent of the Body.

5. The Woman's Auxiliary, and any other Auxiliary of this Association shall give an annual written report at the October meeting.

6. Obituary reports from each church should give name, date of birth, and date of death of deceased members in the annual report to the Association. This information will be given to the Resolutions Committee.

7. It shall be the duty of the Moderator to call the meeting to order and to maintain order and harmony.

8. It shall be the duty of the Assistant Moderator to assume the duties of the Moderator in his/her absence or upon the request of the Moderator.

9. It shall be the duty of the Treasurer to keep accurate financial records in terms of receipts, expenditures, and balance of funds to be reported to the Association quarterly and prepared for yearly publication.

10. The Assistant Treasurer shall perform such duties as are incumbent on the Treasurer in his/her absence or upon the request of the Treasurer.

11. It shall be the duty of the Clerk to keep a minute of the proceedings and to prepare the Minutes for publication, including all items of business, committee reports, and all other matters which effect the program of this Association.

12. The Assistant Clerk shall perform such duties as are incumbent on the Clerk in his/her absence or upon request of the Clerk.

13. These By-Laws may be amended by a two-thirds (2/3) vote at any regular session.
