

#### Prefece

Thank you for the opportunity to have served as your clerk for the past four years. Hopefully my effort has pleased the Lord. I have tried to conduct my effort in a professional way for your Association. I appreciate the recognition you gave me at the fourth Quarterly Meeting. Please pray the Lord's Will be done as I try to help establish the Bible Institutes.




Figure 1. Martin Association Churches' Sunday School enrollment compared for the years of 1999 and 2000.

My prayer is that the effort to gather and report basic statistical data in regard to our Sunday Schools has raised our awareness of a serious problem in our Association. A very large percent (59%) of our Sunday School students are adults. Very small numbers of young students are attending the various grade levels. Please see Figure 1. on page 27 that shows the percent of students per class in the nine Churches that reported data.

What does this tell us about the future of our churches?

The Barna research group has collected data for two years that may shed some light on things we might do to improve our Churches. This information emphasizes that the unchurched are not looking for a different style of sermon, music or if an offering is taken. There are seven things they are looking for. See page 29 to get an idea of what Barna's research indicates.

## MARTIN ASSOCIATION OF FREE WILL BAPTISTS - Minutes First Quarterly Session

January 8, 2000

Martin Association of Free Will Baptists convened at the New Home (M.C) Church at 10:00 a.m. The meeting began with a congregational hymn led by Brother Scott Roberts, followed with prayer by Rev. Andy Merritt. After prayer, Sister Martha Williams extended a welcome to those in attendance. Sister Melinda Pinson responded. Brother Bobby Roberts gave a devotional from Luke 12 entitled, "Bind the Strong Man."

Business Session: After the devotion, the meeting was called to order by Moderator Daniels. Standing delegates were recognized. Elected delegates were asked to stand and were officially seated. Each minister and his wife were recognized. Each deacon and his wife were also recognized. Minutes of the first session of 2000 were read and approved with one correction. Financial report for the first session was also read and approved without changes. Roll call of association churches was made and the number of members attending from each church was recorded.

**Committee Appointments:** Moderator Daniels appointed two committees as follows: Sister Margaret Daniels, Brothers Earl Daniels and Claude Newsome were appointed to serve on the Credentials Committee. Sisters Lillian Gibson, Patsy Merritt and Jean Tully were appointed to serve on the Resolutions Committee. Moderator Daniels also asked the Ordaining Council to meet in regard to receiving Reverend Charles Powell into the Martin Association.

State Board and Woman's Auxiliary Reports: Brother Frazier reported the Board of Christian Education met on November 20, 1999 immediately following the State Meeting. The major topic of discussion was the proposed plan for establishing Bible Institutes across the State. Brother Frazier said a 25-page planning document was distributed at the last meeting for review. He gave an abbreviated review of the plan and asked if the Association agreed with the general concept. Brother Matt Pinson suggested we vote on the issue. There was unanimous approval. Brother Frazier indicated he would make the Board aware of the Martin Association's very

positive response to the possibility of establishing Bible Institutes in the State.

Credentials Committee Report: Brother Boyd related the following statistics: Standing delegates (18); Ministers (8); Ministers' Wives (8); Deacons (13); Deacons' Wives (9); Visitors (0); Churches reporting (11); Churches with delegates (11); Total present (58); Martin Church Membership reported (504), Quarterly fees total (\$377.50); Benevolent Fund totaled (\$557.00); and the General Offering collected at the Quarterly Meeting was (\$115.00). Attendance banners were awarded to the Highway Church for the highest percent present and to the New Home (M.C.) Church for highest number present.

**Recess:** Moderator Daniels called for a 20-minute recess so the Committees could complete their work.

**Completion of Business:** Moderator Daniels called the meeting back to order. Brother Scott Roberts opened this session with a congregational hymn. Moderator Daniels called for the Resolutions Committee Report.

**Resolution Committee Report:** Sister Sauls read the following resolutions for consideration by the body. Be it resolved:

A. We to keep II Chronicles 7:14 as our key verse. "If my people which are called by my name, shall humble themselves, and pray and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and heal their land."

- B. We win the lost at any cost by increasing our outreach to those who do not know the Lord.
- C. We visit the shut-ins and elderly regularly, encouraging them in the Lord.
- D. We support our missionaries through prayer in the year 2000.
- E. We give New Home (M. C.) Church congregation a rising

vote of thanks for their effort in hosting the Quarterly Association.

These resolutions were adopted as a whole, then voted on as separate entities. The body approved all five resolutions. Moderator Daniels asked for a rising vote of thanks to the New Home (M.C.) Church for their hospitality.

**Ordaining Council:** The Ordaining Council recommended that Reverend Charles Powell be accepted into the Martin Association pending a letter of transfer from the Northern Quarterly Cumberland Association of Tennessee.

**State Meeting Delegates:** Moderator Daniels asked for volunteers to represent the Association at the State Meeting in March. Brother Ken Griffin indicated he would serve. Without other volunteers, Moderator Daniels indicated our other two delegates would be appointed as Martin Association members arrive for the State Meeting.

General Information: Moderator Daniels asked Rev. Pinson for an update on the State Meeting. He reported good preaching. There was a spontaneous response to Rev. Pinson's request for financial help with the establishment of the official Free Will Baptist professional journal relating to Christian studies in the amount of \$1160.00. He also indicated the effort to establish term limits for State board officers was defeated. He reminded the assembly that the next State Meeting is March 16-18, 2000, which will establish the new month for the yearly State Meeting.

Reverend Russell indicated the Association has enough in the treasury to award the Free Will Baptist Bible College "Preacher Boys" \$250.00 to help defray their expenses in traveling to Georgia. This suggestion was translated to a motion, which passed unanimously.

**Worship Service:** The business part of the meeting was adjourned and the worship service began. Brother Scott Roberts led a congregational hymn. After special music was presented by the New Home (M.C.) Church and the offering was collected, Reverend Charles Powell delivered the message from God's Holy Word.



The percent of S.S. students per age group collectively is about the same as we experience in our individual churches. Older adults are the majority of our Sunday School attendees. The percent of S.S. students below the adult level ranges from 12% to 2%.

#### What does this tell us about the future of our churches?

Dear God . . . raise up men to lead us to a sense of responsibility to the next generation . . . to help us understand what needs to be done . . . swiftly. Should not this be our prayer?

Three churches, of the 10 that reported, had a gain in Sunday School attendance. These gains were 11%, 12% and 15%. Praise the Lord! S.S. enrollment remained the same in two Churches and the others that reported had small decreases.

What can we do to improve our S.S. attendance? All of churches have adequate facilities - actually what we have is underutilized. We have teachers available to teach; but, we have very few young students.

Traditionally we have depended on biological growth, growth of our families to fill our S.S. classes. Folks, that day is past, as evidenced by our empty S.S. classrooms. Many young adult couples are not attending Church and of course their children are not being sent. We must get a vision of these young adults and their families exiting this life and tumbling into the depths of Hell.

~~

Contrary to the "gimmicks" some Churches use to attract a crowd, Barna's research indicates, "Many of the Churches we studied who are successful at bringing unchurched people into the fold have done little, if anything, to alter the style of services they offer. They have realized that other elements make a bigger difference than the style of music, the nature of the sermon or whether or not an offering is taken."

He goes on to say, "In general they want a place that is caring, casual, creative, child-friendly, control-granting and contextualized." Frankly they want many of the same things that churched people want. They are simply less forgiving in terms of the level of excellence with which these elements are provided."

In addition to praying for God to burden our hearts for the unchurched in our communities, attention to some of the information in Barna's book based on his two years of research, *Re-Churching the Unchurched*, may be of some value. If these data would help us improve some things in our Churches and help us develop an organized outreach program based on better information than we have had in the past would not it be to the advantage in our effort to extend the Kingdom?

We should never compromise our Bible-based standards, but we should be aware of what unchurched folks' expectations are. We may be surprised to learn there are some areas that we have neglected to improve over the years. What has been good enough for us older folks may not measure up to the expectations of excellence to this generation of younger couples.

## CONSTITUTION MARTIN ASSOCIATION OF FREE WILL BAPTISTS

#### **PREAMBLE**

We, the Martin Association of Free Will Baptists of Georgia, do establish and ordain this Constitution for the purpose of advocating, promoting, and increasing our fellowship with one another as fellow members of the Church of Jesus Christ, and for the extension of the Kingdom of God through the preaching of the Gospel of the divine Son of God.

#### ARTICLE I

#### NAME:

This Association shall be called the Martin Association of Free Will Baptists, and shall be composed of such regularly organized and well-disciplined churches as may embody themselves under this constitution.

#### ARTICLE II

#### COMPOSITION AND DELEGATES:

Section 1. This Martin Association shall be composed of its general officers, all ordained and licensed ministers of Gospel, all ordained deacons who are in good standing with the churches of which they are members, duly elected delegates from the local churches comprising the Association, and all Home and Foreign Missionaries who are members in good standing with a church belonging to this Association.

Section 2. Local churches shall be allowed two (2) delegates for the first fifty members or fraction thereof, and one (1) delegate for each additional twenty-five (25) members or fraction thereof.

#### ARTICLE III

#### **MEETINGS:**

The Sessions of this Association shall be held quarterly in January, April, July, and October on Saturday following the first Sunday of these months. The place of meeting to be determined by vote of the Association. It shall be the duty of the member churches to represent by letter and delegates at these meetings and report their condition and statistics on forms provided by the Association. The October session shall be considered the annual session of this Association.

#### ARTICLE IV

#### INDEPENDENCE OF THE LOCAL CHURCHES:

Every church in this Association shall be considered an independent body and shall control its own internal affairs, having unrestricted right to administer its own government without interference from any higher body, being under Christ free and independent.

#### ARTICLE V

#### ASSOCIATIONAL RELATIONSHIP TO THE LOCAL CHURCHES:

The Martin Association shall be considered an advisory board whose function is to meet quarterly at such places as may be determined according to Article III of this Constitution, and not to adjourn formally until all pertinent matters are disposed of. While in session its duty shall be to examine all questions of interest to this Association and to use its best influence to promote Christian, denominational, and benevolent programs and institutions, such as Sunday Schools, Church Training Service, Woman's Auxiliary, Masters Men, Home and Foreign Missions, and child-care institutions. The only punitive power this Association has in relation to the member churches is the right to withdraw fellowship from such churches who are in open violation of the rules and regulations of said Association or who become unsound in the doctrines and practices of the Free Will Baptist Denomination.

#### ARTICLE VI

#### **OFFICERS:**

Section 1. The officers of this Association shall be Moderator, Assistant Moderator, Treasurer, Assistant Treasurer, Clerk and Assistant Clerk, each of whom shall be elected at the close of the October session and assume the duties of their offices the next day following their election.

Section 2. No individual shall be elected to more than one office at a time.

Section 3. The Moderator may not serve more than (3) terms in succession. The Clerk and Treasurer may serve for an indefinite period of time.

#### ARTICLE VII

#### PROCEDURES FOR JOINING THE ASSOCIATION:

A church desiring to become a member of Martin Association shall submit a petitionary letter to the Association at any of its regular quarterly

sessions, stating the date and place of organization, the Pastor's name and address, list of all elected officers, number of members, and timeand place of regular meetings. The church must conform to the doctrines, and practices of the Free Will Baptist Denomination as set forth in the Treatise of Faith and Practice of the National Association of Free Will Baptists.

This Association reserves the right to send its Executive Committee to investigate any applicant for membership in this Association if it deems necessary and to subsequently act on the report of said Executive Committee before approval for membership becomes final.

#### ARTICLE VIII

#### FINANCE:

Section 1. It is suggested that each church comprising this Association send to the Association on a quarterly basis fifty cents (.50) per member to be determined on a total membership basis. However, at the discretion of the churches, inactive members need not be in the per-capita figure, but it is hoped that the churches will elect to include all members, active and inactive, in determining their total fee.

Section 2. Regular funds to the Associational treasury shall be disbursed on a quarterly basis as follows:

- A. Retain in the treasury fifty (50) dollars.
- B. State Association, fifteen (15) dollars.
- C. For printing minutes, one hundred fifty (150) dollars.
- D. Moderator's honorarium, five (5) dollars; Clerk's honorarium, twenty-five (25) dollars for three sessions and fifty (50) dollars for the annual session.
- E. The remaining funds will be allocated as follows: State Cooperative Program, 70% Benevolent Fund, 30%.

#### ARTICLE IX

#### COMMITTEES, BOARD, COUNCIL

Section 1. Committees may be chosen for any particular function at any session of the Association as the need arises. Unless otherwise specified, the Moderator shall appoint these committees.

Section 2. Standing Committees may be set up by the Association as the need arises and unless otherwise specified, the Moderator shall appoint these committees.

Section 3. The Standing Committees of this Association shall be the

Executive Committee and the Investigating Committee. The Executive Committee shall consist of the Moderator, Clerk, Treasurer, and three (3) members to be elected annually by the Association. The Executive Committee shall act for and in behalf of the Martin Association on matters pertaining to its interests which may arise between sessions and which by their nature require immediate action. Such actions shall, however, be subject to final approval by this Association at its next regular session and consequently must be reported in full to the Association at its regular meeting.

The Investigating Committee shall consist of three (3) members who shall be elected as follows: one for a three (3) year term; one for a two (2) year term; and one for a one (1) year term. Election thereafter shall be for the three (3) year term. This committee shall act on instruction from the Association in investigating any irregularities among the churches which threaten the harmony and well being of the Association. It shall have no legislative or jurisdictional powers within itself, but must report all its findings to the Association for official action.

Section 4. There shall be an Ordaining Council consisting of three (3) ordained ministers in good standing with Martin Association. They shall be elected as follows: one for a three (3) year term; one for a two (2) year term; and one for a one (1) year term. Election thereafter shall be for the three (3) year term.

The Ordaining Council shall examine candidates for ordination to the Gospel ministry under the procedures adopted by this Association.\* (Guidelines adopted by the State Association.)

#### ARTICLE X

#### **ALTERATIONS OR AMENDMENTS:**

This Consitution may be altered or amended by the Martin Association at any of its regular sessions by a two-thirds (2/3) vote of the members present and voting, provided that notice of the proposed alteration or amendment be presented in writing, filed with the Clerk of the Association, and read publicly before the Body at least two (2) times at a previous regular meeting.

#### BY-LAWS

#### MARTIN ASSOCIATION OF FREE WILL BAPTISTS

- 1. It is recommended that each church close its books on September 1st and mail the quarterly and annual reports to the clerk two weeks before each session of the Association.
  - 2. It is suggested that the Pastoral year begin September first.
- 3. All business of this Body shall be conducted according to established parliamentary procedures as set forth in Robert's Rules of Order.
- 4. No member shall absent himself from the house without leave from the Moderator, and no member shall leave the Association without the consent of the Body.
- 5. The Woman's Auxiliary, and any other Auxiliary of this Association shall give an annual written report at the October meeting.
- 6. Obituary reports from each church should give name, date of birth, and date of death of deceased members in the annual report to the Association. This information will be given to the Resolutions Committee.
- 7. It shall be the duty of the Moderator to call the meeting to order and to maintain order and harmony.
- 8. It shall be the duty of the Assistant Moderator to assume the duties of the Moderator in his/her absence or upon the request of the Moderator.
- 9. It shall be the duty of the Treasurer to keep accurate financial records in terms of receipts, expenditures, and balance of funds to be reported to the Association quarterly and prepared for yearly publication.
- 10. The Assistant Treasurer shall perform such duties as are incumbent on the Treasurer in his/her absence or upon the request of the Treasurer.
- 11. It shall be the duty of the Clerk to keep a minute of the proceedings and to prepare the Minutes for publication, including all items of business, committee reports, and all other matters which effect the program of this Association.
- 12. The Assistant Clerk shall perform such duties as are incumbent on the Clerk in his/her absence or upon request of the Clerk.
- 13. These By-Laws may be amended by a two-thirds (2/3) vote at any regular session.
