## THE MARYLAND STATE ASSOCIATION BY-LAWS

1. The clerk or his assistant or in their absence the senior minister in years shall call the Association to order if a quorum is present. The Moderator or in his absence the Assistant Moderator shall take charge. If neither is present, a Moderator Pro Tem shall be elected.

2. It shall be the duty of the Secretary to enroll the ordained personnel and delegates to this Association who shall sign the register upon arrival with name, address, and Quarterly Meeting they represent. Visitors will also be registered.

3. It shall be the duty of each Quarterly Meeting belonging to this Association to send a letter to each annual meeting of this Association reporting in the same its statistics and benevolent work. Any Quarterly Meeting belonging to this Association may be dismissed from the Association by a two-thirds vote of all members present.

4. Each session shall be opened by Scripture reading and prayer and shall be closed with prayer.

5. By a two-thirds vote of all members present a ruling of the Moderator can be overruled.

6. The Moderator shall have the same privileges to speak as any other person, provided the Chair is filled.

7. This Association may correspond by letter or otherwise with other religious bodies.

8. This Association shall sit with open doors except when it shall go into a committee of the whole.

9. Any person not a member of this Association may be allowed to take part in discussion by obtaining permission from the Moderator and properly identifying themselves.

10. Anyone desiring to speak shall stand and address the Moderator by the appellation "Brother Moderator" but shall not speak further until recognized by the Moderator.

11. It shall be the duty of each member of the Association to be present at the time appointed for each meeting. Anyone wishing to retire should first obtain permission from the Moderator.

12. The Moderator of this Association must be an ordained minister.

13. The Moderator shall not allow discussion when not carried on in a Christian spirit or when he thinks it will cause discord or division.

14. No person shall be allowed to nominate more than one member of any committee provided the person nominated be elected.

15. It shall be the duty of the Moderator to seat delegates in a body in a designated section at the beginning of each session.

16. Five Members or a majority of the resident members present shall constitute a quorum in conference.

## CONSTITUTION

### PREAMBLE

We the members of the Free Will Baptist denomination, being baptized upon the profession of our faith in Christ and realizing the necessity of a bond of union and fellowship among us as a State Association and to preserve and maintain correspondence and coordination among us, do therefore adopt this Constitution for our better denominational government.

1. This yearly meeting shall be called The Maryland State Association of Free Will Baptist and shall be composed of such regularly organized and well disciplined Free Will Baptist Quarterly Meetings conveniently located as may embody themselves under this Constitution.

2. The business of this Association shall be conducted by the ordained ministers and deacons and elected delegates and clerks who are members of a Quarterly Meeting within this Association. Each Quarterly Meeting is entitled to three delegates from each Church, in addition to the ordained personnel who are standing delegates.

3. The officers of this Association shall be elected for a term of three years, except the Moderator and Assistant Moderator, which shall be elected annually at the close of the meeting of this Association.

4. Any well-organized Free Will Baptist Quarterly Meeting composed of such church as conform to the usages and adopt the doctrines and the Treatise of the Constitution and By-Laws of this Association may at any time, upon application and by majority vote of this Association, become a member thereof.

5. From this time (June 1970) forward, any minister or deacon applying for membership in this Association must first meet the qualifications set forth in I Timothy, Chapter 3 and Titus, Chapter 1. No minister or deacon shall hold membership in this Association if he or his wife have a living companion from a previous marriage.

6. This Association shall have authority to discipline the Quarterly Meetings of which it is composed and exclude them for practices contrary to the Constitution and By-Laws of this Association.

7. The annual meeting of this Association shall convene on Friday morning at 9 o'clock before the fourth Sunday in June and shall have power to adopt any regulations or by-laws not inconsistent with the further regulation of its sessions.

8. This Association shall not recognize any minister or delegate unless they comply with the Constitution and By-Laws thereof.

9. Parliamentary procedure will be governed by "Robert's Rules of Order."

10. The Constitution and By-Laws of this Association may be altered or amended at any regular session by a two-thirds vote of the members present, providing the change has been submitted in writing, and tabled from one previous Annual Session.

## GENERAL BOARD

The General Board of this Association shall meet at 7:00 P. M. on Thursday before the regular Annual Session convenes on Friday morning, and shall consist of the following: Moderator, Clerk, Executive Committee, also two members-at-large from each Quarterly Meeting and the Chairman of all Boards and Committees. It shall be the duty of all members of this Board to be present at the time appointed for each meeting. Proxy representation will be accepted upon presentation of a statement signed by the member. All meetings of this Board shall convene with open doors except when resolved into a committee of the whole. Any person not a member of this Board may be allowed to take part in the discussions by obtaining permission from the Moderator.

## DISSOLUTION

In the event of the dissolution of the Maryland State Association of Free Will Baptist, any assets of the organization then remaining shall be conveyed to such organizations then existent dedicated to similar objectives to those of this organization, selected by the Executive Board at the time of dissolution, which organization must be exempt under Section 501 (E) (3) of the Internal Revenue Code of 1954 as amended or under successor provisions of the Code as may be in effect at the time of dissolution.

MSC to adopt the Resolution Committee report.

1) WHEREAS, there has been an increase in the use of foul and offensive language on television during prime time, be it resolved that we therefore present a resolution from our State to the National expressing our appreciation for the work of Rev. Wildmon and NFD and adding our voice to the outcry in opposition to sex, violence, and vulgarity on network television. Furthermore, we wish to add our voice to the opposition of the advertisement, use, and promotion of liquor whether it be wine, beer, or whiskey on television and its programs. And that copies of this resolution be sent to the three major networks & to speakers of the House of Representatives & the Senate of the United States Government. (Ref. 2) In view of the trend among many professing Christians toward worldly conformity in appearance and apparel

WHEREAS, the scriptures teach that believers are not to be conformed to the world (Rom12:2)and

WHEREAS, Free Will Baptists have encouraged Christian standards among their members in order to maintain their Christian testimony,

THEREFORE be it resolved that the Maryland State Association of Free Will Baptists reaffirm our committment (adopted in 1979) to maintain these standards by requesting that

a) all members groom and attire themselves in such a fashion that would not be offensive or show tendencies to conform with the unholy fashions of the world.

b) men and boys should groom their hair so as to follow the natural hairline without covering the ears or extending over the forehead or collar ( 1 Cor. 11:14).

c) dress for women and girls should be in good taste and should reflect high concern for modesty (1 Tim 2:9) hair styles for women and girls should not be in accord with male fashions (1 Cor 12:25)

THEREFORE be it further resolved that in order to eliminate a "double standard" that all personnel participating in the worship services of this Association including speakers, singers, musicians, etc. strictly adhere to the above-mentioned standards.

3) WHEREAS there are many great challenges to the people of God and that we as Free Will Baptists believe strongly in the autonomy of the local church, be it resolved that our churches strive diligently to unite in harmony each year at the Maryland State Association with greater effort for total involvement. That Pastors lead and encourage their membership to attend & that churches encourage and make possible for their Pastor to attend.

4) We commend the Heritage FWB Church for their fine effort and growth from mission status to self-support in November, 1985. A standing vote be given expressing our love and admiration for this victory to Bro. David Reece and his family and their congregation.

5) Be it resolved that we commend our Maryland Churches for their effort and the victory experienced this year for Roll Call Sunday, March 1985. That we encourage each church, pastor & member to accept the challenge to increase our attendance for Roll Call Sunday, March 1986.

6) Be it resolved that we give Central Virginia Conference and First FWB Church, Bedford a rising vote of appreciation for hosting the 1985 Maryland State Association and for their gracious hospitality.

7) That the Maryland State Association express its appreciation to the corresponding messengers reporting from our denominational departments.

8) That our State Clerk write a letter of appreciation to the caterer for the fineservice received at the Friday Banquet.

9) That we send a letter of appreciation to the Bedford Baptist Church in appreciation for the use of their church facilities for our banquet.
