At this interval, recognition was given a Rev. Nelson Warren, a guest Minister, was extended the right hand of fellowship, and invited to sit in as advisory council, and accepted as honorary guest.

Next item, a partial report was given by Committee on Divine Service, having chosen the Rev. N. P. Gates for the eleven o'clock hour.

A motion was sustained to adjourn the business session, making way for the morning worship hour.

After a brief intermission, a Testimonial service was engaged in, conducted by Rev. George Butler; Prayer by W. M. Nairemore, and a special song by Revs. J. B. and Lincoln Varney. #### FRIDAY AFTERNOON SESSION -- 1:30 P.M.

ULTIMATUM—After due consideration of problems confronting us relative delinquencies among the ordained authority, and after hearing the report of the Credentials Committee, we deem it necessary to take some disciplinary action against such delinquents.

Therefore, we the members of your Presbytery Board submit the following resolution.

Be it resolved that the Credentials Committee be advised to wait upon such delinquents and ascertain their difficulty, and if needs be to help them regain their proper perspective and relationship to this body, and to inform of the action that may be taken against them.

And, be it further resolved, that, if they are not willing to meet the requirements of the Constitution and By-Laws of the Metropolitan Association of Free Will Baptist, that the Credentials Committee be empowered to request the surrender of said credentials. And upon their refusal to do so, that as such "they will be published."

#### RESOLUTION No. 2

That, Whereas many have been sent before the Presbytery Board, liking in qualifications as required in I Tim. 3 and Acts 6, as pertaining to Ministers and Deacons.

Therefore, be it resolved that said candidates be scrutinized by the Church of which he is a member, concerning his Christian Character, and Biblical qualifications, and having maintained faithfulness to the Church in all things, for a period of not less than (1) One Year, before he be presented before the Presbytery Board.

Met at the usual hour, by Singing led by Rev. George Butler, Prayer by Bro. Nathan Small. Followed by the Moderator reading Scripture lesson from Deut. 6:4-16.

First item of business, was the receiving of reports, and discharging the following committees:

DIVINE SERVICE COMMITTEE, Having discharged their services faithfully, was discharged.

OBITUARY COMMITTEE, With praise and honor to our heavenly Father, for having spared the flock, that none were taken. Therefore, the report, none deceased.

EXECUTIVE COMMITTEE, The Presbytery Board assumed these duties (The Committee was discharged). See Resolution.

## METROPOLITAN ASSOCIATION OF FREE WILL BAPTIST

## To

#### MICHIGAN STATE ASSOCIATION OF FREE WILL BAPTIST

HEREAS, We, as many others of like faith, as also all other Protestant Bodies agreeing with the decrees of our form of Government in maintaining the principle of "Separation of Church and State".

And whereas, from all appearances the Democratic Party will nominate Sen. John F. Kennedy, who being a Roman Catholic owes his allegiance to the Church. And would thereby according to the Canon Law of the Roman Catholic Church be obligated, First to the Church; and Secondly to the Presidency of the United States. Hence, the affairs of our Government would be subject to the dictorial powers of the Pope of Rome.

Therefore, be it resolved that the Metropolitan Association of Free Will Baptist go on record as being opposed to the nomination of Mr. Kennedy, or any other candidate of any political party with such ties that would tend to take away the freedoms that we now enjoy under the Constitution of the United States of America.

Also, that this association draft a recommendation to the Michigan State Association of Free Will Baptist, recommending that they, in turn, draft a like proposal to the National Association of Free Will Baptist convening in Fresno, Calif., July 12-14, 1960.

And that such resolution be directed to the Chairman of the Democratic Convention, when convened in the Sate of California some time in July of this year.
