BUSINESS COMMITTEE REPORT:

1. Whereas the Michigan State Association of Free Will Baptists voted last year to invite the 1963 Session of the National Association to the State of Michigan, and

Whereas Mark Lewis, J. B. Varney, N. P. Gates, George Butler and Joe Ange were elected to look into the matter and carry out the details of the invitation,

Be it resolved that this Association go on record today as re-affirming our invitation to the National Association for the 1963 Session and that the committee be retained to carry out the details.

2. Whereas our Association voted last year to recommend that each church raise \$1.00 per member to apply on the Bible College indebtedness, and

Whereas very little progress was made in raising funds,

Be it resolved;

(1) that this State Association sponsor an iterate for the College Personell in the local churches.

(2) that the Bible College be petitioned to conduct this itinecate.

3. Whereas Free Will Baptists are a Bible believing, Evangelical Body interested in getting the whole Gospel to the whole world, and

whereas we have an opportunity to witness to nearly 1,000,000 people at the State Fair to the things we believe in and stand for, and,

whereas a contribution of \$25.00 will provide a 3x4 feet pictoral display and opportunity for a tract distribution to acquaint the people with Free Will Baptists,

Therefore be it resolved;

(1) That this Association procure this space for a pictoral display from the State Evangelical Committee.

(2) That we recommend that our churches likewise support the work of the Greater Detroit State Fair Evangelical Committee.

4. Whereas the Philadelphia Church and its pastor, Mark Lewis, have been very generous and hospitable in entertaining this Association,

Be it resolved that we extend to them a rising vote of thanks for their every act of kindness in entertaining this session.
