ORDAINING COUNCIL BY-LAWS

- I. Be it resolved that the Ordaining Council of the Midway Association receive each request for the purpose of ordaining of ministers and deacons and that it be impartial and unbiased.
- II. Be it further resolved that a licensed minister of the Midway Association have a waiting period of one year before being ordained and endowed with the full privileges and rights of regular ordained ministers.
- III. Be it further resolved that licensed ministers coming from sister associations bring a letter of recommendation from their association, and that they have a waiting period of one year before being ordained by the Ordaining Council of the Midway Association.
- IV. Be it further resolved that each candidate be questioned as to his beliefs of the fundamentals of doctrine of Free Will Baptists, including doctrine, faith and practices.
- V. Be it further resolved that any candidate disagreeing with the doctrines and practices set forth in the treaties of the National Association of the Original Free Will Baptists be denied membership in our Association.

VI. Be it further resolved that any ordained minister coming from any sister association desiring membership into the Midway Association, bear a letter of recommendation from his association before being received into the fellowship of the Midway Association.

VII. Be it further resolved that each brother minister be given a letter of recommendation by the Association, providing he is in good standing and in full fellowship with the Association.

VIII. Be it further resolved that those who come and petition the Midway Association for membership, be required to satisfy the Ordaining Council as to their faith and practices, before being received.

IX. Be it further resolved that churches making application for constitutes to be ordained, do so three months in advance, so as to give the Ordaining Council time to question the candidate on doctrinal soundness and character.

X. Be it further resolved that each church affiliated with the Midway Association take into consideration the By-Laws that regulate the Ordaining Council and be governed by these rules.

XI. Be it further resolved that these By-Laws governing the activities of the Ordaining Council be ratified by the Midway Association in any one regular session.

XII. Be it further resolved that these By-Laws be amended only by a two-thirds majority vote of the Midway Association.

MIDWAY ASSOCIATION RULES (BY-LAWS)

FOR STANDING BOARDS AND COMMITTEES

Executive Board —

1. This Board shall be composed of seven lay members elected for two year terms along with the other associational officers. Members should be devout Christians, who are alert, active in their local churches, loyal to Christ and His Church, and who are willing to accept the responsibility of this office.

2. This Board shall have a general oversight of our associational work, promoting the Cause of Christ in our association at all times, acting for the association between sessions when necessary, laboring in love to keep our ministry clean and above reproach, striving always for peace and harmony within the association, and assisting any church in any matter when requested to do so by the church. It shall be the responsibility of the Executive Board to make written reports of ALL its work to the association, and it shall be responsible to the association for all its actions.

3. This Board shall elect a chairman and a secretary from its membership promptly after their election.

It shall be the duty of the chairman to call meetings when needed, to preside over the meetings, and to assume all responsibilities relative to the duties of a chairman.

It shall be the duty of the secretary to keep accurate minutes of each meeting, to send copies of these minutes to both the clerk and moderator of the Association as well as to each member of the Executive Board promptly after each meeting, to prepare the Board's report to the Association, and to call meetings of the Board when the chairman fails to do so or is unable to do so.

Ordaining Council –

The Ordaining Council shall be composed of five ministers who are members of our Association in good standing. Council members shall be elected for two year terms along with the other officers of the Association. Duties of the Ordaining Council shall be:

1. To examine applicants for ordination to the ministry relative to their doctrines and walk.
2. To ordain applicants to the ministry who have been recommended and approved by their church and the Ordaining Council.
3. To examine all previously ordained ministers seeking membership in our Association in regards to their doctrines and walk and to recommend those qualified for membership to the Association.
4. To uphold, sustain, and lead the ministry of our Association as befitting disciples of Christ.
5. To ordain or to assist in the ordination of deacons when requested by the deacon-elect's church to do so.

(Recommendation: Deacons should be ordained at their own church in the presence of their local membership whenever possible.)

Credentials Committee –

The Credentials Committee shall be composed of three members, the clerk of the Association who shall serve as its chairman and two other members elected on even years with the other associational officers.

This committee shall receive and examine corresponding letters from all churches, compiling the statistics and reporting same to the Association. A roll call of the delegates shall be made at the beginning of each session of the Association in order that the delegates may be properly seated.

Reports from churches should be mailed to the clerk of the Association by the clerk of each church 15 days ahead of each session. (January, April, July, and Annual.)

Budget and Finance Committee –

This committee shall be composed of five members, the treasurer of the Association, who shall serve as its chairman,

and four others elected by the body every two years on even years along with the other associational officers. Duties of this committee shall be:

1. To receive all associational monies.
2. To receive pleas for help and suggestions for disbursements of money.
3. To revise and prepare recommendations for associational funds from churches whenever deemed necessary by the Association.
4. To present recommendations for disbursements of monies to the Association.
5. To keep a general oversight of the financial work of the Association and to keep the Association informed at all times along this line.

Resolutions Committee –

The Resolutions Committee, composed of three members who shall be elected by the Body for a two year term on even years along with the other officers of the Association, shall receive and present worthwhile resolutions to the Association.

Superannuation By-Laws –

1. That *retired* ministers who have served the Midway Association for a period of at least five years, *are members of our Association and are in good standing with our Association*, be given a quarterly supplement of money (the amount depending upon the financial status of the Association at the time) when they shall have attained the age of 65 provided the income of said ministers is *inadequate for their needs*.
2. That any *qualified* minister of this Association who, by accident or sickness, has been rendered *permanently unable* to continue as a minister of the Gospel, *upon recommendation of his home church and approval of the Association*, be given this same supplement.
3. That at the minister's death, this *same* quarterly supplement be continued to his widow as long as she shall live or remain a widow *provided she meets the same qualifications as set forth for the ministers*.
4. We further state that the recommendations set forth herein do not prevent the Association from taking "love offerings" or

making a "love gift" to any minister or any layman at any time the Association so desires.

WORKING RULES FOR THE HOME MISSION BOARD OF THE MIDWAY ASSOCIATION

PREAMBLE:

The Mission of Christ Jesus into the world was to complete the plan of salvation, to call sinners to repentance, to set up the work and the workers in establishing the Church; then He set in motion the missionary program for the church of all time. Matthew 28: 19-20 simply means to teach all the gospel to all people.

1. The name of this board shall be *The Home Mission Board of the Midway Association*.
2. The Board shall be composed of the following: The Moderator, Assistant Moderator, Clerk, Treasurer, President of the Woman's Midway District Auxiliary Convention, the Chairman of the Executive Board, and the State Mission Board member from the Midway Association.
3. The duties of this Board shall be:
 - (1) To formulate and promote a live missionary program.
 - (2) To aid weak churches.
 - (3) To establish new churches.
 - (4) To strive to keep the revival fires burning high (at all cost) in the bounds of the Midway Association.
4. It shall be the duty of this Board to supervise any and all the home mission programs of the Association.
5. This Board shall ask or require any church that receives much money from the mission treasury to give the Board joint ownership in the property; not for the Board to interfere in the internal affairs of the church, but merely to secure the investment of the mission money.
6. This Board shall be vested with the power of trusteeship; to hold and convey titles to any property coming under the jurisdiction of the Home Mission Board through the Midway Association or as dealing with any or all of the property requiring trusteeship of the Midway Association.

STANDING RULES OF THE MIDWAY ASSOCIATION OF FREE WILL BAPTIST

1. Each church close its books on the 30th day of September and mail its annual report to the associational clerk 15 days before every session.
2. The pastoral year begins September 1st each year.
3. Each Church prepare the program for the day the Association meets at their church, and be responsible for the preacher and speakers, and let the moderator or clerk know 30 days in advance to the date of the meeting.
4. That 40% of all offerings goes for Home Missions.
5. Each Minister who is a member of the Midway Association be required to attend at least one session yearly unless providentially hindered. When he is unable to attend, he must report to the clerk by letter. Failure to attend at least one session annually will result in that minister's name being removed from the active list of Ordained Ministers.
6. Each convention or rally give an annual report at the Annual Association. (Woman's Auxiliary, Master's Men, C T S, Sunday School).
7. That the name, date of birth, date of death, age and church affiliation of any member overtaken by death every year be included in that years minutes, such information to be given to the Obituary Committee by the clerks of all our churches.
8. That at the death of one of our ministers a page in our following years minutes be draped in black to his memory, giving his birth, age, death, church affiliation, when ordained, and pastoral record as much as possible.
9. The deacons be standing delegates to the Midway Association.
10. That the Moderator, Vice-Moderator, Clerk, Assistant Clerk, Treasurer, Executive Board, Credentials Committee, Budget and Finance Committee, Resolutions Committee and the Ordaining Council be elected by the body for a two year term to be re-elected or replaced on even years.
11. The rules (or By-Laws) governing the Standing Boards and committees be printed in the minutes every year.

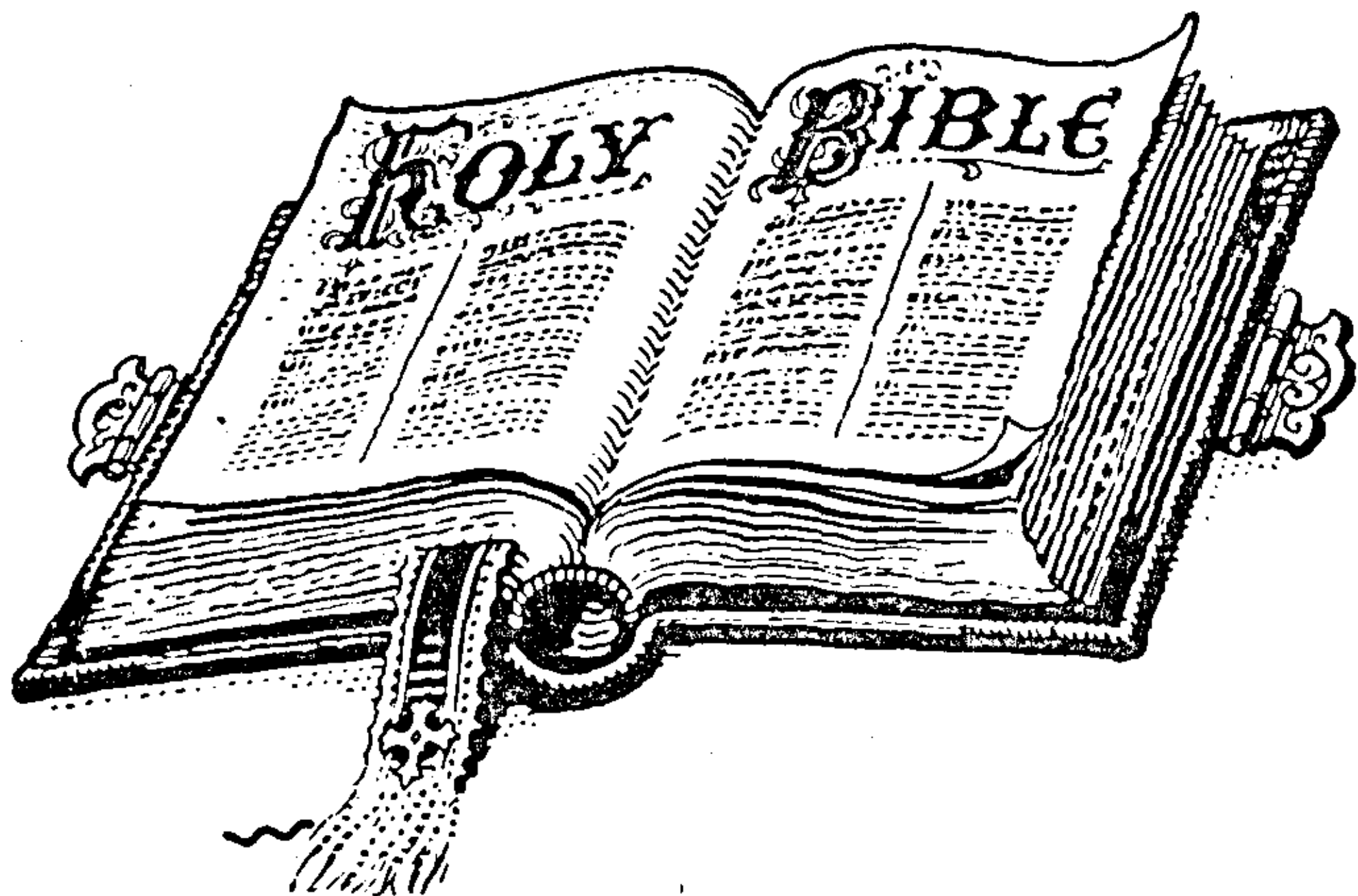

"IN MEMORIAM"

The Lord gave, and the Lord hath taken away; blessed be the name of the Lord. Job 1: 21.

On July 10, 1967, death claimed one of our most beloved, capable preachers. Louis H. Moulton, 53, died in a Norfolk, Virginia, hospital of a heart attack after a brief illness.

A native of Norfolk, he accepted Christ while working with the Virginia Transit Company driving street cars and buses, later as dispatcher with the responsibility of assigning 300 men to their runs and each day he witnessed to all, from the greatest to the least and was highly respected by his employers because of the stand he took for Christ. At this time, he also served as Sunday School Superintendent for the Tabernacle Church and did a lot of supply work speaking in Baptist, Methodist, and Free Will Baptist Churches when asked by the pastor. As a Gideon member, he also filled many speaking engagements for them.

He received a Bachelor of Theology and graduate of Theology Degree at Pioneer Theological Seminary in Rockford, Illinois, and at the time of his call to full time service for the Lord in 1949, he was Director of Youth for Christ in Norfolk.

His first pastoral was in 1949, in Glennville, Georgia, at Glennville and Ebenezer F.W.B. Churches. One year he served Satilla F.W.B. Church, serving all three as half-time pastor doing this by Glennville and Ebenezer Churches exchanging hours of church and Sunday School. Leaving Glennville in 1952, he went to Richmond, Virginia, pastored there one year and came to Savannah, Ga., in 1953. He and Rev. Damon C. Dodd founded the First Free Will Baptist Church there and after Rev. Dodd left, he organized the church and was called as its first pastor, serving until 1959, at which time he went to Nashville, Tenn., and was Assistant Director with the Foreign Mission Department.

He suffered his first heart attack in 1960. After regaining his strength, he went back to Savannah and organized the Bethany F.W.B. Church and served as its pastor until the later part of 1965. While in Georgia, at this time, he served as president of the local chapter of "Protestants and other Americans for separation of church and state". He served as assistant moderator for the State Association of Free Will Baptist for the year 1964, and was moderator in 1965, when he resigned the Bethany Church to go to Norfolk, Virginia, as pastor of the Princess Anne F.W.B. Church. The Bethany Church dissolved when he left. In the 18 months he had been at the Princess Anne Church a wonderful spiritual and material growth had been experienced. Church attendance had increased from six to the upper fifties and Sunday School in the upper forties and giving from \$20. per week to \$120.00

In addition to his work at Princess Anne Church, God had opened another door to wonderful opportunities with the Christian Broadcasting Network. Nothing but christian programs go out from WXRI radio and WYAH television all day long. Brother Moulton had his own program from 6:00 to 9:00 A. M. to use as he felt led. Staying on then as announcer until 12:00 o'clock each day.

Only eternity will reveal the souls that were reached through this ministry. Since his passing, Mildred, his beloved wife has received many letters telling what a blessing his message had been and how much they have missed him.

Rev. Pat Robertson, owner of the station, conducted services for him using Is. 57: 1&2 - "No one who had ever worked at Christian Broadcasting had endeared themselves to us all as had Louis. He loved the Lord so much and hated sin, I believe God took him to spare him the evil that is coming upon the earth", said Rev. Robertson concerning him.

A deep desire to see his Lord was expressed to some even on his last day at work. As with the Apostle Paul - "To be absent from the body is to be present with the Lord", was a desirable experience for this faithful servant.

Christian Broadcasting Network is in a building program, both the radio and television. The new radio control wing is to be named the "Louis H. Moulton Memorial Building". This is a great honor, not only to his family but to all Free Will Baptist and is a wonderful opportunity for all to share in this work of helping to spread the gospel. Besides a great host of friends left to grieve his passing are his faithful and beloved wife, Mildred, and a son, Louis H. Moulton, Jr. and four grandsons.

The gray overcast sky and the tense atmosphere just before a storm is most depressing. As the winds blow and the rain lashes the world looks dark and hopeless. But as one continues to look upward above the stormy clouds painted in vivid colors of the spectrum appears a rainbow - the promise of God's faithfulness. A storm and a sun are required to make a rainbow - as the dark stormy clouds of sorrow surround us with the passing of a loved one, if we look upward the sunshine of God's great love will break through, and in tenderness He will speak to the dark recesses of the soul. "I will never leave you nor forsake you". Knowing Him as our Savior with joy we can look forward with hope and confidence to that glorious promise of reunion with our loved ones by and by.
