FIRST QUARTERLY SESSION

The first Quarterly Session of the Midway Association of Free Will Baptist met with Patmos Church in Baker County, Georgia on January 26, 1968. The session was opened with singing led by Mr. Jessie Griffin and prayer by Rev. H. L. Knighton. Rev. W. F. McDuffie gave the devotional using II Kings 4:26 as his text.

Rev. C. R. Houston, Moderator, called the Session to order. Report of the Credentials Committee was given. M.S.C. to adopt the report and seat the delegates. Eight ministers were present for the roll call: Rev. C. R. Houston, Rev. Lewis Williams, Rev. T. B. Calloway, Rev. S. T. Shutes, Rev. H. L. Knighton, Rev. Milton Fields, Rev. Paul Irvin and Rev. Charles Hollingshead.

The Moderator recognized as visitors Rev. W. F. McDuffie, pastor of Oak Grove Church, and Rev. Mance Cason. Rev. Milton Fields was appointed to serve on the Resolutions Committee as proxy for Rev. Coy Watson.

The Mission Board reports were read. M.S.C. that these reports be tabled until the afternoon Session. (see reports)

The business Session was recessed until the afternoon. The congregation was led in singing and Bro. G. C. King offered a prayer. A group of ministers sang "At Calvary". A worshipful offering was received with prayer by Rev. Charles Hollingshead. Rev. Paul Irvin brought the message using text from Luke 19:13 with his subject being the words of Jesus, "Occupy till I come". The noon meal was served by the host church.

The afternoon Session was opened with singing and prayer by Mrs. Nancy Johnson. The devotional was by Rev. T. B. Calloway using the subject, "Jesus Calls Us" from John 21:19-25.

The Resolutions Committee report was read by Rev. Fields. M.S.C. to receive the report and the items be taken up one at a time. All items 1-11 were adopted. (see reports)

Motion made to take from the table the Mission Board reports, which were read again at this time. M.S.C. to adopt the September 22, 1967 report. (see reports) M.S.C. to adopt the December 4, 1967 report. (see reports).

M.S.C. to receive the January 9, 1968 Mission Board report and take up the items one at a time. M.S.C. that item No. 1 be adopted. (paragraph 5 of Mission Board report, Jan. 9, '68) Item No. 2 was amended (paragraph 6 of Jan. 9, '68 Mission Board report). The amendment was that the Moderator appoint a committee of three to meet with Immanuel Church members to secure legal title of the church property. M.S.C. to adopt the amendment. M.S.C. to adopt item No. 2 with the amendment. The Moderator appointed Bro. O. B. Everson, Bro. Alvin Day and Bro. Martin Murkerson as the committee.

Rev. Mance Cason, State Promotional Secretary, gave a report of the State Office work and the work over the state. M.S.C. to receive his report as information.

M.S.C. to adopt the Finance Committee report as read. (see reports).

M.S.C. to adjourn and Rev. Mance Cason dismissed with prayer.

MISSION BOARD REPORT – January 9, 1968:

The Midway Mission Board met Tuesday night, January 9, 1968, at Macedonia Church and members present were Rev. C. R. Houston, Rev. S. T. Shutes, Rev. J. W. Loyless, Mr. B. Houston, J.W. Clower, Earl Tabb, Mrs. Ida Tabb and a visitor, Mrs. Grace Houston.

The meeting was opened with the responsive reading of the Free Will Baptist Church covenant. Prayer was led by Mr. B. Houston. Rev. C. R. Houston called the meeting to order for the transaction of business.

Mr. B. Houston gave a report of the committee appointed to go to Immanuel Church to inspect the property. The locks on the doors were changed, the water and gas were cut off but the elec-

tricity was left on because the building would need lights for anyone to see in the building. The books and papers of the Church are in a vault in the bank. Rev. C. R. Houston has an appointment with Bro. Lamar Jordon to see the papers on January 10, 1968.

Bro. J. W. Clower read a letter from the Bonding Company in reply to the letter he wrote about delaying the bond payments. The Bonding Company is asking for \$544.50 to pay the payments through July 1, 1968. They also stated that Immanuel Church has the list of bond holders.

Motion made whereas the Bonding Company states a payment of \$544.50 will pay up to July 1, 1968 and the Mission Treasury has only \$196.66 that we recommend that the Midway Association pay the balance of \$347.84. All members voted for this motion.

Motion made that the Mission Board recommend to the Midway Association that we are agreed to sell the Immanuel Church property and ask the Association to approve our recommendation. All members voted for this motion.

M.S.C. to adjourn and we were dismissed with prayer by Mrs. Grace Houston.

September 22, 1967:

The Midway Mission Board met at Travelers Rest Church on September 22, 1967. The meeting opened with singing led by Rev. S. T. Shutes and Mr. B. Houston offered prayer.

Rev. C. R. Houston, Moderator, called the meeting to order. Mission Board members present were Rev. C. R. Houston, Rev. S. T. Shutes, Mr. B. Houston, J. W. Clower, Earl Tabb and Mrs. Eleanor Sheffield. Also present were members of Immanuel Church and visitors.

A report of Immanuel Church was given by Bro. Herman Irvin. In his report, he stated that Immanuel Church could not make it on their own any longer and the Church was surrendering to the Mission Board and it was now in their hands.

Rev. Houston reported to the Mission Board that Rev. Hubert Henderson had contacted him and that he could work half-time at Immanuel Church if agreements were worked out with the State Mission Board.

M.S.C. that the Mission Board Treasurer pay the bond payments which are behind on Immanuel Church.

M.S.C. to adjourn.

December 4, 1967:

The Midway Mission Board met at Arlington Church on December 4, 1967. The meeting was opened with singing led by Rev. C. R. Houston. Rev. J. W. Loyless led in prayer. Mission Board members present were Rev. C. R. Houston, Rev. S. T. Shutes, Rev. J. W. Loyless, Mr. B. Houston, J. W. Clower, Earl Tabb, Mrs. Ida Tabb and three visitors.

The purpose of the meeting was a report Rev. Houston had received from Bro. Herman Irvin about Immanuel Church. Bro. Irvin had called Bro. Houston and told him all the Immanuel members had left the church and gone somewhere else and that he was the only deacon left along with some children. Rev. Irvin told Rev. Houston, as Moderator of the Midway Association, that the church was in the hands of the Association since nobody was there to have church. No services had been held for the last 3 weeks, The lights, telephone, gas and water are still connected and bills will have to be paid. There are 6 keys among members that will unlock the doors.

A general discussion of the situation concerning the Immanuel Church was held. A motion was made by Rev. S. T. Shutes that the Moderator, Rev. Houston, Bro. J. W. Clower and Mr. B. Houston make a trip to inspect the Immanuel Church building, change the door locks and cut off the water, gas, lights and telephone and contact the necessary people about the indebtedness of the church and secure any other information they need so they will be able to give a report to the Midway Association at the January meeting pertaining to the disposition of the Immanuel Church property. Motion was seconded by Rev. J. W. Loyless and all the Mission Board members voted for the motion.

M.S.C. that the Treasurer, Bro. J. W. Clower, write the Bonding Company telling them there will be a delay in the payments to be made by the Midway Association and ask the company to send a list of persons who bought bonds with the Immanuel Church and the Bonding Company.

Minutes of the September Mission Board were read and corrected. M.S.C. to adopt the minutes as corrected. Motion was made to read the minutes of this meeting before the meeting adjourns. These minutes were read and adopted. Bro. Leron Clower dismissed with prayer.

RESOLUTIONS COMMITTEE REPORT -

We, your Resolutions Committee, wish to submit the following recommendations:

- 1. That the DAY for our Associational Meeting be changed to SATURDAYS before the fourth Sunday in the SAME MONTHS that we presently meet and that this recommendation be tabled until the Annual Session at which time action be taken on this resolution.
- 2. That ALL OFFICERS and BOARDS of the Midway Association be elected for two year terms and that NO ELECTED official of the Association may serve for more than two consecutive terms in the same office.
- 3. That no person may serve in more than one elected office in the Midway Association at the time.
- 4. That our Association cooperate with the State Mission Board in promoting TARGET CITY ATLANTA and that each church in our Association be encouraged to give an offering toward this project during the month of March.
- 5. That Number 2 of the Standing Rules for the Home Mission Board of the Midway Association be amended as follows:
- "The Board shall be composed of five members elected for two year terms along with the other associational officers. The State Mission Board Member from the Midway Association may serve as an ex-officio member of this Board in an advisory capacity only."
- 6. That a Number 7 be added to the Standing Rules for the Midway Association Mission Board to read as follows:
- "This Board shall elect a chairman and a secretary from its membership promptly after their election. It shall be the duty of the chairman to preside over the meetings, and to assume all responsibilities relative to the duties of a chairman. It shall be the duty of the secretary to keep accurate minutes of each meeting; to send copies of these minutes to both the clerk and the moderator of the Association as well as to each member of the Mission Board promptly after each meeting; to prepare the Boards report to the Association; and to call meetings of the Board when the chairman fails to do so."
- 7. That the number of members on the Ordaining Council be changed from five to three. (not adopted at the July session).
- 8. That we offer the following recommendation to the Midway District Sunday School Convention and the Midway District CTS Rally:

That we merge the SS Convention and CTS Rally into one.

- 9. That upon their approval of this recommendation, the Midway Association would elect a Board of Christian Education to work out plans to present to the Association concerning this merger.
- 10. That Mrs. Thelma Bell, the widow of the late Rev. Ralph Bell, be placed on the Superannuation Roll of the Midway Association, so long as she maintains Christian character and remains a widow.
- 11. That we give Patmos Church a rising vote of thanks for their hospitality to us today.

The moderator declared Resolutions 2, 3, 5, 6, and 7 presented in the January Session to be out of order. MSC that Resolutions 2, 3, 5, 6, and 7, as stated in the January Session, be received and tabled until the July Session.

Motion made by Rev. Charles Hollingshead that the profit from the sale of Immanuel property be earmarked for a church in East Albany in the future. Motion seconded and carried.

Motion by O. B. Everson that the Mission Board not have joint ownership with any church or mission if money is loaned but that a note be taken on the property and that this motion be tabled until the July Session. Motion seconded and carried.

MSC to adopt the Finance Committee report. (see report)

REPORT OF COMMITTEE ON IMMANUEL CHURCH - April 26, 1968; O. B. Everson's remarks:

Brothers and sisters in Christ, I bring this report to the Association with a broken heart. The work assigned to this committee has been most difficult for all concerned. Only Eternity can re-

veal the real consequences of our action on this most serious matter.

As we discussed this grave situation with the people of Immanuel Church, all our hearts ached because we know that this church should have been a successful, thriving church, and we know it would have been with the proper leadership and encouragement. With sacrifice and dedication, great good for the Cause of Christ could have been accomplished there.

But, under the present circumstances, we believe it is impossible to go on. We, as a committee, hope and pray that proper foresight and guidance will be used to prevent such an occurrence in our Association ever again. May God help us to take the necessary precautionary measures to forestall another tragedy like this one.

We, your committee appointed by the Moderator of the Midway Association to work with the Immanuel FWB Church on its financial problem, wish to submit the following report:

We contacted Bro. Howard Davis on January 26 to request a meeting with the deacons of Immanuel Church to discuss the situation and see what they would like to do. He expressed appreciation for the contact and set up a meeting for Monday night, February 5th.

All three deacons of Immanuel Church and the three committee members were present for this meeting. We discussed possibilities of continuing services at Immanuel Church. The deacons' opinion was that although they needed the church in East Albany, they knew they could not keep going with the few they had in the church to take care of finances. After much discussion of the possibility of the Midway Association subsidizing the church so it could continue to function, all present agreed that the Association could not, at this time, assume this financial responsibility. The deacons of the church then determined that the only solution would be to sell the property or turn it over to the Midway Association. So they decided to call a meeting of the entire church for Monday night, February 12th, at the First Albany Free Will Baptist Church, in order that the Church might make its own decision as to the proper steps to take.

The members of your associational committee were present when Immanuel Church met in conference on February 12th. After much discussion and many tears, the church took the following action: It was moved, seconded and carried that the Immanuel FWB Church cease to be; that all members be granted letters; that the personal items in the church be returned to their owners; that the piano, desk and many other useful items belonging to the church be donated to Camp Mt. Bethel; and that the money in the church treasury be given to the Midway Association. A motion was made by Bro. Howard Davis and seconded by Bro. Floyd S. Morey to deed the church property itself to the Midway Association. The motion was carried.

At this time, your committee would like to present the legally executed deeds for this property to this body.

MISSION BOARD REPORT – July 26, 1968:

On April 29, 1968, the Midway Association Board went to Rev. Paul Davis, pastor of Grace Baptist Church, Albany, Georgia, to discuss selling the Immanuel Church property. Agreement was made that they pay a \$2,000.00 retainer with the balance in 6 months. They were to be given the keys to the church when the retainer was paid. The Mission Board did not receive any word from the church nor the pastor. However they had moved into the church when the Mission Board went to see them on May 8th.

On June 15, 1968, Mr. B. Houston, Chairman of the Executive Committee, called a joint meeting of the Executive Board and the Mission Board. A discussion concerning the Grace Baptist Church and pastor's possessing the church building for the past 2 months and having made no arrangements nor signed any papers to the Mission Board and Association in the way of making payment for the property. The Mission Board treasury had paid the light bills since they have been using the church.

Earl Tabb made a motion that the Mission Board go Monday, June 17, to secure a lawyer and have papers drawn up for Grace Baptist Church to sign giving us a \$2,000.00 retainer. Then if they do not get a clear title to the property that we will refund the \$2,000.00 less \$65.00 a week for the time they have been in the church building. If they do not pay the retainer in 12 hours after we present the paper that we secure a dispossession warrant. Motion was seconded by Bill Lofton and carried unanimously by all persons present.

On June 17, 1968, the Mission Board went to Lawyer Eugene C. Black who was checking the records on the property for the

Grace Baptist Church pastor. An option agreement was drawn up in accordance with the motion made at the joint board meeting. A meeting was called for 8:00 at Grace Baptist Church. The Mission Board met with 4 deacons of the church. They did not know about the agreement their pastor, Paul Davis, had made with the Mission Board. They told us Paul Davis had resigned as their pastor and asked for time to meet in church conference to discuss the matter.

On June 24, 1968, the Mission Board met with the members of Grace Baptist Church by their invitation. The church had decided they would not be able to buy the church property but asked about renting the church for \$25.00 a week. The Mission Board considered and decided not to rent.

MSC that the Mission Board proceed to sell the church property and check the insurance on the property; if no insurance, to buy some insurance.

MSC that J. W. Clower and Rev. C. R. Houston advertise the property for sale and buy the insurance.

MSC that Rev. C. R. Houston and Rev. S. T. Shutes secure a loan of \$2,000.00 for the Mission Board to make the bond payment due on July 1, 1968.

MSC to adjourn.

MIDWAY ASSOCIATION RULES (BY-LAWS) FOR STANDING BOARDS AND COMMITTEES

Executive Board -

1. This Board shall be composed of seven lay members elected for two year terms along with the other associational officers. Members should be devout Christians, who are alert, active in their local churches, loyal to Christ and His Church, and who are willing to accept the responsibility of this office.

- 2. This Board shall have a general oversight of our associational work, promoting the Cause of Christ in our association at all times, acting for the association between sessions when necessary, laboring in love to keep our ministry clean and above reproach, striving always for peace and harmony within the association, and assisting any church in any matter when requested to do so by the church. It shall be the responsibility of the Executive Board to make written reports of ALL its work to the association, and it shall be responsible to the association for all its actions.
- 3. This Board shall elect a chairman and a secretary from its membership promptly after their election.

It shall be the duty of the chairman to call meetings when needed, to preside over the meetings, and to assume all responsibilities relative to the duties of a chairman.

It shall be the duty of the secretary to keep accurate minutes of each meeting, to send copies of these minutes to both the clerk and moderator of the Association as well as to each member of the Executive Board promptly after each meeting, to prepare the Board's report to the Association, and to call meetings of the Board when the chairman fails to do so or is unable to do so.

Ordaining Council -

The Ordaining Council shall be composed of five ministers who are members of our Association in good standing. Council members shall be elected for two year terms along with the other officers of the Association. Duties of the Ordaining Council shall be:

- 1. To examine applicants for ordination to the ministry relative to their doctrines and walk.
- 2. To ordain applicants to the ministry who have been recommended and approved by their church and the Ordaining Council.
- 3. To examine all previously ordained ministers seeking membership in our Association in regards to their doctrines and walk and to recommend those qualified for membership to the Association.
- 4. To uphold, sustain, and lead the ministry of our Association as befitting disciples of Christ.
- 5. To ordain or to assist in the ordination of deacons when requested by the deacon-elect's church to do so.

(Recommendation: Deacons should be ordained at their own church in the presence of their local membership whenever possible.)

Credentials Committee -

The Credentials Committee shall be composed of three members, the clerk of the Association who shall serve as its chairman and two other members elected on even years with the other associational officers.

This committee shall receive and examine corresponding letters from all churches, compiling the statistics and reporting same to the Association. A roll call of the delegates shall be made at the beginning of each session of the Association in order that the delegates may be properly seated.

Reports from churches should be mailed to the clerk of the Association by the clerk of each church 15 days ahead of each session. (January, April, July, and Annual.)

Budget and Finance Committee -

This committee shall be composed of five members, the treasurer of the Association, who shall serve as its chairman, and four others elected by the body every two years on even years along with the other associational officers. Duties of this committee shall be:

- 1. To receive all associational monies.
- 2. To receive pleas for help and suggestions for disbursements of money.
- 3. To revise and prepare recommendations for associational funds from churches whenever deemed necessary by the Association.
- 4. To present recommendations for disbursements of monies to the Association.
- 5. To keep a general oversight of the financial work of the Association and to keep the Association informed at all times along this line.

Resolutions Committee -

The Resolutions Committee, composed of three members who shall be elected by the Body for a two year term on even years along with the other officers of the Association, shall receive and present worthwhile resolutions to the Association.

Superannuation By-Laws -

- 1. That retired ministers who have served the Midway Association for a period of at least five years, are members of our Association and are in good standing with our Association, be given a quarterly supplement of money (the amount depending upon the financial status of the Association at the time) when they shall have attained the age of 65 provided the income of said ministers is inadequate for their needs.
- 2. That any qualified minister of this Association who, by accident or sickness, has been rendered permanently unable to continue as a minister of the Gospel, upon recommendation of bis bome church and approval of the Association, be given this same supplement.
- 3. That at the minister's death, this same quarterly supplement be continued to his widow as long as she shall live or remain a widow provided she meets the same qualifications as set forth for the ministers.
- 4. We further state that the recommendations set forth herein do not prevent the Association from taking "love offerings" or making a "love gift" to any minister or any layman at any time the Association so desires.

WORKING RULES FOR THE HOME MISSION BOARD OF THE MIDWAY ASSOCIATION

PREAMBLE:

The mission of Christ Jesus into the world was to complete the plan of salvation, to call sinners to repentence, to set up the work and the workers in establishing the Church; then He set in motion the missionary program for the church of all time. Matthew 28: 19-20 simply means to teach all the gospel to all people.

- 1. The name of this Board shall be The Home Mission Board of the Midway Association.
- 2. The Board shall be composed of five members elected for two year terms along with the other associational officers. The State Mission Board member from the Midway Association may serve as an ex-officio member of this Board in an advisory capacity only.
- 3. The duties of this Board shall be:

- (1) To formulate and promote a live missionary program.
- (2) To aid weak churches.
- (3) To establish new churches.
- (4) To strive to keep the revival fires burning high (at all cost) in the bounds of the Midway Association.
- 4. It shall be the duty of this Board to supervise any and all the home mission programs of this Association.
- 5. The Board shall not hold joint ownership of churches but rather take a note on the property as security.
- 6. This Board shall be vested with the power of Trusteeship; to hold and convey titles to any property coming under the jurisdiction of the Home Mission Board through the Midway Association or as dealing with any or all of the property requiring trusteeship of the Midway Association.
- 7. This Board shall elect a Chairman and a Secretary from its membership promptly after their election.

It shall be the duty of the Chairman to preside over the meetings, and to assume all responsibilities relative to the duties of a chairman.

It shall be the duty of the Secretary to keep accurate minutes of each meeting; to send copies of these minutes to both the Clerk and Moderator promptly after each meeting; to prepare the Boards report to the Association; and to call meetings of the Board when the Chairman fails to do so.

STANDING RULES OF THE MIDWAY ASSOCIATION OF FREE WILL BAPTIST

- 1. Each church close its books on the 30th day of September and mail its annual report to the associational clerk 15 days before every session.
- 2. The pastoral year begins September 1st each year.
- 3. Each Church prepare the program for the day the Association meets at their church, and be responsible for the preacher and speakers, and let the moderator or clerk know 30 days in advance to the date of the meeting.
- 4. That 40% of all offerings goes for Home Missions.
- 5. Each Minister who is a member of the Midway Association be required to attend at least one session yearly unless providential-

- ly hindered. When he is unable to attend, he must report to the clerk by letter. Failure to attend at least one session annually will result in that minister's name being removed from the active list of Ordained Ministers.
- 6. Each convention or rally give an annual report at the Annual Association. (Woman's Auxiliary, Master's Men, C T S, Sunday School).
- 7. That the name, date of birth, date of death, age and church affiliation of any member overtaken by death every year be included in that years minutes, such information to be given to the Obituary Committee by the clerks of all our churches.
- 8. That at the death of one of our ministers a page in our following years minutes be draped in black to his memory, giving his birth, age, death, church affiliation, when ordained, and pastoral record as much as possible.
- 9. The deacons be standing delegates to the Midway Association.
- 10. That the Moderator, Vice-Moderator, Clerk, Assistant Clerk, Treasurer, Executive Board, Credentials Committee, Budget and Finance Committee, Resolutions Committee and the Ordaining Council be elected by the body for a two year term to be reelected or replaced on even years.
- 11. The rules (or By-Laws) governing the Standing Boards and committees be printed in the minutes every year.
- 12. That our standing resolutions be printed in the minutes every year.
- 13. The association funds from churches be given to the associational treasurer by the beginning of each session.
- 14. That a Nominating Committee of 5 be nominated and elected from the floor at the July session of the Association preceding the Annual Session in which the associational officers are to be elected.
- 15. That the Day for our Associational Meeting be changed to Saturdays before the fourth Sunday in January, April, July and October. The Annual Session of the Midway Association be a one day session beginning at 9:30 A. M. and continuing until all business is finished.
- 16. That all Officers and Boards of the Midway Association be

elected for two year terms and that no elected official of the Association may serve for more than two consecutive terms in the same office.

17. That no person may serve in more than one elected office in the Midway Association at the same time.

MIDWAY DISTRICT SUNDAY SCHOOL CONVENTION

June 30, 1968 - Enterprise Church, Blakely, Georgia:

The Convention was called to order by President Wyatt Brackin. Mrs. Hoyt Sheffield led the group in several songs. Mrs. Edith Shiver led in prayer.

An offering of \$24.15 was received after which Rev. Moody gave the offertory prayer.

Mrs. Lewis Williams, Cedar Springs Church, taught the Sunday School lesson with scripture from James 5: 7-16. Points stressed for our everyday lives were patience and prayer.

Mrs. Hoyt Sheffield called the attention of the group to the suggestion made at the State SS Convention concerning the union of the CTS and the Sunday School Convention to form one day as a rally for the youth, called a *Teach and Train Rally*.

Mr. O. B. Everson made a motion that the Midway Sunday School Convention merge with the Midway CTS Rally in one great meeting to form a *Teach and Train Rally* programmed to feature clinics,

workshops, training courses, CTS competitive activities and worship services. The planning of programs, scheduling of rallies and operation of the organization would be the responsibility of the Midway Association. The motion was seconded. During the discussion, Mr. Martin Murkerson, Mr. Everson, Rev. Fields, Rev. Calloway and Mrs. Edith Shiver spoke on the question. The motion was *not* carried.

Mr. Murkerson made a motion that the Convention continue on the 5th Sunday. After much discussion, the notion was not carried.

Brother Rudolph Shores made a motion that the Convention be held on the last Saturday in the 3rd Quarter; the date for 1969 would be June 28th. Motion was carried.

Mr. O. B. Everson made a motion for all to give the host church a rising vote of thanks for the gracious hospitality of the day. Motion carried.

Mrs. M. G. Shiver made a motion the Convention adjourn to meet at Hammock Springs Church, Donalsonville, Georgia on Saturday, June 28, 1969. Motion carried and the Convention was dismissed with prayer.
