FIRST QUARTERLY SESSION

Minutes of the 1969 First Quarterly Session of the Midway Association of the Free Will Baptist convening with New Enterprise Church in Seminole County, Georgia.

Brother E. B. Ard led the congregation in singing, "Have Thine Own Way," and "Praise Him, Praise Him" with Miss Joan Shores at the piano. The devotion was given by Rev. S. T. Shutes using as a subject "A Man Who Will Stand." Brother Wyatt Brackin gave the welcome.

The session was called to order for the transaction of business by the clerk introducing the Moderator of the Association, Rev. Charles Hollingshead. The Moderator introduced the officers of the Association.

A partial report of the Credentials Report was given by calling the roll of the delegates. Moved, second and carried that this portion of the report be received and the delegates seated. (See Report)

Moved, second and carried that the Moderator be given permission to change the scheduled program in the interest of time.

A letter of resignation from Rev. T. B. Calloway from the Chairmanship of the Mission Board was read. Moved, second and carried that the letter be received and referred to the Nominating Committee for replacement of Rev. Calloway. The Moderator appointed Brother Leron Clower and Brother Wyatt Brackin to alternate on the Nominating Committee for Rev. C. R. Houston who would be busy with other business, and Rev. J. W. Loyles, who was not present.

A letter of recommendation was read from New Light Free Will Baptist Church, requesting that Rev. Floyd Glass be examined by the Ordaining Council for the purpose of receiving him into the Association as an ordained minister. Moved, second and carried that the letter be received and referred to the Ordaining Council.

The twelve (12) ministers answering the roll call were: Rev. Charles Hollingshead, Rev. H. L. Knighton, Rev. Milton Fields, Rev. Bobby Register, Rev. T. B. Calloway, Rev. S. T. Shutes, Rev. Jerry Johnson, Rev. C. R. Houston, Rev. Lewis Williams, Rev. Mike Goss, Rev. Trellis Mayhall and Rev. Donald Reed. Rev. Coy Watson came in later.

The morning offering was taken while the congregation sang "Blessed Assurance."

The Moderator recognized as visitors: Rev. Hubert Henderson from the Home Mission Board, Rev. Jack Paramore from the Free Will Baptist College, Rev. Kenneth Faison from the Martin Association, Brother Alton Everson and son, Wayne, from the Union Association and Brother O. F. Everson from the Martin Association.

The business session was recessed until the afternoon.

The call to worship was opened with the congregation singing, "At Calvary" led by Brother E. B. Ard. A special message in song was beautifully rendered by Brother Ard and Mrs. Ard singing "The Two Ways."

Rev. Jack Paramore brought the morning message using, Ephesians 2:1-10 as scripture and vs. 8 as his text.

The balance of the Credential Report was read by the Clerk. (See Report) Moved, second and carried that it be received.

Moved, second and carried that we receive the Ordaining Council Report and vote on it item by item. (See Report)

All recommendations were approved.

Moved, second and carried that we receive the Nominating Committee Report, and that its nominee be elected by acclamation. (See Report) It was approved 100%.

Moved, second and carried that we give the host church a rising vote of thanks for a wonderful meal and their gracious hospitality.

January 13, 1969

Moved, second and carried that the Chairman of the Mission Board and the Chairman of the Executive Board together with the Moderator of the Association get bids on the Emmanuel Church property.

Moved, second and carried that the Treasurer of the Association pay one hundred fifty dollars (\$150.00) on printing of the Association minutes for the annual session.

5. To ordain or to assist in the ordination of deacons when requested by the deacon-elect's church to do so.

(Recommendation: Deacons should be ordained at their own church in the presence of their local membership whenever possible.)

Credentials Committee:

The Credentials Committee shall be composed of three members, the clerk of the Association who shall serve as its chairman and two other members elected on even years with the other Associational officers.

This committee shall receive and examine corresponding letters from all churches, compiling the statistics and reporting same to the Association. A roll call of the delegates shall be made at the beginning of each session of the Association in order that the delegates may be properly seated.

Reports from churches should be mailed to the clerk of the Association by the clerk of each church 15 days ahead of each session. (January, April, July and Annual.)

Budget and Finance Committee:

This committee shall be composed of five members, the treasurer of the Association, who shall serve as its chairman; and four others elected by the body every two years on even years along with the other Associational officers. Duties of this committee shall be:

1. To receive all Associational monies.
2. To receive pleas of help and suggestions for disbursements of money.
3. To revise and prepare recommendations for Associational funds from churches whenever deemed necessary by the Association.
4. To present recommendations for disbursements of monies to the Association.
5. To keep a general oversight of the financial work of the Association and to keep the Association informed at all times along this line.

Resolutions Committee:

The Resolutions Committee, composed of three members who shall be elected by the body for a two year term on even years along with the other officers of the Association, shall receive and present worthwhile resolutions to the Association.

Superannuation By-Laws:

1. That retired ministers who have served the Midway Association for a period of at least five years, are members of our Association and are in good standing with our Association, be given a quarterly supplement of money (the amount depending upon the financial status of the Association at the time) when they shall have attained the age of 65 provided the income of said ministers is inadequate for their needs.

2. That any qualified minister of this Association who, by accident or sickness, has been rendered permanently unable to continue as a minister of the Gospel, upon recommendation of his home church and approval of the Association, be given this same supplement.

3. That at the minister's death, this same quarterly supplement be continued to his widow as long as she shall live or remain a widow provided she meets the same qualifications as set forth for the ministers.

4. We further state that the recommendations set forth herein do not prevent the Association from taking "love offerings" or making a "love gift" to any minister or any layman at any time the Association so desires.

WORKING RULES FOR THE HOME MISSION BOARD OF THE MIDWAY ASSOCIATION

PREAMBLE:

The mission of Christ Jesus into the world was to complete the plan of salvation, to call sinners to repentance, to set up the work and the workers in establishing the Church; then He set in motion the missionary program for the church of all time. Matthew 28:19-20 simply means to teach all the gospel to all people.

1. The name of this Board shall be The Home Mission Board of the Midway Association.

2. The Board shall be composed of five members elected for two year terms along with other Associational officers. The State Mission Board member from the Midway Association may serve as an ex-officio member of this Board in an advisory capacity only.

3. The duties of this Board shall be:

(1) To formulate and promote a live missionary program.

(2) To aid weak churches.

(3) To establish new churches.

(4) To strive to keep the revival fires burning high (at all cost) in the bounds of the Midway Association.

4. It shall be the duty of this Board to supervise any and all the home mission programs of this Association.

5. The Board shall not hold joint ownership of churches but rather take a note on the property as security.

6. This Board shall be vested with the power of Trusteeship; to hold and convey titles to any property coming under the jurisdiction of the Home Mission Board through the Midway Association or as dealing

with any or all of the property requiring trusteeship of the Midway Association.

7. This Board shall elect a Chairman and a Secretary from its membership promptly after their election.

It shall be the duty of the Chairman to preside over the meetings, and to assume all responsibilities relative to the duties of a chairman.

It shall be the duty of the Secretary to keep accurate minutes of each meeting; to send copies of these minutes to both the Clerk and Moderator promptly after each meeting; to prepare the Board's report to the Association; and to call meetings of the Board when the Chairman fails to do so.

STANDING RULES OF THE MIDWAY ASSOCIATION OF FREE WILL BAPTIST

1. Each church close its books on the 30th day of September and mail its annual report to the Associational clerk 15 days before every session.

2. The pastoral year begins September 1st each year.

3. Each Church prepare the program for the day the Association meets at their church, and be responsible for the preacher and speakers, and let the moderator or clerk know 30 days in advance to the date of the meeting.

4. That 40% of all offerings goes for Home Missions.

5. Each Minister who is a member of the Midway Association be required to attend at least one session yearly unless providentially hindered. When he is unable to attend, he must report to the clerk by letter. Failure to attend at least one session annually will result in that minister's name being removed from the active list of Ordained Ministers.

6. Each convention or rally give an annual report at the Annual Association. (Woman's Auxiliary, Master's Men, C.T.S., Sunday School).

7. That the name, date of birth, date of death, age and church affiliation of any member overtaken by death every year be included in that year's minutes, such information to be given to the Obituary Committee by the clerks of all our churches.

8. That at the death of one of our minister's a page in our following year's minutes be draped in black to him memory, giving his birth, age, death, church affiliation, when ordained, and pastoral record as much as possible.

9. The deacons be standing delegates to the Midway Association.
10. That the Moderator, Vice-Moderator, Clerk, Assistant Clerk, Treasurer, Executive Board, Credentials Committee, Budget and Finance Committee, Resolutions Committee and the Ordaining Council be elected by the body for a two year term to be re-elected or replaced on even years.
11. The rules (or By-Laws) governing the Standing Boards and committees be printed in the minutes every year.
12. That our standing resolutions be printed in the minutes every year.
13. The Association funds from churches be given to the Associational treasurer by the beginning of each session.
14. That a Nominating Committee of 5 be nominated and elected from the floor at the July session of the Association preceding the Annual Session in which the Associational officers are to be elected.
15. That the Day of our Associational Meeting be changed to Saturdays before the fourth Sunday in January, April, July and October. The Annual Session of the Midway Association be a one day session beginning at 9:30 a.m. and continuing until all business is finished.
16. That all Officers and Boards of the Midway Association be elected for two year terms and that no elected official of the Association may serve for more than two consecutive terms in the same office.
17. That no person may serve in more than one elected office in the Midway Association at the same time.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
