First Quarterly Session,

First Session of Midway Association met with Patmos Free Will Baptist Church on January 26, 2002.

Our meeting began with song #350 "Brethren We Have Met To Worship" led by Leron Clower with prayer by Bro. Steve Faison. Our next song #450 "Tis So Sweet To Trust In Jesus".

Our welcome by the host pastor Brother John Amburgey and our devotion by Leron Clower with his text in Psalm 37:1-9. He pointed out that (1) Righteous people do not need to be concerned about the evil people - they will be repaid. (2) God will take care of us if we trust Him, live for Him, and love Him (3) We need to use our time to get closer to God, get our priorities straight in the year 2002.

We were called to order by Gene Gilbert, our clerk, who presented our moderator Brother Steve Faison. Our moderator asked for a roll call of ministers and the seating of the delegates. MSC. We were welcomed back by singing #705 "This Is The Day" We then went into our business session and had the following reports from the boards:

Camp Board: Junior Camp - Bonifay, Florida, June 2-7, 2002 could use some more counselors. Teen Camp - July 14-19, 2002 Forsythe, Georgia. We can save almost \$12,000 by using this week and facility, and he stated he could still use some help. The teen winter retreat that was held in December 2001 was a good success, and had about 140 teens there. Given for information by Mark Walker

Mission Board: Recommended to divide Acts 1:8 giving quarterly and gave \$65.00 at this time to Acts 1:8, also recommended to give Heather Paul (from New Light Church) \$200.00 who will be visiting a mission work. Total given from mission board \$265.00. MSC Reported by Mack Harrison.

Budget & Finance: Recommended \$400.00 to Heather Paul, stated she is

one of ours from the association, and wanted to help her, and also that if there had been more that was going from our association, we would try to help them if the money was available from our funds. Recommended to give \$300.00 to the Camp Board, \$100.00 to FWBBC, leaving a balance of \$283.22 in the fund. MSC Reported by Joe Murkerson.

Treasurer: Gave a printed financial statement to everyone and asked if there were any questions. Gave a final balance for the day of \$6,469.78. Reported by Rhonda Paul. See financial report for details.

Ordaining Board: (1) Recommended that a letter of good standing be given to Chuck Walker to join the Union Association MSC (2) Recommended that we accept Wayne Parker into Midway Association pending a letter of good standing from State Line Association in Alabama. He is the new pastor at First Church in Blakely, and has a wife Starla, and daughter Michelle. MSC Reported by John Amburgey.

Resolution: Recommended that we give a rising vote of thanks to Patmos Church for hosting our meeting today. MSC Reported by Jean Ethridge

Final Credential Committee Report: Total Present today 62, consisting of 16 ministers, 9 deacons, 26 delegates, 11 lay members. Reported by Ruby Ethridge. MSC

Nominating Committee: (1) Ed Kimbrel asked to come off the State Trustee Board and they recommended Bro. Gene Gilbert to replace him MSC (2) Shirley Kimbrel on the association resolutions committee asked to come off, so they recommended Jean Ethridge. MSC (3) Moderator Steve Faison is moving to Virginia, they recommended Bro. Burt Hall for moderator. MSC Reported by Melvin Moody

WAC Report: March 2, 2002 is our WAC workshop at New Enterprise Church and the registration starts at 9 am. Teresa Smith is in charge of the program and told us that James and Joann Ethridge, missionaries to the Congo will be there to show slide and tell about their calling. Reported by Janice Temples.

At this time we elected delegates to the State Meeting in Kingsland, Ga. March 14-16, 2002: Bonnie Amburgey, Edwina Drinkwater, Wylene Clower, Janice Temples, and the body gave the moderator or clerk the authority to appoint anyone that was there to be a delegate from our association. MSC

State Reports:

Our District Competition will be at First Church, Albany on April 6, 2002,

and the registration form needs to be in by March 25, 2002. Reported by Mark Walker received as information.

Christian Education Board: Sponsoring the Couples Retreat February 1-2, 2002; Ministers Wives Retreat April 11-13, 2002; Ministers Retreat April 22-24, 2002. MSC Reported by Mark Walker.

Camp Board: Reminded us of the Teen Camp dates July 14-19, 2002 at Lizella, Georgia. MSC Reported by John Amburgey

Mission Board: Kingsland, where Billy Bevan is pastor, is doing well, and the Atlanta mission, where Paul Smith pastors, is struggling to make the mortgage payments, and we had to make the mortgage payment last month. Please pray for them. MSC Reported by Billy Hanna.

Bro. Glenn Thomas suggested that we need to read our minutes at every meeting, and Bro. Steve Faison noted that we had not done this for a long time but asked if there were any suggestions from the body. Brother Steve called for a motion before we had any more discussion. Second Quarterly Session

The Second Session of Midway Association of Free Will Baptists convened on April 27, 2002, at Travelers Rest Free Will Baptist Church. The music was directed by Harvey Henderson. Judy Ethridge was the pianist and Tammie Williams was the organist.

The meeting opened with the congregation singing "Victory in Jesus". The welcome was given by Larry Ethridge, of Travelers Rest Church. Larry explained that Brother Gene and Paula had to be in Athens and could not be here today. "At the Cross" was sung by the congregation. The devotion was given by Brother Mark Williford. He read from II Timothy 4:6-8. He asked three questions. 1. Are you fighting a good fight (are you keeping the door open)? 2. Are you finishing the race? 3. Are you keeping the faith? Constitution of the Midway District Association of Original Freewill Baptist of the State of Georgia

Preamble

We, the Midway District Association of Original Freewill Baptist of the State of Georgia, do ordain this constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

Article I NAME:

The organization shall be known as the Midway District Association of Original Freewill Baptist of the State of Georgia.

Article II MEMBERSHIP:

This association shall be composed of such Freewill Baptist Churches as shall adopt this compact and agree to this constitution.

Article III REPRESENTATION:

- Section 1: The standing delegates of this association shall consist of all ordained ministers, ordained deacons, and officers of this association.
- Section 2: Voting privileges shall extend to all standing delegates and to those duly elected delegates representing the churches of this association.
- Section 3: Each church shall be entitled to two (2) delegates for the first (50) members or fractional part thereof and one delegate for each additional twenty-five (25) members.

Article IV OFFICERS:

- Section 1: The general officers of this association shall be the Moderator, Vice-Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer. These officers shall be elected on even years for the term of two years.
- Section 2: There shall be a General Board composed of the officers of the association and the Chairman of the various boards which shall serve as the association out of session.
- Section 3: The standing boards of this association shall be the Missions Board, Ordaining Board, Budget and Finance Board, and the Camp Board.

Article V MEETINGS:

The meetings of this association shall be the Saturdays before the fourth Sunday in: January, 9 o'clock thru 12 o'clock noon; April, 9 o'clock thru 12 o'clock noon; October, 9 o'clock thru 12 o'clock noon; and the Saturday after the fourth Sunday in July, 9 o'clock thru 12 o'clock noon, followed with lunch by the host church.

Article VI AMENDMENTS:

This constitution may be amended or altered at any regular session of the association by a two-thirds majority vote of the delegates present provided that the proposed amendment or alteration is presented in writing during one session, placed on the table

and voted on the next session. Further it shall be understood that the proposed amendment or alteration be furnished in writing to each church at least thirty (30) days prior to the session during which the vote is taken.

BY-LAWS of the Midway District Association of Original Freewill Baptists of the State of Georgia

Article I MEMBERSHIP:

Section 1: All churches affiliated directly with this association shall be required to adopt the Treatise of the Faith and Practices of the Original Freewill Baptists as adopted by the National Association of Freewill Baptists. Applications for membership must contain a statement to this effect.

Section 2: Churches desiring to affiliate themselves with this body must make application by letter and representation to this association while in session.

Article II REPRESENTATION:

Each church shall be required to pay a minimum fee per member of 50 cents per quarterly session and seventy-five cents per member each annual session.

Article III FUNCTIONS OF THE OFFICERS:

- Section 1: The duties of the Moderator shall be to preside at all meetings of the association. He shall be empowered with the authority to appoint any committees not otherwise provided for the constitution.
- Section 2: The duties of the Vice-Moderator shall be to preside at the request or absence of the Moderator and assist him in such ways as we are necessary and advisable.
- Section 3: The duties of the Clerk shall be to keep accurate minutes of the association, to compile the minutes of the boards and the auxiliaries, to prepare them and to publish them. It shall further be the duty of the Clerk to take care of all necessary correspondence.
- Section 4: The duties of the Assistant Clerk shall be to function at the request of the Clerk and to assist him in any way necessary.
- Section 5: The duties of the Treasurer shall be to receive all association funds and to disburse them as directed by the association.
- Section 6: The duties of the Assistant Treasurer shall be to function at the request of or in the absence of the Treasurer and to assist him in any way necessary.

Article IV FUNCTION OF THE BOARDS:

- Section 1: The Missions Board shall be composed of five (5) members whose terms of office shall be two years and who shall be reelected or replaced on even years. The function of this board shall be:
 - a. To supervise any and all mission's programs of this association and to coordinate their efforts with our state and national agencies.

- b. To be vested with the power of trusteeship; to hold and convey titles of any property coming under the jurisdiction of Mission Board through the Midway Association or as dealing with any or all of the property requiring trusteeship of the Midway Association.
- c. To formulate and promote a live missionary program by the aiding of weak churches, the establishment of new churches and by an earnest effort to keep the spirit of revival ever present within our association. It shall not be the function of this board to hold joint ownership of any church.
- Section 2: The Ordaining Board shall be composed of five (5) members who are members of our association in good standing. Boards members shall be elected on even years for the term of two years. The functions of this board shall be:
 - a. To examine all applicants for ordination to the ministry and all previously ordained ministers seeking membership in our association.
 - b. To ordain or assist in ordination of deacons and ministers when requested to do so by the church of the candidate.
 - (1) That all ministers wishing to become members of this Midway Association be recommended from the church of which they are members.
 - (2) That all examinees be called upon to present their credentials for examination and answer satisfactorily such questions as may be asked them.
 - (3) That a person who is presented for ordination or to be recognized as ordained must be pastoring, involved in a pastoral ministry, or be in a state of retirement due to age or health or have justifiable cause preventing his pastoring.
 - (4) That ministers desiring to be ordained must have been licensed for the period of one year and have pastored or been involved in a pastoral ministry for at least six (6) months prior to ordination, six (6) months pastoring, or pastoral ministry during the one year tenure of licensing will be accepted as a prerequisite for ordaining.
- Section 3: The Budget and Finance Board shall be composed of three (3) members, one of whom shall be the Treasurer, and who shall serve as its Chairman. These members shall be elected on even years for the period of two (2) years. It shall be their duty to:
 - a. Receive and disburse all association moneys at the request of the association.
 - b. To receive all pleas for help and suggestions for disbursements of moneys.
 - c. To recommend to the association the disbursements of moneys received.
 - d. To keep a general oversight of the financial work of the association and to keep the association informed at all times of its financial conditions.

Section 4: The Camp Board shall be composed of five members. Lay members shall be at least two of the five members. The Chairman of the Board shall be the Camp Director, or the board may appoint a Director and Co-Director. This board shall be elected or reelected yearly. It shall be their duties to:

20

- a. Plan and promote the Youth Camp over the district.
- b. Set time for the Midway Camp.
- c. Set fees for the camp in accordance with the State Camp Board.
- d. Secure volunteer or hire sufficient help and supervision for the camp session.

Article V COMMITTEES:

Section 1: The Nominating Committee shall be composed of three members whose terms of office shall be two tears, and who shall be elected or reelected on even years.

Section 2: All committees not provided for by either the constitution or its By-Laws may be appointed by the Moderator as deemed necessary.

Article VI

Section 1: Each church is requested to mail its report to the Clerk fifteen (15) days before each session.

Section 2: Each auxiliary of the association shall give a report to the association meeting which meets in October for the Annual Meeting. It is requested that this report be mailed to the Clerk fifteen (15) days before the Annual Session.

Article VII MISCELLANEOUS:

Section 1: After payments to the Moderator, the Clerk, and the superannuates, forty percent (40%) of association fees (dues) and offerings will go for missions.

Section 2: Each minister who is a member of the Midway Association shall be expected to attend at least one session yearly unless providently hindered.

Section 3: The name, date of birth, date of death, age and church affiliation of any member overtaken by death, each year shall be included in that year's minutes, and such information is to be given to the Clerk by the various Clerks of the churches.

Section 4: At the death of a minister, a page in that year's minutes shall be draped in black in his memory, giving all pertinent information concerning him and his ministry.

Section 5: The General Officers of the association shall be elected on even years for the term of two (2) years.

Section 6: No person may be elected to more than one (1) office in the Midway Association at the same time. No General Officer (top six officers) may succeed himself or herself more than once.

Section 7: The Constitution and By-Laws with any amendments and alterations shall be printed each year in the minutes.

Section 8: A quorum shall consist of a majority of any board or committee.

Article VIII SUPERANNUATION:

Section 1: Retired ministers who have served the Midway Association for a period of at least five (5) years, are members of the association, and are in good standing with

the association will be given quarterly supplement of money (the amount depending upon the financial status of the association at the time) when they shall have attained the age of sixty-five (65) years; provided the income of said ministers is inadequate for their needs.

- Section 2: Any qualified minister of this association who, by accident or sickness, has been rendered permanently unable to continue as a minister of the Gospel, upon recommendation of his church and the approval of the association, be given the same supplement.
- Section 3: At the minister's death, this same quarterly supplement shall be continued to his widow as long as she shall live or remain a widow, provided she meets qualifications as set forth for the ministers.
- Section 4: The above sections do not prevent the association from taking "love offerings" or making a "love gift" to any minister or any layman at anytime the association so desires.
- Section 5: The Budget and Finance Board shall examine each applicant at each annual association meeting to see if they are still in compliance with these By-laws.

Article IX AMENDMENTS

These By-Laws may be amended or altered at any regular session of the association by a two-thirds majority vote of the membership present provided that the proposed amendment is presented in writing during one session, placed on the table and voted on in the new session. The proposed amendment or alternation shall be furnished in writing to each church at least thirty (30) days prior to the session during which the vote is to be taken.

CONSTITUTION AND BY-LAWS

FOR THE

MIDWAY DISTRICT WOMEN OF GEORGIA ACTIVE FOR CHRIST CONVENTION

ARTICLE I. NAME:

The name of this organization shall be the Midway District Women of Georgia Active for Christ Convention.

ARTICLE II. PURPOSE:

The Purpose of this organization shall be: (1) to assist various women of the Midway District of Free Will Baptists in providing opportunities for them to understand and fulfill their place in the Great Commission through their responsibilities in the family, the church, the community, and around the world, and (2) to bring women of each local church together for fellowship, for sharing information, and for encouraging one another.

ARTICLE III. OFFICERS AND EXECUTIVE COMMITTEE:

Section 1: The officers and executive members must be in good standing of a church in the Midway Association of Free Will Baptists. She must be a member of a local WGAC. Each officer shall perform the duties set forth for her office in the present manual.

Section 2: The officers shall be a President, Vice President, Secretary, Treasurer, Field Worker, Study Chairman, Mission Chairman, Prayer Chairman, and Service Chairman. These shall constitute the Executive Committee, five (5) of who shall be a quorum for transacting business.

ARTICLE IV. MEMBERSHIP:

Section 1: This Convention shall be composed of the officers of the Convention together with the local Co-ordinators and five (5) delegates from each local group in the Midway District which has paid in full its membership fee as required by the Midway District WGAC Convention.

Section 2: Any eligible WGAC group wishing to become a member of the Midway District WGAC Convention shall present a petitionary letter signed by the officers of the local group, a report of work done and its proportionate part of dues to the secretary who shall present this to the Credentials Committee. The Convention shall vote upon the recommendation of the Credentials Committee.

ARTICLE V. MEETINGS:

Section 1: The annual meeting shall be held each year on the first Saturday in October or at such time as may be determined by the Executive Committee.

Section 2: A workshop shall be held each year on the first Saturday in March, or at such time as may be determined by the Executive Committee.

Section 3: Other meetings may be held at the discretion of the Convention.

Section 4: The Convention and Workshop shall convene with the WGAC groups in the Midway District according to alphabetical order. If a local group is unable to serve as host, the Executive Committee must be notified by the group.

ARTICLE VIAMENDMENTS:

This Constitution may be amended at any annual meeting of the Convention by a 2/3 vote of the members present.

BY-LAWS

ARTICLE I Duties of Officers:

Section 1: President – The President shall preside over all meetings and serve as Chairman of the Executive Committee, appoint such committees as may be needed, call a meeting of the Executive Committee, when necessary, be an ex-officio member of all committees, (with the exception of the Nominating Committee, see that reports are made promptly by the Secretary and Treasurer to the State and perform all duties usually pertaining to such an office.

Section 2: Vice President – The Vice-President shall preside in the absence of the President, or by her request and otherwise assist her in the overall tasks in general. She shall serve as chairman of the Credentials Committee.

Section 3: Recording Secretary – The Recording Secretary shall keep an accurate record of all proceedings of the Convention and Executive Committee meetings, preserve all valuable papers and turn them over to her successor. She shall compile a list of the local WGAC officers immediately after the Convention. She shall send a copy to each local Secretary, a copy to each District officer, and a copy to each Committee chairman. She shall send the proper report to the State Secretary. She is responsible for sending the appropriate minutes to the Midway Association Clerk to be published in the Annual Association Minutes.

Section 4: Treasurer – The Treasurer shall have charge of all funds belonging to this Convention, and shall disburse moneys only when authorized by the Convention. She shall keep an accurate account and shall give a written report of all funds received and disbursed at each Convention. She shall send an annual report to the District Association Clerk to be published with the minutes in the Midway Minutes. She shall end the per-member dues as designated by the State WGAC to the State Treasurer. The Treasurer shall encourage support of missions through the WNAC Gift Plan and support of the Dot Harvey Loan Fund. She serves as Chairman of the Finance Committee. She shall secure a report of the Dot Harvey Loan Fund as well as a report of the State Project and report this information to the District.

Section 5: Field Worker – The Field Worker shall have charge of all Field work pertaining to or necessary for the promotion of the work of the District. She should visit each local WGAC and help in any way she can.

Section 6: Study Chairman – The Study Chairman shall work with the local WGAC groups' Study Chairmen through personal contact or correspondence. She shall recommend books for study in the local groups, and may even teach some study courses in the local groups. She shall plan, along with the Executive Committee, the District Workshop and be in charge of its activities. She shall encourage local Study Chairmen to have the following:

- 1) two (2) Mission studies a year
- 2) one (1) Christian living study a year
- 3) one (1) Prayer Study
- 4) Studies to prepare women for special ministries
- 5) A study of the WNAC Manual when needed

She shall be responsible for training local officers for their duties and leadership responsibilities.

Section 7: Prayer Chairman – The Prayer Chairman shall encourage Prayer Chairmen of local groups to promote family altar; special Seasons of Prayer, Prayer Retreats, and Prayer fellowships. She shall offer periodic suggestions for prayer requests.

Section 8: Service Chairman – The Service Chairman shall promote projects in the District for service to Missionaries, community needs, ministering to sick, aged, retired ministers, or the promotion of other Christian organizations.

Section 9: Mission Chairman – The Mission Chairman shall encourage the local WGAC groups to give through the WNAC Gift Plan, to the Provision Closet, to the Dot Harvey Loan Fund, and the State Project. She is to encourage Mission Chairmen in local groups to learn missionaries' names, send needed gifts, get acquainted with Missionary Kids and find out their needs. She shall encourage locals to present a special program during WNAC Emphasis Month in August and send an offering to WNAC.

ARTICLE II ELECTIONS:

The general offices and four (4) chairman of the Executive Committee shall be nominated by a Nominating Committee and elected every two (2) years by acclamation, unless there are other nominations. In the event of more than one nominee for any office, a vote will be taken on each one. All elections shall be held at the closing business session of the Annual Convention. Election of officers will be held on all uneven years.

ARTICLE III EXPENSES:

The Treasurer's expenses, such as postage, stationary, telephone calls, may be appropriated by each local WGAC sending in \$1.00 a month. The Convention may decide when this fee needs to be increased. Other appropriations may be decided upon by the Convention.

ARTICLE IV COMMITTEES:

Section 1: Executive Committee — The Executive Committee shall hold annual meetings for the transaction of needed business and to prepare the program for the annual Convention. It shall maintain an over-all view of the work at large, having authority to call extra meetings of the Committee when necessary, and act for the

Convention concerning any matter. It shall also fill vacancies occurring between elections.

Section 2: Resolution Committee – The Resolution Committee, consisting of five (5) members, shall be appointed by the President. This committee shall serve for two (2) years.

Section 3: The Nominating Committee shall be composed of five (5) members who are delegates. They shall be nominated from the floor and elected by the body at its annual meeting on even years to serve for two years. They shall present a slate of officers for the body to vote on at the annual Convention on the uneven years.

Section 4: Credentials Committee – The Vice President shall be Chairman of the Credentials Committee. Two (2) other members may be appointed by the President. This Committee shall examine the reports of the local WGAC groups to determine if fees are paid and if reports are in order. New local groups of WGAC that have been organized since the last Convention are examined by this Committee and voted upon. This Committee shall serve for two (2) years.

Section 5: Finance Committee – The Finance Committee is composed of the Treasurer and four (4) members appointed by the President. It is their duty to audit the financial records for the year and report on same to the Convention. They make recommendations to the body.

Section 6: Registration Committee—The Registration Committee consists of three (3) members who are appointed by the President. This Committee's responsibility is to register those in attendance. This Committee serves for one (1) year.

ARTICLE V FEES AND REPORTS:

Section 1: Membership fee per member of this Convention shall be set in accordance with the State and National fees.


Section 2: The Minutes of the previous Convention shall be read as information at the beginning of the business session.

The desired financial programs for WGAC local groups are Mission Offerings following each special Season of Prayer, Co-Laborer Offerings, State WGAC projects, and annual gifts to WNAC general fund, the Dot Harvey Loan Fund, and other gifts designated by the Convention.

ARTICLE VII

These By-Laws may be amended at any Annual Meeting of the Convention by a 2/3 vote of members present.



John Amburgey Called to Glory August, 2002

Reverend John Amburgey died at his home Wednesday, August 14, 2002. He was sixty-two years old. He is survived by his wife Bonnie. They had been married for thirty-five years. He is also survived by one daughter: Jana Brooks of Dublin, Georgia, and two sons: David of Windsor, Virginia, and Daniel of Midland City, Alabama. John and Bonnie have four granddaughters and three grandsons.

Brother John was born and raised in Robinette, West Virginia. He graduated from Man High School in Man, West Virginia. He served in the United States Army and received an honorable discharge in 1965. He was an alumnus of Brevard Community College, Cocoa, Florida; Hillsdale Free Will Baptist College, Moore, Oklahoma; Salem Bible College, Scottsmoor, Florida; and Bethany Theological Seminary, Dothan, Alabama.

Brother Amburgey has been active in the service of the Lord his entire adult life. Before answering the call to preach, he served as youth director and deacon at First Free Will Baptist Church in Scottsmoor, Florida. He was licensed to preach in 1979 and was ordained as a Free Will Baptist minister in July of 1980. Brother Amburgey had served as pastor of Patmos Free Will Baptist Church since 1997. He also served Pine Level Free Will Baptist Church in Chester; Bethany Free Will Baptist Church in Hazlehurst; Corinth Free Will Baptist Church in Iron City, and churches in Florida, Mississippi and Alabama. He held the following positions on the district association level: executive board, assistant clerk, ordaining council, camp director, youth board, resolutions committee, and nominating committee. On the state association level he served as secretary of the Georgia State Board of camping (1986-1988) and (1998-2002). John was active in all levels of the Free Will Baptist work. He was known as a man who supported and promoted every phase of our denomination.

His zeal and sense of humor will be missed. When called upon, he was always willing to serve. Those who knew John referred to him as a "good and honest man." T.E. Moye, deacon of Patmos Church said, "When Brother John said something, you could count on it."

Funeral services were conducted August 17 at the Patmos Free Will Baptist Church in Leary, with long time friend Reverend Jim Foster bringing the funeral message. Reverend David Young assisted in the service. Internment was at the church cemetery.
