PROCEEDINGS

The Seventh Annual Session of the National Association of Free Will Baptists of the United States convened with the East Nashville Church, Nashville, Tenn., on Tuesday evening, July 13, 1943.

Rev. Henry Melvin, pastor of the local Church and also director of music for this session of the Association, opened the session by leading the congregation in several hymns, after which, Rev. B. F. Rogers read the Scripture and led in the opening invocation. After the choir rendered a special number the speaker of the evening, Rev. Dr. Bob Jones, founder of the Bob Jones College, Cleveland, Tenn., was introduced by Rev. Melvin, the host pastor. Dr. Jones, read the 17th Chapter of The Acts from which he based his subject, "Evangelism and Character Building." The message was highly instructive and interspersed with wit and humor.

After the opening sermon, the Moderator called for a business session in keeping with the arranged program. The opening prayer of the business session was offered by Rev. E. C. Morris, then the welcome address was delivered by Rev. Henry Melvin and the response was given by Rev. John B. Rollins. Prayer was then offered by Rev. J. R. Davidson.

Election of general officers was called for at this time and by motion, all incumbent officers were re-elected. (see list of officers on front page).

The next on the program was the Moderator's message, which was delivered in usual order.

By motion, the session adjourn to meet according to the program on Wednesday morning.

WEDNESDAY MORNING

The Association came together at appointed time, song service and devotions were conducted by Revs. J. R. Davidson and R. C. Wiggs, after which, the Moderator took charge and called the body to business.

The General Board made a partial report at this time and same adopted.

The Treasurer's report was read and adopted.

Mrs. Fannie Polston read a report of the Women's Auxiliary Convention and the same was received with favorable comments.

A letter was read from the Statistician, Rev. C. F. Bowen and received as information. Rev. Mr. Bowen was re-elected as Statistician.

FREE WILL BAPTIST BODIES

At this time, a report of the Free Will Baptist Bible College was made by the business manager, Rev. J. R. Davidson and after some discussion of praise for the work, the same was adopted by the body.

After the above report was made, the College President, Rev. L. C. Johnson, delivered a very timely address on the subject, "Ye Shall Know the Truth."

The hour now having arrived for the Associational sermon, the Moderator presented the Rev. L. R. Ennis, the Executive Secretary, who delivered the sermon based on Heb. 6: 1, 3. Subject, "Let us go on, and this will we do, if God permit." The speaker mentioned some of the great doctrines, such as repentance, faith, baptism, etc., but the emphasis of his message was placed on the practical side of our Christian experience such as progress, evangelism and Christian growth. The sermon was considered a masterpiece.

WEDNESDAY AFTERNOON

The Association reassembled per adjournment and the devotions were conducted by Rev. Damon Dodd, after which the business was resumed.

The Executive Secretary read his annual report and the same adopted.

Report of the Promotional Secretary was read by Mrs. McAdams and the same adopted.

Report of the Board of Publication and Literature was read by the Chairman, Rev. J. C. Griffin and same adopted.

Proposed Constitution and By-Laws of the Board of Publication and Literature was offered to the body as recommended by the General Board, and it was adopted by the body.

After an address by Rev. E. C. Morris, on, "Our Debt to the Retired Ministers," was delivered, the Superannuation Board made its report which was adopted.

By motion, the session was adjourned until the Evening hour.

WEDNESDAY EVENING

The Evening service was devoted to the Cause of Foreign Missions. The music director led the congregation in several hymns and Dr. Leonard Earl Harris rendered several solos by popular request.

The report of the Foreign Mission Board was read by the Chairman and same adopted. The proposed Constitution and By-Laws, by which the Foreign Mission Board is to be governed, was read and adopted.

The message of the evening was delivered by Rev. Thos. H. Willey, our Missionary to Cuba. Bro. Willey brought greetings from our churches and

brethren in Cuba. The message imparted information which was perhaps the most encouraging of any missionary report yet given to this body.

An appeal was made for a Bible School in Cuba and the Association passed a motion which provided authority for \$5,000.00 to be raised for such a School as suggested.

After the showing of pictures of the Cuban mission work, the Association stood adjourned until Thursday morning.

THURSDAY MORNING

The Association met per adjournment with devotions being led by Rev. R. C. Wiggs.

The report of Credential Committee was read by the Clerk and same adopted. In this report the Committee recommended that the Liberty Association of Florida be admitted into this body. A motion was carried that the recommendation of the Committee be adopted, and the Liberty Association of Florida become a member of this body.

At this time the proposed Constitution and By-Laws of the Board of Superannuation was taken from the table, duly discussed and adopted.

Motion, That this Association approve the recommendation of the Board of Superannuation, for adoption by the several state associations in the Free Will Baptist connection, and that the Clerk of this body be instructed to publicize the recommended Constitution through our Church papers at his earliest convenience.

Report of the National Free Will Baptist Sunday School Convention was made at this time and same adopted.

Committee on Nomination made report and same adopted.

Committee on Resolutions made report and same adopted.

Committee on Temperance made report which was adopted.

Motion, that a copy of the Temperance report be furnished the local pastor for publication in the local papers.

The final report of the General Board was read, received and adopted.

Report of the Free Will Baptist League Board was read, received and adopted.

On motion, the provision for the Executive Department be the same as of last year.

On Motion, the matter of Mrs. McAdam's salary be left with the Executive Committee.

By a motion, Mrs. McAdams was re-elected as Promotional Secretary.

By motion, the Clerk be authorized to prepare and have printed the same number of minutes as of last year.

The business of this, the Seventh Annual Session of the National Association having been transacted a motion was made that the body be adjourned to meet in its next session with the Church of Flat River, Missouri. Benediction by Rev. F. C. Zinn.

Georgia gives no statistical report.

Kentucky reports 129 members received, 99 baptized, 8 dismissed by letter, 15 deceased, 4,496 resident members, 6 prayer meetings, 12 Sunday Schools with an average number of pupils 503. \$200.00 paid on building and repairs, values of church property \$64,990.00, amount raised for home missions \$458.00.

Michigan reports 6 churches, 300 members, 6 F. W. B. Leagues, 7 Sunday Schools, 11 ordained ministers and 3 licensed ministers. \$143.18 reported raised for the "Unified Budget Program," \$477.31 for Foreign Missions.

Mississippi reports 22 churches, 2,468 members, 17 ministers, 13 Sunday Schools with an enrollment of 925, Leagues reported 5, with an enrollment of 305, number of women's auxiliaries 4. Value of Church property \$35,000.00. Value of parsonage property \$1,500.00. Amount raised for Christian education \$207.57, Orphanage \$1,400.00, Foreign missions \$24.85, Home missions \$160.00, Superannuation \$12.00.

Missouri reports 219 members received, 165 baptized, 53 dismissed by letter, 77 excluded, 60 deceased, 3,750 resident members, 1,891 non-resident members, total membership 5,461. Number of prayer meetings 31. Number of Sunday Schools 74, with an average number of pupils 3,441, number of officers 292. Number of Leagues 23, with a membership of 664. Number of Mission Societies 22, with a membership of 473. Amount paid pastors \$9,471.95, Evangelistic work \$2,189.34, for building and repairs \$4,679.64, for incidentals \$2,166.29. Value of church property \$80,350.00. Raised for Foreign Missions \$2,334.84, Home Missions \$1,588.60, for Education \$1,283.62, for Literature, etc. \$1,604.72.

North Carolina reports 2 associations, 23 churches, 3,300 members, 15 ministers, 23 Sunday Schools with an enrollment of 3,100, 8 Leagues, 14 auxiliaries. Value of church property \$69,000. Amount raised for Christian Education \$65.00, Orphanage \$1,475.00, Foreign Missions \$50.00, Home Missions \$70.00 and Superannuation \$48.00.

Oklahoma reports 14 associations, 210 churches, 20,000 members, 274 ministers, 210 Sunday Schools, 50 Leagues, and 60 women's auxiliaries. Value of church property \$130,000.00, Value of parsonage property \$20,000.00. Other property \$3,000.00.

Ohio reports 51 churches, 2,731 members, 57 ministers, 48 Sunday Schools with an enrollment of 2,411. Number of Leagues 5, number of women's auxiliaries 4. Value of church property \$100,000.00.

Tennessee reports 81 churches, 6,696 members, 81 ministers, 81 Sunday Schools with an enrollment of 4,864. 21 leagues with an enrollment of 350. 27 women's auxiliaries with an enrollment of 405. Value of church property \$250,550.00, value of parsonage property \$8,000.00, value of denominational property \$24,000.00. Name of denominational, Tennessee Free Will Baptist Orphanage. Amount raised for Christian Education \$2,326.15, Orphanage \$3,287.44, Foreign Missions \$712.90, Home Missions \$99.16, Superannuation \$6.80, Unified program \$272.10.

REPORT OF THE EXECUTIVE SECRETARY

F. S. Van Hoose, Treasurer.

Rev. L. R. Ennis

Another year of delightful history has been written by Free Will Baptists of the United States. Surely the Lord is among us and we know it: let every heart be glad; A unity of experience, faith, and method is proclaiming victories of eternal significance. Diverse obstructions, such as; imperfect organization, new and untried working plans, inefficient leadership, sparsity of population, inadequate means of communication, varied traditions, preoccupation, and sin—all lead to the rational conclusion that Free Will Baptists are basically inconsistent and destined to fail. But I dissent. There is one evidential fact which changes the whole perspective—Jesus is alive among us. Yea, "I can do all things through Christ who strengtheneth me." Has he not been the source of our power and wisdom? Let the achievement speak.

The Unified Program Fund is now an established financial system. Its gains for the past year justify the wisdom of its inauguration. There has been a total of \$3,841.44 received and \$2,972.50 allocated to the respective boards during the year. This system is a growing revelation of the cooperative ability of Free Will Baptists.

The Bible College and Foreign Missions reveal a trend in the thinking of our people. Trained Christian workers, who see the whole world as their field of labor, is our grand objective. The school and the mission field should be inseparable. The receipts of the College show a total of \$18,139.03 since the first of last July and the Foreign Mission treasury a total of \$8,769.71. We should be reverently thankful.

Seven sessions of the Christian Workers' Institute have been held in five states of the National Association since our last national meeting. An enrollment of 185, with 135 receiving certificates or diplomas, attended these sessions as registered students. In addition to 420 hours spent in class work, evangelistic services were held, promotional itineraries and rallies conducted.

and general meetings attended. Collections for the work of the Association as a whole in the amount of \$811.18 were received; and the actual cost, in salaries and expenses, of all institute work for the year amounted to \$796.50. The Christian Workers' Institute is the most potent promotional factor in existence among Free Will Baptists.

The responsibilities and duties of the Executive Office have steadily increased since its inception three years ago. The past year has been a delightful but difficult one; and, regretably, may I say, physical strength has been too inadequate. Strictest economy has been enforced in all the functions of the office, as the following figures will show: Amount drawn from standing boards \$2,500.00; amount received in offerings and in registration fees from Institute students \$387.33; Total received \$2,887.33. The cost of maintaining the Executive Office for the year has been \$1,672.07. It is only proper that I inform this body of the liberality of my pastorate in the support of this great Cause. There has been forwarded to the treasuries of our various interprises by my churches \$1,258.67, or \$58.67 more than the Association has paid me for the past year. I desire to go on record in this report as favoring only the election of ministers to office in this National Association who lead their churches in supporting the entire program of the Association.

It is delightful beyond measure that our records show an increase again this year of over 100 per cent above the receipts of last year. We report to this Association the receipt of \$31,469.03 from July 1, 1942 to June 30, 1943.

Let us continue to worship, work, and witness as Jesus leads us through to victory.

REPORT OF PROMOTIONAL FIELD SECRETARY

From July 1942 to July 1943

REPORT OF GENERAL BOARD

Recommendations by the General Board

1. The General Board does hereby recommend that the Unified Program Fund be allocated monthly for the ensuing year according to the schedule of the previous year; namely, 10 per cent to Superannuation, 20 per

cent to Home Missions, 30 per cent to Foreign Missions, and 40 per cent to Christian Education.

- 2. The General Board does hereby recommend that the general expenses of the National Association be paid from the Association Fund. The printing of the minutes of the Association, the honorarium and traveling expenses allowed the Moderator and Clerk, the traveling expenses resulting from convening the Executive Committee of the General Board in called sessions, and any expenses incurred by the National Treasurer in discharging his official duties shall all be paid from the Association Fund.
- 3. The General Board recommends the ascension of last year's action which provided that the salary of the Executive Secretary be set at \$1200 annually.
- 4. The General Board does hereby recommend the election of a full time Executive Secretary.
- 5. The General Board does hereby recommend that the office of the Secretary be located in Nashville, Tennessee.
- 6. The General Board does hereby recommend the election of Rev. Henry Melvin to the office of Executive Secretary and that the Executive Committee of the General Board be charged with the responsibility of negotiating the terms of the salary.
- 7. The General Board does hereby recommend that the genius of the Unified Program Fund be proclaimed throughout the Associations that compose the National Association and that response to it be encouraged.

REPORT OF NATIONAL FOREIGN MISSION BOARD FOR YEAR 1942-43

During the past year has been witnessed the greatest advancement in the foreign mission department of the Free Will Baptist church ever to be known in any equal period of time in the history of the denomination. It has been true both in the interest manifested in the home land and in results produced on the foreign field. The Lord is crowning the denomination with an unusual missionary revival, and the fact that our people are adhering to the command of the Lord as given to us in the great commission may well strengthen our faith to believe He will bless and continue to bless in all other departments of our beloved church.

We have come to the close of the associational year with a cash balance in our foreign mission treasury which exceeds \$2,200. And let us remember this nice sum remains on hand after a current expense of from five hundred to six hundred dollars every month of the year.

In summarizing the blessings of the Lord upon the work in Cuba, we are permitted of Him to present the following:

Number of native preachers 6, number of Bible women 1, number of organized churches 5, number of preaching points aside from organized churches 34, number of horses 8, number of saddles 7, number of benches furnished at various preaching points 60, number of baptized believers 76, number of probationers awaiting baptism more than 200, number of prospective students for training in Christian service 15, area being evangelized approximately 100 miles.

While these marvelous results are a reality for which we are very thankful yet Bro. and Sister Willey with their band of Cuban co-workers have merely touched the service in that province of tremendous opportunity for missionary service. All along new doors of opportunity are swinging ajar, and the people are calling for services in their respective villages and communities.

During the month of February, 1943, your Board of Foreign Missions sponsored Rev. Henry Melvin in a tour of our work in Cuba during which time he assisted Rev. and Mrs. Willey in the organization of the work. On February 14 the first Free Will Baptist association was organized on the island of Cuba. It is known as the Free Will Baptist Association of Pinar Del Rio. Bro. Melvin's visit proved of great value to the work for which we are grateful. May the Lord indeed be praised for the wonderful progress being made in the work in Cuba.

As pertaining to the work in India the work started by Miss Barnard near Kotagiri, South India, is still in progress. During her absence, the work has been under the care of Rev. H. M. Clay. Rev. Clay kindly consented to look after the work until such a time when the war conditions might become adjusted so as to permit Miss Barnard's return to the field. We have been sending some money occasionally to Rev. Clay thereby enabling him to care for the work.

As to the prospects in Purnea District, it is understood the work is still open there for us. Rev. Alexander Banks, a former acquaintance of Miss Parnard, has consented to act as a go between for us in order to help get some native workers into this needy field; and in view of this, our board voted at the board meeting held in April of this year to send the sum of \$25 to Rev. Banks to be used in sponsoring an investigating tour in Purnea. This has been done and word has been received to the effect he received the money and stated that prospects were favorable. However, just recently the Department of State has notified Miss Barnard that they are ready to grant her facilities for travel to India, and so she is now making definite preparations to sail. For this, we are very grateful knowing that her heart is in India, and realizing as we do the great need over there. Of course, the human shudders for her when we reflect upon the danger of sailing the seas in these warring times; but, when we turn our minds and hearts to the greatness of the protecting and keeping power of our Christ, fears immediately vanish. Let us be much in prayer for her as she leaves us to return to that which is the desire of her heart. These late developments greatly renew our hopes for the work in India. Miss Barnard has served very beneficially during the past school year as teacher of the missionary course in our school in

Nashville; and, at the same time, acting as secretary for the school. Our board agreed last fall to release Miss Barnard for this work at which time she, of course, came under the supervision of the Board of Education for the school term.

Miss Bessie Yeley of Ohio, who for some years has been doing missionary work in Venezuela, South America, under the supervision of Mid Missions, returned to the states last August. Since that time she has been doing itinerate work in some sections of the country; and, on June the 12th, she went across to Cuba to help keep the work moving there while Bro. and Sister Willey are in the states for a few weeks rest and to attend this session of the National Association. Sister Yeley, however, expects to remain in Cuba, the Lord willing, and continue to assist in the work. She has good knowledge of the Spanish language which enables her to enter into the work immediately.

Your Board has been busy during the past year keeping in close touch with each other and with the work on the mission field by correspondence. We had a very splendid meeting at the school building in Nashville April 13, and 14 of this year. It was attended unanimously by the board. Several important items were transacted among which was the decision to send Miss Yeley to the field in Cuba. Bro. Melvin's report of his trip to Cuba was heard with great interest, and it was voted that he write up a constitution and by-laws for our board. Approval was given to the increasing of the Cuban promotional fund by \$50 on the month. The allowance to the Willey children was increased from \$10 each to \$15 each per month. Motion carried that we provide our missionaries with living quarters in addition to their salary, motion carried that the chairman of the Board compile and have printed a missionary phamplet for distribution throughout the bounds of our denomination or wherever opportunity affords. Miss Barnard's release from the work at the school was accepted, and she was placed again under the supervision of our Board at her former salary of \$50 per month and traveling expenses. She was also granted time for rest during the summer. Rev. Willey was appointed as Superintendent of the Free Will Baptist Mission work in Cuba. In all, we had a very splendid board meeting, and we were fortunate in having two of our missionaries, Miss Barnard and Miss Yeley, with us at this meeting.

Our board has been busy since coming here to this session of the National Association. We feel that we are very fortunate in having Bro. and Sister Willey here to meet with us, and with whom we can council concerning the work in Cuba. After conferring with them, we felt led of the Lord to present to you as a body the following recommendations:

- 1. We recommend that steps be taken immediately to establish a Bible school in Cuba.
- 2. We recommend that plans be formulated whereby funds to the amount of not less than \$2,000 may be made available at the earliest possible date for the purpose of purchasing permanent property as a school and station center. Several other items of interest have been transacted as follows: Motion carried that all our missionaries be paid the same salary for

the coming year as they have been the previous year. It was further voted that the promotional fund to Cuba be increased to the amount of \$50 on the month, which will make three hundred dollars per month. Motion carried that the chairman be authorized to make an effort to secure a missionary teacher for the work in Cuba. Our corresponding secretary was authorized to send a message of greeting to Sister Barnard owing to the fact that she is absent from this meeting and is making preparation to take her departure from us on the condition, of course, she is able to secure passage. Motion carried that the chairman of the board be deputized to make a tour of the mission field in Cuba during the coming fall. Motion carried to approve the constitution and by-laws as drawn up by Bro. Henry Melvin, and a vote of thanks was extended him for his service in that capacity.

Bro. and Sister Damon Dodd appeared before our Board and expressed their willingness to go anywhere and any time the Lord and our people might see fit.

We express our sincere thanks for the splendid co-operation we have enjoyed on the part of our people at large during the past year. We are praying the Lord will give us a far greater response this coming year, even more than we have enjoyed during the past year, in the interest of our foreign missions program.

PROPOSED CONSTITUTION AND BY-LAWS OF THE BOARD OF FOREIGN MISSIONS OF THE NATIONAL ASSOCIATION OF FREE WILL BAPTISTS IN THE U. S. A.

Preamble. Realizing that the supreme mission of the Church is to win the lost to Christ, not only in the home-land, but throughout the world; we do ordain this Constitution and By-Laws for the guidance of the Board of Foreign Missions in the prosecution of the task of worldwide evangelism.

We shall desire to make the Lord Jesus Christ known to all peoples in all lands as their Divine Saviour, to persuade them to become His disciples, and to gather these disciples into the Christian Church.

ARTICLE I .- Name and Object

The name of this organization shall be the Board of Foreign Missions of the Free Will Baptist Church in the U. S. A. Its objects are religious, philanthropic, and educational, designed to make Christ known as the Saviour of men and to diffuse more generally the blessings of Christianity in every part of the world.

ARTICLE II.—Membership

The Board of Foreign Missions of the Free Will Baptist Church in the U.S. A. shall be composed of those members elected by the National Association of Free Will Baptists in accordance with its Constitution and By-Laws.

ARTICLE III .- Authority

The Board of Foreign Missions shall have the right to regulate its own proceedings in accordance with its Constitution and By-Laws and the direction of the National Association of Free Will Baptists.

The Board of Foreign Missions shall ever be responsible and answerable for its acts to the National Association.

The Board of Foreign Missions shall have the right to conduct a promotional campaign in the interest of missions through the borders of the Church and to ask for special offerings at any time a definite need justifies the action.

The Board shall have the right to buy, acquire, receive by gift, devise, and dispose of property; to secure, appropriate, and administer funds for its work; to sue and be sued, and to elect the necessary officers among its members for the proper execution of its work.

The Board shall have full oversight of all missionary activities of the Free Will Baptist Church in every land it may propose to carry the Gospel.

The Board shall establish a standard course of training for all missionaries in accordance with the field they may propose to serve. The appointment of all missionaries shall be done by the approval of the National Association in regular session, and none shall be appointed without the recommendation of the Board.

The Board shall have the right to set the salary of the missionary in accordance with the responsibilities incurred and the particular field in which he serves.

The Board shall have the right to recommend to the National Association new fields of labor; to accept, train and maintain workers, to secure and administer funds for the support of all work under its charge.

ARTICLE IV .- Supervision of Fields

The Board shall have the right to designate a superintendent of missions in every field which the Church may carry the Gospel. It is understood that the designated Superintendent shall be furnished credentials setting forth this particular appointment and that all missionaries, both native and foreign, shall be under the direction of said Superintendent.

The Superintendent of missions in each field shall be answerable to the Board of Foreign Missions for the promotion of the work, the distribution of funds allotted and the general program of the work.

The Superintendent of Missions, shall upon the action of the Board, have the right to act with the power of attorney for the Board of Foreign Missions, in his particular field. The power of attorney covering the right to buy and sell, hold title to property, both personal and real, or mixed, the right to buy and sell in the name of the Board of Foreign Missions of the National Association of Free Will Baptist in the U. S. A.

BY-LAWS

Section 1. Any part of this Constitution and By-Laws that may conflict with the Constitution of the National Association of Free Will Baptists is hereby automatically repealed.

Section 2. This Constitution and By-Laws may be amended by a majority vote at any regular session of the National Association.

REPORT OF THE BUSINESS MANAGER, FREE WILL BAPTIST BIBLE COLLEGE TO THE 1943 SESSION OF THE FREE WILL BAPTIST NATIONAL ASSOCIATION

July 14, 1943.

My work under the present plan of operation will be recognized as educational rather than mere solicitation. Since having been ordered to take up responsibilities as business manager for the Board of Trustees for the Free Will Baptist Bible College, I have engaged in the following activities:

The first week of September, 1942, was spent in Bryan, Texas, getting printed matter in shape for my work, and lining up support for the school program in that territory. Then I moved to Nashville, according to the order of the Board of Trustees, and began dealing with matters relative to the opening of the school, according to schedule. I launched out into the field of further duties by attending some assemblies, making personal calls, holding revivals, and engaging in Christian workers' institute work. Throughout the nine months from September 1, 1942, to June 30, 1943, I have gone forth with the best wisdom God has granted in the sundry duties which have developed on me by virtue of my responsible position. I have personally visited nine different states, having made one or more return visits to six

of these. I have traveled almost enough miles to average 2,000 per month, and the approximate total of 17,000 miles. I have attended thirteen different associational assemblies, visited fifty churches, spent 50 days in revival work, twenty days in Christian workers' institute service, sent special messages to more than sixty assemblies, corresponded with individuals in nineteen states and one foreign country, and prepared a number of manuscripts for publication.

I have executed the duties placed upon me as the business conditions have commanded to the best of my ability, and have attempted to avoid overlapping any responsibilities devolving upon others. I have seen a young cause which is dearer to my heart than gold flourish and grow far beyond my fond expectations. When asked before the opening for the year, I said, "I shall consider it a success if twelve to fifteen are enrolled." The records show that eighteen were enrolled. When asked what I thought of financial support, I said, "The last thing we shall do is to borrow funds with which to operate." A steady increase in cash balance has been realized since the retirement of the indebtedness on the college property on October 13, 1942. The work has been very strenuous, but the dividends realized have far more than balanced the investments made. A very fond dream of my Christian service has borne fruit of "good measure pressed together and running over." However, we have seen a mere beginning of God's plan in this great field of endeavor. I have contended for a making-out program for this year, hence in many cases the bare needs have been enjoyed by those associated with the institution. It seems that we are in line for some very serious emergencies with our present facilities. There is need of increased facilities for male and married students by September 8, 1943. I feel that wisdom will justify the purchase of another piece of property near the college for the meeting of at least a few of our acute needs.

In the months of July and August, 1942, the following cash receipts were realized and disbursements made:

This may be understood to include all the expenses incurred in purchases, travelling, necessary installations, etc., in July and August, 1943, and salaries, freight and express, kitchen supplies, lawn mower, other necessary tools, travelling expenses, transfer of \$5,000 from the First State Bank, Bryan, Texas, to the Third National Bank, Nashville, Tennessee, and check issued in retirement of indebtedness on property of \$3,914.55. Thus, the records were cleared with the Bank of Bryan, Texas, which handled the finances for the Board of Education for the National Association and business transactions necessary through a bank were transferred to the Third

National Bank of Nashville, Tennessee for the Board of Trustees of the Free Will Baptist Bible College.

CONSTITUTION

Proposed by the National Board of Superannuation of Free Will Baptists in the United States of America

PREAMBLE

Whereas, The establishment and maintenance of a Minister's Protection Benefit has become the accepted obligation of the National Association of Free Will Baptists in the United States, and the administration of this Benefit has been assigned, by constitutional provision, to the National Board of Superannuation; therefore, be this Constitution established as a basis of government and regulation for said Superannuation Board in its management of this Benefit throughout the National Association.

ARTICLE I

This Board of Superannuation of the National Association of Free Will Baptists in the United States shall consist of the following members and their successors in office, as provided in the Constitution of said National Association: Clyde Goen, Bryan, Texas; A. D. Ivey, Jakin, Georgia; Rev. F. C. Zinn, Fredericktown, Missouri; Rev. E. J. Kilgore, Coeburn, Virginia; and E. C. Davidson, Glennville, Georgia.

ARTICLE II.

It shall be the purpose of this Board of Superannuation to promote and regulate, without profits or commissions, the writings of all-purpose life insurance on insurable Free Will Baptist ministers of the National Association on a basis of 50 per cent of the cost of maintenance being paid by the Board and 50 per cent by the insured. Insurance shall be issued only to qualified applicants and shall not be subject to cancellation, surrender, incumbrance, or conversion without the approval of the Board of Superannuation, and then, only 50 per cent of the cash or loan value shall be subject to incumbrance or surrender.

ARTICLE III.

This Board shall adhere to democratic principles in organization and management. It shall elect its own officers, choose its seat of administration, and prosecute the purpose for which it was constituted. It shall have right to sue and be sued, to receive, hold, convey, disburse, and utilize all properties, real and personal, acquired by gift, trust, bequest, purchase, or otherwise, consistent with the will of the benefactor, the approval of the National Association, and the stipulations of this Constitution.

ARTICLE IV.

A strict account of all funds received and disbursements made shall be kept in the administrative office, and detailed reports of same shall be made annually to the National Association—ad interim reports being made at the discretion of the Board. The Secretary-Treasurer shall be charged with the

duties of the administrative office and shall, at the direction of the Board or the National Association, furnish indemnity bond equal to his (her) liability.

ARTICLE V.

All salaries and expenses essential to the administration of the Minister's Protection Benefit shall be approved by the Board and paid out of the general fund, thus exempting all insured ministers of service charges.

ARTICLE VI.

This Constitution may be amended, or revised, by a two-thirds vote of the members present at any annual session of the National Association.

BY-LAWS

(Proposed by the National Board of Superannuation)

Section 1. The officers of the Board of Superannuation of the National Association of Free Will Baptists in the United States of America shall be a Chairman, an Assistant Chairman, Secretary-Treasurer, and an Executive Committee. These shall be elected at each annual meeting of the Board. If, however, the Board, for cause, shall fail to convene in a given annual session, all officers shall be retained until the next annual meeting. The offices of Secretary and Treasurer may be filled by one member of the Board of Superannuation, or by anyone whom the Board may choose. The two offices thus combined shall bear the title, "Secretary-Treasurer." The Executive Committee shall consist of the Chairman, the Secretary-Treasurer, and one additional member of the Board.

Section 2. The Chairman and Assistant Chairman shall perform the usual duties of such officers. The Secretary-Treasurer shall have charge of the work of the administrative office and shall be allowed an equitable salary for the service rendered, said salary, with all the administrative expenses, being approved by the Board. The Executive Committee shall be charged with the direction of the work of the Board of Superannuation, not otherwise provided for, between the meetings of the Board, and subject to the approval of the Board. It shall make a complete report of its work and achievements at each session of the Board. It shall have power to fill any vacancy on the Committee that may be found necessary between the meetings of the Board.

Section 3. There shall be an annual meeting of this National Board of Superannuation at such a time and place as the Board or its Executive Committee shall determine. A general report, financial and otherwise, covering all phases of the work done and promotional plans to be launched, shall be reviewed and approved for subsequent adoption by the National Association. Special meetings for business only may be called at any time by the Executive Committee or the Chairman of the Board. Any members of the Board who may not be able to attend a stated meeting in person shall represent by proxies bearing written authority, it being understood that proxy representation shall be restricted to a minority of the Board members and that such

representatives shall be approved by the majority of the members in attendance at the particular meeting of the Board of Superannuation to which said proxies were appointed. A majority of the duly qualified members of this Board at any meeting shall constitute a quorum.

Section 4. The administration of the Minister's Protection Benefit shall be impartially and equitably regulated. A survey of the ministry shall be made periodically for the purpose of maintaining adequate information regarding the status of Free Will Baptist ministers. An accurate record of each insurance contract issued, together with the cost of maintenance, shall be kept in the Board's home office. All working plans, including an agreement with a desirable insurance company, together with essential advertising matter, and application forms shall be printed for distribution; and this Benefit shall be offered to ministers as a bonified, Christian superannuation service.

Section 5. These By-Laws may be amended by a two-thirds vote of the members present at any meeting of the National Association.

CONSTITUTION

Proposed for Free Will Baptist Superannuation Boards of State or District Associations

PREAMBLE

Whereas, The Superannuation of ministers of the Free Will Baptist denomination is now accepted as a mutual obligation incumbent upon both ministers and laymen; and the National Association of Free Will Baptists in the United States, through its Board of Superannuation, has established a Minister's Protection Benefit in the form of all-purpose life insurance for eligible ministers; and said National Association now recommends that its affiliated state associations (and district associations within states which have no state association) inaugurate a system of Benevolent Superannuation for retired ministers; therefore, be this Constitution established as a basis of cooperation with the Minister's Protection Benefit administered by the National Board of Superannuation, and as a means of regulating and executing an adequate system of Benevolent Superannuation for Free Will Baptist ministers affiliated with this

ARTICLE I.

This Board of Superannuation of the State Association of Free Will Baptists in North Carolina shall consist of the following members and their successors in office, as provided in the Constitution of said State Association: M. L. Johnson, F. A. Rivenbark, W. A. Hales, W. L. Moretz, C. F. Bowen, and Mrs. M. A. Woodard.

ARTICLE II.

It shall be the purpose of this Board to organize and unify all superanhuation work throughout this State Association. It shall encourage the abolition of duplicated district boards; and, as a central agency charged with the administration of all Benevolent Superannuation service within the Association, seek the commendation and authoritative representation of all Free Will Baptist organizations engaged in superannuation work in the State. It shall support and promote the patronage of the Minister's Protection Benefit of the National Board of Superannuation and strive through educational means and judicious management to make a Benevolent Superannuation service available to every retired Free Will Minister affiliated with this North Carolina State Association.

ARTICLE III.

This Board shall adhere to democratic principles in organization and management. It shall elect its own officers, choose its seat of administration, and prosecute the purpose for which it was constituted. It shall have right to sue and be sued, to receive, hold, convey, disburse, and utilize all properties, real and personal, acquired by gift, trust, bequest, purchase, or otherwise, consistent with the will of the benefactor, the approval of this State Association, and the stipulations of this Constitution.

ARTICLE IV.

A strict account of all funds received and disbursed shall be kept in the administrative office and reports of same shall be made monthly through denominational papers and annually to this State Association. There shall be a monthly allocation and payment made of 25 per cent of all general funds received, without deductions for expense, to the National Board of Superannuation for the maintenance of the Minister's Protection Benefit. Benevolent gifts and pensions shall be paid periodically on a merit basis to retired and disabled Free Will Baptist ministers of the Association; also temporary loans for personal medical, hospital, and surgical expenses shall be allowed at the discretion of the Board on adequate security with interest at the rate of 1 per cent per annum. The Chairman of the Board (who may be also elected as Treasurer) shall be charged with the duties of the administrative office and shall, at the direction of the Board or the State Association, furnish indemnity bond equal to his (her) liability.

ARTICLE V.

All salaries and expenses deemed essential to the successful administration of this State program of Benevolent Superannuation shall be paid out of the general treasury of this State Board of Superannuation.

ARTICLE VI.

This Constitution may be amended, or revised, by a two-thirds vote of the members present at any annual session of this North Carolina State Association, provided that said amendment or revision has been previously approved by the National Association.

(Recommended by the Association)

REPORT OF THE BOARD OF PUBLICATIONS AND LITERATURE

To the National Association or General Board of the Association of Free Will Baptist of the United States of America, when convened with the East Nashville Free Will Baptist Church, Nashville, Tennessee, July 13-15, 1943.

With a deep sense of responsibility, and an appreciation for the opportunity of serving, we present to you the first annual report of the Board of Publication.

We met at the close of the 1942 session in the city of Columbus, Miss., and organized by electing J. C. Griffin, Chairman; and Rev. Mark Lewis, of St. Louis, Mo., Secretary.

At the time of our organization Mrs. Agnes Frazier appeared before us in regards to the publication of the Year Book of Programs for the Woman's Auxiliary and we instructed her to go ahead with her plans for the publication of the lessons for 1942-43. Also the following recommendations were offered and accepted by the board.

"I. We recommend that this body request one lesson Quarterly on the Standard F. W. B. S. S. System to appear in the Quarterlies each Quarter for one year. The lesson to be prepared by our National Director of Literature. (Rev. L. R. Ennis).

II. We petition the F. W. B. Press to print the Standard of efficiency on the inside of the front cover of the Quarterlies, and the Three Year Program of progress on the inside of the back cover.

III. We petition the Board of Publication and Literature to supervise and finance the publication of a Sunday School text book. The manuscript to be furnished by W. E. Coville. And the profits from the sale of books to be divided 50-50 between the Board and the National Sunday School Convention." (copy).

As to the aforesaid recommendations we ran into difficulty. We were informed that the "Franchise" for sending the Quarterlies through the mails would have to be changed if these additions were made to the Quarterlies. As to the Third recommendation if anything was ever done the Chairman of the Board knows nothing of the said work. We certainly have not had the money to finance such a work, and we have heard of no profits.

The Board being widely located over the National field, has failed to have a meeting since the few minutes at the close of the session of 1942, and therefore we have had no opportunity to talk matters over and arrange plans for the future. However, the Chairman of the Board has talked at length with the National Executive Secretary and we are offering a set of By-laws for the governing of the activities of the Board, which are to be given in connection with our report.

I have communicated with Rev. John B. Rollins, Editor of the Gem and with Mr. C. K. Dunn, Sr., Manager of the Free Will Baptist Press and find that both of these gentlemen are anxious and ready to cooperate with the Board of Publications and Literature in whatever constructive methods that we may set forth for the work.

We find that both institutions are in shape to print and publish literature as may be desired in keeping with justice to all concerned.

"The Free Will Baptist Gem is owned and controlled by the Missouri State Association of Free Will Baptist" and "is free" from all debt including the building and all equipment." "It has a valuation of \$10,000" and "has served fifteen years in its present capacity." Brother Rollins, states, "We have a modern equipment and are capable of much greater service." "While our institution is State owned, we are in full co-operation with the National Association and serve Free Will Baptist throughout the many states without respect to any and with fairness to all."

"The capacity of our services is the publication of the Gem monthly; the publication of booklets, books, and minutes of the various associations" states Bro. Rollins.

The Free Will Baptist Press is owned by the various conferences, associations, district union, or quarterly meetings, churches and a few individuals of North Carolina with a few shares purchased by one of the Associations in Tennessee, and is chartered as a "Non-profit sharing institution" with stipulations "that all surplus beyond that needed for the safeguard and the enlargement of the institution shall be allocated to religious work in the Free Will Baptist church." Thus the institution has distributed to the Orphanage in North Carolina and to other causes when invited or requested, whenever its capacity to do so would permit, and it has recently been assured the Chairman of this Board, that an "allocation would be made to the National Association, or to the Board of Publication and Literature, in the near future." This assurance sounds good since the present Board has had no funds to do any work.

The Free Will Baptist Press is valued at \$35,000.00 in its new home, however, there is a small amount of debt, but sufficient funds to meet all obligations.

The business has grown in ten years from a \$9,668.00 to \$23,174.00 income, or an increase of \$13,506.00, however the expense has gone in this period of ten years from \$8,794.00 to \$19,408.00 or an increase of \$10,613.00 in round numbers, which shows a growth in the institution and also the denomination at large. This institution publishes and sells the Advanced. Senior, Junior, Intermediate and Primary Quarterlies, together with filling orders for the Standard of Efficiency, S. S. Records as prescribed and published under the direction of the National Sunday School Convention of Free Will Baptist. Also it carries a large stock of Bibles, religious books and periodicals published by the leading presses of the United States, and last but not least, publishes the Free Will Baptist, a weekly magazine, true to its name.

We recommend that every Free Will Baptist subscribe to both the Free Will Baptist Gem, and the Free Will Baptist, and keep posted, as well as in the fellowship of the brotherhood throughout the world.

We, herewith, present the proposed By-laws for the government of this Board, thanking you for your patience thus far, and praying that the By-laws may be accepted and put into action, and that when the next annual

session of this National Association shall have convened that it will find us much advanced in the work of our Lord.

BY-LAWS

Proposed by the National Board of Publications and Literature

Section 1. The officers of the Board of Publications and Literature of the National Association of Free Will Baptists in the United States shall be a Chairman, an Assistant Chairman, a Secretary-Treasurer, and an Executive Committee. These officers shall be elected from among the members of the Board at each annual meeting. Should, however, the Board, for cause, fail to convene in a given annual session, all officers shall be retained until the next annual meeting. The Executive Committee shall consist of the Chairman, the Assistant Chairman, and one additional member of the Board.

Section 2. The Chairman and Assistant Chairman shall perform the usual duties of such officers. The Secretary-Treasurer shall have charge of the administrative office. He shall keep an accurate record of all business proceedings, contracts and agreements executed, funds received and disbursed, and expenses incurred. He shall promote, through correspondence, Writing to church papers, circular advertising, the operation of book stands at general meetings, and any other worthy means, the use of periodicals, tracts, pamphlets, uniform and graded literature, books, and Bibles as a service to those concerned for the enrichment of their personal lives the ad-Vancement of the Church of Christ and the Free Will Baptist denomination. The Executive Committee shall have authority to manage and direct the Work of the Board between its regular sessions, subject to the approval of the Board. It shall make a complete report of its accomplishments at each meeting of the Board and shall render full cooperation to the administrative office. It shall fill any vacancies on the Committee that may be found necessary between the meetings of the Board.

Section 3. There shall be an annual meeting of this Board of Publications and Literature at a time and place determined by the Board or its Executive Committee. A complete report, covering all phases of work done and plans for advancement, shall be examined and approved for subsequent adoption by the National Association. Special meetings for business only be called at any time by the Executive Committee, or the Chairman of the Board. Absent members from stated meetings of the Board shall represent by proxies bearing written authority. It is provided, however, that proxy representation shall be restricted to a minority of the Board members, and that such representatives shall be approved by a majority of the members present at the particular meeting of the Board to which said proxies

were appointed. A majority of the duly qualified members of this Board shall constitute a quorum.

Section 4. The work of this Board shall embrace the publication, distribution, and sale of Christian literature distinctly designed, or created, for the advancement of the general program of the National Association and its auxiliaries. It is provided, however, that literature and periodicals now published by Free Will Baptist institutions shall not be competitively duplicated, and that contracts which provide an equitable basis of cooperation shall be worked out with the Free Will Baptist Press, of Ayden, North Carolina, and the Free Will Baptist Gem, of Monett, Missouri.

Section 5. This Board shall have authority to employ authors, editors, stenographers, and typists; negotiate and execute contracts, appraise and commend manuscripts, advertise and sell its publications, allocate and disburse funds, receive gifts and bequests, and perform all the functions for which it was constituted.

Section 6. All salaries and expenses essential to the administration of a worthy literature service among Free Will Baptists and mankind shall be authorized by the Board and paid out of its general treasury.

Section 7. These By-Laws may be amended, or revised, by a two-thirds vote of the members present at any annual session of the National Association.

TEMPERANCE REPORT

We, your committee on Temperance, respectfully submit the following report and recommendations:

Intoxicating liquors have no place in the life or home of Christians. In recognition of this truth we urgently recommend that all members of the F. W. B. faith prohibit the use of intoxicants in their homes by visitors, boarders or other transients.

We protest against the sale of beer and other intoxicants in our Military training camp and adjacent territory. In addition to the protest we do here by petition the National Association of Free Will Baptist to adopt this protest as a National movement, and resent the same to the proper military authorities in Washington, D. C.,

We believe in education and are interested in youth, therefore, we suggest that special studies of the effects of alcohol on the physical, mental and spiritual man be included as a part of the curriculum of our F. W. B. School. We urge that all ladies of our association enlist and become active workers in the woman's Christian Temperance Union.

REPORT OF DIRECTOR OF EDUCATION AND ORGANIZATION

To the National Sunday School Convention,
Free Will Baptist Church,
1943 Session, Nashville, Tennessee.

Greetings

That which I have to report as Director of Organization for the past year, grieves my own heart. I report that there have been calls from far and near for the services that I have been supposed to render, and which I have wanted to render, showing that there are great and glorious possibilities for development of organizations, and for the education and training of Workers in our Sunday Schools. This has brought a glow of joy to my heart, but to turn that joy to grief has been the ever present reality of the truth that I have not been able to do but very little to meet the challenge of this great need. Owing to travel conditions, funds not available for expensive trips, no gasoline for using our own car for travel beyond the needs of my husband's pastoral responsibilities, the best that I have been able to do has been to try to answer all letters, give the best advice of which I am capable by correspondence, endeavor, when possible, to refer inquirers to persons closer by who might help, pour out my soul in prayer, and shed tears of regret that I could not do more. I have had the privilege, and found it possible, to work some in my own state in endeavoring to help develop Daily Vacation Bible Schools, and other institute work in the interest of S. S. and Youth education, but since this work has been done under the auspices of, and with the support of, our state organizations, detail reports are in order to be made to those organizations. Under present conditions, I feel that the success of our general Sunday School program is dependent more upon trying to co-ordinate in so far as possible our program with the various state and district programs, using the district and state workers as our promotion agents, rather than trying to maintain a separate field staff. We do badly need National Workers in the field, but unless they can have some support and backing, and unless some of the travel difficulties can be overcome, there 18 very little that they can do.

I appreciate the co-operation, encouragement, and confidence that has been given to me, and renew my pledge of interest and devotion to our

National S. S. Program—a ppledge that is sustained more by the longing of my heart than by the record that I have made.

REPORT OF BUSINESS RESOLUTIONS COMMITTEE

The Resolutions Committee of the National Sunday School Convention of Free Will Baptists submits the following report:

1. Whereas, there is a definite need for funds sufficient to carry on the activities of this body from year to year, and whereas, there is no definite system for raising such funds, therefore be it resolved that a new paragraph be inserted under Article 4 of Section 1 of the Standard of Efficiency for Free Will Baptist Sunday Schools to read as follows:

"Each Sunday School shall pay an amount equal to five percent (5%) of all regular Sunday School Offerings each quarter for the purpose of supporting the promotional work of the National Sunday School Convention. These funds shall be sent from the Local Sunday School to the Treasurer of the District Convention to the Treasurer of the State Convention, and thence to the Treasurer of the National Sunday School Convention. Where there is no District, or State Convention, this amount shall be sent directly to the Treasurer of the National Sunday School Convention.

- 2. Realizing the need of the laity in the propagation of the National S. Program now in hand, we recommend that the Ministers strive to stimulate more interest on the part of the superintendents, teachers and officers in the District, State, and National Convention. We further recommend that more of the laity be used in programs of these conventions, hence, stimulating more interest.
- 3. Whereas, we find that there is a lack of uniformity in form 13 and form 10 of the National Free Will Baptist Sunday School Convention Blanks we recommend that this matter be called to the attention of the Director of Records and Reports.

PROCEEDINGS

The National Auxiliary Convention met at East Nashville Free Will Baptist Church, Monday, July 12th, 1943, in the evening. The devotional service was conducted by Mrs. L. E. Ballard, of Greenville, North Carolina, in the absence of Mrs. Raymond Sasser, who was scheduled to lead. Mrs. Ballard used as her theme, "Ye are my Witnesses."

BUSINESS SESSION

The first business was that of enrollment of Delegates to the Convention, after which the Nominating Committee were elected as follows: Miss Tommie Franklin, of Texas; Mrs. Jewel Campbell, Missouri; Mrs. E. C. Davidson, Georgia; Mrs. L. O. Burroughs, Tennessee; Mrs. N. E. Harris, North Carolina; Mrs. J. B. Bloss, Alabama; Mrs. Ethel Robbins, Virginia; Mrs. Eula Cichols, West Virginia; Miss Gladys Baxter, Mississippi; Miss Opal Hiltibedal, Illinois.

The address of welcome was given by Mrs. Henry Melvin, and was very cordial throughout, ending with the words, "The Love of Christ constraineth me to bid you a heart welcome to East Nashville Church."

The response was given by Mrs. McAdams, in a few timely and well chosen words.

A musical selection, "Awake, Put on Thy Strength," was rendered by a mixed chorus from the Bible College.

At this time, Mrs. J. C. Griffin, President, in a few well selected words presented Rev. Eunice Edwards, of St. Louis, Mo., who was designated to bring the evening message. The business session was called off for devotional service and a message by Mrs. Thomas Willey. "Send the Light," was sung, after which Rev. L. R. Ennis led in prayer.

Mrs. Willey read from John 4: 34, "Jesus saith unto them, My meat is to do the will of Him that sent me, and to finish His work."

She gave encouraging reports from the Mission field in Cuba, portraying vividly a description of life in Cuba, brought greetings from Christian Natives to their brethren of the North, and of the great opportunities for more missionary activities, if only they could secure other helpers from the Home land.

She gave some of her own experiences, many of them coupled with hardships, self-denial, and that they were wearing and bearing the scars for Jesus sake. She also earnestly and tenderly solicited the prayers of this Convention, in holding them up to the throne of grace, that they may always abound in this work in the Master's vineyard. She brought greetings from Miss Bessie Yeley, former Missionary to South America, but now in Cuba, while she and Mr. Willey are in the States. She said the people in Cuba are a patient people, and that their social standard is very high morally, and that our American way of life would shock them amazingly and that

even our Church life, from a general standpoint, would be discouraging to them. She said that the Gospel of Christ has not been handed down to them, through Christian generations, that about forty years will take in about all they know of the religion of Jesus Christ. Help must be given, she said, if we are to exercise our opportunity of saving Cuba for God, and in so doing, we hoped to make it a gate-way into South America. Mrs. Willey held her audience almost spellbound, as she depicted the many angles of life in Cuba; and of their work and plans for the future.

An offering was taken, and the convention adjourned with prayer untils the afternoon session.

With a spirit of obedience to the Great Commission Fre Will Baptists are making a close relation between its forces of evangelist and education.

Poor equipment is the plea that most of us use when seeking to escap some duty God lays upon us. Moses, with no weapons, no chariots, no se mies, with which to meet the might of Pharaoh, felt justified in refusing undertake the liberation of his people. To Moses it seemed a hopeless tass but in the narrative found in Exodus 4, we realize, if we read it diligente that God was teaching Moses some lessons that we also need to learn today First, when there is a divine call, ways to prepare for and to perform service are at hand.
