PROCEEDINGS

TUESDAY EVENING

Mr. I. L. Stanley, Tennessee, associational music director, led the large congregation in singing "Blessed Be The Name of The Lord" and "Jesus Saves." The Scripture lesson was read by Rev. Ronald C. Creech. After Mr. Creech had led us in prayer we sang "Lift Him Up" and the Chorus "I'm On the Upward Trail."

The clerk of the National Association called the session to order and introduced the assistant moderator, Rev. Homer E. Willis, Hazel Park, Michigan, and the moderator, Rev. N. Bruce Barrow, Snow Hill, North Carolina.

Brother Barrow called to our attention that the work of the Association was to prepare men to live; that to reach those who need to prepare to live, we, as individuals, must say, "I must decrease, but He must increase."

An announcement was made concerning the meeting of state presidents or moderators with the moderator of the National Association for a discussion on civil defense. Two committees were appointed at this time. They were the Committee on Committees, and the Committee on Location of the National Meetings for 1952. (See the section of the minutes reserved for committees.)

Motion to adopt the program with the changes recommended by the program committee (see the program in another section of the minutes) as the order of business for this session. Motion carried.

The Bible College Chorus sang the hymn, "Master, The Tempest Is Raging." They were directed by Mrs. Sterling Sawyer, music instructor at the college.

Rev. F. B. Cherry, North Carolina, was introduced by the moderator to bring the keynote message, "What Price Evangelism in Our Present World Crisis." Brother Cherry gave a very timely message using Ezek. 16:49 as a text verse. He outlined his message in the following way: (1) The Present Crisis. (2) The Possibility of Evangelism. (3) The Price of Evangelism. He finished his message with the challenge that we can have the kind of evangelistic program we are willing to pay for; and the payments are: Submission to the will of Christ; Sacrifice for the cause of Christ; Supplication in His name; and Service for His glory.

The service began with the congregation singing hymns and choruses.

REPORT OF RESOLUTIONS COMMITTEE

Partial Report of Resolutions Committee:

Realizing the need of a broader basis of representation in the National Association of Free Will Baptists so that reports of our work and conferences may be disseminated more fully to our people,

Be it resolved, therefore, that the following constitutional changes be made in Article IV, Representation; and Article V, Section 1, Finance:

Article IV

Representation—Representation in the National Association is to be by states and churches. Each state association shall be entitled to five delegates to be elected from the laity, regardless of the number of district associations in the state; but in addition to the five delegates, each church within the bounds of the state association shall be entitled to one delegate. Churches in the states which have no state association, and those whose state organizations may not be affiliated with this body, may elect and send their delegates directly to the National Association.

Article V

Finance—Each state association representing in this body shall send the sum of \$25.00. Churches representing in this body shall send the sum of \$5.00 with their reports.

REPORT OF THE FOREIGN MISSION BOARD

National Ass'n of Free Will Baptists
Nashville, Tennessee.

Greetings:

We the Foreign Mission Board of the National Association of Free Will Baptists are grateful indeed for the blessings of the Lord upon this department of our church since our last Annual Convention. Truly, "The Lord hath done great things for us whereof we are glad."

During the first part of the month of October 1950, a Missionary Conference was held in our Bible College in Nashville. This Conference was attended by many of our preachers and pastors from the various states. We were especially glad to have in attendance the majority of the state directors who showed an intense interest in the Foreign Mission work, and seemed eager to promote the same in their state. The state directors and itinerate workers have done a magnificent job this year toward making this report possible.

The Missionary Conference in October was highlighted by the presence and messages of Miss Laura Bell Barnard, on furlough from India. Also, the open forums held in the afternoon proved very helpful to the state directors and itinerate workers.

It was at this Conference that the Missionary Film, "Letter to Melitino" made its official 'Debut' and was received with commendations. Since that time, "Letter to Melitino" has been shown in scores of churches in portraying the message of salvation through Free Will Baptist Missionaries in Cuba. As of this date seven (7) copies of the film have been purchased and being used for the glory of Him who gave His life a ransom that men everywhere might have eternal life.

It was also at the special called board meeting, held during this Missionary Conference that Rev. Winford Davis and Rev. Bert F. Rogers officially presented their resignation to the Foreign Mission Board. The Board accepted their resignation and officers were elected to the board as follows:

Rev. Rashie Kennedy_____Chairman Rev. J. W. Alford_____Vice-Chairman

Rev. Raymond Riggs was elected Secretary-Treasurer of the board with the understand that he was to serve as Promotional Secretary, and that he be authorized to employ such assistance as he thinks necessary, the cost not to exceed \$75.00 per month.

Rev. Winford Davis closed out and transferred his treasurer's books on October 31st and the Foreign Mission office was moved to 242 Victor Ave., Highland Park, Michigan as of November 1, 1950. As we entered into our new and inexperienced duties, we confess we were somewhat filled with anxiety. There was a deficit of over seven thousand dollars (\$7,000.00) and some of our Missionaries had not been paid their allotment for three months. We do not believe that this condition should be charged to any one person, but to every Free Will Baptist in America.

Immediately, we began to sound the Macedonian call, and to flood our people with literature containing figures and facts. Immediately came the response and in three and one-half months, God had answered prayer, and our Missionaries had received their salaries and all bills were paid. Since that time our Missionary offerings have been coming in with greater regularity than ever before. Surely the time has come when we will no longer be "spasmodic" in our support to this all important cause but will make it a part of our regular church budget. It has been encouraging to note the several churches who have assumed partial, and in some cases, whole support of a missionary. It is also edifying to note those who have pledged themselves specific amounts every month. Then too, the response to special offerings has been most gratifying.

Not only do we praise God for His blessings in this department at home, but most of all for the wonderful way He has blessed on the Foreign Field proper.

India-

During Miss Barnard's furlough the work in South India was maintained by native help and under the supervision of our other American Personnel. Of course they were anxious for her to return. On June 12, 1951, Miss Laura Bell Barnard set said for her third term as a Missionary to India. No doubt this date was arranged providentially, as the original sailing date was to have been earlier, but was postponed, thus giving time for Miss Volena Wilson's visa to come through and accompany Miss Barnard to India. Also on the day after their ship sailed a strike was called and no other ships sailed for many days. Dozens of Missionaries were stranded in New York, but somehow God permitted our Missionaries to be on their way. We are thankful to announce that at least we have sent out one new Missionary this year in the person of Miss Volena Wilson of Marion, N. C. These Christian Missionaries are scheduled to arrive in India some time during the sitting of this National Association. Please remember them in prayer.

Rev. and Mrs. Paul Woolsey and Rev. and Mrs. Dan Cronk report progress in their work in North India, with several converts this year and bap-

tisms. Word recently reached us that Brother Cronk has been ill but was much improved. We ask every one to please pray for the physical needs of our missionaries in India.

Through the gifts of the fine folk from the state of North Carolina, a new Chevrolet car has been ordered for our missonaries in India and we are praying that delivery may be made soon.

Upon the request of Miss Barnard and the other Missionaries in India the board has authorized the purchase of property in India ,the price not to exceed \$7,000.00. This property is badly needed in South India and we ask our people to make this a matter of definite prayer. Not only pray-butgive!

Cuba-

The work in Cuba continues to grow. Brother and Sister Willey report a wonderful year in the school. Rev. Rashie Kennedy, our Foreign Mission Board Chairman attended the graduation service and National Convention in Cuba this year and reports a wonderful time, with marked improvements and evident accomplishments.

Rev. Willey, our Missions director in Cuba, spent a few weeks in the states this year in itinerate work which proved very fruitful.

Plans are under way by the Association of Free Will Baptists in Cuba to underwrte the support of future Native Workers. We feel this is definitely a step toward a self-supporting church in Cuba. Our present American staff in Cuba is as follows:

Our Missionary family in Cuba increased this year by the birth of Jo Ellen Wilfong, daughter of Rev. and Mrs. Robert Wilfong.

Africa-

We have a very fine Free Will Baptist Missionary in Africa, working under the South Africa General Mission, in the person of Mrs. Harold Stevens. Some very fine reports have come in concerning her work. We are grateful to those who support her through our board.

Following are excerpts from the minutes of the regular annual meeting of the Foreign Mission Board held in Nashville, Tennessee, April 16, 1951:

- 1.—Brother Riggs reported his meeting with the E. F. M. A. in Chicago on April 10-12, 1951 and cheered and encouraged us with the report of their helpfulness.
 - 2.—On motion that we continue our membership with the E. F. M. A.
- 3.—On motion we recommend that Section 10 of the By-Laws of the Foreign Mission Board be amended to read as follows:

"The Corporation shall have a Corporate seal."

4.—It was mutually agreed that we request the State Convention, Execu-

tive Committee, or State Mission Board, of the various states to suggest and certify to us, as soon as possible, the individuals we could appoint and use as Directors for the Foreign Mission Program in their respective states.

- 5.—On motion that Bros. Riggs and L. C. Johnson be instructed and authorized to set the date and arrange a program for a Missionary Conference to be held during the month of October, 1951, preferably during the first week of the month.
- 6. On motion the items of equipment belonging to the Board, remaining at Monett, Missouri, be placed in the hands of Brother Rggs for disposition; he being authorized to move any item to the office at Detroit for the conduct of the work of the office there.
- 7.—It was agreed that we make a Child's allowance of \$15.00 a month for the Wilfong baby in Cuba, this being retroactive to the birth of the child.
- 8.—Upon the request of our Missionaries in Cuba and after a visit to the field by the Chairman, Rev. Rashie Kennedy, we recommend a budget of \$2,-250.00 per month for our mission field in Cuba for the next fiscal year.
- 9.—Upon the appointment of a new missionary to our staff in India, we recommend a budget of \$1,350.00 per month for our mission field in India for the next fiscal year.
- 10.—We recommend a minimum of \$60,000.00 for our overall budget for the next fiscal year with the quota of each state as follows:

Commendation-

We would like to commend the National Home Mission Board for their renewed effort during the past year and for the correlated plan whereby Foreign Missionary Candidates may work through the National Home Mission Board for more practical experience before final approval and appointment for foreign service.

Channels for Expansion-

Even though Free Will Baptists only have missionaries in three foreign countries at this time, through our affiliation with Evangelical Foreign Mission Association, (EFMA) we have access to channels whereby we may send missionaries to almost every country in the world where the mission doors are still open. This is particularly true of the Far East. We have a few applications pending, so while others are planning and preparing to go, and we see the harvest so white, let us "pray the Lord of the harvest, that He would send forth laborers into His harvest."

New Board Members:

Since October of 1950 your Foreign Mission Board has functioned with only three members. We have felt very keenly our responsibility, while on the other hand we have been conscious of your prayers. We have looked forward to this National Convention when you will select two other men to aid us in this all important work. We realize that "in Counsel, there is Wisdom."

Office Staff

Upon moving the Foreign Mission Office to Detroit, we secured the services of Mrs. Hubert Sloan as bookkeeper. She works full time for the Foreign Mission Board pays her a salary of \$75.00 per month. Her services are invaluable and we appreciate it so much. As the duties of the Promotionnal Secretary-Treasurer requires much time and effort, the board agreed to pay \$50.00 per month for his services, as of March 1, 1951.

Missionary Films

These are days when the Lord is blessing the efforts of those who use Visual Aids to present the message of salvation. This has been evident in the use of our own Missionary film "Letter to Melitino." We are glad to report that the entire cost of the production of this film has been paid except \$500.00. The Lord willing this will be paid in the next three months. Within the next year we hope to produce another film of our Missionary work in India. Please add this project to your prayer list. The National Home Mission Board met in called session Friday, February 23, 1951, at Hector, Arkansas. Members present were Chairman, Rev. J. B. Bloss, Clerk-Treasurer Rev. Harry E. Staires, and members, Revs. Willard Day and George McLain. Rev. Paul Pursell was elected to serve as proxy for Rev. James A. Evans. Others present at the meeting were Revs. Damon Dodd and J. D. Coffman.

Services opened under the direction of the Chairman, Rev. J. B. Bloss. Song Service was conducted by Rev. D. C. Dodd. Prayer was offered by Rev. Paul Pursell. Rev. Willard Day delivered a message on the subject "My Church", using as a text Matt. 16:18. One soul rededicated her life to the service of God.

- (2) Motion carried that Rev. Willard C. Day serve as regional director for the Central District composed of Kansas, Missouri, Illinois, Arkansas, Texas, Louisiana, and Oklahoma.
- (3) Motion carried that Rev. Luther Gibson serve as regional director for the Southeastern District composed of Mississippi, Alabama, South Carolina, and Georgia.
- (4) Motion carried that Rev. George McLain serve as regional director of the Western District composed of Arizona, New Mexico, and California.
- (4) Motion carried that Rev. George McLain serve as regional director of the Western District composed of Arizona, New Mexico and California.
- (5) Motion carried that Rev. Willard Day be empowered to have fifteen hundred cards printed for the reports for the simultaneous revivals for month of April.
- (6) Motion carried to sponsor two new places for revivals and the establishment of new churches. Conday, Arkansas and Florence, South Carolina, were accepted.
- (7) Motion carried that Rev. George McLain investigate the possibility of revivals in Albuquerque and Las Vegas, New Mexico.

- (9) Motion carried to employ two college students for revival work in the towns of Lewisburg, Fayetteville, and Pulaski, Tennessee, at a salary of \$75.00 per week.
- (10) Motion carried to receive applications and establish a waiting list for home mission workers, rules are to be compiled by Rev. Harry E. Staires and Rev. Willard C. Day.
- (11) Motion carried that Rev. George McLain go to Cuba, Illinois, and investigate the two independent Free Will Baptist Churches for the purpose of bringing them into cooperation with the National Association of Free Will Baptist.
- (12) Motion carried to share the expense of Rev. Damon C. Dodd in the extension program to New York, Pennsylvania, New Hampshire, Vermont and Maine.
- (13) Motion carried to ask the National Association for the sponsorship of the church signs.
- (14) Motion carried that Rev. J. B. Bloss and Rev. W. S. Mooneyham work out a plan on the publishing of a special National Home Mission issue for the month of April for the simultaneous revivals.
- (15) Motion carried to give the Free Will Baptist Church of Hector, Arkansas, and their good pastor, Rev. J. B. Coffman, a vote of thanks for their splendid hospitality shown during the board meeting.
 - (16) Motion to adjourn. Prayer by Rev. Willard C. Day.

REPORT OF NATIONAL HOME MISSION BOARD

The National Home Mission Board is evangelizing now. To evangelize is to preach the Gospel and to convert.

Paul says, (Roms. 1:16) "For I am not ashamed of the Gospel of Christ for it is the power of God unto salvation to every one that believeth; to the Jew first, and also to the Greek."

The apostles were to begin at home.

"And that repentance and remission of sins should be preached in His name, among all nations, beginning at Jerusalem." Lu. 24:47.

This is why the Home Mission Board is trying to enlarge our Home Mission program; our aim and our goal is a Free Will Baptist Church in every town in every state.

Christ says, "Lift up your eyes, and look on the fields, for they are white already unto harvest." Jno. 4:34. There are three points in this verse: First, Vision ("Lift up your eyes—")—without a vision people perish. Second, Compassion—("look on the fields—")—look on the towns that are crying for a Free Will Baptist Church. Third, Commission—Go ye—("... white unto harvest ..."). One of the last commands of Christ was

-"Go." Mark 16:15. The word "missions" comes from the Latin word "mitto" meaning "I send." Will you go? Will you help to send workers to the home mission fields?

In our National Association at Richmond, California, we voted to set aside the month of April as simultaneous revival month. We have received 37 reports on these revivals with a total of 412 professions, 275 additions, and 87 baptisms. The failure of sending in the simultaneous revival reports is the reason our report is so small.

The Home Mission Board has sponsored seven (7) revival meetings this associational year. The first was among the Cherokee Indians of Western North Carolina. The second was at Norman, Oklahoma. This resulted in the organization of a Free Will Baptist church with 38 professions, 37 charter members, and a Sunday School of 75 members. They are supporting a full-time pastor, have purchased property, and a building program is now well under way. Their property when completed will be worth \$25,000.00.

The third, was conducted at Prague, Oklahoma. This resulted in the organization of a Free Will Baptist church with 21 charter members, a Sunday School of 45 members. They are supporting a full-time work and have purchased a church and property worth \$8,000,00.

The Fourth was at Florence, South Carolina. A Free Will Baptist church with 52 charter members, and a Sunday School enrollment of 87 members resulted from this revival. They are now supporting a full-time work and plans are being made to purchase property.

The Fifth was conducted at Lewisburg, Tennessee, and resulted in the organizing of a Free Will Baptist church with 13 charter members and 17 enrolled in Sunday School. They are now supporting a full-time work and have rented a church building at \$40.00 per month.

The Sixth conducted was at Springfield, Tennessee with the following results: A Free Will Baptist Church was organized with 24 charter members, 21 professions, and a Sunday School enrollment of 32. They are supporting a full time work and have purchased property.

The Seventh was conducted at Blanchard, Oklahoma. This resulted in the organizing of a Free Will Baptist church with 27 charter members and a Sunday School enrollment of 55. They are supporting a full-time work and have property valued at \$20,000.00.

Rev. J. L. Waltman, State Director of California, reports that California has organized 6 churches this Associational year at: Garden Grove, North Ridge, Rockinfield, Stocton, Huntington, and Livingston, California.

The Board has received applications from twenty workers who desire to work on the Home Mission fields.

Leaguers from nineteen states and Cuba converged upon the campus of our Free Will Baptist Bible College, 3609 Richland Avenue, Nashville, Tennessee, July 3-5, to mark another milestone in the history of our youth. Actually, only 436 registered for the fourth nationwide league conference, but in reality more than 800 were in attendance during the session, which many said was the best one yet.

Outstanding among the features of this conference were:

Simplicity. This conference was stripped of all complexities and a simple program was followed, providing only four major sections in the afternoons instead of the usual 20 or more.

Evangelism. Following the keynote, "The Hour Has Come," evangelism was stressed throughout the entire meeting. A deep spirit of consecration prevailed in each session, culminating in more than 100 dedications and conversions. The young people were constantly aware that the presence of the Holy Spirit endowed all that was said and done.

Messages. The highlights of the conference were the messages brought by young ministers. These preachers and ministerial students were chosen for the task of stirring the large assemblies to action. No one could have done a greater job than did these. The opening message was brought by Mrs. T. H. Willey, missionary to Cuba.

Music. As always, the music of the conference was superb. There was an abundance of special music each day. An outstanding musical feature was the Cumberland League Chorus led by Mrs. Sterling Sawyer, head of

our college music department ,and composed of leaguers from Middle Tennessee. Outstanding also was the college male quartet.

REPORT OF BOARD OF PUBLICATIONS AND LITERATURE

Greetings:

Brother Moderator:

We are offering the following report, which as usual is not very lengthy.

We had our annual Board meeting while the Bible Conference was held at the Bible College in April at which time several matters pertaining to literature were considered among which was the "Uniform Bible Lessons" series of lessons for our Sunday School literature. A resolution coming from the Chairman of the Sunday School Board to us in the way of request regarding this matter was acted upon favorably and passed on to the Board of Directors; and is to be requested of the Free Will Baptist Press in the preparation of the Sunday School lessons, which request gives the time for changing "as quickly as possible."

Other negotiations are in process of making which assures us of better and more adequate literature for our people. We have under consideration literature published by other publishers as supplementing literature which our own denominational presses cannot produce according to our needs; however, we are assured that by another year in that which we have been lacking in this field, we will be able to supply the need of our Sunday School work much better.

With what we have had to do with and the restrictions placed upon us in the field of Literature, we have done but little; but we see in the making a greater cooperation between our various departments and the presses be-

longing to our denomination which is encouraging. We note that improvements have been made in this work during the past year and we are looking for more improvements in the near future.

We are in receipt of manuscripts for the printing of a Minister's Manual; and the preparation of manuscript for a History of The Free Will Baptist is continuing by our committee. As you know, it takes a great deal of time for preparation of a manuscript for History.

We own Sunday School Record plates for which the Gem Press of Monett, Missouri, is the custodian. We value these plates at \$200.00. Our people have failed to use this Six-Point Record System on a large scale, yet we find that there are schools a system, practically the very same as ours, published by other concerns. From the records we find that the Gem only sold \$111.18 worth of records this past year of which we benefit to the amount of 50% of the net profits. Why not give the Gem an order for the Six-Point Record System of Records and give them a trial?

"The hour is come" for a greater and more adequate system of record keeping and for soul-stirring, evangelistic messages in the printing and distribution of literature. We believe that the "Day Star" is appearing and drawing nigh when a better understanding, which has already begun with our people, will be manifested toward a united effort and the producing of literature which will be in keeping with the doctrine as set forth by our Fathers and the Lord Jesus Christ the Founder and the Foundation of The Church.

We cannot hope to ever get literature from other denominational presses that is in keeping with what we believe in the whole, however, in some parts we can be benefitted. But the thing that we need and the thing that we must have is literature that will meet the needs of both the large and small Sunday School. It will take capital. What I mean it will take money to produce the need of this hour. We need tracts and other printed matter as well as Sunday School and League Literature. We need to produce authors who can and will write books.

We have on hand eighteen hundred to two thousand copies of "Personal Soul Winning," by Mrs. Eunice Edwards, which can be obtained by sending orders to the Gem Press, Monett, Missouri. Write for rates in quantities. Alarming Information

Recently, I learned from the Editor of the Gem, that only about three hundred copies of the Gem are coming east of the Mississippi river. May I appeal to you, my dear readers, to rally to all of our denominational papers which are published for our information and inspiration.

We have a good selection of samples of our denominational papers, both weekly and monthly, over at the Snack Shop on the Sword Lot. Also a good selection of books which are on sale by the Board of Publication and Literature. Also a Yearbook of the Denomination can be secured at \$1.00 per copy.

In addition to these books we have an interest in the books, "The One Foundation," and "Why the Atonement Is Necessary." The latter by Mrs.

Marie Hyatt and the former by your servant. These books are being sold by the Free Will Baptist Press at Ayden. Copies of these books await your inspection and purchase.

Let us go forward in the evangelization of the world through the printed page. "The hour is come" and we must produce more, read more, send more, and go more for the glory of God and the evangelization of the world in which we live.

REPORT OF THE NATIONAL SUNDAY SCHOOL BOARD

To the National Association of Free Will Baptists when in session July 10, 1951 at Free Will Baptist Bible College Greetings in the Name of the Lord Jesus:

Herewith is a report of the activities of the National Sunday School Board since the annual Sunday School Convention in East Tupelo, Mississippi, in August, 1950.

The report from this Convention was an inspiring one. The program was carried out much as previously arranged with the guest speaker, Rev. Paul Copeland, the workshop sessions directed by our own folks, and a good musical program directed by the W. S. Mooneyham.

The business at this convention consisted of the adoption of a motion to dissolve the Sunday School Convention, placing the business into the hands of the National Sunday School Board of Free Will Baptists. A rising vote of thanks was extended to the retiring officers of the Convention.

Rev. M. L. Sutton, whose term on the Sunday School Board expires in 1952, submitted his resignation. Thus, we are asking the General Board to appoint a man to serve the remainder of the term of Brother Sutton, or until July, 1952.

It has also come to our attention that Rev. Luther Gibson is now serving on the Sunday School Board and the Board of Trustees of the Bible College. Brother Gibson's term on the Sunday School Board expires with this session of the National Association, and we would like to request as a Sunday School Board that Rev. LaVerne Miley be chosen to serve on the Sunday School Board for a term of five years.

This Sunday School Board met in called session in Nashville, Tennessee, on November 3, 1950. Upon instruction from this Board the secretary of the Sunday School Board wrote Brother W. E. Coville about revising his Sunday School Manual. To date no word has been received from him.

The secretary was invested with authority to secure a portable typewriter and recommendation was made to get it through NAE chanels. This was done and we were able to secure a Smith-Corona portable at a good discount.

On instruction from the Board, \$25 dues was sent to the National Sunday School Association officially affiliating us with this organization. The secretary was also instructed to contact this Association for recommendations for a feature speaker for the 1951 Sunday School Convention. Upon recommendation from this Association, we contacted a speaker but we were so late in contacting him that it was impossible to get him for the Convention. Our own men were substituted on the program.

This Sunday School Board met again on April 17, 1951 to complete plans for the annual Sunday School Convention which just closed this past Saturday.

This 1951 Sunday School Convention is the best we have ever had. An actual count of registration cards reveals 270 in attendance, and 30 report forms were returned with 3 state Sunday School organizations reporting. A total of \$374.46 has been received with the report forms and the offering taken on Thursday night of the Convention.

This represents the work of the National Sunday School Board of Free Will Baptists in the past year. We are well aware that there is a great deal to be done yet, and we are feeling keenly the responsibility that is ours. We look forward to marked progress as we feel that we are now in a posi-

tion to really begin going forward in the most important work of the church —that of the Sunday School.

Supplement to Report of Sunday School Board

Recommendations to the General Board:

We recommend that we be given a Sunday School man to promote Sunday School Administration throughout the denomination.

Motion was carried to reimburse the following for expenses connected with the 1951 Sunday School Convention: D. C. Dodd, \$8 for film 'Bible on the Table;" John H. West, \$26 for telephone calls, etc., arranging for speakers.

We also recommend that the National Association ask for each state convention's cooperation with and through the National Sunday School Board in the matter of literature and promotion.

As a matter of information, the manual is in process of revision to be reprinted.

REPORT OF FREE WILL BAPTIST BIBLE COLLEGE

Free Will Baptist Bible College closed its ninth year on May 25, 1951. Three significant events marked the year as outstanding; viz: An all-time high in enrollment—104 from 17 states—and the graduation of the first four-year class composed of four men and one woman upon which was conferred the B.A. degree with a major in Bible. The third event was the erection of Memorial Auditorium in which these sessions of our National Meetings are being held. The total cost of the building as it now stands was \$27,852.39.

The Bible College is meeting a definite need in the life of our denomination in the training of our leadership. Three courses are offered Bachelor of Arts degree in Bible; 3 Year Bible Course; 1 Year Christian Education Course.

It is the plan of the Board of Trustees and Administration to expand the courses as rapidly as conditions will permit. This is based upon two major things: increased financial support and increased enrollment.

Our people gave \$20,321.43 to the General Fund last year and \$22,563.57 to the Building Fund.

Indications point to an increased enrollment for the 1951-52 school year. Below is the detailed financial report for the year 1950-51.

PROMOTING EVANGELISTICALLY

REPORT OF THE PROMOTIONAL SECRETARY

"When thou shalt hear the sound of going . . . then shalt thou go out to battle." I Chronicles 14:15.

The day in which we live is marked by an upsurge in revival fervor. It seems as if the church is being given new life in spite of the inroads which the enemy has made during the past decade. While this revival is not necessarily paced by denominational organization, it is good to note that here and there certain denominations have recognized that they must include in their planning a genuine effort toward the salvation of the lost. I am happy to say that Free Will Baptists have been among this number. God has given us the "go" sign even as He did the great man about whom the scripture text which we have used speaks. We have heard the sound of going and we are ready to go out to battle against the prevailing evils of the day.

This spirit of Denominational revival has resulted in the best year which we have ever known as a National Association of Free Will Baptists. This is not to say, however, that we have attained the ultimate in denominational life. There are many goals toward which we have been striving that yet remain unreached. We shall continue working toward the realization of these ambitions. This report has to do only with that which we have actually accomplished. In addition, we shall also discuss our needs and our aims for the coming year.

I. ACCOMPLISHMENTS

1. Training Institutes

Through the Promotional Department we have carried on an intensive program of training. This has been done through the Christian Workers Institute and the Evangelical Teacher Training Association. Courses designed to present our church doctrines, organizations, National Association Administration, studies in Old and New Testament, Sunday School Management and Teaching, and Child Study have been offered to those who have enrolled. Eleven such sessions have been held with a total enrollment of 400. Of this number, 49 were ministers and 125 were Sunday School teachers and officers. 275 certificates and 7 diplomas have been awarded through the C. W. I. while 190 Sunday School certificates have been earned. Al-

ready more than a dozen Institutes have been scheduled for the coming year. Through our plan of \$2.00 registration fee and a free will offering at the close of each session, these Christian Workers Institutes have been self-supporting.

2. Public Relations

We have been most active in the line of public relations and have provided a good quantity of literature designed to give information about the Free Will Baptist church. We have compiled a list of nearly ten thousand names of our constituency which will be the nucleus of what we hope to be a mailing list covering our entire denomination.

We have distributed more than 50,000 pieces of literature through the Promotional office. At the present time we are offering the Yearbook of the National Association of Free Will Baptists to our people. Errors in the information regarding the Free Will Baptist Orphanage in Middlesex, N. C., and the Free Will Baptist Press in Ayden, N. C., have been noted and corrected in this initial issue of the Yearbook. All proceeds from the sale of this book will go to the Board of Publication and Literature.

3. Evangelism and Church Extension

The Board of Home Missions has been active in these fields so it will not be necessary to go into detail here. Suffice it to say that more than 60 new organizations have been reported in the past two years. Since the release of the Yearbook information cleared through the Promotional Office warrants us to conclude that there are at least 3,000 Free Will Baptist churches with a membership well toward the half-million mark.

We are maintaining constant contact with a group of 9 Free and Free Will Baptist churches in the northeast, located as follows: Thompson, Pa., Binghampton, N. Y., Buffalo, N. Y., Rochester, N. Y., South Portland, Maine, Gonic, New Hampshire, Rochester, N. H., Windsor, New York, Middlesex, New York. Whether or not anything will come of these contacts remains to be seen. For the present we are only maintaining correspondence.

Reports on the days of Prayer which were called during the year reveal that only about 25% of the churches observed the days. No doubt there were numbers of churches which kept the days which did not report.

4. New Equipment

In order to meet the increased demands on the office, we have acquired the following pieces of equipment during the year: Steel Filing Cabinet, Adding Machine (used), Model 200 Speed-O-Print Mimeograph Machine, Adjustable Utility table for typewriter and Mimeograph.

II. NEEDS

Our needs are becoming greater as we grow and to say which is the more urgent need resolves itself into a magnanimous task. However, outstanding among our needs to get ourselves located officially. WE MUST HAVE A HEADQUARTERS BUILDING. We have nearly \$1,600.00 in a fund to purchase such a building. Now we have come to the place where we must have it. We have outgrown the office in the home or church stage. We need centralize our set-up under one roof and have all our offices located there. With a minimum of effort we can have this by the end of the present church year. \$10,000.00 more will put us in a position to buy suitable quarters for Free Will Baptist Headquarters.

1. Unified Program

At present, our Unified Program system is not working. Our receipts for the year from this source dropped off some 40%. This, of course, was in the face of intensified drives for various phases of the work. This is the very thing which we must work to eliminate. We must work out a system whereby a combined National Program budget can be submitted proportionately to the various states and they, under the direction of their State Promotional departments, can raise this amount, plus the amount necessary to operate their local and state programs. Oklahoma has taken the first step in this direction by combining their Mission budgets and operating through a state promotional department.

Honorable mention must be made here of one of our newest churches. The Free Will Baptist church, of Mt. Pleasant, Tennessee has been the most consistent supporter of the Unified Program and stands at the top of the list in the National Association. This church is only two years old and has made rapid progress since its organization. Loyal Chapel church, of Columbia, Tennessee, has also been a ardent supporter of the unified fund.

III. A COMPARISON

While we cannot completely measure our growth in terms of dollars and cents, we can index our denominational interest pretty well by this means. Thus, the following has been prepared:

It has been a genuine pleasure to contact the work over the states and to enjoy the satisfaction of seeing that it is being amply taken care of. A splendid spirit of fellowship and good will prevails throughout the bounds of our National Association.

Every endeavor at promoting the cause has met with outstanding cooperation. I have traveled more than 50,000 miles, visited in 17 states where there was Free Will Baptist work, and made contacts in 4 others in the interest of the work. Through Christian Workers Institutes and revival services there have been a total of 376 decisions for Christ.

OF FREE WILL BAPTISTS

It is my sincerest prayer that we will continue in our far-reaching spiritual conquests during the coming days and that we will attain to heights hitherto unknown to Free Will Baptists.

CONSTITUTION OF THE NATIONAL ASSOCIATION

As Revised by the 1950 Session at Richmond, Californiao

*No revisions were made at the 1951 session at Nashville, Tennessee.

From experience we, the members of the Free Will Baptist denomination being regularly baptized upon a profession of our faith in Jesus Christ, and revealing the necessity of a bond of union and fellowship among us as a church; and to preserve and maintain correspondence and coordination with us, do therefore ordain this Constitution for our better denominational government.

Article I

NAME-This organization shall be known as the National Association of Free Will Baptists of the United States of America.

Article II

PURPOSE—The object and purpose of this organization shall be to unify the work of the various bodies composing the National Association, and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may be hereafter represented therein.

Article III

COMPOSITION-This National Association shall be composed of its general officers, the members of all standing boards, or committees, the duly appointed delegates of Free Will Baptist organizations which actively promote and support the work of the Association and all ordained ministers and missionaries who belong to general bodies which are affiliated with this National Association.

Article IV

REPRESENTATION-Representation in the National Association is to be by states. Each state association shall be entitled to five delegates to be elected from the laity, regardless of the number of district associations in the state; but in addition to the five delegates, each state shall be entitled to

one delegate for each district association within the bounds of District Association. Districts in the state which have no state association, and those whose state organizations may not be affiliated with this body, shall elect and send their delegates directly to the National Association.

Article V

FINANCE—Each State Association representing in this body shall send the sum of \$10.00 with \$5.00 extra for each District Association composing the said State Association or Convention. The district or subordinate associations representing directly shall send the sum of \$5.00 with their reports.

Section 2. The Moderator and Clerk shall receive an honorarium of \$50.00 annually plus 5c per mile travel expense to and from sessions of the National Association. Assistant Moderator and Assistant Clerk shall receive the same benefits as Moderator or Clerk in the absence of either the Moderator or the Clerk.

Article VI

DISCIPLINE—This National Association shall have the right to settle any question of discipline, doctrine or practice that may properly come before it from any of the bodies composing said organization of the National Association of the Free Will Baptist Church, or act upon any appeal that may be made by any body belonging to the National Association. Said appeal shall have been written and properly signed by the constituent body or bodies, and its decision shall be final. Such appeals are to come before the National Association, after having been appealed from the lower to the next higher body.

Section 2. All appeals coming before the National Association may be settled in either of the following ways: (1) By the National Association when sitting in a committee as a whole. (2) By a special committee whose report shall be voted on without discussion.

Article VII

Officers—The Officers of this National Association shall consist of a Moderator, an assistant moderator, a clerk, an assistant clerk, promotional secretary who shall serve as treasurer, each of whom shall be elected at the close of each regular session.

Section 2. Committees, as necessary, shall be appointed by the Chairman unless otherwise provided for, and shall hold office until their work is completed, or until their successors are elected.

Article VIII

Boards—All standing Boards shall be composed of five members, exclusive of the General Board and the Board of Trustees of the Free Will Baptist Bible College. Standing Boards include the General Board, the Board of Trustees of the Free Will Baptist Bible College, the Foreign Mission Board, the Home Mission Board, the Free Will Baptist League Board,

the Sunday School Board, the Board of Superannuation, and the Board of Literature and Publications. The personnel of each of the foregone, exclusive of the General Board and the Board of Trustees of the Free Will Baptist Bible College, shall be elected as follows, the first named for a term of one year, the second for a term of two years, the third for a term of three years, the fourth for a term of four years, and the fifth for a term of five years. Succession to office thereafter shall be determined as order requires.

Section 2. The personnel of the General Board shall be composed of the general officers of the National Association and the chairman of each of the following Boards: The Foreign Mission Board, the Home Mission Board, the Free Will Baptist League Board, the Sunday School Board, the Board of Superannuation, and the Board of Literature and Publications. There shall also be elected by the National Body one member from each affiliated State Association and one member from each affiliated association comprising one or more than one state. The President of the National Woman's Auxiliary Convention and the President of the National Sunday School Convention shall be ex-officio members of the Board.

The term of office of those chosen within given State Associations shall be two years; and so constituted that the expiration of the term of office of those residing east of the Mississippi River shall alternate with those residing west of the Mississippi.

Section 3. The General Board shall have power to act in behalf of, and for the National Association from one regular session to another, and shall also have power to elect such officers as may be necessary for its own government, and to carry out the plans and undertakings of the National Association.

Section 4. The General Board shall have power to fill irregular vacancies that may occur in its own body, and shall also have power to fill any irregular vacancies that may occur in any department of the work between sessions of the National Association. It shall be the duty of this Board to make written reports of all its work to each annual session of the Association.

Section 5. The General Board shall organize at its own discretion for the promotion of the work set forth in sections three and four of this article. It is understood that an Executive Committee consisting of seven members shall be elected by the General Board from among its membership, whose duty it shall be to act on all matters coming within the scope of the work of the Board when said General Board is not in session.

Section 6. The duties of the various standing Boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their worrk as may become necessary, and as may be found in harmony with the principles and tenets of the National Association.

Each standing board shall prepare a budget of its proposed financial expenditures at the beginning of each fiscal year, and present same for ap-

proval of the National Association before any expenditures are made for the year.

Section 7. No person shall fill more than one office at the same time, or any office and a place on any standing board, except as he may become a member of the General Board by virtue of his office. No person shall serve on more than one standing board at the same time, except as he may become a member of the General Board by virtue of being chairman of the board of which he is an elected member.

Article IX

A Board of Trustees of not less than nine members nor more than fifteen shall be elected by the National Association and charged with the responsibility of establishing, organizing, controlling, and operating a Free Will Baptist Bible College in the city of Nashville, of the state of Tennessee. It is provided, however, that the first Board of Trustees shall be composed of nine members, who shall be classified and elected in groups of 3's as follows: The terms of office of the first three named shall expire July 15, 1946; the terms of office of the second three named shall expire July 15, 1948; and the terms of office of the last three named shall expire July 15, 1950. Successors in office thereafter shall be elected biennially in groups of 3's, each for a term of six years, and they shall continue in service until their successors have been chosen. Any trustee may be re-elected to office at the option of the National Association.

In addition to the original nine trustees prescribed for the Bible College, the National Association may, at its option, elect six others to membership on the Board; but they shall be elected, two biennially, until six members have been added to the board. These elections shall coincide with the respective biennial elections of the original groups of 3's, and shall, in actual practice, effect or result in a reclassification and biennial election of all trustees in groups of 5's. Under this option, if elected, trustees shall be chosen by the National Association biennially in groups of 5's, each for a term of six years.

The trustees of the Bible College shall have power to apply for and receive a charter of incorporation under the name and style of FREE WILL BAPTIST BIBLE COLLEGE of the National Association of Free Will Baptists. It is provided, however, that the charter of incorporation, as proposed, shall be approved and authorized by the National Association previous to its submission for registration, and that no revision or amendment thereafter shall be sought without the specific direction of the National Association.

The Board of Trustees of the Bible College shall also have power to organize at will and to create such by-laws as may be deemed essential for their government and for the control, administration, and promotion of the college, consistent with the provisions of its charter of incorporation and the constitution and regulations of the National Association.

Article X

The National Association shall hold its regular meetings annually, at the time and place announced by the committee appointed by the Association while in session.

Article XI

AUXILIARIES—The National Woman's Auxiliary Convention and the National Sunday School Convention shall be recognized as subordinate organizations to the National Association. They shall organize at their own discretion, and have power to create and adopt their respective constitution and by-laws, and maintain complete management of the work for which they are constituted. The scope and character of the work of these organizations shall conform to the general program and promotional plans of the Association. They shall report their accomplishments annually to the National Association.

Article XII

Should necessity arise, from war, or pestilence, or any cause which prevents a regular meeting whether such a condition is of a local or general condition, then the General Board shall be privileged to call and act with full authority in all matters pertaining to the general welfare of the National Association and the Church as a whole, providing whatever transactions passed shall be by a two-third vote, of the full membership of the said General Board, providing that such transactions shall not conflict with the purpose, and edicts of the Constitution as set forth in the preceding articles.

Article XIII

This Constitution may be amended or altered at any regular session of the National Association by a two-thirds vote of members present, provided proposed amendment or alteration be presented in writing to the body one day in advance.
