## PROCEEDINGS Friday, May 11, 1979, 7:30 P.M.

The thirty-first annual session of Mission Association was called to order by the clerk, Rev. Max Courtney. Rev. Greg McAllister led the congregation in the hymn, "All Hail The Power." Opening prayer by Rev. Gene Postelwait.

Rev. McAllister led the congregation in the hymn, "We'll Work

Till Jesus Comes.

The clerk introduced the moderator, Rev. Howard Bowers, pastor of Rock Chapel Free Will Baptist Church. Rev. Bowers gave the moderator's message. (See Worship Service and Messages in this book)

A motion and second carried that the Moderator appoint an assistant moderator in the absence of Rev. Helsley who was in revival services. The temporary assistant to serve for the Friday Evening Session. Rev. Clyde Montgomery was appointed to serve.

The moderator and assistant moderator appointed the following committees: (1) Pulpit Committee: (2) Committee on Committees: (3)

Credentials Committee. (See Committees in this book)

Visiting delegates and members of other bodies were recognized by the moderator. Bro. and Sis. Crawford, Free Will Baptist Bible College, Nashville, Tennessee; Bro. Tommie Allen, Norman, Oklahoma were introduced.

The moderator called the attention of the body and delegates to the Constitution and By-Laws of the Mission Association printed on pages 21 through 24 of the minutes and stated that these by-laws

would be strictly adhered to in all the precedings.

A call was made for church letters by the moderator. He pointed out that in addition to the long-form letters mailed to the clerk, a short letter of presentation from all the churches would be necessary in order to accommodate the delegates, requests, and recent statistics of the churches. All those to be licensed or ordained, and those whose papers from other associations were pending approval by the Mission Association should report to the proper committees during this Friday Evening Session.

The moderator called for the business session to be adjourned for the Evening Worship Service that was to follow. (See Worship

Services and Messages in this book)

Following the worship service, the clerk read a report from the pulpit committee. The committee reported that Rev. Ralph Cook, Pastor of Wayside Free Will Baptist Church would bring the Saturday Morning Message.

A motion and second carried to adjourn the Friday Evening

session. Dismissed in prayer by Rev. Gene Crewse.

# Saturday, May 12, 1979, 9:00 A.M.

The session was called to order by the moderator, Rev. Howard Bowers. Rev. Greg McAllister led the congregation in the hymn, "Leaning On The Everlasting Arm." Prayer was offered by Rev. Joe Day.

The moderator called for all church letters to be turned into the credentials committee.

A devotion was presented by Rev. Lester Davis, Pastor of Cabool Church. (See Worship Services & Messages in this book)

The report of the Christian Education Board was read. (See Reports in this book) A motion and second carried to receive this report.

Report of Missions Co-Ordinator for Mission Association was read. A motion and second carried to adopt this report. (See Reports in this book).

This Statistical Report was read by the Clerk. A motion and second carried to adopt this report. (See Reports in this book) (It was noted by the clerk that two churches had failed to report on the long-form report in time to be included in the statistics. (1) the Trinity Church, (2) the Happy Ridge Church had failed to send their reports to the clerk by April 15th, the deadline for filing the reports. For this reason, the statistical information would not be exactly correct.)

The report of Hillsdale Free Will Baptist College was read by the clerk. A motion and second carried to receive this report. (See Reports in this book)

The letter from the Mission Association to the Missouri State Association was read by the clerk. A motion and second carried to adopt the report, and to approve the representation fee of \$145.00. Mr. & Mrs. Ralph Cummins and Delia Neil were elected as delegates and the Moderator was given the authorization to appoint the other four delegates at the State Association. (The clerk noted that the information in the letter was the same information given in the statistical report. See reports in this book)

Two areas of concern were noted by the clerk. The finances are dangerously low in relationship with the needed expenditures. Due to the inflating prices for printing, postage, etc. (\$275.45 for printing of programs, minutes, & envelopes & postage this past year) The treasurery is now \$23.00 at this point. We will need even more money to operate on this coming year. We need to urge the churches to send their proper representational fee and to be aware of this problem.

Also, we are lacking three of the minute books in having a complete set of minutes from the origin of the Mission Association. Even though we have the minutes in a ledger for these years, it would be well if we also had the missing books. I would like to recommend that we secure copies of these books, (1954, 1955, & 1971 minutes) and try to have them bound in a binder to preserve them. I would like for us to take some action on the financial condition during this meeting, and take action on the minutes at the next meeting.

The report of the Committee on Committees was read. A motion and second carried to adopt the report. (See reports in this book)

An auditing committee was appointed by the moderator to audit the treasurer's books. Bro. Nolan Neil, Bro. Bart Austin, and Sis. Dora Fry were appointed.

The Youth Camp Board report was given by Rev. Lynn Wood. A motion and second carried to receive the report. (See Reports in this book)

Rev. Roger Reeds, National Sunday School & C.T.S. Director,

gave the National Sunday School Board report. A motion and second

carried to receive the report. (See Reports in this book)

Rev. Clarence Burton gave the report of the Missouri State Promotional Secretary. A motion and second carried to receive this report. (See reports in this book)

The Credentials Committee Report was read by the clerk. A motion and second carried to adopt the report, receive the churches,

and seat their delegates. (See Reports in this book)

A resolution from the Credentials Committee was read concerning the Greater Springfield Association. After a motion and second, Rev. Millard Sasser noted that the three Springfield Churches that are members of the Mission Association along with the other churches of the new association were asking that this resolution be passed for the sole purpose of organizing a local Springfield association for a closer fellowship there in that area. He stated that none of these churches were in opposition to any of the policies or operations of the associations of which they are now members. This resolution carried unanimously by the vote of the body. (See Reports in this book)

The clerk read a further report from the Credentials Committee stating that the total amount of money received from all churches with their letters was \$250.00. A motion and second carried to adopt this segment of the Credentials Committee Report. (See reports in this book for the list of churches and amount given by each church)

Bro. Crawford gave the report from the Free Will Baptist Bible College, Nashville, Tennessee. A motion and second carried to receive this report and extend the appreciation of the association to the Bible College, the Sunday School Department, and others for sending representatives to the Mission Association to share these reports and fellowship. (See reports in this book)

The Credentials Committee reported on the ministers to receive Annual cards of good standing with the Mission Association for the coming year. A motion and second carried to adopt the report and grant cards of good standing to the list of ministers read along with those approved by this association. (See Reports in this book for the

list of ministers)

A pulpit committee was appointed to select a speaker for the closing service. Charles Franklin, Russel McDaris, and Lester Davis

were appointed.

The moderator asked that the association adjourn for the eleven o'clock worship service. Dismissed in prayer by Rev. Clyde Montgomery. Rev. Ralph Cook to bring the message. (See Messages & Worship

Services in this book)

The services were resumed following the worship services and visiting ministers and delegates were recognized. Rev. Bill Eaton, Niangua Association, Rev. Silas Johnson, Cabool, Rev. Gary Hutsell, Salem, Rev. Ivan Parker, Rev. George Bryant, Hartville, Rev. Roger Reeds, Nashville, Tennessee, Rev. Glen Murray, Batesville, Arkansas, Rev. & Mrs. Robert Crawford, Nashville, Tennessee, Rev. Clarence Burton, Lebanon.

The Pulpit Committee reported that Rev. Glen Murray of Batesville, Arkansas would bring the afternoon message.

The moderator asked that an offering be received for the expenses of the association. Prayer of thanksgiving offered by Rev. Lester Davis.

Services were adjourned for the noon meal. Services dismissed and thanks offered for the food by Rev. R. E. Helsley.

### Saturday Afternoon, May 12, 1979, 1:00 P.M.

The afternoon service was called to order by the assistant moderator, Rev. R. E. Helsley. Rev. Lynn Wood led the congregation in the hymn, "Where He Leads I'll Follow." Prayer by Rev. Clarence Burton.

A devotion was given by Rev. Tommie Allen of Norman,

Oklahoma. (See Worship Services & Messages in this book)

The Credentials Committee reported that Rev. Earl Irish, Rev. Silas Johnson, and Rev. Gary Hutsell had been examined and they had found their papers were in order. The committee requested that the requests of the churches of which these ministers are members be honored and that they be received into full fellowship of Mission Association. A motion and second carried to grant this request.

The Credentials Committee also reported that they had examined Rev. David McGowan and found him to be sound in his doctrinal position. They recommended that the request of his church be granted, and that he be granted his first year's license to preach the Gospel. A motion and second carried to grant this request.

A motion and second carried to accept the invitation of the First Free Will Baptist Church of Mtn. Grove, and hold the 1980 session of Mission Association with their church on May 9th & 10th, 1980.

A motion and second carried to adopt the Obituary Committee

Report. (See Reports in this book)

A motion and second carried to adopt the Auditing Committee's Report. (See Reports in this book)

A motion and second carried to adopt the Sunday School &

C.T.S. Committee's Report. (See Reports in this book)

A motion and second carried to adopt the report of the Temperance Committee and commend them for the good report. (See Reports in this book)

The moderator called for the report of the Observance of the Lord's Day Committee. The committee reported that they had not

prepared a report.

A motion and second was made that we eliminate the "Observance Of The Lord's Day Committee." In the discussion that followed it was stated that this committee seemed to be in contrast with the doctrinal position of the Free Will Baptist Denomination in as much as our position is and has always been that Sunday is the Lord's Day and worship services and Sunday School are to be observed in all of our churches on this day. It was also pointed out that it is and has always been the duty and privilege of all Free Will Baptists everywhere to attend these services and support them with our presence and precepts. A motion and second carried to table this resolution so that

it could be acted upon in accordance with our by-laws in a future meeting.

Rev. Gary Hutsell, Pastor of the Salem Church was nominated and elected by acclamation to preach the keynote message at the next Mission Association Meeting at the First Church of Mtn. Grove.

Rev. Lynn Wood, pastor of the Mtn. Grove First Church was nominated and elected by acclamation to be the alternate speaker for

the keynote message at the next association meeting.

A letter of representation from the Union Association of Free Will Baptists was read. A motion and second carried that the letter be received, the delegates be recognized, and the request of Union Association be granted that we send corresponding delegates and a letter to their Association when it next meets.

Rev. & Mrs. Clyde Montgomery were nominated and elected by acclamation to serve as corresponding delegates to the Union Associa-

tion.

Rev. & Mrs. R. E. Helsley were nominated and elected by acclamation to serve as corresponding delegates to the General Baptist Association when it meets September 13th through 15th, 1979.

Rev. R. E. Helsley was nominated and elected by acclamation to serve as moderator of Mission Association for the coming year.

Rev. Lynn Wood was nominated and elected by acclamation to serve as assistant moderator of Mission Association for the coming year.

Rev. Max Courtney was nominated and elected by acclamation to serve as clerk-treasurer of Mission Association for the coming year.

Bro. Dan Vandivort was nominated and elected by acclamation to serve as assistant clerk of Mission Association for the coming year.

A motion and second carried to give the host church a standing vote of thanks for their hospitality and the good food and also for our retiring moderator, Rev. Howard Bowers to wish him Godspeed in his new missionary endeavour.

A motion and second carried to adjourn the business session of Mission Association for 1979 to meet at the Mountain Grove First

Free Will Baptist Church on May 9th and 10th, 1980.

We appreciate your confidence and support of the camp. The Swimming Pool is undergoing some remodeling and Work-day was the last Saturday in April. We did not have very good response to our Work-day. I hope you will consider giving some time this next year to

help with the improvements.

One of the Mission Association Cabins is desperately in need of a

paint job. It has never been painted. We need to do some work on our

cabins, especially on the boys side of the campground.

We have built and installed a laundry room this year which has a washer and dryer facility. It is coin operated and we have learned this was desperately needed, especially by sponsors and workers. Several of these who attended camp got together and raised the money for this project, asking some of our people to contribute.

We ask for your prayers that God will give us a great time of

fellowship and spiritual rejoicing at the camp sessions this year.

The cost of camp will be \$20.00 per student. We regret that we have been forced by inflating prices for food, to again raise these prices. We feel, however, that we are still well within reason with

these prices.

The first week of camp will be Elementary week, the second week will be Jr. High week, and the last week will be Teen week. We urge you to support by prayer, finances, and attendance by both sponsors and students, our Youth Camp this year.

# NATIONAL SUNDAY SCHOOL-CTS BOARD REPORT, by Rev. Roger Reeds, Director

Departments merged last year and now operate under the name "National Sunday School & C.T.S. Department." We are a service agency of the National Association. Also I want to announce that the dates will be back on the material this next quarter.

We are now producing a combination of Sunday School & C.T.S. materials of nearly 400,000 pieces every quarter, or over one

We also produce a series of books and booklets. We have over one hundred titles of our own written by Free Will Baptist people and we have more planned.

Rev. Roy Thomas has just written a book on "How To Start A Fundamental Church." We hope you will buy and read this book. It

has just come off the presses.

Our new catalog will be ready by the time our National Association meets in Charolette, North Carolina this year. It will be

available through your state bookstore.

Not only are we involved in the area of publishing, but also in the area of promotion. We are trying to help our churches in the area of growth in their Sunday Schools. We try to do this in several ways. One way is through our Spring & Fall enlargement campaigns. The reports from our Spring campaign are encouraging. The Fall campaign is coming up soon. We would like for your church to participate. We have designed these campaigns to churches, both large and small, can participate. Even if your church is small, we want you to take advantage of this service.

Also we have the Teacher Training Program, the Institutes hold in several areas, local rallies, etc. as well as sponsoring the Youth

Program at the National Association.

Finally, also, we are involved in the area of printing. We now print 95% of all of our own literature used by our churches. We also do outside printing; such things as minutes, letter-heads, envelopes, revival bills, bulletins, etc. This helps to keep our presses busy and helps keep us going the year round.

We have had a good year. We have had about \$1,400,000.00 in sales, we have operated in the black again this year. We had about a 10% net this year, and praise you for helping to make this possible.

# REPORT OF FREE WILL BAPTIST BIBLE COLLEGE, Rev. Robert Crawford

We express our appreciation for all the prayers, finances, and students you have given to Free Will Baptist Bible College. God has used these in marvelous ways. The first student to receive a B.A. Degree was Bro. Adam Scott in 1952 from your State. Also Mary Ruth Wisehart who has made an outstanding contribution to the cause of Christ.

We want to thank you for your contributions and prayers for this work in the past, and urge you to pray for us as we pray and labor for you.

The college has an A rating academically and as a Bible College, everyone who attends is required to carry a major in Bible, whether the course is ministry, missions, music, or school teaching. You then would have two majors in most fields. All classes are opened by prayer, and taught according to Bible principals. The college is sound in its program physically, spiritually, mentally, emotionally, and academically. Counsellors are available to assist the students in all their efforts. Christian living is the norm for those who are on the campus. We didn't want a college because others have problems, we wanted a college because God has ordained it. Christ is the head and is the foundation of the ministry of Free Will Baptist Bible College.

Those who have gone out, we feel, are fully prepared to meet the needs of the people they serve. The four months in 1978, 614 students made contact with 9,104 persons for their personal relationship with the Lord on street corners, nursing homes, and personal contacts, in Sunday School Classes, and 616 of these made commitments to Christ and were won to Him. Also 829 others made some spiritual decisions. They also handed out 46,794 tracts pertaining to salvation with a prayer they would be effective.

Missouri's suggested quota for 1978-1979 was \$22,000.00. You have given \$17,109.99. You are now 78% of your quota. If you were on

PREAMBLE. From experience, we the Free Will Baptist Churches, in order to form a more perfect union and that we may affiliate ourselves with other Free Will Baptist bodies, have come together and organized into an Association.

- 1. This Association shall be called Mission Association of Free Will Baptist and shall be composed of such well regulated quarterly meetings and churches as many as may embody themselves under this constitution.
- 2. It shall be the purpose of this organization to co-operate with the Missouri State and National Associations in their efforts to combine and direct the energies of the Free Will Baptist Church, for the promotion of Home and Foreign Missions, Christian Education. Sunday School, Church Training Service and Woman's Auxiliary and for the extension of the Kingdom of God in general.
- 3. The acting members of this association shall be two delegates from each church, chosen by the members while in conference, together with all ministers, minister's wives, deacons, deacon's wives and church and associational clerks belonging to any church composing this body; also three members from each Quarterly Meeting under the Association, two to be chosen by each Quarterly Meeting, and the other shall be the clerk of the Quarerly Meeting.
- 4. The officers of this Association shall consist of a moderator, and assistant moderator, a clerk-treasurer who shall superintend the printing of the minutes each of whom shall be elected at the closing of each regular session and shall hold their offices until their successors are elected. The clerk shall receive Forty (\$40.00) for his or her services.
- 5. An Executive Board composed of five members, consisting of three ministers and two deacons, whose duty shall be to transact the business of this Association when this Body is not in session; whose term of office shall be as follows: one for 1 year, one for 2 years, one for 3 years, one for 4 years, and one for 5 years and at the expiration of each of these terms shall be elected for a term of 5 years, who shall hold office until his successor is elected, further: if any vacancies occur between sessions of this Association the Board shall fill such vacancies until the next session of this Association. The Moderator and Clerk shall also serve on this board, as they hold these offices in the Association.
- 6. Any regularly organized Free Will Baptist Church or Quarterly Meeting, maintaining Gospel order, agreeing with the denomination in doctrine, in favor of benevolent enterprises, such as Sunday Schools, Missions, Temperance and Education, may be received into this Association by presenting a petition asking to be received, and by a majority vote of this Association.
- 7. This Association shall have the power to discipline its churches, exclude them for disorderly conduct, if labor proves unsuccessful, ordain deacons, to license or ordain ministers, such as given evidence of being qualified and called of God, by request of the Church to which members belong; to settle questions of discipline and doctrine as the Churches or Quarterly Meetings may refer to it; to make any rules and by-laws necessary to its regulations and not inconsistent with its constitution, but in no case shall this Association reverse a decision of one of its churches or Quarterly Meetings, nor in any way interfere with its internal regulations, nor hold any ecclesiastical authority over the Churches or Quarterly Meetings composing the Association.
  - 8. Each session of this Association shall convene annually beginning on

Friday at 7:30 p.m., before the 2nd Sunday in May, and shall be held with only such churches as call for it by vote of the church while in conference, and this shall be decided by a majority of all votes cast.

- 9. The Moderator or Assistant Moderator shall call the Association in session, and in their absence the chairman of the Executive Board shall take charge, and in his absence any member of the Executive Board shall take charge until a Moderator is elected.
- 10. This Constitution may be amended or changed at any regular session of this body, by a two-third vote, after notice of contemplated change has been read and placed on the table one day previous to the time the vote was taken.

#### **BY-LAWS**

- 1. All business meetings shall be opened by singing, reading a portion of God's word and prayer, and shall be closed with prayer.
- 2. Seven members from three or more churches shall constitute a quorum for the transaction of business.
- 3. Any ruling of the moderator may be over-ruled by a majority vote of the members present.
- 4. This association may correspond by messenger or otherwise with other religious bodies.
- 5. This association shall sit with open doors except when it shall go into committee as a whole.
- 6. Any member of this body may appeal from the decision of the moderator to the association and by a majority vote therein, the objection shall be sustained or rejected.
- 7. The moderator shall stop all discussion when not carried on in a Christian spirit.
- 8. No member of this association will be allowed to speak more than ten minutes nor more than twice on the same subject without permission of the moderator.
- 9. Anyone desiring to speak shall rise to his feet and address the moderator by the appelation, "Brother Moderator," but shall not speak further until recognized by the moderator.
- 10. All business, except routine, shall be brought before the body by committees, but should any committee refuse or fail to present to this body any business given it by any member of this association, then such business may be presented to the body by any members but cannot be discussed unless by a vote of this body.
- 11. All officers of this Association shall be nominated from the floor and elected by a vote.
- 12. The Pulpit Committee, Credentials Committee, and the Committee on Committees shall be appointed by the Moderator on Friday Night at the beginning of the session. All other Committees and nominations for Board Members and Delegates shall be made by the committee on committees.

As stated in Roberts Rules of Order, the Moderator shall give opportunity for the body to place in nomination the name of any qualified person as the Committee on Committees report is received.

Any appointment by the Moderator may be changed by a majority vote of this body.

- 13. A majority of all votes cast shall be final upon all subjects except the Constitution and By-Laws, then it shall require a two-thirds majority.
- 14. Churches of the Mission Association shall not call a pastor who does not have a yearly certificate.
  - 15. Each ordained minister in good standing shall be given a yearly

certificate. Each licensed minister, upon receiving a call for pastoral work or the administering of the Gospel ordinances shall upon request from the church of which he is a member, be examined for ordination.

- 16. All applicants for license or ordination shall be examined by an examining committee composed of five members, at least three of whom shall be ordained minister, the committee to be appointed by the moderator. The examining committee shall interview all applicants in private and shall use the standard of examination formerly approved as resolution, to be printed in separate form and distributed to all ministers and churches in the association.
- 17. No member of this body shall serve on the Executive Board of both this annual meeting and the quarterly meeting at the same time.
- 18. All churches that compose this body shall prepare a statistical report in the form supplied by the clerk, who is the statistician, of the association, as soon as possible after receipt of the form at the end of the calendar year.
- 19. These By-Laws may be amended or changed at any regular session of this association by a two-thirds vote of the association.

### ARTICLES OF FAITH

- 1. The Bible. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.
- 2. God. There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the universe; and in the Scriptures as Father, Son and Holy Ghost, yet as one God, infinitely wise and good; whom all intelligent creatures are supremely to love, adore and obey.
- 3. Christ. Christ is God Manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified, and is our ever present Savior and Lord.
- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God.
- 5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.
- 6. The Sinfulness of Man. Man was created innocent but by disobedience fell into a state of sin and condemnation. His posterity, therefore inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.
- 7. The Work of Christ. The Son of God, by his incarnation, life, suffering, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 8. The Terms of Salvation. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved commital of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith and souls is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance of faith and obedience until death.
- 9. Election. God determined from the beginning to save all who would comply with the conditions of salvations. Hence by faith in Christ, men become His elect.
- 10. Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit or to resist

them and perish.

11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the waters of life freely.

12. Perseverance. All believers in Christ, who through grace perseverance holiness to the end of life, have promise of eternal salvation.

13. Gospel Ordinances. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the GOSPEL; FEET WASHING an ordinance teaching humility, of universal obligation, and to be ministered to all true believers.

14. Tithing. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel. Matt. 23:23 and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." (1 Cor. 16:2).

15. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship; holy works and activities, and for personal communion with God.

16. Resurrection, Judgment and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

#### **CHURCH COVENANT**

Having given ourselves to God, by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in his solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligation in references to the study of the Scriptures, secret prayer, family devotions and social worship; and by self-denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences; public worship, and the observance of the ordinance of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace to be careful of one anothers happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, as far as we are able to promote the success of the church and of the Gospel.

We will everywhere hold Christian principal sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done in earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, the evangelistic efforts for the salvation of the World. And, may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

- 9. What is the proper mode of water baptism? (Explain your answer).
- 10. How would you receive a member into your Church? (Explain each step beginning with the first contact with the prospective member until he is received into the Church)

11. Is Sunday the proper day of worship? Why?

- 12. Could you receive a member into your church who is working in a liquor store selling liquor? Why?
- 13. Explain sanctifiction. What is it and when do we receive it?
- 14. Do you feel tithing is God's plan for the support of His Church?
- 15. In your own words, describe what Jesus meant in Matthew 28:19 and in Acts 1:8.
- 16. How does the Bible tell us to handle matters of discipline within the church?
- 17. Do you feel that a pastor's duty to the lost is just preaching or do you feel he should involve himself in personal soul winning? Why?
- 18. Do you feel that the Bible is the infallible Word of God? If you do answer the following:
  - a. Do you believe Jesus was God's Son, born of a virgin?
