### THURSDAY MORNING SESSION

The Mississippi State Association of Free Will Baptists met in its first annual Session with Lovewell Church in Greene County on Oct. 15-16, 1942. The Association assembled by singing "What a friend we have in Jesus" led by Rev. George Lee. Devotional conducted by Bro. W. A. Mason using as a basis the 12th Chapter of Hebrews, prayer by Rev. G. M. Pearson. Welcome address given by pastor Rev. Pearson, response by L. E. Duncan. Songs were led by Rev. D. W. Jones and Bro. W. G. Prude.

The moderator, Rev. M. L. Hollis, took stand and called for letters and delegates. The following churches were represented by both letter and delegation: East Tupelo, W. G. Prude and L. E. Duncan. ### Resolution Commtitee report:

1st. Resolved that we begin now for an Orphanage in Mississippi, by appointing an Orphanage Board, same to organize and make a report, to this body, of its plans so that they may be acted upon.

2nd. Resolved that meeting date of this Association be held on Thursday and Friday before the third Sunday in November of each year instead of date defined in constitution.

3rd. Resolved that next session be held with Antioch Church in Pontotoc county.

4th. Resolved that we show our appreciation to our officers for services rendered by giving the moderator \$5.00, clerk \$10.00 and treasurer \$5.00.

5th. That we extend to Lovewell Church and community our sincere thanks and appreciation for the courteous and capable entertainment during this session. May God's richest blessings ever be theirs to enjoy.

### Committee

The above report was unanimously adopted and the Orphanage Board appointed as follows: M. L. Hollis, W. G. Prude, L. E. Duncan, G. C. Lee and G. M. Pearson.

Mississippi State Free Will Orphanage Board organized Oct. 16, 1942 by electing the following officers: M. L. Hollis, chairman, L. E. Duncan secretary and W. G. Prude, treasurer. The following recommendations were presented to the Association, by the board, and were unanimously adopted:

1st. That each church keep an Orphanage Bank before the people at all services for offerings and that a special offering be taken once each month for same. These funds to be mailed to treasurer quarterly so that he can make a written report and forward to F. W. Papers for publication.

2nd. That there be added to the Board two other members, we suggest that Bro. W. A. Mason and Bro. C. R. Hollis be designated as same

3rd. That Board be empowered to purchase and establish this institution and that the actual expenses incurred by same be paid from treasury of said board.

4th. That the subscription for public funds be taken care of by or through this board.

### M. L. Hollis, chairman

The body went on record as to their interest in this move by subscribing the amount of \$705.00 and giving a freewill offering of \$27.50. A subscription list will be published from time to time in the church papers.

### HOME MISSION REPORT

We ask that the churches comprising this association support in full the program of the National Home Mission Board.

2nd. We ask that each church take a freewill offering as often as they see fit for State Home Mission work. Funds to be brought to each meeting of the association, or mailed to treasurer.

3rd. We urge the necessity of State Mission work and ask that a Gospel tent be purchased and an evangelist be placed in the field as soon as funds are available.

### THURSDAY EVENING SESSION

A fine program of gospel songs was led by the various leaders present and the Greene County singers rendered some fine special numbers. Rev. M. L. Hollis preached from Rev. 5th chapter using as a subject, "The Seven Seals." Many were moved to seek a closer walk with Jesus as evidenced by their coming to the altar at the close of the service.

### FRIDAY MORNING SESSION

Devotions directed by Rev. W. H. Fondren, using Psalms 153, opened the 2nd days session. Prayer by Rev. Pearson.

Moderator called house to order. A vote was taken on a resolution to change the 12th article of the Constitution to read as follows, "The association shall hold its sessions annually on Thursday and Friday before the third Sunday in November. It was adopted.

### Report Of Committee on Christian Education and Literature:

We recommend that our people support our National Program on Education as enthusiastically as possible, and that we observe November of each year as Christian Education month by taking an offering for same. Funds to be forwarded to treasurer for transmission to National treasurer and records to be kept by State teasurer for yearly auditing.

We recommend that our people support our denominational publications, namely: The Free Will Baptist, Free Will Baptist Gem and Free Will Baptist Landmark.

We urge that our people use Free Will Baptist literature in Sunday schools and League. That we furnish our homes with clean and wholesome literature for reading by our young people. We also stress a systematic study of God's Word. "Study to show thyself approved unto God a workman that needeth not to be ashamed, rightly dividing the word of truth."

### Report of Auditing Committee:

We have checked receipt and disbursement of finance and find the amount of \$28.00 was paid into the treasury between April 16th and October 15th, 1942, and the amount of \$27.72 paid out, leaving a balance of \$0.72 brought from last session. Collected during this session \$72.75. Total on hand \$73.47.

After a few minutes recess Rev. J. M. Haas filled the stand and preached an inspiring sermon using as a subject, "Let Us Remember."

Association was closed to meet with Antioch Church 3 miles south of Toccopola, Miss., on Thursday before third Sunday in November 1943 at 10:00 o'clock a.m.

## CONSTITUTION OF THE MISSISSIPPI STATE ASSOCIATION-

### OF FREE WILL BAPTISTS

PREAMBLE: The Mississippi State Association of Free Will Baptists is designed to consolidate the efforts of the different associations of the state; to harmonize the work; to unify the sentiment of the common cause of the Redeemer; and by a fraternal interchange of views among their members, to prmote the cause of the denomination and stimulate a growth in grace and in the knowledge of gospel truth.

### Article 1-Name

This body shall be known henceforth as The Mississippi State Association of Free Will Baptists.

### Article 2—Purpose.

The object of this association shall be to more thoroughly unity the work of the various associations of Mississippi and to devise and execute measures for the extension of Christ's kingdom in connection with the various associations comprising this organization.

### Article 3—Membership.

This association shall be composed of the various associations of the above named state when joined to this association in duly constituted ways.

### Article 4—Delegation.

Each association shall be allowed three delegates, to the annual meeting of the state association, from each of their respective, local churches. Each ordained minister, in good standing in his respective churches and association, shall have the same privilege as a duly elected delegate.

### Article 5—Discipline.

The State Association shall have the right to settle any question of discipline, doctrine or usage that may properly come before it from time to time from any of the Associations composing the said State Association, or act upon any appeal that may be made by any of the associations belonging to the State Association; said appeal shall have been written and signed by the Association making the appeal, then forwarded by mail or in person to the State Association. The State Association shall not ursurp any of the powers of the local associations or any church within any association.

### Article 6—Officers.

The officers of the association shall consist of a Moderator an assistant Moderator, a Clerk, an assistant Clerk and a Treasurer, each of whom shall be nominated from the floor at each regular meeting. Election shall be determined by a majority of those present and voting. All officers shall hold office until their successor is elected and installed.

### Article 7—Executive Board. Sec. 1.

The Executive Board shall be composed of seven members, three of whom shall be the moderator, the clerk and the treasurer of the State Association and four which shall be elected from the floor of the association, the terms to run from one to four years for the first four elected, then one member to be elected every year.

Section 2. Duties of Executive Board: 1st. To act for the association in matters that demand consideration between the regular annual sessions of the association. 2nd. To fill vacancies in the association that may occur by death, resignation or otherwise between regular sessions of the Association. 3rd. To make written reports of its work to the next regular session of the association.

### Article 8—Boards and Committees.

The association shall have as many Boards and Committees as it thinks necessary to carry out the program it may determine to promote in connection with the National Association.

### Article 9—Finance.

Annual dues shall be in the amount of FIVE CENTS per member for each member in the respective churches of each local association.

### Article 10-Legal representation.

Each delegation to the State Association shall be required to present its credentials, together with a report of the work from the body they represent, to a duly elected Credential Committee.

### Article 11-Parliamentary Laws.

The members of this association shall be governed by the standard parliamentary rules and usages of deliberative bodies.

### Article 12—Meetings.

The association shall hold its regular meetings annually on Thursday and Friday before the third Sunday in November. Special meetings may be called by the Executive Board in case of extreme necessity provided the clerk of each local association has been advised at least 15 days prior to such meetings. Fifteen legal delegates shall constitute a quorum for the special meeting of the association.

### Article 13—

This Constitution may be amended at any regular session of the State Association by a two-thirds vote of the members present, pro-vided the change is recommended in writing on the day before the vote is taken.
