MINUTES OF SEVENTH ANNUAL SESSION OF MISSISSIPPI STATE FREE WILL BAPTIST ASSOCIATION HELD WITH EAST TUPELO CHURCH

NOVEMBER 18-19, 1948

THURSDAY MORNING SESSION

The Seventh Annual Session of Mississippi State Free Will Baptist Association opened with song service led by Bro. W. G. Prude. "Amazing Grace", "What a Friend," and "We'll Work Till Jesus Comes" were sung by the congregation. Rev. George C. Lee led the prayer. Rev. G. M. Pearson read Psalm 116 for devotions and Bro. W. A. Rev. W. O. Knight led the congregation in the hymn "Marching to Zion." Rev. G. C. Price led in Prayer.

Rev. M. L. Hollis read Rev. 3:8, using for a Subject, "The Open Door" His message was inspirational and a challenge to Free Will Baptist of Miss., to go through the open door for the Lord Jesus in this coming Associational year. May we accept this challenge and not let our selfishness as individuals or churches hinder the work of the Lord.

During the noon hour a delicious lunch was served in the Sunday School annex by the ladies of East Tupelo, Beech Springs and Priceville churches.

BOARD OF MISSIONS ANNUAL REPORT

We feel that we have had a very good year although we got a late start and did not have any funds to begin our work with. We believe that with your cooperation and prayers that this coming year that we have great things in store toward the promotion of Christ's Kingdom through the Free Will Baptists of Mississippi. At a meeting of the Board in Amory on January 18th, this year it was agreed that if there was any further work done on the home field we would have to purchase a New Tent and trailer. At this meeting every Board member was present or his proxy was there, also our State Evangelist. The following resolutions were unanimously passed at this meeting.

First—That a New Tent be bought and that at least 30 seat ends be purchased to increase the seating capacity.

Second—That the Evangelist take care of offerings as he thinks best, look to the interests of the Board when the erection of a church building is not under consideration.

Third—That the Evangelist be allowed \$75.00 per week for his services. This amount to be paid from Home Mission funds of State Association where a new church building is to be erected, and by freewill offerings where no building is erected, it being understood that if freewill offerings are inadequate to take care of the weekly salary that the difference be paid from Home Mission funds and should the offerings be more than enough to pay the regular weekly salary, that the surplus be deposited as Home Mission funds.

Fourth—That where a church is being erected and the service of the Evangelist are required and he has to make a trip for which they are unable to pay that he be allowed five cents per mile to take care of expenses.

Five—That the Evangelist select a Choir leader and take care of same through Love offerings.

Sixth—That a suitable and dependable trailer be purchased and equipped for the transportation of Tent and equipment.

Seventh—That the old tent and trailer be sold and whatever funds received be placed to credit of Home Missions.

Eighth—That revival be arranged as soon as possible—some in North Miss., and some in South Mississippi. It was suggested by State Evangelist that we investigate the possibilities for a revival at Bucatunna.

Ninth—That the State Secretary be allowed .10 cents per mile for his expense in connection with the transportation of Tent.

Tenth—That a tenative budget of the year's work be planned in conjuncion with the Board of Education and the Board of Superannuation and when ready be printed in Messenger.

In the Foreign Mission field we have made a fine start toward helping to keep our present Missionaries on the field as well as help in sending others. Revs. Kenneth Turner and Dan Cronk, visited the State in the interest of Foreign Missions the past associational year. We know that when we give a portion of the Lord's money toward sending the Gospel to the lost at home and abroad that He will bless it. May we as Free Will Baptist here in Mississippi awake to the "Macedonian call."

We feel that if the Association will accept the State Unified Program Budget and back it through the years that our Missions efforts will improve and that the Lord will pour us out his blessings far beyond our expectations.

The Board of Missions gave unanimous approval of an agreement where by the Tent and equipment might be used when not in use by State Evangelist. The agreement is as follows:

CONTRACT FOR THE USE OF TENT AND EQUIPMENT BE-LONGING TO MISSISSIPPI STATE FREE WILL BAPTIST AS-SOCIATION.

I, or we, do hereby agree to pay to The Mississippi State Association of Free Will Baptist the amount of \$35.00 per week for first week or part thereof and \$25.00 for each succeeding week or part thereof for the use of tent and equipment.

I, or we, further agree to assume all responsibility for damages to tent or equipment and to pay for same promptly the amount of damages agreed upon by a joint board of arbitration.

I, or we, further agree to pay all expenses incurred in the transportation, erection and dismantling of tent and equipment.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.

CONSTUTION AND BY-LAWS

Of The Mississippi State Association of Free Will Baptist

Article I—Name

This organization shall be known as MISSISSIPPI STATE AS-SOCIATION OF FREE WILL BAPTIST.

Article II—Purpose

The purpose of the Association shall be to more thoroughly unify the work of the various district associations and churches of Mississippi, and to devise and execute measures for the extension of Christ's Kingdom in connection with the various district associations and churches comprising the association.

Article III—Composition

This association shall be composed of the various district associations and churches of Mississippi, when joined in this association in duly constitutional ways.

Article IV—Representation

East district association shall be allowed FIVE delegates from the laity of the association at large, same to be chosen at the annual meeting of the district association, in addition each church will be allowed TWO delegates. Each ordained minister in good repute with his church or district association will have the same privilege as a duly elected delegate.

Article V-Discipline

The State Association shall have the right to settle any question of discipline, doctrine or usage that may properly come before it from time to time, from any district association or church comprising its membership, or may act upon any appeal made by same provided, that, questions or appeals are made in writing presented in person to the moderator of the State Association. The State Association shall not usurp any of the power of the district associations or churches.

Article VI-Officers

The officers of the State Association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer and Field Secretary. These shall be nominated from the floor during the final business session of each annual meeting. Election to be determined by a majority of the duly elected delegates present and voting. All officers shall hold office until their successors have been installed.

Article VII—Boards

The Association shall have the following named Boards, for the purpose of seeing that the work program of the Association is carried on in the best possible manner, namely: Executive Board, Board of Missions, Board of Christian Education, and Board of Superannuation.

Article VIII—Boards and Committees

The Association may add as many other Boards of Committees as deemed necessary to carry out its program.

Article IX-Finance

Associational Funds shall be an amount equal to TEN CENTS per member for each member in the respective churches in each district association.

Article X-State Unified Program

For the purpose of carrying on the various phases of our work, funds received by the Field Secretary will be credited to STATE UNIFIED PROGRAM unless otherwise designated. These funds will be allocated, through the Treasurer to the Boards as follows: Board of Missions will be allocated 60 per cent of total, 40 per cent for Home Missions and 20 per cent for Foreign Missions, 20 per cent to Board of Christian Education and 20 per cent to Board of Superannuation.

Article XI-Official Organ

THE FREE WILL BAPTIST MESSENGER shall be the official organ of the Mississippi State Association. The officers of this organ to be elected annually by the body while in session. Funds for the support of the organ to be furnished through church and individual subscriptions, gifts and from general or association funds of the body.

BY-LAWS

Article I

Section 1. It shall be the duty of the Moderator to preside over each session, preserve order, govern the body according to established parliamentary usage, and appoint all temporary committees.

Section 2. The duties of the Assistant Moderator shall be the same as those of the Moderator when that officer is not present.

Section 3. The Clerk shall keep an accurate record of the transaction of the Association and preserve the same, keep all valuable documents and surrender the same to his duly elected successor in office. He shall have supervision of the printing of the minutes of each session, getting this done at the most reasonable price for quality printing.

Section 4. The Assistant Clerk shall perform the duties of the Clerk when that officer is not present.

Section 5. The Treasurer shall be custodian for all funds of the Association. Funds for out of state expenditures should be sent through this office that a complete record may be available. Allocation of State Unified Program funds will be made by him to various Boards. The Treasurer shall make an annual report to the Association of all funds handled by his office.

Section 6. It shall be the duty of the Field Secretary to see that each district association and church is given a chance to help in the State Unified Program. It is also his duty to look after any field work which the Association deems necessary to its progress.

Section 7. The Moderator and Treasurer shall be allowed \$5.00 per annum for their services. The Clerk will be allowed \$10.00 per annum for his services. The above amounts to be paid from the general or associational fund. The Field Secretary shall receive 10 cents per mile for traveling expenses and the Association may allow him any additional remuneration it may see fit, same to be paid out of Unified Program funds.

Section 8. The Executive Board shall consist of the general officers of the Association and the chairman of the standing boards.

The Board shall act for the Association in matters that demand consideration between regular sessions of the Association. They shall fill all vacancies of officers or board members in the Association that occur by death, resignation or otherwise between regular sessions of the body. The Secretary of Executive Board must record all business transacted in any session and read the same at the next regular sitting of the Association.

Section 9. Each of the standing boards shall organize by electing a Chairman and Secretary-Treasurer. The terms of officers of all boards except the Executive Board shall run for five years each after the original members have served from one to five years as elected by Association.

Section 10. The duties of the Board of Missions shall be to regulate and supervise all mission work in Mississippi and support the Foreign Mission work of the National Association of Free Will Baptists. They shall also aid in raising funds for the mission program and build sentiment favorable to missions.

Section 11. The duties of the Board of Christian Education shall be to keep our people informed concerning the Christian Education program of our denomination; endeavor to promote the cause of Christian Education, receive funds and work in harmony with the National Board.

Section 12. The duties of the Board of Superannuation shall be to provide for our aged, retired or infirm ministers in some form of superannuation and to work out a way of helping our younger and active ministers to prepare for their support when days of active service are past.

Section 13. Each delegation from district association or church shall present credentials with an annual report of year's work.

Section 14. The members of the Association shall be governed by the standard parliamentary rules and usages of deliberative bodies.

Section 15. The Mississippi State Association of Free Will Baptist shall meet annually on Thursday and Friday before the Third Sunday in November.

Section 16. This Constitution and By-Laws may be amended at any regular session of the Association by a two-thirds vote of the duly elected delegates present and voting, provided the change or amendment is presented in writing on the day prior to that on which the vote is taken.
