EXECUTIVE BOARD'S REPORT

To the Missouri State Association of Free Will Baptists when convened in the 1945 session.

June 21, 1945—The Executive Board of the Missouri State Association of Free Will Baptists met in a call session at the Free Will Baptist Gem Publishing House. The meeting was called to order by the chairman, Rev. B. F. Brown, Scripture read from Galatians 6:1-10; prayer by Rev. O. T. Allred. Chairman appointed Rev. Noel Greenway as proxy for Rev. Arlie Hooyer.

Report of the Indian Creek Executive Board was read and received for discussion, relative to the guilt of Cecil Campbell a lengthy discussion followed relative to this matter after which Campbell wrote the following statement:

"In as much as certain who are children of the wicked one have desired to hinder the work of Christ by bringing a false accusation against my christian character and reputation, and because of my love for the Church and the Kingdom, I offer my resignation as a member of the Board for one year, with the privilege of appointing my proxy to prove my innocency. This resignation to take effect at the close of this meeting."

Rev. Kenneth Turner appointed as Proxy.

State Unified Program Fund was brought up for discussion after which it was passed that the funds be allocated as follows: 50% for retirement of note, 25% for general expenses of the Association, 15% for maintenance of Publishing House, and 10% for Superannuation.

Motion carried that Rev. B. F. Brown be responsible for securing a man for the repairing the Publishing House.

Program was planned for the 1945 session of the State Association.

Motion carried that we recommend the lawyer (Mr. Sater) go ahead with the proposed charter.

Motion carried that we allocate \$25.00 per meeting to the needy churches of the Northeast Missouri Association for Evangelistic endeavor from the Church Extension Fund.

A discussion relative to the publishing of the Gem was carried on for some time.

CONSTITUTION

- 1. This association shall be called the Missouri State Association of Free Will Baptists.
- 2. The object of this association shall be for the bringing together of the Free Will Baptists of the State of Missouri in one great annual gathering, so they can get better acquainted with each other, and for the upbuilding of the Free Will Baptist churches of Missouri, and for the salvation of souls.
- 3. This association shall be composed of duly elected delegates, elected by the bodies holding membership in this body.
- v 4. The officers of this Association shall be a moderator, an

assistant moderator, a clerk who shall be treasurer and shall superintend the printing of the minutes at \$5.00 per annum, and shall hold their offices until their successors shall be elected, a board of trustees of five members whose term of office shall be as follows: One for one year, one for two years, one for three years, one for four years, and one for five years, and at the expiration of these terms, one is to be elected for a term of five years, and who shall hold their offices until their successors are elected; and further, if any vacancies occur between sessions of the Association, the Board shall fill such vacancy or vacancies until the next session of the Association, who shall perform the following duties: First, shall be the legal corporation of the Association with the corporate name of the Board of Trustees of the Missouri State Association of Free Will Bantists, to be a Board of Missions and Church Extension, to secure, hold, use and convey money, homes or lands for the propagation of the gospel in connection with the Free Will Baptist denomination. Second, to receive, hold, manage, use, control or convey any property intrusted to the Association for and in accordance with the donor's purpose. Said Board of Trustees shall also compose the Home Mission Board. They may be chosen from ministers, deacons or delegates.

- 5. This Association shall not usurp any authority over the Quarterly Meetings, Yearly Meetings, or Associations that shall be under its supervision, but shall be an advisory body to help them.
- 6. Seven or more ordained ministers or deacons from two or more bodies, belonging to this Association shall constitute a quorum to transact business.
- 7. The clerk or assistant clerk, and in their absence, the senior minister in age, shall call the association to order for business, and call moderator or his assistant to chair, and if neither moderator nor his assist. are present, then the senior minister in age shall act as moderator. On taking his chair, the moderator shall call for the reading of the letters from the different bodies composing this Association, and after the letters are read he shall seat the delegates. After the delegates are seated, the election of officers shall be in order.
- 8. Any organized Quarterly Meeting, Yearly Meeting or Association of Free Will Baptists may unite with this body at any regular session through a letter or delegates by a two-thirds vote of all members present.
- 9. This constitution may be added to, amended or changed at any regular session of this body a two-thirds vote of all

members present, after written notice of the contemplated change has been published in the official paper three months previous to the session at which such change is to take place.

BY-LAWS

- 1. All business meetings shall be opened by singing, reading a portion of God's Word, and prayer; and shall be closed with prayer.
- 2. All business, except routine, shall be brought before the body by committees, but should any committee refuse or fail to present to this body any business given to it any member of this Association, then such business may be presented to the body by any member, but cannot be discussed, unless by a vote of this body.
- 3. No one shall speak more than five minutes or more than twice on the same subject without consent of the moderator.
- 4. Any member of this body can appeal from the decision of the moderator to the Association, and by a majority vote thereon, the objection shall be sustained or rejected.
- 5. No one shall leave the association without the consent of the moderator.
- 6. Anyone desiring to speak shall arise and say, "Brother Moderator," but shall not speak further until he or she is recognized by the moderator.
- 7. The moderator shall stop all discussion when not carried on in a Christian spirit, or when he thinks it is likely to lead to discord and division.
- 8. The officers of this body shall submit, at every annual session, a report of the work done for this Association.
- 9. This Association may correspond by messenger of otherwise with other religious bodies.
- 10. All officers of this Association shall be nominated from the floor and elected by ballot, except when the rules are suspended, then election may be by acclamation.
- 11. All resolutions and reports shall bear the names of all the members of the committee who favor them; and if the names be not a majority of all members of such committee, then the clerk shall not read the resolution or report.
- 12. All committees shall be appointed by the moderator, but any appointment may be changed by a two thirds vote of this body.
- 13. All business coming before this association shall be decided by secret ballot when there is any opposition or object-

- 14. A majority of all votes shall be final upon all subjects except to amend the constitution, receive quarterly meetings or associations, and the changing of the members of the committees appointed by the moderator, then it shall require a two-thirds majority.
- 15. The number of delegates to the State Association shall be one delegate for the association and in addition, one delegate for every fifty resident members or major fraction thereof.
- 16. The standing delegates to this Association shall be all ordained ministers and their companions, provided the companion is a member in good standing in some Free Will Baptist Church belonging to this State Association; all ordained deacons; and Associational Clerks.
- 17. These By-Laws may be amended or changed at any regular session of this Association.

FREE WILL BAPTIST ARTICLES OF FAITH

- 1. THE BIBLE.— The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

- 2. GOD There is one living and true God, revealed in nature as the Creator. Preserver, and Righteous Governor of the universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.
 - 1 Cor. 8:6; Matt. 28:19.
- 3. CHRIST.—Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified and is our ever present Savior and Lord.
 - St. John 1:1-12.

Psalm 22:28; 97:2.

4. THE HOLY SPIRIT.—The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

- 5. THE GOVERNMENT OF GOD.—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires
- 6. THE SINFULNESS OF MAN.— Man was created innocent, but by disobedience fell into a state of sin and condemnation

His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

- 7. THE WORK OF CHRIST.—The Son of God, by His incarnation, life, sufferings, death and ressurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.

- 8. THE TERMS OF SALVATION The conditions of galva tion are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2.
