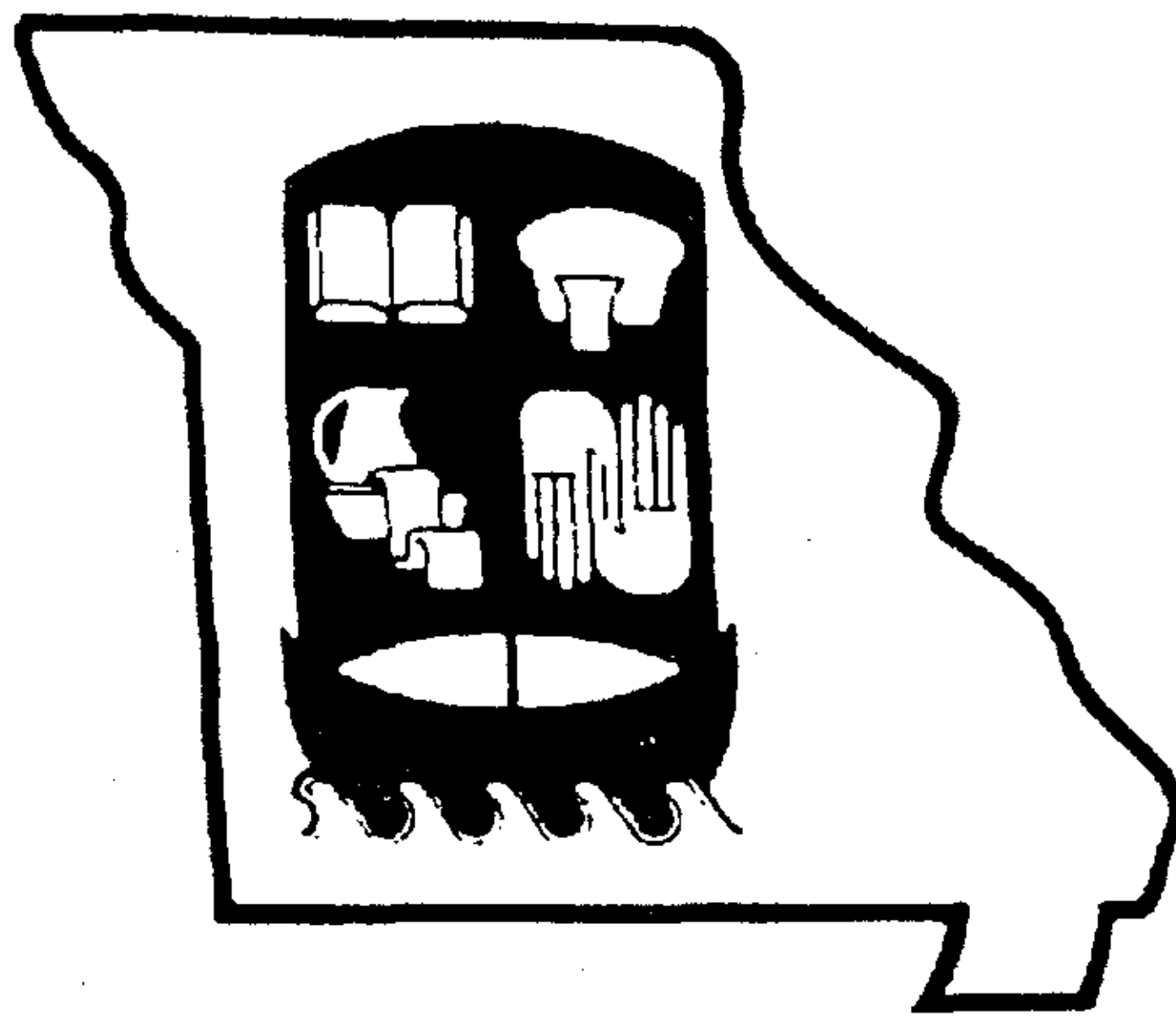

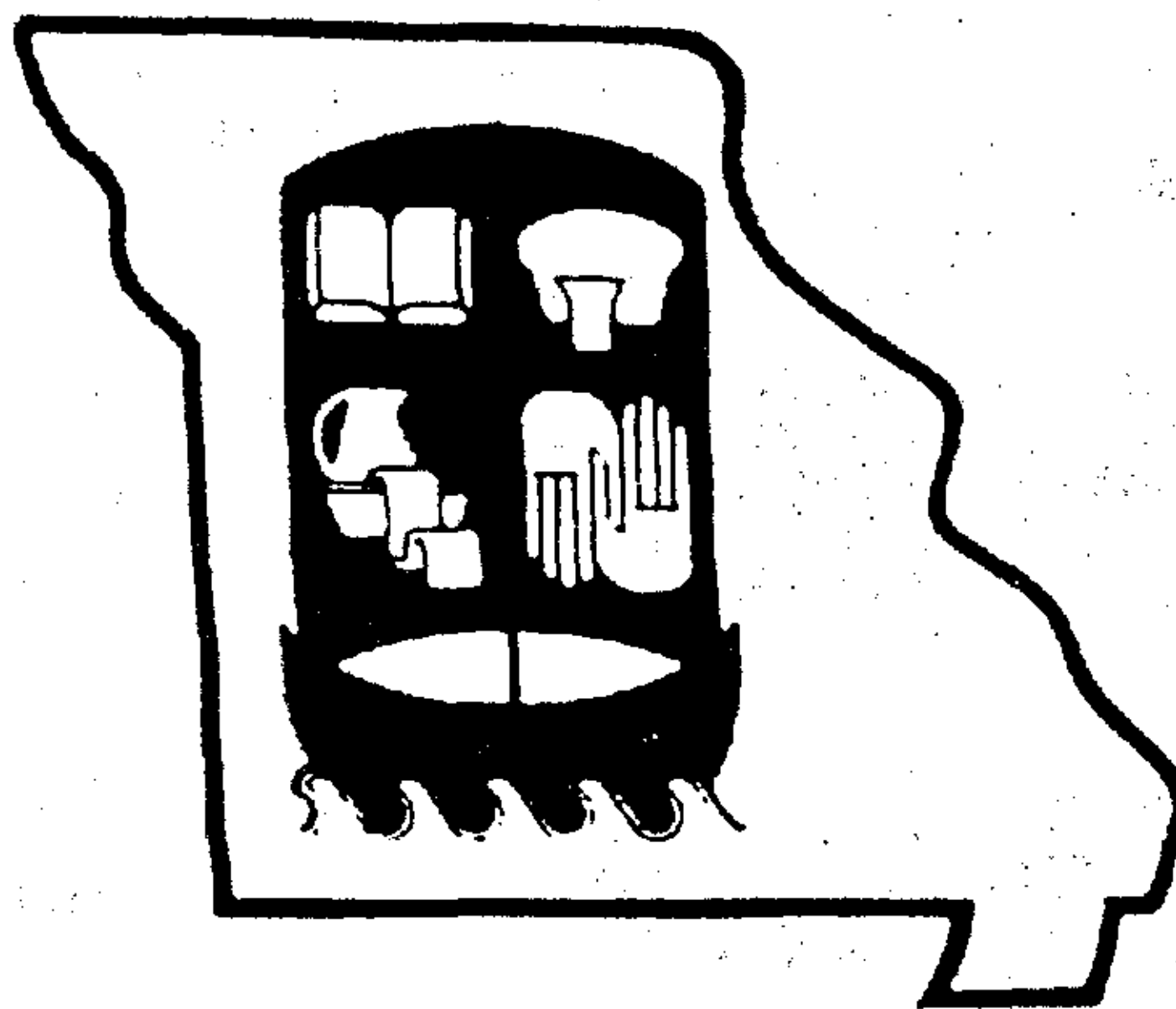

- #3. A. We recommend the year 2000 budget be accepted as approved by the General Board.

B. We recommend the Executive Department be allowed to transfer \$40,000.00 from the Executive Department Trust Account to the Youth Camp Board for building a new Tabernacle and to do other expansions, on the condition the Missouri State Association approves the Youth Camp Board's Proposal.
- #4. We recommend a proposed goal amount of \$100,000 for the Free Will Baptist Bible College re-location program be accepted. (Letter provided).
- #5. We recommend the Youth Camp Board be approved to construct a multi-purpose building, and the Youth Camp Board to begin raising money for this project.
- #6. We recommend that the MoArk District Association of Free Will Baptists be received into fellowship of good standing in the Missouri State Association of Free Will Baptists.

Scholarship Program

Missouri State Association of Free Will Baptists

OBJECTIVES

(Primary)

1. To encourage and promote an increased involvement of MO Free Will Baptist students in attendance of one of our four Free Will Baptist Colleges.
2. To provide financial assistance to current and future MO Free Will Baptist ministerial students in preparation for ministry who are or will be attending one of our four Free Will Baptist Colleges.

(Secondary)

3. To encourage and promote an increased level of academic and clerical preparedness and proficiency among members of MO Free Will Baptist clergy by enrollment in an approved, accredited seminary.
4. To provide financial assistance to Free Will Baptist ministers who are currently serving in Missouri, who are attending approved seminaries in pursuit of their Masters or Doctoral degrees in any area of theology or ministry.

INCOME SOURCE & PLAN

1. The Scholarship Fund shall be funded by revenue received from Brotherhood Insurance Company through retro premium refunds, gifts, and a percentage of the Lebanon Bible & Book Store Co-op funds. The percentage will be determined each year with the adoption of the budget.
2. A revocable Trust shall be established with the Free Will Baptist Foundation to establish a perpetual fund that will supply future scholarship needs.

RECIPIENT QUALIFICATIONS

The student shall:

1. Be a member and maintain membership in good standing in a MO Free Will Baptist Church.
2. Maintain at least a 2.0 GPA on a 4.0 scale.
3. Be pursuing minimally an A.A. in a ministerial degree.
4. Undergraduates must be full-time students maintaining at least the minimal hours of credit each semester for that status.
5. Graduate level students must maintain minimal part-time status enrolled in at least 2 courses per semester or a combined total of 4 courses per year.

ADMINISTRATION & DISBURSEMENT

1. The scholarship program shall be administered by the Executive Committee of the MO Free Will Baptist State Association.
2. Specific allocation amounts to individual students shall be determined annually by dividing budgeted money by the number of qualified students with equal distribution to each student.
3. Scholarship awards will be limited to five years of undergraduate work and three years of graduate work.

AGREEMENT

A recipient of this scholarship agrees to repay the funds which he receives from this scholarship if he fails to have an active ministry in a Free Will Baptist Church for five years after completing his course of study.

We have not changed our purpose in these years and continue to produce some of the finest servants of the Lord.

Because....we believe that the training of Christian workers was the historical intent of our denomination in bringing FWBBC into existence.


Because....the need for such training is even more critical than when we began,

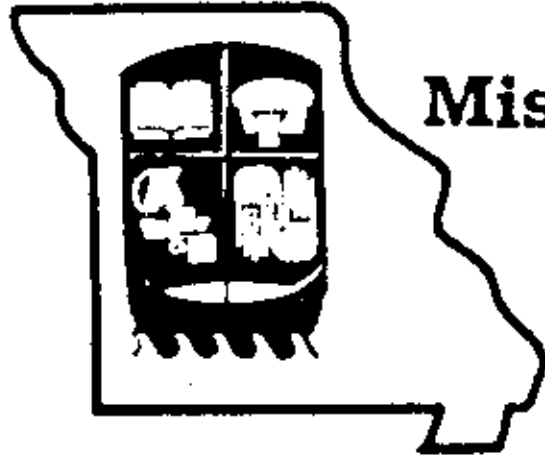

God has graciously blessed Missouri Free Will Baptists during 1998. He is to be praised for His blessings, and Missouri Free Will Baptists are to be commended for their labors as instruments of His grace.

In 1998, Missouri Free Will Baptists gave \$507,438.82 through the Cooperative Plan and \$303,462.39 through the Show-Me Plan. This was an increase over 1997 Cooperative gifts which totaled \$464,453.81, and the 1997 Show-Me gifts which totaled \$252,902.00. Altogether, \$1,038,158.75 was given through the State Office.

The Executive Office helped sponsor two special meetings in 1998. A Minister's Retreat was held at Stonecroft in March. Rev. Carl Cheshier and Rev. James Forlines were the guest speakers. I would encourage the ministers to make a special effort to attend the 2000 retreat which will be held March 20-22, 2000. The retreat is a joint effort of the Executive Office and the Christian Education Board. The annual Minister/Layman's Retreat and All Boards meeting was held at the Youth Camp in September. Rev. Dale Skiles and Rev. Rick Dablemont were the speakers. The 1999 Pastor/Layman's Retreat will be held September 13.

The Executive Office has been assisting the Youth Camp Board in making the financial arrangements needed to obtain funds for building a new worship center at the camp. The General Board recommendations and the proposed budget for 2000 reflect the changes needed to help the Youth Camp obtain financing and to enable them to repay the indebtedness.

The National Home Mission Board hosted the North American Strategy Forum in January '99, to form a strategy for growth and advancement for Free Will Baptists. A seven-point strategy was developed which I recommend Missouri Free Will Baptists adopt and implement.

There has been a good response to the 2004 National Convention Fund. However, we are still about \$2,000 short of what we need. I would encourage each church to participate with their local association in raising the needed funds.

Missouri Christian Education Board Of Free Will Baptists

Report to the 1999 Missouri State Association

Virtually all of our funds are allocated to seven specific projects. First, we are happy to sponsor Al Taylor at this year's Missouri State Association. Dr. Al Taylor, Stewardship Director for the Church of God, Cleveland, Tennessee, will be conducting the Tuesday morning seminar/services on Stewardship. He has been greatly used within our denomination.

Second, we are always seeking to expand and upgrade our Lending Library. These series can be used as a Sunday School elective, Wednesday night program, etc. If you have a suggestion for a possible purchase of a specific series, please give the information to one of our board members. Three years ago, we had a booth at the State Association in which we distributed many of our library products. Many of those items have yet to be returned. Please check your library for these items. We have made efforts to strengthen the "Leadership" segment of our library. Board Member, Melvin Moon, is primarily responsible for the library.

Third, we were happy to work with the State Executive Department in a joint project regarding a Minister's Retreat March 22-24, at Stonecroft Conference Center. Rev. Rob Morgan, pastor of the Donelson FWB Church in Nashville, Tennessee, did a fantastic job. Those tapes are available at this year's State Association. We are hoping to announce the dates and speaker for the 2000 Pastor's Retreat. We try to combine some time for relaxation and fellowship with practical instruction and motivation. Plan to join us this year.

Fourth, we are assisting, through equipment purchase, scholarships, and shared expenses, the External Studies program which meets at Cuba, Mountain Grove (Gary Fry), Park Hills (Ken Dodson). We have been providing two minister's scholarships up to \$160.00 each based on need. Scholarship recipients will be determined by the faculty. The External Studies Program continues to develop at a tremendous pace. Rev. Rick Dablemont, is both the ESP Administrator and teaches at the Cuba Institute.

Fifth, we continue to be the data gathering agency for Roll Call Sunday. Board Member, Gary Fry, is assuming responsibility for Roll Call Sunday.

Sixth, we have produced the *C. E. News* on a quarterly basis. This paper contains several items including: a spotlight church, promotional ideas, suggestions on leadership and finances, and Christian education helps. We include a sermon by one of our men with a "how I prepare" segment. The current issue is available here at this meeting. Frequency has diminished because of the time required to produce the paper.

Seventh, we continue to provide a scholarship to deserving college students at Hillsdale College and Free Will Baptist Bible College. These scholarships are determined by the college administration.

Greetings from your Missouri State Youth Camp Board

As a result of your prayers, work and support the 1998 camp session ended with 65 young people receiving the Lord as their Savior and 81 rededicated their lives. The total registration was 1,222 and our youth gave \$3,791.99 to complete the "New Hope In Panama Project" which was started in 1997. The total amount raised was \$13,900 with special thanks going to the Missouri WNAC for their help in this great endeavor.

We are also thankful to report that the law suite which was filed against the camp was finally settled , out of court, on August 26 for an undisclosed amount. Thanks for your prayers concerning this matter.

At the State Meeting in June our board was instructed to do the following: To place a moratorium on building cabins at the camp by churches or associations. Seek to obtain title from those churches and associations who own cabins there. Then do a self study to evaluate the needs and estimated costs of updating the present camp facilities for future use of Missouri Free Will Baptists. The results of that study was presented to the General Board in November. In this report we stated that our pressing need is a new tabernacle. This will involve relocating the ball field to the west side of the camp on property we recently purchased. The estimated costs of a new tabernacle will be around \$300,000.

We greatly desire your prayers and support as we plan for the coming millennium.

Monday Morning, June 7, 1999

The meeting was opened with the theme song "Yes, Lord Yes" led by Anita Haney. The welcome was given by Ann Poletti and the response by Barb Lee. The song, "The King is Coming" was sung by Debbie Beck.

The President, Shirley Jackson, introduced Shirley Lotz, new missionary appointee to the Denver, Colorado area, who gave the morning devotion. Shirley used the theme "Yes to the King" and told of the times in her life that she said "Yes" to the King. She told of her experience in the death of her husband and her marriage to Rev. Chuck Lotz. This is "The Message" and God will bless it. They have seen three people saved this year and have a present membership of 42.

Debbie Beck, home missionary to Moberly, MO, told of the blessing of being without her cane for almost a year. She shared that the people of the Moberly Church are showing excitement about what the Lord is doing in the Moberly area. She and her husband, Lynn, have been in Moberly about four years. She quoted Philippians 4:13 "I can do all things through Christ which strengtheneth me."

Brian Brinkchoff, home missionary to Joplin, MO, brought greetings from the Cornerstone Church in Joplin. 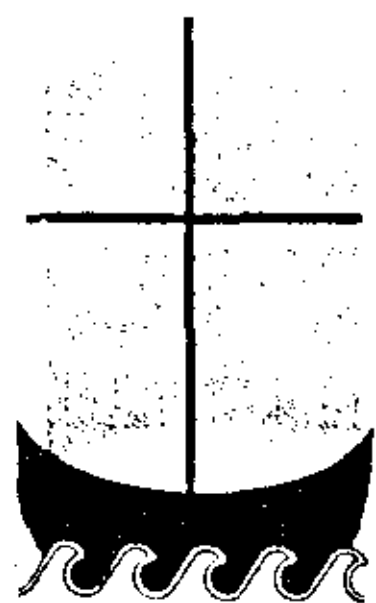

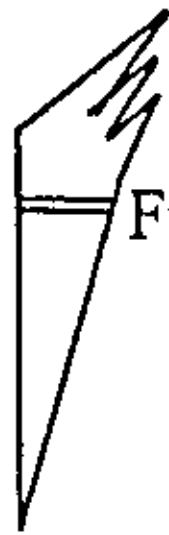

By-Laws

BY-LAWS

NAME

1. This Association shall be called the Missouri State Association of Free Will Baptist.

PURPOSE

2. The object of this Association shall be the bringing together of the Free Will Baptists of the State of Missouri in one annual gathering that we may become better acquainted with one another, the upholding of the Free Will Baptists Churches of Missouri, and a world-wide outreach of souls.

MEMBERSHIP

3. The Association shall be composed of the members of the various local affiliated Associations.
4. Any organized Quarterly Meeting, Yearly Meeting, or Association of Free Will Baptists may unite with this body at any regular session, through a letter or delegates by a two-thirds vote of all delegates present.

OFFICERS

5. The officers of this Association shall be Moderator, Assistant Moderator, Clerk, and Assistant Clerk, who shall be elected annually at the close of each session and hold their office until their successors are elected and qualified.
6. The officers of this body shall submit, at every session, a report of the work done for this association.
7. The Moderator shall be the principal executive officer of the Association and he shall sign, with the clerk or any other people, officer or agent of the Association there unto authorized by the General Board, any deeds, mortgages, bonds, contracts, or other instruments which the General Board has authorized to be executed, except in cases where the signing and execution thereof shall be expressly delegated by the General Board or by these By-Laws to some other officer or agent of the Association, or shall be required by law to be otherwise signed or executed. The duties of Moderator shall include presiding at the meetings of the State Association, the General Board, and the Executive Committee when the conditions of By-Law 44 are fulfilled, to appoint such committees as are created without provision for their selection, to set the time and place for the meetings of the General Board and Executive Committee, and in general, to fulfill whatever responsibilities that may be commensurate with his office or delegated to him by the body or General Board.
8. In the absence of the Moderator, or in the event of his death, inability or refusal to act, the Assistant Moderator shall perform the duties of the Moderator, and when so acting, shall have all the powers of and be subject to all the restrictions upon the moderator. The Assistant Moderator shall perform such duties as from time to time may be assigned to him by the

Moderator or by the General Board.

9. The Clerk shall keep an accurate record of all business transactions, shall superintend the printing of the minutes, and shall receive an honorarium of an amount agreed upon by this body.
10. The Clerk shall:
 - a. Keep the minutes of the Association and of the General Board meetings in one or more books provided for the purpose.
 - b. See that all notices are given in accordance with the provisions of these by-laws or as required by law.
 - c. Be custodian of the Association records and of the seal of the Association and see that the seal of the Association is affixed to all documents the execution of which on behalf of the Association under its seal is duly authorized.
 - d. In general, perform all duties incident to the office of clerk and other duties as from time to time may be assigned to him by the Moderator or by the General Board.
 - e. In the absence of the clerk, or in the event of his death, inability, or refusal to act, the Assistant Clerk shall perform the duties of the Clerk and when so acting shall have all the power of and be subject to all the restrictions upon the clerk.

The Assistant Clerk shall perform such duties as from time to time may be assigned to him by the clerk or by the General Board.

11. No Officer shall serve the same office more than three consecutive years.
12. All standing boards shall be composed of five (5) members, exclusive of the General Board. Standing Boards include the Board of Christian Education, the Home Missions Board, the Senior Adult Ministries Board, the Youth Ministries Board, the Youth Camp Board, and the General Board.
13. The duties of the various standing boards shall be to:
 - a. Plan and supervise both short and long-range programs of ministry.
 - b. Manage as good stewards all funds and properties entrusted to its care.
 - c. Annually submit a detailed budget for approval by the State Association. The budget shall include:
 - (1) Projected income along with expected sources of income.
 - (2) Projects planned and the cost of said projects.

(3) Maintenance along with its cost.

(4) Work in harmony with and toward the common vision of the entire State Association.

14. No board shall initiate any litigation in pursuit of its ministry. Neither shall any board enter into any litigation in the pursuit of its ministry except as required because suit has been initiated against the board. The only exception is that which the State Association may authorize when the State Association is not in session.
15. The personnel of each of the foregoing, exclusive of the General Board, shall be elected as follows: The first named for a term of one year, the second for a term of two years, the third for a term of three years, and thereafter each shall be elected for a term of five years.
16. The personnel of the General Board shall be composed of the officers of the State Association, the chairman of all standing boards, and one member from each affiliated Association, to be elected by the state body, whose term of office shall be two years and so constituted that the ' expiration date of the term of office of half of these shall expire one year and the other half the following year. This shall be determined by alphabetical order of the names of the affiliated Association.
17. No person shall fill more than one office at the same time except as he may become a member of the General Board by virtue of being chairman of the board which he is an elected member.
18. Any vacancy occurring in the General Board may be filled by the affirmative vote of a majority of the remaining board members through less than a quorum of the General Board, unless otherwise provided by law.
19. All board members elected to fill a vacancy shall be elected for the unexpired term of his predecessor in office.
20. Any member of the standing boards of the State Association who does not put forth any interest in or function on said board for the period of one year, shall have his office declared vacant and a new member be elected by this Association to fill his unexpired term of office.

DUTIES

21. The General Board shall have power to act in behalf of, and for the State Association from one regular session to another, and shall have power to elect such officers as may be necessary to carry out the plans and undertakings of the State Association. The General Board shall have the right to employ an Executive Secretary who shall serve as treasurer of the Association except in cases where this responsibility shall be expressly delegated by the General Board or by these by-laws to some other officer, agent, or board of the Association. He shall make an annual financial report to the Association.
22. The General Board shall have the power to fill any irregular vacancies that may occur in its own body and shall also have power to fill any irregular vacancies that may occur in any

department of work between sessions of the State Association. It shall be the duty of this Board to make written reports of all its work to each session.

23. An Executive Committee consisting of seven members of the General Board shall be composed of the Moderator, Assistant Moderator, Clerk of the State Association, and four other members to be elected by the General Board; two members to be elected for a two year term and two members to be elected for a one year term and then two members to be elected each year thereafter, whose duty it shall be to act on all matters coming within the scope of the work of the Board when said Board is not in session. It shall also plan and execute the program for the annual sessions of the Missouri State Association. The Executive Committee shall be the governing board of the Lebanon Bible and Book Store and shall establish policy for the operation of the Book Store Manager. The Book Store manager shall employ and supervise the other employees. The Executive Committee shall serve as the Budget Committee.
24. A majority of the number of the General Board members shall constitute a quorum for the transaction of business at any meeting of the General Board, but if less than such a majority is present at a meeting, a majority of the Board members present may adjourn the meeting from time to time without further notice.
25. An act of the majority of the Board members present at a meeting of the General Board at which a quorum is present shall be an act of the General Board.
26. A Board member of the Association who is present at a meeting of the General Board at which action on any Association matter is taken shall be presumed to have assented to the action taken unless his dissent shall be entered in the minutes of the meeting.
27. The General Board may authorize any officer or officers, agent or agents to enter into any contract or execute and deliver any instrument in the name of or on behalf of the Association and such authority may be general or confined to specific instances.
28. Any person or agent elected or appointed by the General Board may be removed by the General Board whenever in its judgement the best interests of the Association would be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the persons so removed.
29. By resolution of the General Board, the Board members may be paid their expenses, if any, of attendance of each meeting of the General Board. No such payment shall preclude any Board member from serving the Association in any other capacity and receiving compensation therefore.
30. The General Board shall provide an Association seal which shall be circular in form and shall have inscribed thereon the name of the corporation and the state of incorporation and the words "Corporate Seal."

COMMITTEES

31. The Moderator shall appoint a committee on committees consisting of five members who shall appoint all committees with the exclusion of the Auditing Committee who shall be appointed by the General Board. The first appointed shall serve a term of one year, the second a term of two years and the third a term of three years; thereafter, each shall be appointed for a term of three years, Members of standing boards, with the exception of the General Board, are not eligible to serve on the Auditing Committee. Their duties are to audit all state books.
32. All resolutions and reports shall bear the name of all the members of the committee who favor them, and if the names be not a majority of all members of such committee, then the clerk shall not read the resolutions or report.

REPRESENTATION

33. The standing delegates of this Association shall be all ordained Free Will Baptist ministers and their companion, all ordained deacons, and Associational Clerks, provided they are members in good standing in some Free Will Baptist Church in this State Association.
34. The number of elected delegates to the State Association shall be seven delegated from each affiliated local association or yearly meeting, one delegate from each church, plus one delegate for fifty members or larger fraction thereof. Each church which represents must be a member of a local association or a yearly meeting holding membership in this body.
35. This Association may correspond by messenger or otherwise with other religious bodies.

VOTING

36. Those entitled to vote at any annual or special meeting of this State Association shall be the elected delegates and the standing delegates as defined By-Laws 33-34, and each elected delegate or standing delegate shall be entitled to one vote.
37. A majority vote shall be final upon all subjects except to amend the By-Laws, receive Quarterly Meetings or Associations, and the changing of the members of the committees appointed by the Moderator, then it shall require a two-thirds majority.

MEETINGS

38. The sessions of the Association shall convene on Monday evening at 7:30, following the first Sunday, in June beginning 1987.
39. The membership of the State Association may designate any place, either within or without the State of Missouri, for any annual meeting. Any special meeting may be called by the General Board. A waiver of notice signed by all members entitled to vote at a meeting may designate any place, either within or without the State of Missouri, unless otherwise prescribed by stature, as the place for holding of such meeting. If no designation is made, or if

a special meeting be otherwise called, the place of the meeting shall be the principle office of the corporation of the State of Missouri.

40. In the event the necessity arises from war, or pestilence, or any cause which prevents a regular meeting of the State Association, whether such a condition is of a local or general condition, then the General Board shall be privileged to call and act with full authority in all matters pertaining to the general welfare of the State Association, providing whatever transaction passed shall be by two-thirds vote of the members present, and providing that such transactions shall not conflict with the purpose and edicts of the By-Laws of the State Association.
41. Special meetings of the Association for any purpose or purposes, unless otherwise prescribed by statute, may be called by the General Board, and shall be called by the Moderator at the request of not less than fifty percent of all the delegate members duly elected by local Associations, Quarterly Meetings and local churches affiliated with the Association.
42. All committees and standing boards shall be permitted to take official votes on any item of business within the scope of their work by mail or by telephone conference call, provided such action is called by a chairman of a board or committee and has been proposed by at least two members of the board or committee.
43. Seven or more ordained ministers or deacons from two or more affiliated Associations belonging to the State Association shall constitute a quorum to transact business.
44. All business meetings shall be opened by singing, reading a portion from God's Word, and prayer, and shall be closed with prayer.
45. Special meetings of the General Board or the Executive committee shall be called when necessary by the Moderator, with the written consent of three other members of the Executive Committee. Special meetings of the General Board shall also be called upon written request of one-fourth of its members. Special meetings of the Executive Committee shall also be called upon written request of a majority of its members.
46. Notice of any special meeting shall be given at least fifteen days previously thereto by written notice delivered personally or mailed to each Board member at his business address, or by telegram. If mailed, such notice shall be deemed to be delivered when the telegram is delivered to the telegraph company. Any Board member may waive notice of any meeting. The attendance of a Board member at a meeting shall constitute a waiver of notice of such meeting, except where a Board member attends a meeting for the express purpose of objecting to the transaction of any business because the meeting is not lawfully called or convened.
47. Unless otherwise provided by law, whenever any notice is required to be given to any member or Board member of the Association under the provisions of these By-Laws or under the provisions of the articles of incorporation, a waiver thereof in writing, signed by the person or persons entitled to such notice whether before or after writing, signed by the person or

persons entitled to such notice whether before or after the item stated therein shall be deemed equivalent to the giving of such notice.

DISCIPLINE

48. The State Association shall not usurp any authority over the Quarterly Meetings or Associations that shall be under its supervision, but shall be an advisory body to help them.
49. The fiscal year of the Association shall begin on the first day of January and end on the 31st day of December each year.
50. All checks, drafts, or other orders for the payment of money notes or other evidences of indebtedness issued in the name of the Association, shall be signed by such officer or officers, agent or agents or the Association and in such manners as shall from time to time be determined by resolution of the General Board.
51. No loans shall be contracted, and no evidence of indebtedness shall be issued for which the State Association shall be legally or morally responsible except as approved by the Missouri State Association of Free Will Baptists while in session, or by the General Board while in session.
52. The General Board by a majority vote of the voting delegates of the State Association, shall be authorized to create or to increase any bonded indebtedness of the Association.
53. The General Board of the Association shall be authorized by a majority vote of the voting delegates of the State Association, to sell, lease, exchange, mortgage, pledge, or otherwise dispose of all, of the property and the assets of the Association.
54. All funds of the corporation not otherwise employed shall be deposited from time to time to the credit of the Association in such banks, trust companies, or other depositories as the General Board may select.
55. The salaries of employees shall be fixed from time to time by the General Board.
56. The meetings of the State Association and the General Board shall be governed by the rules of parliamentary law as set forth in Robert's Rules of Order, except in the case of those rules which are superseded by some rule of this organization.
57. The Clerk or Assistant Clerk, or in their absence the senior minister in age, shall call the Association to order for business, and call the Moderator or Assistant Moderator to the chair, and if neither moderator or assistant moderator is present, then the senior minister in age shall act as chairman to open the floor for nominations and carry out the election of a moderator pro-tem.
58. All business, except routine, shall be brought before the body by committee, but shall any committee refuse or fail to present to this body the business given it by any delegate of this

Association, then such business may be presented to the body by any delegate, but cannot be discussed unless by a majority vote of this body.

59. Anyone desiring to speak shall rise and say "Brother Moderator" but shall speak no further until he or she is recognized by the Moderator.
60. No one shall speak more than five minutes, or more than twice, on the same subject without the consent of the Moderator.
61. Any delegate of this body can appeal from the decision of the Moderator of the Association, and by a majority vote thereon, the objection shall be sustained or rejected.
62. No one shall leave the Association when in a business session without the consent of the moderator.
63. The moderator shall stop all discussion when not carried on in a Christian spirit, or when he thinks it is likely to lead to discord or division.
64. All business coming before this Association shall be decided by secret ballot when there is any opposition or objection to open vote.

AMENDMENTS

65. These By-Laws may be amended at any regular session by a two-thirds majority vote after the proposed amendment has laid on the table one day.
