

# Proceedings of the Mt. Moriah Free-Will Baptist Association

The Sixty-fifth Annual session of the Mt. Moriah Free-Will Baptist Association was held with Union Hill Church, Pickens Co., Ala., Oct. 9, 10, 11, 1915.

The introductory sermon was preached by Rev. W. B. Montgomery-text 7-17-2 Corinthians, 4-42 after which an intermission of one hour

and a half was taken for refreshments.

At the appointed time the house was called to order by the former Moderator. After reading 133 Psalm and prayer, the former Clerk serving until the body was organized. The letters from various churches were handed in and read and names of delegates enrolled as per statistical table. The Association proceeded to elect Moderator and Clerk, whereupon Rev. Woods Springfield was elected Moderator and J. S. Stokes Clerk.

Extended an invitation for new churches. None present. Invited visiting brethren to seat with. None present.

Mission Committee, M. B. Fields, J. R. Hall, C. E. Hamlin, R. D. Belk, J. M. Stokes. By motion the association adjourned until Monday morning at 8 o'clock.

#### SUNDAY SERVICE.

Rev. T. L. Walker preached at 9 o'clock, text Heb. 14-14, Rev. J. D. Byars preached at 11 o'clock, text Revelations 2-1, 2 and 3.

At 2 o'clock the body was called together by the Moderator for the purpose of ordaining Rev. W. R. Robertson as a minister of the gospel.

The ordaining council consisted of Revs. Wood Springfield, J. D. Byars, J. E. Mathis, W. B. Montgomery, T. L. Walker. After the laying on of hand and prayer we recommended Rev. W. R. Robertson to

the religious world a worthy and consistent minister of the gospel to preach the gospel where ever his lot may be cast. After which Rev. Woods Springfield preached a very impressive sermon to a large and attentive congregation.

#### MONDAY MORNING AT 8 O'CLOCK.

The Association met persuant to adjourn and after a scriptural lesson from the 4th chapter of Ephesians and prayer by the Moderator.

The Moderator called the house to order and the following business was conducted:

(1)—Call the roll. All churches represented.

(2)—Call for the reading of minutes of Saturday. They were read and approved.

(3)—Report of committees called for and read.

Committee on order of business.

(1)—We recommend the usual order of business adopted.

(2) We recommend that the secretary be elected treasurer and that he superintend the printing of the Minutes and that he have it done to the best interest of the body and that he be allowed \$10 for his service. Adopted.

(3)—Recommend that we continue the executive committee.

Adopted.

(4)-That the next sessior of the Association be held with Macedonia Church, Pickens County, Alabama on Saturday before the second Sunday in Oct. 1916.

(5)—That Rev. T. L. Walker preach the introductory sermon and

Rev. W. E. Hardin be his alternate. Adopted.

(6)—That our Moderator b eour associational evangelist that he visit the churches sometime during the year that the officials of the churches see that he is reasonably payed for his service. Adopted.

(7)—That we organize a ministers conference and that we meet an-

nually with our association.

(8)—That we elect delegates to meet with the Cahaba River Association and that we pay their expenses. Adopted.

(9)—That we have our church covenant printed in our minutes.

Adopted.

(10)—That we elect delegates to represent us in the State Convention.—Adopted.

Call for report on temperence.

We, your Committee on temperance beg leave to report as follows:

We recommend that all of our people be temperate and self-controlling and not participate in sin nor ungodliness and totally abstain from all intoxicating drinks and we urge that our Deacons and Ministers in charge of all churches to urge that the brothers and sisters be temperate in all things. Rev. T. E. Walker, Chairman—Report received and Committee discharged.

#### SABBATH SCHOOL.

We, your Committee on Sabbath School submit the following: After

paying close attention to the reading of letters from various churches we find but very little interest taken in Sabbath School, we urge that each of our churches organize a Sabbath School and maintain it, Rev. W. E. Hardin, Chairman.—Received the report and Committee discharged.

#### PUBLICATION, EDUCATION AND LITERATURE

We, your committee beg leave report:

1st—We recommend that the printing of our minutes be done where

the churches can get in possession of them as quick as possible.

2nd—Seeing that we are in a progressive age. We recommend that our people take greater interest in education and training our children as the moral training of the mind has a great tendency to cause the mind to think, the heart to feel the necessity of higher attainments and we especially urge our people to read and study the Bible as all of the revelations come from God through the Bible.

The demand for education was never greater than now.

Young men entering the ministery should be encouraged to strive for

a more thorough education.

3rd—We recommend that we be very careful in selecting for our home reading, more especially for our children. Believing that the reading of novels and the histories on the lives of bad characters have a tendency to lead our young men astray.

4th—We recommend that we use the Sunday School literature pub-

lished by our own denomination.

5th—We recommend that our churches use some good paper publish

ed by our own denomination.

6th—We recommend that this Assocition aid in the education of our young ministers—and there was some money paid in for this purpose—

#### CONSTITUTION

Article 1.—This Association shall be known as the Mt. Moriah Free-Will Baptist Association of Alabama, and shall be composed of delegates from the different churches forming the same, each church being

entitled to three delegates.

Art. 2.—This body shall be considered an advisory council, but having no authority over the affairs of other churches, unless they depart from the articles of faith of this Association. In case any church departs from the articles of faith and support doctrines of heresy, or allows any ministers of her body to teach doctrines not in keeping with our articles of faith, the same shall be dealth with by this Association as it may deem Proper and right, according to the teachings of the Bible.

Art. 3.—Each church in this Association shall be considered an advisory board and shall control its own internal affairs in matters of discipline, etc., though the church may in extreme cases claim aid from sister churches, but the Association shall rule in all matters of doctrine

and general interest.

Art. 4.—All questions of doctrine and matters of general interest shall be settled by a two-third vote of the Association and the decision shall be final.

Art. 5.—The officers of the Association shall be Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority of votes.

Art. 6.—The Association shall meet annually at such time and place as may be agreed upon by the previous annual session, and shall not adjourn finally until all the business is transacted.

Art. 7.—Churches wishing to become members of this Association

must adopt its articles of faith and conform to its usages.

Art. 8.—We agree, as churches of this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sabbath Schools, missionary work, etc.

#### RULES OF DECORUM

Rule 1.—The Association shall be called to order by the Moderator, who presided at last session. The former Clerk also officiating until the body is fully organized.

Rule 2.—The Association shall be openel and closed with singing

and prayer.

Rule 3.—The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

Rule 4.—The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

Rule 5.—A majority of delegates present shall rule in all cases, except in the reception of new churches then it shall be unanimous.

Rule 6.—The Moderator shall not be entitled to vote except in case of a tie and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided, he shall appoint some one to the chair while he is speaking.

Rule 7.—Only one person shall speak at the same time, who shall

arise and address the Moderator.

Rule 8.—No brother shall be interrupted while speaking unless he depart from the subject under discussion, or use words of personal reflection.

Rule 9.—No person shall be allowed to speak more than twice on the same subject, without leave of the Association, nor more than fifteen minutes at a time.

Rule 10.—No member shall talk or laugh during the time the de-

bate is going on

Rule 11.—No member shall absent himself from the Association without leave of the Moderator.

Rule 12.—The Molerator shall have power to call the Association together at any time upon a petition of two-thirds of the churches composing the Association over which he presides.

Rule 13.—That the appointment of all committees by the Moderator be confined to the ministers and delegates composing the Associa-

tion.

#### ARTICLES OF FAITH

Article 1.—We believe there is one true and living God, who is the Supreme Ruler of heaven and earth, self-existent Creator of all things, and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distinct but harmonious offices in the great work of redemption.

Art. 2.—We believe the Holy Bible was written by men, divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; and it reveals the principles by which God will judge us, and therefore is and shall remain to the end of the world, the center of Christian union, the supreme standard by which all human conduct, creeds and opinions will be tried.

Art. 3.—We believe that man was created holy under the law of his Maker, but from voluntary transgression fell from that holy state, in consequence of which all mankind are deprived and wholly unable of their own free will and ability, to recover from the faller state in which they are by nature.

Art. 4.—We believe that God has not fixed the future state of man-

kind by an absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.

Art. 5.—We believe tha tChrist, by his death and suffering, made an atonoment for the sins of all mankind in general, and every individual in particular; however, that none but those who believe in Him can pe partekers of the divine benefits.

Art. 6.—We believe that true faith cannot priceed from the exercise of our natural faculties and powers or from the force and operation of the fre will, since man in consequence of his natural corruption is in-

capable either of thinking or doing anything spiritually good.

Art. 7.—We believe in the general application of the grace of God forfallen man sufficient to enable him morrally and actually to obey the requirements of the law of liberty—James 1.25, this is to act saving faith. John 1.19, however, none but those who believe or acquiesce in Christ will be saved thereby; Acts 17.32; Romans 2.9; John 3.19.

Art. 8.—We believe in the free moral agency of man, by the grace of God, before and after conversion; that he is laid under no invincible necessity, by his Creator, to act in a given way, that if he lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, men is always a proper subject of admonition and exhortation. Hebrews 11.12, 13; Romans 12.14; Mark 14.12; Ezekel 18.24; Rev. 2.3; Ezekel 33.13 and 28; 1st Tim. 4.1; Hebrews 3.5; 1st Cor; 10.12 and 22; 1st Peter 1.10.

Art. 9.—We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith fellowship of the Gospel, observing the ordinances of Christ, governed by His laws, and exercising the gifts, rights and privileges invested in them by His word; that its only proper officer sare bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistles of Timonthy and Titus.

Art. 10.—We believe that Christian Baptism is immersion in water in the name of the Father, Son and Holy Ghost, and that believers

are proper subjects.

Art. 11.—We believe the Lord's Supper is a perpetual obligation, by which the members of the church in the use of bread and wine, are to commemorate together the dying love of Christ preceded always by solemn self-examination.

Art. 12.—We believe in the resurrection of the dead and the general judgment; and joys of the righteous and the punishment of the wicked

will be eternal upon principles of grace and justile.

Art. 13.—We believe in open and mixed communion and the churches of our body are authorized, their pastors, to invite Christians of all orthodox churches who are in good standing in their respective churches to commune with us at the Lord's table.
