Leon McAdams served as songleader and led the congregation in the first song "At Calvary." Opening prayer was given by Rev. Roy G. Plymon, followed by the song "Praise Him, Praise Him." The introductory message was rendered by Rev. Dewey Thomas, using Luke 12:16 as his key scripture. His text, "Our Help Is In The Lord" emphasize we should not leave God out of our plans but practice Psalm 121:1 and lift up our eyes from whence cometh our help. The invitational song was "Have Thine Own Way."

The Moderator, Rev. William Atkinson, called to order this session. He recognized the preachers and deacons and stated their voting rights. Rev. Larry Reynolds, Chairman of Credentials Committee, made a motion that delegates from respective churches be seated and alternates be placed where needed. The Clerk, M. P. Gore, read the recommendations voted upon during the General Board Meeting held at Shiloh Church on September 29, 1984. The voting body approved all items of the General Board's report. They were as follows:

 - October 12 Macedonia Church (Annual Session)
- 2. Pay Clerk same as last year; and that this item, along with item affecting Article 18, page 29, become part of the Constitution as adopted in October of 1983.
- 3. That we receive an offering during the annual session and in each quarterly meeting for associational expense.
- 4. That we give at least \$15.00 per church for the next three years toward the expense of entertaining the 1987 session of the National Association in Birmingham.
- 5. That Rev. Terrell Jones replace Rev. Raymond Tilley on the Credentials Committee.
- That Waymon Fields be re-elected to the Home Missions Board.
- 7. That Vaudine Lancaster be re-elected to the Board of Christian Education.

After the song "Sunlight" the roll call of ministers was given. "I Am Thinne O Lord" was followed by the offertory prayer by Rev. William Atkinson. An offering of \$152.05 was received for this session.

The 11:00 message was preached by Rev. Larry Reynolds stressing "Power In Our Churches" using Acts 11:22 - 26 as key verses. He quoted there are no great preachers - but preachers preaching about a GREAT GOD, who should leave a heritage of the pure word of God. Before dismissing for the lunch hour, the Moderator assigned delegates to committees, also as host pastor, he welcomed the body to a bountiful meal spread outside on the tables.

AFTERNOON SESSION

The afternoon session opened with congregation singing of "I Want To Be A Worker" Rev. Arlis Barksdale led in prayer, then a thank-you note was read from our missionary appointees to Mexico, Rev. and Mrs. Fred Jones. They expressed their appreciation for the offering given to them at the July session. Rev. G. P. Perkins had the devotional. His scripture was from John 3. He challenged Christians to make sure of their salvation in this time of turmoil in our sinful world. Committee reports were given. All reports were adopted with the committees retained until the next annual session.

MRS. MYRTIE CRAWFORD

Who can find a virtuous woman? For her price is far above rubies.

Proverbs 31:10

Mrs. Myrtie Crawford - a loving helpmate, a caring mother, a capable housewife, a concerned friend. The previous titles would be adequate to describe most women; but, the main attribute that excelled above all others in the life of Mrs. Crawford was: she was a dedicated Christian.

As a minister's wife, she possessed the qualities given in the Scriptures. She was truly an example for younger women to emulate. She is probably best remembered for her kind, loving manner with those she was associated with at the churches she attended. When a meal was served at the church, she would bring enough delicious homecooked food to serve many people. Though she was hungry, you could be sure she would not eat until she saw that everyone around her was served.

God's house was to her a place of reverent worship and her delight was to go to God's house. It was very rare to see Bro. Crawford without the presence of his dear wife. Although she did not speak out in church, she was supportive of each Christian endeavor.

ARTICLES OF FAITH

- ART. I. We believe there is one true and living God, who is the Supreme Ruler of Heaven and earth, self existent Creator of all things and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distant but harmonious offices in the great work or redemption.
- ART. 2. We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; that it reveals the principle by which all human conduct, creeds and opinions will be tried.
- ART. 3. We believe that man was created holy under the law of the maker, but from voluntary transgression fell from that holy state, in consequence of which all mankind are depraved and wholly unable of their own free will and ability to recover from that fallen state in which they are by nature.
- ART. 4. We believe that God has not fixed the future state of mankind by any absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.
- ART. 5. We believe that Christ by His death and suffering, made an atonement for the sins of mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the divine benefits.
- ART. 6. We believe that true faith cannot proceed from the exercise of our natural facilities and powers, or from the force and operation of the free will since man in consequence of his natural corruption is incapable of either thinking or doing anything spiritually good.
- ART. 7. We believe in the general application of the Grace of God for fallen man, sufficient to enable him morally and actually to obey the requirements of the law of liverty James 1:25, this is to act saving faith; John 1:9, however, none but those who believe or ecquiesce in Christ will be saved thereby; Acts 17:32; Romans 2:9; John 3:19.
- ART. 8. We believe in the free and moral agency of man, by the Grace of God, before and after conversion that he is under no invincible necessity, by his Creator, to act in a given way that if he lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject of admonition and exhortation, Heb. 3:11-

- 12-13; Rom. 13:14; Mark 13:33; Eze. 18:24; Rev. 2nd & 3rd chapters; Eze. 33:13-18; 1 Tim. 4:1; Heb. 3:6; I Cor. 10:12-22; I Peter 1:10.
- ART. 9. We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel observing the ordinances of Christ, governed by His laws and exercising the gifts, rights and privileges invested in them by His work; That its only proper officers are bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistle of Timothy and Titus.
- ART. 10. We believe that Christian baptism is immersion in water in the name of the Father, Son and Holy Ghost, and that believers are proper subjects.
- ART. 11. We believe the Lord's supper is a perpetual obligation, by which the members of the church in the use of bread and wine, are to commemorate together the dying of Christ preceded always by solemn self-examination.
- ART. 12. We believe in the resurrection of the dead and the general judgement and joys of the righteous and the punishment of the wicked will be eternal upon principles of grace and justice.
- ART. 13. We believe in open and mixed communion and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches, who are in good standing in their respective churches to commune with us at the Lord's table.

RULES OF DECORUM

- ART. 1. a. The Association shall be called to order and officiated by the Moderator, who was elected at the last session.
- b. The new officers (Moderator and Clerk) will take office at the close of the annual session and serve through the annual session of the following year.
- ART. 2. The Association shall be opened and closed by singing and prayer.
- ART. 3. a. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes, by delegates present, elect.
- b. The Moderator and Clerk cannot serve more than four years in succession.
- ART. 4. It shall be the duty of every church belinging to this Association to send a letter to every annual session of this Asso-

ciation, reporting in the letter its spiritual condition, benevolent work and its statistics. Also, that we receive the letters and seat the delegates on the strength of the Credentials Committee report and omit public reading of the letters. All letters be mailed with minutes fee to the Clerk of this Association two (2) weeks prior to the annual session of the Association. The names of the delegates from the different churches shall be enrolled and called for, as necessary, during the session.

- ART. 5. A majority of the delegates shall rule in all cases except the reception of churches, all questions of doctrines, and matters pertaining to the Constitution and Rules of Decorum, then it shall be by two-thirds vote.
- ART. 6. The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on all questions after all others have spoken, provided he appoint someone to the chair while he is speaking.
- ART. 7. Only one person shall speak at a time and he shall rise and address the Moderator and after recognition by the Moderator, he shall proceed.
- ART. 8. No member shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.
- ART. 9. No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than five (5) minutes at a time.
- ART. 10. No member shall laugh or talk while debates are going on.
- ART. 11. No member shall absent himself from the Association without leave of the Moderator.
- ART. 12. The Moderator shall have the power to call the Association together at any time he deems necessary or upon a petition of two-thirds of the churches composing the Association over which he presides.
- ART. 13. That the appointment of all committees by the Moderator be confined to Ministers and delegates composing the Association.

CONSTITUTION

ART. 1. This Association shall be known as the Mount Moriah Free Will Baptist Association of Alabama, being composed of delegates from the different churches forming the same, each being en-

titled to three elected delegates.

- ART. 2. The body shall be considered an Advisory Council, but have no authority over the affairs of other churches unless they depart from the Articles of Faith of the Association. In case any church departs from the Articles of Faith and supports doctrines or heresy, or allows any Minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Association as it may deep proper and right, according to the teachings of the Bible.
- ART. 3. Each church in this Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, etc., and each church reserves the right to retain ownership of their property and buildings should the church split or decide to sell. Each church should control its internal affairs concerning all property under their name. It may however, in extreme cases, call aid from sister churches, but the Association shall rule in all matter of doctrine.
- ART. 4. All questions of doctrines and matters pertaining to the Constitution and Rules of Decorum shall be settled by a two-thirds vote of the Association; provided the same is presented in written form; presented in the morning session; and voted on in the afternoon session; and the decision shall be final.
- ART. 5. The officers of the Association shall be a Moderator, Assistant Moderator, Clerk-Treasurer, and Assistant Clerk-Treasurer, who shall be chosen by ballot at each annual session by a majority of votes. The Clerk shall be paid \$125.00 each year, plus expenses, incurred in carrying out his duties. Each church send each year to the annual session the sum of \$25.00 as associational funds.
- ART. 6. a. This Association shall meet annually, at such time and place as may be agreed at a previous annual session, and shall not adjourn finally until all business is transacted.
- b. There shall be a short business session and a report from all standing committees at each quarterly meeting.
- ART. 7. Churches wishing to become members of the Association must adopt its Articles of Faith and conform to its usuage.
- ART. 8. We agree as churches of this Association to use our best influences to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sabbath Schools, Missionary Work, etc.
- ART. 9. Any minister pastoring a church or churches in the

Mount Moriah Association shall be regularly ordained minister in good standing and become affiliated with this Association.

ART. 10. All ministers and deacons shall be standing delegates in this Association.

ART. 11. We adopt the Treatise of Faith and Practice of the Original Free Will Baptist.

ART. 12. SECTION ONE: GENERAL BOARD

- A. <u>COMPOSITION</u>: The General Board shall be composed of the Moderator, Clerk, and one member from each local church that is a part of this body. Each member from a local church shall serve a two-year-term with one-half of the members being elected each year.
- B. <u>DUTIES</u>: The General Board shall formulate all ideas of business during the annual session of the Association, act as a Nominating Committee, as well as any other responsibility so delegated by the body. It shall not have power to commit the Association to any cause or policy not authorized by the Mount Moriah Association, nor to reverse any action of the Mount Moriah Association.

SECTION TWO: BOARD OF CHRISTIAN EDUCATION

- A. <u>COMPOSITION</u>: The Christian Board shall be composed of five members. These are elected to serve a 5-year-term with one expiring each year.
- B. DUTIES: 1. The Christian Board shall act in an Advisory capacity to the youth organization of the Association.
- 2. The Christian Board shall work with all churches in the Association to promote the youth work and other related projects.
- 3. The Christian Board, along with the youth officers and host church, shall plan the program.

ART. 13.

STANDING COMMITTEES

SECTION ONE: CREDENTIALS COMMITTEE

- A. The Credentials Committee shall consist of three lay brethren and two ordained ministers, elected at the annual session of the Association, each serving a five (5) year term, the senior member coming off each year. A committee member cannot serve more than one term without a years' leave.
- B. It shall be the responsibility of this committee to examine letters coming to this body from churches, ministers, and

other Associations. This committee shall also examine all ministers who become a part of this body, either by ordination or by letter, and make recommendations to the Association.

C. It shall be the duty of this committee to make an annual report to the Association as to the standing, character, and orthodoxy of the ministers and churches of this Association.

SECTION TWO: HOME MISSION COMMITTEE

- A. The Home Mission Committee shall consist of three lay brethren and two ordained ministers elected at the annual session of the Association, elected for a five-year-term, the senior member coming off each year.
- B. It shall be the responsibility of this committee to take charge of the Home Mission work of this association, to promote the cause of Home Missions, and to take oversight of any mission church so organized.
- C. The Home Mission Committee shall have a Secretary-Treasurer and use funds given for Home Mission Work.
- D. The Home Mission Committee shall make a report to the annual session of the Association.
- ART. 14. The Moderator of the Association shall be an ex-officio member of all Boards and Committees.
- ART. 15. No person shall be allowed to serve on more than one Standing Board or Committee, with the exception of the General Board. A person may be a member of the General Board and still be eligible for a Standing Board or Committee.

ART. 16. DEACONS:

To be ordained, he must be elected by the church of which he is a member. A deacon must meet the conditions stated in the third chapter of I Timothy, verses 8-13. The term "husband of one wife" means he shall not have more than one living wife, that is, he shall not be married to one wife at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. The ordination council shall consist of at least one ordained minister and two deacons of the Mount Moriah Association.

ART. 17. MINISTERS:

The authority to ordain or license ministers has its source in the local church.

1. LICENSED MINISTERS:

Must be a member of a church which belongs to the Mount Moriah Association. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. The ministerial license shall be valid for a period of one year but is renewable annually. He must have his license renewed annually by said church and kept enforced until ordination. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of pastoring a church and officiating at the observances of the ordinances and weddings.

2. ORDINATION:

He must follow the guidelines for licensed ministers. A minister must meet the conditions stated in the third chapter of I Timothy, verses 1 - 7. The term, "husband of one wife" means he shall not have more than one living wife, that is, he shall not be married to one wife, at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. After he has been licensed and has proven his worth to the local church, the local church has the authority to ordain or ask the Association to ordain. The place of ordination and ordination council will be selected by the candidate. The ordination council shall consist of at least three ordained ministers from the Mount Moriah Association.

3. RULES FOR MINISTERS:

- A. Ministers wishing to transfer from another Free Will Baptist Church or Association into the Mount Moriah Association, shall present a letter of good standing from the church or Association of which he is a member, be examined by the Credentials Committee, and be approved by this Association.
- B. Ministers of other denominations who unite with our churches shall be as a member and if they wish to preach, they must follow the procedure required of our licensed ministers.
- C. Ministers of this Association, that are in good standing, shall be granted a card annually, signed by the Clerk and Moderator with the minister's name, address, and the church of which he is a member.
- D. Any minister who is on the ordained ministers list and does not attend an Associational meeting in any one year or who makes no contacts, will be dropped from the ordained ministers list.

- E. Any minister who behaves himself unbecomingly to his calling into the ministry of the gospel shall be reported by the Credentials Committee to the Association, who shall deal with him.
- ART. 18. This Association shall be a member of The Alabama State Association of Free Will Baptists. It is expected that each church will send the necessary fee for representation in the State body.

RULES OF DECORUM FOR CONFFRENCE

The conference shall be called to order by the Pastor who is the Moderator. The clerk shall be seated in order.

- 1. Invite visiting members to seat with us and aid in council.
- 2. Open the door of the church for members.
- 3. Call for reference.
- 4. Calls for communications.
- 5. Calls for new business.
- 6. Calls for miscellaneous business.
- 7. Adjournment.
