The annual meeting marking the one hundred and thirtyseventh session of the Mount Moriah Association met at Carolwood Church on October 10, 1987, with Leon McAdams conducting the singing and Helen Lucas at the piano, the opening song was "We'll Work Till Jesus Comes." Welcome and prayer was given by the host pastor, Rev. Willard Pless, followed by the congregation singing "Heavenly Sunshine."

The introductory sermon was preached by Rev. J. L. Lavender who used scripture from Proverbs 22, entitling his sermon, "Stepping Stones for Christ." He stressed the importance of a good name and character.

Rev. Larry Reynolds, Moderator, called the meeting to order. He asked the Clerk to give the roll of churches. All churches were Represented. The roll call of ministers was given by the Credentials Committee Chairman, Rev. Terrell Jones. A total of 21 ordained ministers was present. Twenty-six deacons were counted. Delegates were seated and replacements where needed.

A welcome was given to our visiting ministers: Rev. Harold Pitts, Rev. Dennis Kizzire, and Rev. Robert Crawford. New associational ministers were also welcomed. They were: Rev. Jackie Adcox, Rev. Milton Fields, Rev. Billy R. Smith and Rev. Mark Barber. Also recognized were those licensed in their local church: Bro. Travis House, Bro. Elmer Lynn, Bro. Gordon Tingle, and Bro. Scott Montgomery.

Rev. Dennis Kizzire, representing the State Mission Board, read from the 13th verse of Romans 10. He spoke briefly on the home mission work and also praised our association for the interest shown in missions. The Finance Committee served as ushers for the General Fund offering. \$197.00 was received.

The Clerk read the following proceedings of the General Board meeting: "The General Board met on September 26 at Shiloh with the Moderator, Rev. Larry Reynolds, presiding. Opening song was led by Milford McAdams with Rev. Delbert Townsend giving the opening prayer.

The Credentials Committee was excused to examine the church letters. The 14 they examined were reported in order.

A time of special prayer requests was concluded with George McJenkins leading the prayer.

The Moderator read from Acts 14 and spoke on "So Speak the Word of God." Following his closing prayer, he then read the correct procedure for voting. MSC to seat the General Board.

He called attention to a word in Article 8 which needed to be changed from "Sabbath" to "Sunday."

Bro. Reynolds also noted our articles of Faith do not elaborate on what is our belief concerning the work of the Holy Spirit. MSC that the Credentials Committee look into this matter on what needs to be done to make our stand clear on what we as Free Will Baptists believe.

Rev. Roger Lucas announced a seminar on the work of the Holy Spirit will be held at Sardis Church on October 23 and 24 with Rev. Don Robirds.

Rev. Mark Barber, new pastor for Eastside, was introduced and welcomed to our association. He gave the closing prayer.

The Clerk read Article 8 of the Constitution to clarify the requested change of the word "Sabbath" to "Sunday". MSC

Rev. Terrell Jones read the interpretation of what is the work of the Holy Spirit. This was voted on to table until the afternoon session.

A time of prayer requests was given by members of the congregation. Rev. Milton Fields prayed in petition of these numerous requests.

Special singing was rendered by a quartet composed of Mr. and Mrs. Raiford Galloway, Leon McAdams and Rev. Jerry Montgomery.

AFTERNOON SESSION

After food and fellowship the body assembled together with congregational singing "When We All Get To Heaven." Rev. Billy R. Smith led in prayer. The afternoon devotional was presented by Rev. Raymond Tilley. He used Matthew 7:15 as his text, emphasizing the importance of being grounded in the Word to be able to rightly divide the word of truth.

Special recognition was given to all those present who were seventy years or older.

The Woman's Auxiliary report was read by our district president, Sherry Reynolds.

The Clerk gave the attendance count. We had a total of 195 present.

Rev. Robert Crawford, representing Free Will Baptist Bible College of Nashville, TN, gave a promotional talk concerning the college. "Passing The Torch" is the new program to help people meet financial needs for college. He also said he was grateful for the ministry of the Mount Moriah Association.

Committee reports were given and accepted, with the following changes or additions:

After the Deceased Committee report was given, the congregation sang "Precious Memories" in memory of those from our association who had passed away. Special prayer was given for the George (Nub) Perrigin family. Bro. Nub's funeral will be Sunday.

Rev. Ben Logan served as chairman of the Home Mission Committee in the absence of Waymon Fields. The Children's Home Committee report had an amendment added to delete the part of taking up a collection for the Children's Home since the Finance Committee had already made provision for this in their report.

Board of Christian Education Chairman, Rev. Roy Plymon, concluded his report with giving recognition to those who won on the state and national level in the CTS competition. The Youths present who received awards were asked to stand and be recognized.

Credentials Committee Chairman, Rev. Terrell Jones expressed an apology to Eastside and Holman Churches for the committee's failure to get to examine Bro. Scott Montgomery and Bro. Gordon Tingle, whose names had been submitted, requesting to be licensed. He explained this was because of lack of time to do this and was no reflection on these two men. They will be examined at the next Quarterly Meeting.

Also, concerning the article submitted concerning the Holy Spirit, was brought to the floor at this time. The Moderator gave equal time to the pro and con opinions. After this discussion it was voted on. MSC.

Other items recommended by the committee were approved as requested.

New Associational ordained ministers and licensed ministers were recognized and given an opportunity to speak. They were received by a handshake from the Moderator and Clerk and by applause from the congregation.

Rev. Roger Lucas urged the congregation to attend the seminar on the Holy Spirit presented by Dr. Don Robirds, Communications Director for National Home Missions. This seminar will be at Sardis on October 23 and 24.

"There's Within My Heart A Melody" was sung by the congregation. While preparing for communion service, Milford sang "When They Ring Those Golden Bells." During the discourse of this beautiful ordinance, prayer was given by Rev. Harold Pitts and Rev. Roy Plymon.

The singing of "Amazing Grace" concluded the day's service followed by the closing prayer by Rev. Albert Montgomery.

HISTORY OF CHURCHES

JANUARY QUARTERLY MEETING

The National Home Mission Team consisting of Rev. Roy Thomas, Rev. John Gibbs and Bro. Trymon Messer were guest speakers at our Church Growth and Evangelism Conference held at Phillips Chapel on January 9 and 10. Bro. Gibbs presided over both sessions and began the service with two songs "The Gloryland Way" and "I'd Rather Be An Old Time Christian." He asked Rev. Jack Rollins, pastor of the Forestdale Church, to give the opening prayer. Next, all ministers present were asked to stand and introduce themselves. There were about 20 present. Bro. Gibbs then requested that the Fields Family sing and commented how this family blessed him as they render the Word in song.

Bro. Trymon Messer, Lay speaker, gave the first message from Mark 6:44 - 52. His topic was "The Lord's Remedy for Coldness." He emphasized that we must have a warm heart if we are a Christian.

A motion was made by Rev. Terrell Jones, a second, and carried. The Moderator then asked the body if they wished to wait until April. A motion was made by Waymon Fields, seconded by Everett Bryant and carried... to vote on this at the April meeting.

The Moderator reminded the congregation of meeting places since we do not have the minutes.

Rev. George Perrigin expressed his thanks for the consideration and appreciation on his recuperation from concer.

Rev. Mike Rogers reminded the ministers of their fellowship meal at 4:00 p.m.

Bro. Reynolds also expressed words of appreciation to his church and our association. He requested that we be concerned that our teenagers will get in God's work. ARTICLES OF FAITH

ART. 1 We believe there is one true and living God, who is the Supreme Ruler of Heaven and earth, self existent Creator of all things and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every diving perfection, and existing in distant but harmonious offices in the great work or redemption.

ART. 2 We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; that it reveals the principle by which all human conduct, creeds and opinions will be tried.

<u>ART.3</u> We believe that man was created holy under the law of the maker, but from voluntary transgression fell from that holy state, in consequence of which all mankind are depraved and wholly unable of their own free will and ability to recover from that fallen state in which they are by nature.

ART. 4 We believe that God has not fixed the future state of mankind by any absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.

ART. 5 We believe that Christ by His death and suffering, made an atonement for the sins of mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the divine benefits.

ART. 6 We believe that true faith cannot proceed from the exercise of our natural facilities and powers, or from the force and operation of the free will since man in consequence of his natural corruption is incapable of either thinking or doing anything spiritually good.

ART. 7 We believe in the general application of the Grace of God for fallen man, sufficient to enable him morally and actually to obey the requirements of the law of liberty - James 1:25, this is to act saving faith; John 1:9, however, none but those who believe or acquiesce in Christ will be saved thereby; Acts 17:32; Romans 2:9; John 3:19. **ART.8** We believe in the free and moral agency of man, by the Grace of God, before and after conversion that he is under no invincible necessity, by his Creator, to act in a given way that if he lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject of admonition and exhortation, Heb. 3:11-12-13; Rom. 13:14; Mark 13:33; Eze. 18:24; Rev. 2nd & 3rd chapters; Eze. 33:13-18; I Tim. 4:1; Heb. 3:6; I Cor. 10:12-22; I Peter 1:10.

ART. 9 We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel observing the ordinances of Christ, governed by His laws and exercising the gifts, rights and privileges invested in them by His work; That its only proper officers are bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistle of Timothy and Titus.

ART. 10 We believe that Christian Baptism is immersion in water in the name of the Father, Son and Holy Ghost, and that believers are proper subjects.

ART. 11 We believe the Lord's supper is a perpetual obligation, by which the members of the church in the use of bread and wine, are to commemorate together the dying of Christ preceded always by solemn self-examination.

<u>ART. 12</u> We believe in the resurrection of the dead and the general judgement and joys of the righteous and the punishment of the wicked will be eternal upon principles of grace and justice.

<u>ART. 13</u> We believe in open and mixed communion and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches, who are in good standing in their respective churches to commune with us at the Lord's table.

ART. 14 We believe that the Holy Spirit enters the heart of the Believer at the time of conversion, and that speaking in tongues (languages) is neither an evidence of being infilled with the Holy Spirit nor does it bring about sanctification. We teach and preach the fullness of the Holy Spirit and heed the scriptural admonition, "Be filled with the Spirit." We thank God for our great Comforter, Guide, and Empowerer, the precious Holy Spirit, the Third Person of the Trinity. (John 3:5-8; Romans 8:9; Ephesians 5:18; I Corinthians 14:22).

RULES OF DECORUM

ART. 1 (a) The Association shall be called to order and officiated by the Moderator, who was elected at the last session.

(b) The new officers (Moderator and Clerk) will take office at the close of the annual session and serve through the annual session of the following year.

ART. 2 The Association shall be opened and closed by singing and prayer.

ART. 3 (a) The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes, by delegates present, elect.

(b) The Moderator and Clerk cannot serve more than four years in succession.

ART. 4 It shall be the duty of every church belonging to this Association to send a letter to every annual session of this Association, reporting in the letter its spiritual condition, benevolent work and its statistics. Also, that we receive the letters and seat the delegates on the strength of the Credentials Committee report and omit public reading of the letters. All letters be mailed with minutes fee to the Clerk of this Association two (2) weeks prior to the annual session of the Association. The names of the delegates from the different churches shall be enrolled and called for, as necessary, during the session.

ART. 5 A majority of the delegates shall rule in all cases except the reception of churches, all questions of doctrines, and matters pertaining to the Constitution and Rules of Decorum, then it shall be by two-thirds vote.

ART. 6 The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on all questions after all others have spoken, provided he appoint someone to the chair while he is speaking.

ART. 7 Only one person shall speak at a time and he shall rise and address the Moderator and after recognition by the Moderato, he shall proceed.

ART. 8 No member shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.

ART. 9 No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than five (5) minutes at a time. ART. 10 No member shall laugh or talk while debates are going on.

<u>ART. 11</u> No member shall absent himself from the Association without leave of the Moderator.

ART. 12 The Moderator shall have the power to call the Association together at any time he deems necessary or upon a petition of two-thirds of the churches composing the Association over which he presides.

ART. 13 That the appointment of all committees by the Moderator be confined to Ministers and delegates composing the Association.

CONSTITUTION

ART. 1 This Association shall be known as the Mount Moriah Free Will Baptist Association of Alabama, being composed of delegates from the different churches forming the same, each being entitled to three elected delegates.

ART. 2 The body shall be considered an Advisory Council, but have no authority over the affairs of other churches unless they depart from the Articles of Faith of the Association. In case any church departs from the Articles of Faith and supports doctrines or heresy, or allows any Minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Association as it may deem proper and right, according to the teachings of the bible.

ART. 3 Each church in this Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, etc., and each church reserves the right to retain ownership of their property and buildings should the church split or decide to sell. Each church should control its internal affairs concerning all property under their name. It may however, in extreme cases, call aid from sister churches, but the Association shall rule in all matters of doctrine.

ART. 4 All questions of doctrines and matters pertaining to the Constitution and Rules of Decorum shall be settled by a two-thirds vote of the Association; provided the same is presented in written form; presented in the morning session; and voted on in the afternoon session; and the decision shall be final. ART. 5 The officers of the Association shall be a Moderator, Assistant Moderator, Clerk-Treasurer, and Assistant Clerk-Treasurer, who shall be chosen by ballot at each annual session by a majority of votes. The Clerk shall be paid \$125.00 per year, plus expenses incurred in carrying out his duties. Each church send each year to the annual session the sum of \$25.00 as associational funds.

ART. 6 (a) This Association shall meet annually, at such time and place as may be agreed at a previous annual session, and shall not adjourn finally until all business is transacted.

(b) There shall be a short business session and a report from all standing committees at each quarterly meeting.

ART. 7 Churches wishing to become members of the Association must adopt its Articles of Faith and conform to its usage.

ART. 8 We agree as churches of this Association to use our best influences to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sunday Schools, Missionary Work, etc.

ART. 9 Any minister pastoring a church or churches in the Mount Moriah Association shall be regularly ordained minister in good standing and become affiliated with this association.

ART. 10 All ministers and deacons shall be standing delegates in this Association.

ART. 11 We adopt the Treatise of Faith and Practice of the Original Free Will Baptist.

ART. 12 SECTION ONE: GENERAL BOARD

A. <u>COMPOSITION</u>: The General Board shall be composed of the Moderator, Clerk, and one member from each local church that is a part of this body. Each member from a local church shall serve a two-year-term with one-half of the members being elected each year.

B. <u>DUTIES</u>: The General Board shall formulate all ideas of business during the annual session of the Association, act as a Nominating Committee, as well as any other responsibility so delegated by the body. It shall not have power to commit the Association to any cause or policy not authorized by the Mount Moriah Association, nor to reverse any action of the Mount Moriah Association;

SECTION TWO: BOARD OF CHRISTIAN EDUCATION

A. COMPOSITION: The Christian Board shall be composed of five members. These are elected to serve a 5-year-term with one expiring expiring each year.

B. DUTIES: 1. The christian Board shall act in an advisory capacity to the youth organization of the Association.

2. The Christian Board shall work with all churches in the Association to promote the youth work and other related projects.

3. The Christian Board, along with the youth officers and host church, shall plan the program.

ART. 13 STANDING COMMITTEES

SECTION ONE: CREDENTIALS COMMITTEE

A. The Credentials Committee shall consist of three lay brethren and two ordained ministers, elected at the annual session of the Association, each serving a five (5) year term, the senior member coming off each year. A committee member cannot serve more than one term without a years' leave.

B. It shall be the responsibility of this committee to examine letters coming to this body from churches, ministers, and other Associations. This committee shall also examine all ministers who become a part of this body, either by ordination or by letter, and make recommendations to the Association.

C. It shall be the duty of this committee to make an annual report to the Association as to the standing, character, and orthodoxy of the ministers and churches of this Association.

SECTION TWO: HOME MISSION COMMITTEE

A. The Home Mission Committee shall consist of three lay brethren and two ordained ministers elected at the annual session of the Association, elected for a five-year-term, the senior member coming off each year.

B. It shall be the responsibility of this committee to take charge of the Home Mission work of this Association, to promote the cause of Home Missions, and to take oversight of any mission church so organized.

c. The Home Mission Committee shall have a Secretary-Treasurer and use funds given for Home Mission work.

D. The Home Mission Committee shall make a report to the annual session of the Association.

ART. 14. The Moderator of the Association shall be an exofficio member of all Boards and Committees.

ART. 15 No person shall be allowed to serve on more than one Standing Board or Committee, with the exception of the General Board. A person may be a member of the General Board and still be eligible for a Standing Board or Committee.

ART. 16 DEACONS:

To be ordained, he must be elected by the church of which he is a member. A deacon must meet the conditions stated in the third chapter of I Timothy, verses 8-13. The term "husband of one wife" means he shall not have more than one living wife, that is, he shall not be married to one wife at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. The ordination council shall consist of at least one ordained minister and two deacons of the Mount Moriah Association.

ART. 17 MINISTERS:

The authority to ordain or license ministers has its source in the local church.

1. LICENSED MINISTERS:

Must be a member of a church which belongs to the Mount Moriah Association. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. The ministerial license shall be valid for a period of one year but is renewable annually. He must have his license renewed annually by said church and kept enforced until ordination. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of pastoring a church and officiating at the observances of the ordinances and weddings.

2. ORDINATION:

He must follow the guidelines for licensed ministers. A minister must meet the conditions stated in the third chapter of I Timothy, verses 1 - 7. The term, "husband of one wife" means he shall not have more than one living wife, at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. After he has been licensed and has proven his worth to the local church, the local church has the authority to ordain or ask the Association to ordain. The place of ordination and ordination council will be selected by the candidate. The ordination council shall consist of at least three ordained ministers from the Mount Moriah Association.

3. RULES FOR MINISTERS:

A. Ministers wishing to transfer from another Free Will Baptist Church or Association into the Mount Moriah Association, shall present a letter of good standing from the church or Association of which he is a member, be examined by the Credentials Committee, and be approved by this Association.

B. Ministers of other denominations who unite with our churches shall be as a member and if they wish to preach, they must follow the procedure required of our licensed ministers.

c. Ministers of this Association, that are in good standing, shall be granted a card annually, signed by the Clerk and Moderator with the minister's name, address, and the church of which he is a member.

D. Any minister who is on the ordained ministers list and does not attend an Associational meeting in any one year or who <u>makes no contacts</u> will be dropped from the ordained ministers list.

E. Any minister who behaves himself unbecomingly to his calling into the ministry of the gospel shall be reported by the Credentials Committee to the Association, who shall deal with him.

ART. 18 This Association shall be a member of The Alabama State Association of Free Will Baptists. It is expected that each church will send the necessary fee for representation in the State body.

RULES OF DECORUM FOR CONFERENCE

The conference shall be called to order by the Pastor who is the Moderator. The clerk shall be seated in order.

- 1. Invite visiting members to seat with us and aid in council.
- 2. Open the door of the church for members.
- 3. Call for reference.
- 4. Calls for communications.
- 5. Calls for new business.
- 6. Calls for miscellaneous business.
- 7. Adjournment.
