

The one hundred-fortieth session of the Mount Moriah Association of Free Will Baptists convened with Shiloh Church on October 13, 1990. The Moderator, Rev. Terrell Jones, greeted the congregation. "Where the Soul Never Dies" was led by Milford McAdams with Helen Sanford at the piano. They served in this capacity throughout the day. A welcome was given by the host pastor, Rev. Billy Ray Smith, followed by the song, "I Feel Like Traveling On."

Because the first speaker did not receive the letter stating he was first on the program, Rev. J. H. Tilley relinquished his time to our guest missionary, Rev. Louie Nix. Rev. Nix had to return from Hawaii because of health problems. He praised God that his health now permits him to return to Hawaii, but he is still low on funds. He requested prayer for this and his safety in travel. Time was given for questions concerning his mission effort.

A roll call of churches was given by the Clerk, Sue Plymon. All churches were represented. She then called the roll of ministers. Visitors were welcomed by the Moderator. While we were waiting for the Credentials Committee to return, a time of testimonies was given.

Rev. Roger Lucas, a member of the State Mission Board, gave a report on the Alabama mission work. The Huntsville church will be ready to move in sometime in November despite the enormous financial load and compliance with strict city ordinances. He suggested that our Association buy a pew (\$500 per pew). Prayer was requested for Bro. Hendrix and his family as he leads this project; also, for Bro. Mike Rogers and Beth as they assist in this work. Bro. Lucas mentioned he had some books and items in the Sunday School room which could be purchased (that were left over from previous walk-a-thons). He stated that they had cut expenses for the walk-a-thon but had not reached the goal because of less participation. The money received will go to the Larry Reynolds and Louie Nix accounts. He concluded in telling that the Mission Board is working on new future church sites - possibly in north

Dothan or Troy. He also stated that the State Missions Board can handle all monies and requested they be sent through the Alabama State Home Mission Board.

The area-wide missionary conference was discussed. Because of excellent participation our association has an Area 1 and Area 2. Area 1 will be in session from January 20-23 and Area 2 will be from January 24 - 27. Eastside will not participate this year.

The Credentials Committee stated the letters were examined and found to be in order. All standing and voting delegates were seated. A motion was made to take an offering because of the low general fund. MSC.

GENERAL BOARD MEETING REPORT

The Clerk gave the following report:

The General Board Meeting was held at the Shiloh FWB Church, September 22, 1990, at 2:00 p.m. Brother Tony Latham opened the meeting with prayer. Roll call of churches was given by the Moderator. All general board members were present except Mt. Moriah, Glen Echo, and Sardis. Due to the lack of a quorum of the Credentials Committee, the Associational letters were to be examined at the Association in October. All letters of the association were received by the September 22, General Board Meeting date.

Question was raised of his re-election as you cannot succeed your-self in this office, but it was verified that he did not fill a complete term of 5 years.

Bro. Raymond Tilley was nominated for re-election. The statement was given that maybe a younger member would serve more appropriately on this board. Jaimie Lancaster was then nominated. Question was given as to the fact of Jaimie's being a member of the Mt. Moriah Association. These items would be finalized at the Annual Meeting.

Question was then raised of the fact that Bro. Milton Fields resigned at the last associational meeting in October of 1989. He did agree to fill his position through this associational year. Bro. Tony Tilley was nominated to fill his position if he decided to continue his desire to resign as a member of the Christian Board. Both these positions would be finalized at the October Associational Meeting.

Home Mission Board: Bro. Roger Lucas to fill the position of Bro. Jackie Adcox.

Nominations were now selected for the Associational meetings of the year. They are as follows:

Question was now raised as the \$1.25 per minute was not taking care of printing costs. Last year 400 minutes were ordered at the sum of \$626.40. The amount paid was \$465.00. This left a deficit of \$161.40 as we order additional minutes to be used in committee folders, etc. There was a move, seconded and carried to charge \$2.00 per minute in the future and that an offering be taken at the Association to help with the low general fund. It was also mentioned that maybe each church could give a \$10.00 gift at the association for the general fund. Also mentioned was the fact of a \$10.00 raise in the amount of State dues last November at the State Meeting. The clerk wishes to express apologies for the lack of knowledge concerning this and ask that this be taken care of at the association in October. State dues are now \$30.00. Those lacking in the paying of the additional \$10.00 are: Mt. Moriah. Macedonia, Union Hill, Glen Echo, Reform, Ethelsville and 1st Church of Tuscaloosa.

Motion was moved, seconded, and carried to adjourn.

Ballots from nominations made from the General Board meeting were passed out. Douglas Watson resigned from the Home Mission Board because of not being able to take an active part at this time. The body granted him his wish and thanked him for his dedicated and outstanding job he had done during his years with the Board. Nominations were given from the floor. Buddy Lancaster's name was given to be submitted in Douglas Watson's place. MSC

The ballots were counted and reported on. All offices were elected as submitted by the General Board's recommendations.

Delegates were assigned to various committees and replacements were necessary. A short break followed.

We assembled to sing "When We All Get To Heaven." The Finance Committee received an offering for the General Fund. Special music was rendered by some of our Associational youth who sang "Near The Cross."

The 11:00 a.m. message was given by Rev. Terrell Jones basing his sermon around scripture reading from Luke 9:57; 10:1-3. He questioned, "Why are laborers so few?" God's work is carried on by a few people and when we become a Christian we will do something for the Lord. We are to present our bodies a living sacrifice. Our needs will be met if we depend completely on the Lord and serve Him in our daily life.

JANUARY 13, 1990

The Mt. Moriah Association met January 13, 1990, at the Sardis FWB Church. "Kneel at the Cross" was led by Leon McAdams with Helen Lucas at the piano. Bro. Roger Lucas gave a warm welcome, as pastor of the Sardis Church. He.also led in prayer at this time.

Bro. Terrell Jones gave opening remarks after which Leon Mc-Adams led another congregational song, "Praise Him, Praise Him." Leon shared words of praise on being thankful for the ability to have health and strength to share at the Lord's work. He shared some very moving words, spoken from the heart.

At this time, Bro. Jones, Moderator, gave a kind introduction for Bro. Dewey Thomas, as he was our first speaker for the day. Bro. Thomas gave a very interesting message on "The Signs of the Times." He used Matthew 16:1-3 as his text. He shared that there was lots

of money spent on the weather, and the prediction of the weather. He made a great point on which was most important - The weather or a man's soul. It is much more important to put time spent on the condition of one's heart, not the weather. He also used II Timothy 3:1-5 and the fact we were in the last days, perilcus times are signs of the times and he mentioned a number of the things mentioned in these verses as being "Signs of the Times." Stanley Sanford closed the message with prayer. There was an invitation to kneel at the altar, asking for those who were seeking the face of God for the Mt. Moriah Association for our New Year! (It was so moving to sit and hear the harmony of mens' voices as they were praying to our Lord. You could feel the power upon those men as they knelt seeking power, especially upon our churches.) Bro. Terrell Jones closed in prayer around the altar.

At this time the meeting was called to order by the Moderator. Roll call of churches was given by the clerk with two churches being absent, Holman and the First FWB of Reform, Roll call of ministers was given by the clerk with sixteen of the twenty-five ministers attending. At this time the delegates were seated and replacements made. All committees were asked to meet during the lunch hour. All deacons, ministers, and visitors were asked to stand. There were two visitors, to be introduced by Rev. Roger Lucas, State Home Mission's Secretary. Bro. Lucas gave an update on the work at Madison at this time. He mentioned they were still working on the securing of \$275,000 to pay off land and building. It was previously mentioned that they would secure monies from the Retirement and Insurance Board but it could be a lot involved in doing so. There was to be a meeting with the Board to continue this decision further. He mentioned the codes that one must follow on the building in the city and the fact of one being for a parking lot. The church in Madison gave \$59,000 in tithes and offerings during the 1989 year, but \$58,000 was spent. The church had done well to be only a little over two years old. He mentioned the new church had an excellent location being between McDonald's and Burger King. There were subdivisions on all four sides. It is building and growing every day. He encouraged those who mentioned they would go up to work to do so. He now introduced our visitors, Rev. and Mrs. Charles Corley, First FWB Church of Montgomery. The couple and their son. Chuck were at the church to help revive it. It is an older mission work. He will be visiting the Free Will Baptist churches in our area to help raise support to help in this endeavor. Bro. Corley was given time to share his burden for the church there. He mentioned the Montgomery Church had been without a pastor since May and there was a loss of interest. He was encouraged with the interest of the people now. They had 10-13 people and on Thursday evening 8 people were on visitation. He asked for prayer and support for the rebuilding of the church there. The Missions Board was not hiring Bro. Corley, but only helping him gain support. Several churches booked Bro. Corley for services.

Bro. Jones gave Bro. Roy G. Plymon time to speak. Bro. Plymon shared he had been on the Christian Board since 1981 and was thankful for the opportunity of working with young people but felt it was time for him to resign his position on the Christian Education Board.

- * Intermission was now given and we were asked to return upon sound of music.
 - * At 10:55 we reassembled for service.
- * "Count Your Many Blessings" was heard ringing through the Sanctuary.
- * The offering was now taken by the Finance Committee' (\$113.15).
- * Bro. Dewey Thomas was given time to speak. He shared that the Carolwood Church had 8-9 acres and the church had met in business meeting and agreed to give the association the space needed to build a building for Associational use for Youth Meetings, Revivals, etc., also maybe used for campgrounds. He shared it to be of good location and had a very free spirit in the manner in which he spoke. It was an exciting invitation.
- * Bro. Jones asked prayer for the decision on this matter, thanking them and encouraged the thinking of the offer.
- * Prayer requests were given at this time. Bro. Plymon led in prayer, remembering the prayer requests.
- * Bro. Lucas now shared in song, "Son, Go Bring My Children Home."

It's 11:00 now and time for the Word of God to be preached. Bro. J. L. Lavender now shared the Word with us. He was such a blessing. This comm ittee requests that Bro. Plymon's position be filled today. The floor was now opened for recommendations for the unexpired term of Bro. Plymon. James South Gave Bro. Milton Fields shared that a youth leader from each church be discussed and name given to the Youth Board.

ARTICLES OF FAITH

- ART. 1 We believe there is one true and living God, who is the Supreme Ruler of Heaven and earth, self existent Creator of all things and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every diving perfection, and existing in distant but harmonious offices in the great work or redemption.
- ART. 2 We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; that it reveals the principle by which all human conduct, creeds and opinions will be tried.
- of the maker, but from voluntary transgression fell from that holy state, in consequence of which all mankind are depraved and wholly unable of their own free will and ability to recover from that fallen state in which they are by nature.
- ART. 4 We believe that God has not fixed the future state of mankind by any absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.
- ART. 5 We believe that Christ by His death and suffering, made an atonement for the sins of mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the divine benefits.
- ART. 6 We believe that true faith cannot proceed from the exercise of our natural facilities and powers, or from the force and operation of the free will since man in consequence of his natural corruption is incapable of either thinking or doing anything spiritually good.
- ART. 7 We believe in the general application of the Grace of God for fallen man, sufficient to enable him morally and actually to obey the requirements of the law of liberty James 1:25, this is to act saving faith; John 1:9, however, none but those who believe or acquiesce in Christ will be saved thereby; Acts 17:32; Romans 2:9; John 3:19.
- ART. 8 We believe in the free and moral agency of man, by the Grace of God, before and after conversion that he is under no invincible necessity, by his Creator, to act in a given way that if he

lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject of admonition and exhortation, Heb. 3:11-12-13; Rom. 13:14; Mark 13:33; Eze. 18:24; Rev. 2nd & 3rd chapters; Eze. 33:13-18; I Tim. 4:1; Heb. 3:6; I Cor. 10:12-22; I Peter 1:10.

- ART. 9 We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel observing the ordinances of Christ, governed by His laws and exercising the gifts, rights and privileges invested in them by His work; That its only proper officers are bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistle of Timothy and Titus.
- ART. 10 We believe that Christian Baptism is immersion in water in the name of the Father, Son and Holy Ghost, and that believers are proper subjects.
- ART. 11 We believe the Lord's supper is a perpetual obligation, by which the members of the church in the use of bread and wine, are to commemorate together the dying of Christ preceded always by solemn self-examination.
- ART. 12 We believe in the resurrection of the dead and the general judgement and joys of the righteous and the punishment of the wicked will be eternal upon principles of grace and justice.
- ART. 13 We believe in open and mixed communion and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches, who are in good standing in their respective churches to commune with us at the Lord's table.
- ART. 14 We believe that the Holy Spirit enters the heart of the Believer at the time of conversion, and that speaking in tongues (languages) is neither an evidence of being infilled with the Holy Spirit nor does it bring about sanctification. We teach and preach the fullness of the Holy Spirit and heed the scriptural admonition, "Be filled with the Spirit." We thank God for our great Comforter, Guide, and Empowerer, the precious Holy Spirit, the Third Person of the Trinity. (John 3:5-8; Romans 8:9; Ephesians 5:18; I Corinthians 14:22).

RULES OF DECORUM

- ART. 1 (a) The Association shall be called to order and officiated by the Moderator, who was elected at the last session.
- (b) The new officers (Moderator and Clerk) will take office at the close of the annual session and serve through the annual session of the following year.
- ART. 2 The Association shall be opened and closed by singing and prayer.
- ART. 3 (a) The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes, by delegates present, elect.
- (b) The Moderator and Clerk cannot serve more than four years in succession.
- ART. 4 It shall be the duty of every church belonging to this Association to send a letter to every annual session of this Association, reporting in the letter its spiritual condition, benevolent work and its statistics. Also, that we receive the letters and seat the delegates on the strength of the Credentials Committee report and omit public reading of the letters. All letters be mailed with minutes fee to the Clerk of this Association two (2) weeks prior to the annual session of the Association. The names of the delegates from the different churches shall be enrolled and called for, as necessary, during the session.
- ART. 5 A majority of the delegates shall rule in all cases except the reception of churches, all questions of doctrines, and matters pertaining to the Constitution and Rules of Decorum, then it shall be by two-thirds vote.
- ART. 6 The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on all questions after all others have spoken, provided he appoint someone to the chair while he is speaking.
- ART. 7 Only one person shall speak at a time and he shall rise and address the Moderator and after recognition by the Moderato, he shall proceed.
- ART. 8 No member shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.
- ART. 9 No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than five (5) minutes at a time.

- ART. 10 No member shall laugh or talk while debates are going on.
- ART. 11 No member shall absent himself from the Association without leave of the Moderator.
- ART. 12 The Moderator shall have the power to call the Association together at any time he deems necessary or upon a petition of two-thirds of the churches composing the Association over which he presides.
- ART. 13 That the appointment of all committees by the Moderator be confined to Ministers and delegates composing the Association.

CONSTITUTION

- ART. 1 This Association shall be known as the Mount Moriah Free Will Baptist Association of Alabama, being composed of delegates from the different churches forming the same, each being entitled to three elected delegates.
- ART. 2 The body shall be considered an Advisory Council, but have no authority over the affairs of other churches unless they depart from the Articles of Faith of the Association. In case any church departs from the Articles of Faith and supports doctrines or heresy, or allows any Minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Association as it may deem proper and right, according to the teachings of the bible.
- ART. 3 Each church in this Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, etc., and each church reserves the right to retain ownership of their property and buildings should the church split or decide to sell. Each church should control its internal affairs concerning all property under their name. It may however, in extreme cases, call aid from sister churches, but the Association shall rule in all matters of doctrine.
- ART. 4 All questions of doctrines and matters pertaining to the Constitution and Rules of Decorum shall be settled by a two-thirds vote of the Association; provided the same is presented in written form; presented in the morning session; and voted on in the afternoon session; and the decision shall be final.

- ART. 5 The officers of the Association shall be a Moderator, Assistant Moderator, Clerk-Treasurer, and Assistant Clerk-Treasurer, who shall be chosen by ballot at each annual session by a majority of votes. The Moderator shall serve as the Association's representative on the General Board of the State Association. The Clerk shall be paid \$125.00 per year, plus expenses incurred in carrying out his duties. Each church send each year to the annual session the sum of \$25.00 as associational funds.
- ART. 6 (a) This Association shall meet annually, at such time and place as may be agreed at a previous annual session, and shall not adjourn finally until all business is transacted.
- (b) There shall be a short business session and a report from all standing committees at each quarterly meeting.
- ART. 7 Churches wishing to become members of the Association must adopt its Articles of Faith and conform to its usage.
- ART. 8 We agree as churches of this Association to use our best influences to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sunday Schools, Missionary Work, etc.
- ART. 9 Any minister pastoring a church or churches in the Mount Moriah Association shall be regularly ordained minister in good standing and become affiliated with this association.
- ART. 10 All ministers and deacons shall be standing delegates in this Association.
- ART. 11 We adopt the Treatise of Faith and Practice of the Original Free Will Baptist.

ART. 12 SECTION ONE: GENERAL BOARD

- A. <u>COMPOSITION</u>: The General Board shall be composed of the Moderator, Clerk, and one member from each local church that is a part of this body. Each member from a local church shall serve a two-year-term with one-half of the members being elected each year.
- B. <u>DUTIES</u>: The General Board shall formulate all ideas of business during the annual session of the Association, act as a Nominating Committee, as well as any other responsibility so delegated by the body. It shall not have power to commit the Association to any cause or policy not authorized by the Mount Moriah Association, nor to reverse any action of the Mount Moriah Association;

SECTION TWO: BOARD OF CHRISTIAN EDUCATION

- A. COMPOSITION: The Christian Board shall be composed of five members. These are elected to serve a 5-year-term with one expiring each year.
- B. DUTIES: 1. The christian Board shall act in an advisory capacity to the youth organization of the Association.
- 2. The Christian Board shall work with all churches in the Association to promote the youth work and other related projects.
- 3. The Christian Board, along with the youth officers and host church, shall plan the program.

ART. 13 STANDING COMMITTEES

SECTION ONE: CREDENTIALS COMMITTEE

- A. The Credentials Committee shall consist of three lay brethren and two ordained ministers, elected at the annual session of the Association, each serving a five (5) year term, the senior member coming off each year. A committee member cannot serve more than one term without a years' leave.
- B. It shall be the responsibility of this committee to examine letters coming to this body from churches, ministers, and other Associations. This committee shall also examine all ministers who become a part of this body, either by ordination or by letter, and make recommendations to the Association.
- C. It shall be the duty of this committee to make an annual report to the Association as to the standing, character, and orthodoxy of the ministers and churches of this Association.

SECTION TWO: HOME MISSION COMMITTEE

- A. The Home Mission Committee shall consist of three lay brethren and two ordained ministers elected at the annual session of the Association, elected for a five-year-term, the senior member coming off each year.
- B. It shall be the responsibility of this committee to take charge of the Home Mission work of this Association, to promote the cause of Home Missions, and to take oversight of any mission church so organized.
- c. The Home Mission Committee shall have a Secretary-Treasurer and use funds given for Home Mission work.
- D. The Home Mission Committee shall make a report to the annual session of the Association.
- ART. 14. The Moderator of the Association shall be an exofficio member of all Boards and Committees.

ART. 15 No person shall be allowed to serve on more than one Standing Board or Committee, with the exception of the General Board. A person may be a member of the General Board and still be eligible for a Standing Board or Committee.

ART. 16 DEACONS:

To be ordained, he must be elected by the church of which he is a member. A deacon must meet the conditions stated in the third chapter of I Timothy, verses 8-13. The term "husband of one wife" means he shall not have more than one living wife, that is, he shall not be married to one wife at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. The ordination council shall consist of at least one ordained minister and two deacons of the Mount Moriah Association.

ART. 17 MINISTERS:

The authority to ordain or license ministers has its source in the local church.

1. LICENSED MINISTERS:

Must be a member of a church which belongs to the Mount Moriah Association. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. The ministerial license shall be valid for a period of one year but is renewable annually. He must have his license renewed annually by said church and kept enforced until ordination. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of pastoring a church and officiating at the observances of the ordinances and weddings.

2. ORDINATION:

He must follow the guidelines for licensed ministers. A minister must meet the conditions stated in the third chapter of I Timothy, verses 1 - 7. The term, "husband of one wife" means he shall not have more than one living wife, at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. After he has been licensed and has proven his worth to the local church, the local church has the authority to ordain or ask the Association to ordain. The place of ordination and ordination council will be selected by the candidate. The ordination council

shall consist of at least three ordained ministers from the Mount Moriah Association.

3. RULES FOR MINISTERS:

. 41

- A. Ministers wishing to transfer from another Free Will Baptist Church or Association into the Mount Moriah Association, shall present a letter of good standing from the church or Association of which he is a member, be examined by the Credentials Committee, and be approved by this Association.
- B. Ministers of other denominations who unite with our churches shall be as a member and if they wish to preach, they must follow the procedure required of our licensed ministers.
- C. Ministers of this Association, that are in good standing, shall be granted a card annually, signed by the Clerk and Moderator with the minister's name, address, and the church of which he is a member.
- D. Any minister who is on the ordained ministers list and does not attend an Associational meeting in any one year or who makes no contacts will be dropped from the ordained ministers list.
- E. Any minister who behaves himself unbecomingly to his calling into the ministry of the gospel shall be reported by the Credentials Committee to the Association, who shall deal with him.
- ART. 18 This Association shall be a member of The Alabama State Association of Free Will Baptists. It is expected that each church will send the necessary fee for representation in the State body.

RULES OF DECORUM FOR CONFERENCE

The conference shall be called to order by the Pastor who is the Moderator. The clerk shall be seated in order.

- Invite visiting members to seat with us and aid in council.
- 2. Open the door of the church for members.
- 3. Call for reference.
 - 4. Calls for communications.
 - 5. Calls for new business.
 - 6. Calls for miscellaneous business.
 - 7. Adjournment.
