ANNUAL ASSOCIATIONAL MEETING First FWB Church-Pleasant Grove, Alabama October 13, 2001

The one hundred and fifty-first annual meeting of the Mt. Moriah Association was held at First Free Will Baptist Church in Pleasant Grove. The opening song, "America The Beautiful", was song by the congregation with Kenneth Isbell leading the singing and Mary Kearney at the piano.

Host pastor, Rev. Jimmy Youngblood, gave the welcome and led in prayer. Moderator Jerry Smith gave the response and introduced the first speaker, Rev. Gary Mullenix, pastor of Glen Echo FWB Church.

In the business session, James South distributed the Treasurer's Report in the absence of Treasurer Jewell South. There was some discussion about the Fifth Sunday Youth Meeting program.

Rev. Terrell Jones, Chairman of the Special Committee appointed to draw up guidelines for new Churches wishing to affiliate with the Mt. Moriah Association, made the following recommendations:

That Article 7 of the Constitution be changed to read as follows:

Article 7 CHURCH MEMBERSHIP IN THE ASSOCIATION

SECTION ONE: GENERAL REQUIREMENTS

A. Any Church desiring to become a member of the Mount Moriah Association of Free Will Baptists or to continue membership must adopt its Articles of Faith and conform to the use thereof and openly identify in all literature, printed material, church sign, etc. that they are indeed a FREE WILL BAPTIST CHURCH.

SECTION TWO: NEW CHURCHES REQUESTING MEMBERSHIP

- A. A Church requesting membership in the association must submit a letter affirming that it has read the Articles of Faith, Rules of Decorum and the Constitution of the Mount Moriah Association and that its membership by majority vote has agreed to abide thereby. The letter shall be signed by the Church Pastor, Deacons of the Church, and the Church Clerk.
- B. A Church transferring from another association must obtain a letter of good standing from the association of which it is transferring from.
- C. The Credentials Committee shall be responsible for examining all requests of Churches desiring to become members. Upon completion of their examination they shall make a recommendation to the association during a regular business meeting session.

There were also some suggestions that came out of the discussion of the committee during their yearlong work on this:

- 1. That each Church should be willing to have a delegation at each meeting to accompany their pastor.
- 2. That each Church should support and encourage participation in the Fifth Sunday Youth Meetings.
- 3. That each Church should be willing to host a quarterly meeting if asked.

The General Board approved the recommendations. The meeting was then adjourned by prayer.

Rev. Terrell Jones talked about the work of the Committee, which had been appointed to look into establishing some guidelines for accepting Churches into the Association. He restated the change in the Constitution that was recommended by the General Board. This item was tabled until the afternoon session.

Rev. Rick Cash leading in prayer dismissed the meeting for a time of fellowship and refreshments.

As the congregation reassembled following the break, we sang "Everybody Will Be Happy Over There", led by Kenneth Isbell, with Mary Kearney on the piano. Members of the host Church also provided special music. David Barry sang "That's What This Altar Is For", and Kenneth Isbell sang "He's Alive".

The second message was preached by Rev. Roger Lucas. His text was I Peter 2:1-10, with commitment being the focus. - He always knows the need in our life. He prepares people for His work. He has prepared a place for us for all eternity. Are we showing respect and appreciation to Him for what He is doing for us?
- #3 Sin Hurts The Church
 80% of the New Testament is written to the Church.
 This generation of God's people is no different than any in the past. If we want God's blessings, we must humble ourselves and be obedient to Him.

We feel at this time more than ever education is a very important thing in the lives of our children. The future relies on this. We encourage parents to promote good, godly education.

We feel that literature should be monitored at all times, especially what we let come into our homes. We emphasize Proverbs 22:6 "Train up a child in the way he should go, and when he is old, he will not depart from it."

SUNDAY SCHOOL & CTS

As our Holy Scriptures admonish us in II Timothy 2:15 to "study to show thyself approved", we admonish this association of Churches to see

that our Sunday Schools and CTS groups be founded in study. Our admonition also envelopes our need not to rely solely upon our literature as good as it may be, but that our study be in the Holy Bible, rightly divided, and our final authority. Our needs for study do not end on Sunday, but should reach out into our personal life, especially in these times of intense evil and tribulation.

WOMEN ACTIVE FOR CHRIST

Sharing Hope and Healing is the theme of WNAC this year which is so appropriate in our country today. Our District WAC will be getting together at 9:30 on October 27th at the P. JANUARY QUARTERLY MEETING Phillips Chapel Free Will Baptist Church January 13, 2001

Singing "Just Over In The Glory Land" opened the January meeting of the Mount Moriah Association. Milford McAdams led the singing, with Myree Galloway at the piano throughout the day. Rev. Waymon Fields opened the meeting by leading the congregation to sing "At The Cross", and was accompanied by Myree Galloway at the piano. Both the welcome and opening prayer were given by host pastor, Rev. Tony Latham.

Absent at the Roll Call of Churches given by the clerk, were the First FWB Church of Reform, and the First FWB Church of Ethelsville. Representatives of the First FWB of Ethelsville came in later. Rev. Jerry Montgomery of the Credentials Committee gave the Roll Call of Ministers, and there were nine absent.

The first message was preached by Rev. Larry Colburn, whose text was taken from Joshua 14:6-13. He brought out three things about Caleb that are relevant to Christians who are in the warfare today:

Caleb was a Soldier By Choice- He chose to fight and claim his inheritance in Canaan. Numbers 24 tells us Caleb had "another spirit" in him. There were 12 spies that originally went into Canaan to view the land, but he and Joshua were the only two that lived.

Caleb was a Career Soldier- As v.10 of the text tells us, there was no stopping place for Caleb. Even at 85 years of age, he was eager to claim the mountain God had given him.

Caleb was a Soldier With An Objective-He always kept his eyes on the prize. He wanted the mountain, and was willing to face the giants to get it.

In closing, Brother Colburn challenged us to be like Caleb, and "wholly follow the Lord God of Israel."

Rev. Rick Cash, State Promotional Director was introduced. He thanked the Association for their gifts to the Acts 1:8 Program, and told us the location for the state meeting had been changed to Madison FWB Church. Brother Cash also encouraged the Churches to be financially responsible toward their pastors.

James Acker, Finance Committee Chairman, prayed the offertory prayer, and the congregation stood together and sang "Down At The Cross" as the offering was received. The offering total was \$184.00. After instructions from the host Church, we were dismissed for break by Brother Earl Johnson.

Deception through the watering-down of the gospel, as mentioned in Matthew 24:4. Division in the world with nations fighting against each other, and nations divided from within, Matthew 24:7. Unconcern, people busy, but no time for spiritual matters, Matthew 24:37-39. Like the Laodicean Church, lukewarm to spiritual things.

He concluded the message by asking us if we were ready for Jesus to come, illustrating the importance of being ready by bringing in Matthew 25:1-13, the story of the foolish virgins. Their lamps had gone out.

An opportunity to respond to his question was given as the congregation stood and sang the invitation hymn, "Just As I Am".

Moderator Jerry Smith then called the Association to order and delegate were seated. Guests were recognized; Rev. Rick Cash, State Promotional Director, and Rev. Randy Key, Director of the FWB Children's Home in Eldridge.

The report was approved by a standing vote, and applause for the Church's hospitality.

The business session was concluded with the congregation standing together and singing "When We All Get To Heaven". Following this, special music was provided by Sis. Donna Johnson, who sang "The Only Thing That Matters".

Rev. Roy Plymon preached the final message of the meeting. His text was I Kings 18:17-21, 36-39 which he titled "Fire On The Altar". Brother Plymon introduced his message by stating that success is not how busy we are, how good our music program is, how attractive our building is, or how qualified our staff might be. Success is God being in our presence! This is what will thrill, encourage, empower and move the Church, His presence.

He then showed how God had used fire in the past to speak to Abraham when he walked through his sacrifices as a burning lamp, and to speak to Moses from the burning bush. This was external.

He then pointed to the New Testament, and the Church in its beginning where God's presence was evidenced by "cloven tongues" that came on the day of Pentecost. This was internal.

He then brought out four points about God's presence in our life:

His Presence Gives Guidance-v.36 "...at thy word". Elijah was not working on his own, but was being guided by the Lord in challenging the prophets of Baal.

His Presence Gives Protection- v.40 "...slew them (450 prophets of Baal) there". One preacher against 450 prophets, but unafraid to challenge them, and fearless in putting them to death after their defeat.

His Presence Gives Power- v.46 "...ran before Ahab to the entrance to Jezreel". Elijah was able to do the supernatural, and unbelievable tasks because God was with him.

His Presence Gives Provisions- v.45 "...there was an abundance of rain". God ended the drought and provided the needs of His people.

He concluded by stating that God is more important than organization, people, finances, earnestness, facilities, location and emotion. All of these were on Ahab's side, but Elijah had God. Until God is in what we do, success will not be ours to enjoy. If there is no fire, sin has crept in and there will be no growth.

Before closing the meeting, Brother Winston Robertson thanked the congregation for their prayers for him over the last few months. The final hymn, "To God Be The Glory" was sung, and the prayer of dismissal was led by Rev. Rick Cash.

JULY QUARTERLY MEETING Union Free Will Baptist Church July 7, 2001

He introduced the message by showing the beautiful picture of Abraham as God the Father, Isaac as God the Son, the steward of Abraham as God the Holy Spirit, and Rebekkah as the Bride, the Church.

He brought out three points about Rebekkah that apply to the Church today:

She Was Moved By A Message. The Church of today is those who have believed a message. We have not seen God, neither have we seen heaven, but we believe it to be the truth that He wants us to spend eternity with Him in heaven. We believe though we have not seen, just as Rebekkah had to leave her family behind.

She Was Made A Companion Of The Steward. The Holy Spirit is our constant companion as we live for God. He starts on the journey the moment we start and stays with us throughout the endeavor just like the steward did Rebekkah.

She Was Met By The Bridegroom, The Son. The body of believers will be met, somewhere between their house and his, just as Rebekkah was met by Isaac. He interrupted their journey to his house,

and one day the Lord will interrupt our journey, but for the purpose of taking us home with Him.

Brother James Acker prayed the offertory prayer, and an offering was received while the pianist played "He'll Hold To My Hand". A break was taken for refreshments.

The meeting was resumed by singing "Adore Our Wonderful King". Our second speaker, Rev. Ben Logan, pastor of Holman, used Jude 1-4 as his text. He talked of the disturbing and dishonoring lives that are being lived today in the professing Church body. He mentioned three scriptures that explain just what it means to be a follower of Christ:

asking us to pray for him, his family, and the work going on in Mongolia.

Rev. Rick Cash, Alabama Promotional Director addressed the meeting. He announced that Rev. Scott Wright would be assuming the mission pastorate in Prattville. Rev. Fred Jones is moving to Cullman to start a Hispanic ministry.

An update on the Russian Institute was also given. Plans are to begin classes for the first group of Russian pastors in September. He requested prayer for all our mission projects in the state and all Alabama missionaries serving outside the state.

Resolutions And Appreciation Committee- given by Nell Acker. We thank the Union Free Will Baptist Church and its pastor for hosting this quarterly meeting. We received a blessing from the sermons and songs. We thank the ladies for the delicious brunch. We thank all the pastors, missionaries and Churches for their support of these meetings.

New Business- A motion was made, and seconded to give \$225.00 dollars to offset the expenses of three Russian pastors for the first training session of the Russian Institute. It was approved.

After the business session, the congregation sang "Palms Of Victory" Brother Ed Miller led us in prayer. Special music was given by the Union FWB Church Choir. They sang "The Old Country Church" and "Time Has Made A Change In Me"

The final message of the day was given by Rev. J.L. Lavender. His text was I Thessalonians 5:14-23 and with three points emphasized as to how we should act and react to life:

Rejoice Evermore. Christians should enjoy life, and the Lord's work. We would rejoice more if we gave more. It is God's will for us to rejoice. We should rejoice over the life that is ours through faith in Christ, and that our names are written in the Lamb's Book of Life.

Pray Without Ceasing. Not when you get in a tight, but daily. We ought to pray and not to faint. There is no place to give up or quit.

Every day ought to be a day when we think about the Lord and pray to Him.

In All Things Give Thanks. Thank Him for the food we have to eat. We ought to thank Him for the ability to get up each morning, the opportunity to be at this meeting. Thank Him for the privilege to live for Him, and to love Him with all our heart, mind, soul, and strength.

After announcements were given, the congregation stood together and sang "Where Could I Go". Closing prayer was led by Waymon Fields.

ARTICLES OF FAITH

- ART 1. We believe there is one true and living God, who is the Supreme Ruler of Heaven and earth, self-existent Creator of all things and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distant harmonious offices in the great work of redemption.
- ART 2. We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; that it reveals the principle by which all human conduct, creeds and options will be tried.
- ART 3. We believe that man was created holy under the law of the maker, but from voluntary transgression fell from that holy state, inconsequent of which all mankind are depraved and wholly unable of their own free will and ability to recover from that fallen state in which they are by nature.
- ART 4. We believe that God has not fixed the future state of mankind by any absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.
- ART 5. We believe that Christ by His death and suffering, made an atonement for the sins of mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the divine benefits.
- ART 6. We believe that true faith cannot proceed from the exercise of our natural facilities and powers, or from the force and operation of the free will since man in consequence of his natural corruption is incapable of either thinking or doing anything spiritually good.
- ART 7. We believe in the general application of the Grace of God for fallen man, sufficient to enable him to morally and actually obey the requirements of the law of liberty James 1:25, this is to act saving faith; John 1:9; however, none but those who believe or acquiesce in Christ will be saved thereby; Acts 17:32; Romans 13:14; John 3:19.
- ART 8. We believe in the free and moral agency of man, by the Grace of God, before and after conversion that he is under no invincible necessity,

- by his Creator, to act in a give way that if he lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject of admonition and exhortation, Hebrews 3:11, 12, 13; Romans 13:14; Mark 13:33; Ezekiel 18:24; Revelation 2nd and 3rd chapters; Ezekiel 33:13-18; I Timothy 4:1; Hebrews 36; I Corinthians 10:12-22; I Peter 1:10.
- ART 9. We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel observing the ordinances of Christ, governed by His laws and exercising the gifts, rights and privileges invested in them by His work; that its only proper officers are bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistle of Timothy and Titus.
- ART 10. We believe that Christian baptism is immersion in water in the name of the Father, Son and Holy Ghost, and that believers are proper subjects.
- ART 11. We believe the Lord's Supper is a perpetual obligation, by which the members of the church in use of bread and wine are to commemorate together the dying of Christ preceded always by solemn self-examination.
- ART 12. We believe in the resurrection of the dead and the general judgment and joys of the righteous and the punishment of the wicked will be eternal upon principles of grace and justice.
- ART 13. We believe in open and mixed communion and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches, who are in good standing in their respective churches to commune with us at the Lord's Table.
- ART 14. We believe that the Holy Spirit enters the heart of the Believer at the time of conversion, and that speaking in tongues (languages) is neither an evidence of being in-filled with the Holy Spirit nor does it bring and heed the scriptural admonition, "Be filled with the Spirit." We thank God for our great Comforter, Guide, and Empowered, the precious Holy Spirit, the Third Person of the Trinity. (John 3:5-8; Romans 8:9; Ephesians 5:18; I Corinthians 14:22)

RULES OF DECORUM

- ART 1. (a) The Association shall be called to order and officiated by the Moderator, who was elected at the last session.
 - (b) The new officers (Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer) will take office at the close of the annual session and serve through the annual session of the following year.
- ART 2. The Association shall be opened and closed by singing and prayer.
- ART 3. (a) The Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer shall be chosen by ballot at each annual session of the Association. A majority of votes, by delegates present, elect.
 - (b) The Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer cannot serve more than four years in succession.
- ART 4. It shall be the duty of every Church belonging to this Association to send a letter to every annual session of this Association, reporting in the letter its spiritual condition, benevolent work, and its statistics. Also, that we receive the letters and seat the delegates on the strength of the Credentials Committee report and omit the public reading of the letters. All letters be mailed with minutes fee to the Clerk of this Association the first week in September. The names of the delegates from the different churches be enrolled and called for, as necessary, during the session.
- ART 5. A majority of the delegates shall rule in all cases except in the reception of churches, all questions of doctrines, and matters pertaining to the Constitution and Rules of Decorum, then it shall be by two-thirds vote.
- ART 6. The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on all questions after all others have spoken, provided he appoints someone to the chair while he is speaking.

- ART 7. Only one person shall speak at a time and he shall rise and address the Moderator and after recognition by the Moderator, he shall proceed.
- ART 8. No member shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.
- ART 9. No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than five (5) minutes at a time.
- ART 10. No member shall laugh or talk while debates are going on.
- ART 11. No member shall absent himself from the Association without leave of the Moderator.
- ART 12. The Moderator shall have the power to call the Association together at any time he deems necessary or upon a petition of two-thirds of the churches composing the Association over which he presides.
- ART 13. That the appointment of all committees by the Moderator be confined to Ministers and Delegates composing the Association.
- ART 14. No more than one (1) person from the same church shall serve on the same standing committee (Credentials, Board of Christian Education, Missions and Church Extension).

CONSTITUTION

- ART 1. This Association shall be known as the Mount Moriah Free Will Baptist Association, being composed of delegates from the different churches forming the same, each being entitled to three delegates.
- ART 2. The body shall be considered an Advisory Council, but have no authority over the affairs of other churches unless they depart from the Articles of Faith of the Association. In case any church departs from the Articles of Faith and supports doctrines of heresy, or allows any Minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Association as it may deem proper and right, according to the teachings of the Bible.
- ART 3. Each church in this Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, etc., and each reserves the right to retain ownership of their property and buildings should the church split or decide to sell. Each church should control its internal affairs concerning all property under their name. It may, however, in extreme cases, call aid from sister churches, but the Association shall rule in all matters of doctrine.
- ART 4. All questions of doctrines and matters pertaining to the Constitution and Rules of Decorum shall be settled by two-thirds vote of the Association; provided the same is presented in written form; presented in the morning session; and voted on it the afternoon session; and the decision shall be final.
- ART 5. The officers of the Association shall be Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer, who shall be chosen by ballot at each annual session by a majority of votes. The Moderator shall serve as the Associational Representative on the General Board of the State Association. The Clerk and the Treasurer shall be paid \$125.00 each, per year, plus expenses incurred in carrying out their respective duties. Each church shall send each to annual session the sum of \$30.00 as associational funds.
- ART 6. (a) This Association shall met annually, at such time and place as may be agreed on at a previous annual session, and shall not adjourn finally until all business is transacted.
- (b) There shall be a short business session and report from all standing committees at each quarterly meeting.

ART 7. CHURCH MEMBERSHIP IN THE ASSOCIATION

SECTION ONE: GENERAL REQUIREMENTS

A. Any Church desiring to become a member of the Mount Moriah Association of Free Will Baptists or to continue membership must adopt its Articles of Faith and conform to the use thereof and openly identify in all literature, printed material, church sign, etc. that they are indeed a FREE WILL BAPTIST CHURCH.

SECTION TWO: NEW CHURCHES REQUESTING MEMBERSHIP

- A. A Church requesting membership in the association must submit a letter affirming that it has read the Articles of Faith, Rules of Decorum and the Constitution of the Mount Moriah Association and that its membership by majority vote has agreed to abide thereby. The letter shall be signed by the Church Pastor, Deacons of the Church, and the Church Clerk.
- B. A Church transferring from another association must obtain a letter of good standing from the association of which it is transferring from.
- C. The Credentials Committee shall be responsible for examining all requests of Churches desiring to become members. Upon completion of their examination they shall make a recommendation to the association during a regular business meeting session.
- ART 8. We agree as churches of this Association to use our best influences to promote the interest of all moral and benevolent institutions, such as the Temperance Cause, Sunday Schools, Missionary Work, etc.
- ART 9. Any minister pastoring a church or churches in the Mount Moriah Association shall be a regularly ordained minister in good standing and become affiliated with this association.
- ART 10. All ministers and deacons shall be standing delegates in this Association.
- ART 11. We adopt the Treatise of Faith and Practices of the Original Free Will Baptists.

ART 12. GENERAL BOARD

- A. COMPOSITION: The General Board shall be composed of the Moderator, Clerk, and one member from each local church that is a part of this body. Each member from a local church shall serve a two-year term with one-half of the members being elected each year.
- B. DUTIES: The General Board shall formulate all ideas of business during the annual session of the Association, act as a Nominating Committee, as well as, any other responsibility so delegated by the body. It shall not have the power to commit the Association to any cause or policy not authorized by the Mount Moriah Association, nor to reverse any action of the Mount Moriah Association.
- C. MEETING DATE: The regular meeting date for the General Board will be two weeks prior to the annual Association meeting (the Saturday before second Sunday in October) and remain the same each year.

ART 13. STANDING COMMITTEES

SECTION ONE: CREDENTIALS COMMITTEE

- B. The Credentials Committee shall consist of three lay brethren and two ordained ministers, elected at the annual session of the Association, each serving a five (5) year term, the senior member coming off each year. A committee member cannot serve more than one term without a year's leave.
- C. It shall be the responsibility of this committee to examine letters coming to this body from churches, ministers, and other Associations. This committee shall also examine all ministers who become a part of this body, either by ordination or by letter, and make the recommendations to the Association.
- D. It shall be the duty of this committee to make an annual report to the Association as to the standing, character, and orthodoxy of the ministers and churches of this Association.

SECTION TWO: MISSIONS AND CHURCH EXTENSION COMMITTEE

- A. The Missions and Church Extension Committee shall consist of three (3) lay brethren and two ordained ministers elected at the annual session of the Association, elected for a five-year term, the senior member coming off each year.
- B. It shall be the responsibility of this committee to take charge and promote the cause of Missions and Church Extension of this Association and to take oversight of any Mission Church so organized.
- C. The Mission Committee shall have a Secretary Treasurer and use funds for Mission and Church Extension work.
- D. The Mission and Church Extension Committee shall make a report to the annual session of the Association.

SECTION THREE: BOARD OF CHRISTIAN EDUCATION

- A. COMPOSITION: The Christian Board shall be composed of five members. These are elected to serve a five-year term with one expiring each year.
- B. DUTIES: The Christian Board shall act in an advisory capacity to the youth organization of the Association. The Christian Board shall work with all churches in the Association to promote the youth work and other related projects. The Christian Board, along with the youth officers and host church, shall plan the program.
- ART 14. The Moderator of the Association shall be an ex-officio member of all Boards and Committees.
- ART 15. No person shall be allowed to serve on more than one Standing Board or Committee, with the exception of the General Board. A person may be a member of the General Board and still be eligible for a Standing Board or Committee.
- ART 16. <u>DEACONS</u>. To be ordained, he must be elected by the church of which he is a member. A deacon must meet the conditions stated in

the third chapter of I Timothy, verses 8-13. The term "husband of one wife" means he shall not have more than one living wife, that is, he shall not be married to one wife at the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. The ordination council shall consist of at least one ordained minister and two deacons of the Mt. Moriah Association.

- ART 17. MINISTERS. The authority to ordain or license ministers has its source in the local church.
 - A. LICENSED MINSTERS. Must be a member of a church which belongs to the Mount Moriah Association. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. The ministerial license shall be valid for a period of one year but is renewable annually. He must have his license renewed annually by said church and kept enforced until ordination. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of pastoring a church and officiating at the observances of the ordinances and weddings.
 - B. ORDINATION. He must follow the guidelines for licensed minister. A minister must meet the conditions stated in the third chapter of Timothy, verses 1-7. The term "husband of one wife" means he shall not have more than one living, that is, he shall not be married to one wife a the present time and there be a wife still living from a previous marriage. The same shall apply to the wife, she shall have only one living husband. After he has been licensed and has proven his worth to the local church, the local church has the authority to ordain or ask the Association to ordain. The place of ordination and ordination council will be selected by the candidate. The ordination council shall consist of at least three (3) ordained ministers from the Mount Moriah Association.

C. RULES FOR MINISTERS.

- a. Ministers wishing to transfer from another Free Will Baptist Church or another Association into the Mount Moriah Association, shall present a letter of good standing from the church or Association of which he is a member, be examined by the Credentials Committee, and be approved by this Association.
- b. Ministers of other denominations who unite with our churches shall be a member and if they wish to preach, they must follow the procedure required for our licensed ministers.
- c. Ministers of this Association, that are in good standing, shall be granted a card annually, signed by the Clerk and Moderator with the minister's name, address, and the church of which he is a member.
- d. Any minister who is on the ordained ministers list and does not attend an Association meeting in any one year or who MAKES NO CONTACTS will be dropped from the ordained ministers' list.
- e. Any minister who behaves himself unbecomingly to his calling into the ministry of the gospel shall be reported by the Credentials Committee to the Association, who shall deal with him.

ART 18. This Association shall be a member of the Alabama State Association of Free Will Baptists. It is expected that each church will send the necessary fee for representation in the State body.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of Scripture, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace. To be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
