

PROCEEDINGS

Minutes of the thirty-fifth annual session of the North Carolina Free Will Baptist Woman's Auxiliary Convention convening with the First Free Will Baptist Church, Wilson, North Carolina, May 10, 1962.

Theme: "Found Faithful."

Scripture: "Moreover it is required in stewards, that a man be found faithful" (1 Corinthians 4:2).

Thought for the Day: Faithfulness is the prime requisite to rewarding success in Christian service.

The convention was called to order by the president, Mrs. J. C. Moye. Reverend C. F. Bowen directed the hymn, "O Zion Haste." Mrs. Ruth Clark Taylor was organist.

Mrs. Lillie Mae Sasser gave the devotional thoughts, "Faithfulness Turns Darkness Into Light for Those on Foreign Shores." Scripture references John 3:3; 2 Corinthians 3:1-6; Matthew 28:19 and Acts 4:12 were used. The Stoney Creek Trio rendered special music, "For Jesus Saves."

Mrs. Boyd Shook, president of the Western Convention, gave the welcome. Mrs. R. Y. Stephenson, president of the Cape Fear Auxiliary, responded. Reverend C. F. Bowen offered prayer.

The president gave her remarks using the Scripture 1 Corinthians 4:2. She said, "We can do all things through Christ which strengtheneth us." She gave her personal report. (See reports.)

The state and district officers were recognized, likewise the delegates.

The minutes of the executive committee were read and approved.

Mrs. Robert Crawford presented the declamation winners. They were Karen Hancock and Brenda Jenkins, St. Mary's Church, New Bern. They challenged our hearts.

The morning worship was begun with the hymn, "To the Work." An offering was taken for the Children's Home. Reverend Wilbert Everton gave the offertory prayer. A congregational number, "No One Ever Cared for Me Like Jesus," was sung.

Reverend C. F. Bowen introduced Dr. Roy O'Donnell, acting president of Mount Olive College, who brought the morning message. He chose as his Scripture, "For a great door and effectual is opened unto me, and there are many adversaries" (1 Corinthians 16:9). Dr. O'Donnell called to our re-

membrance the many opportunities which are ours for service. There is great need for the evangelism of the unsaved; work to be done for both home and foreign missions; Christian education in the Sunday schools, in all phases of the auxiliary work, in the leagues, as well as in the field of higher education. There is also much opportunity for service in the work of enlistment. Truly a great door of opportunity is open to us. But he also reminded us of the adversaries which are at work constantly seeking to hinder the work of Christ. Some of these adversaries are indifference, complacency, procrastination and discouragement. Those who would work faithfully for Christ must never give place to any of these adversaries. Only help which comes from the Father above can carry us through this difficult time. Truly our God is able to help us if we will call upon Him and then obey His leading. Because Paul was faithful he was able to say, "I have fought a good fight, I have finished my course, I have kept the faith." He closed with this challenging statement, "What Free Will Baptists make of the future depends upon the degree of faithfulness during this present time."

Reverend Earl Glenn, host pastor, extended the invitation to lunch.

Reverend J. C. Griffin gave the benediction and blessing.

AFTERNOON SESSION

The afternoon session was opened by singing, "The Light of the World Is Jesus" and, "Majestic Sweetness Sits Enthroned." Reverend R. H. Jackson prayed.

Mrs. Robert Crawford introduced the G. T. A. winner in the essay contest, JoAnn Bryan from the Kinston church who read her essay, "The Worth of a Family Altar." In the absence of the Y. P. A. winner, Neil Hearn, of Malachi's Chapel, Mrs. Crawford read his essay.

Reports were given by the secretary, by the director of Cragmont Woman's Conference, the field worker, the resolutions committee; the resolutions were voted on one by one by motion of the convention. They all carried. (See reports.)

Mrs. Bowen announced the theme for the Yearbook Devotions as, "Walking in the Christ Way" and the theme song "If Jesus Goes With Me."

Mrs. H. L. Spivey made a plea for the promotion of auxiliary pins.

A motion carried that the North Carolina Woman's Auxiliary withdraw from the WNAC. The vote was ninety to one in favor of the motion. (See motion on the N. C. State Convention in Resolutions report.)

A motion carried to send the winners in the Declamation and Essay Contests to youth camp at Cragmont for a week.

The treasurer's report was given by Mrs. Raymond Sasser. It was adopted. (See reports.)

The credentials report was read and accepted. (See reports.) On motion to pay ten dollars on course in Y. P. A. at youth camp. Motion carried.

Reverend R. H. Jackson represented the State Mission Board in a brief summary of the work.

On motion that all Co-Laborer funds be retained in the treasury for use in North Carolina unless designated by the sender to the WNAC. Motion carried.

The courtesy committee report was read and accepted. (See reports.)

The nominating committee report was given. Mrs. T. E. Tyndall presided as the officers were elected unanimously. (See reports.)

On motion to take an offering for Mount Olive College. Motion carried. Rev. C. L. Patrick asked God's blessings on the offering.

After the business session, the new officers were installed by Mrs. Carl Dudley, and a very impressive memorial service conducted by Mrs. L. E. Ballard. Mrs. Ballard and Mrs. Vance Link sang, "I'd Rather Have Jesus" and, "The Way of the Cross." A beautiful tribute was paid Mrs. Alice E. Lupton and those from the various conventions whom God had taken from our midst the past year.

Reverend Wilbert Everton spoke briefly on his leaving the Children's Home. He thanked the convention for their support and urged continuance of same.

Mrs. Clarence Bowen gave the closing meditations, "Great Is His Faithfulness." Rev. David Charles Hansley sang, "Jesus Took My Burden." A rising vote of thanks was given Mrs. Robert Crawford for her work with the youth.

A motion carried to give Rev. Raymond Sasser fifty dollars for auditing the treasurer's books the past two years.

Reverend Wilbert Everton prayed the benediction.

- 2. The sum of \$35.00 should be made available to the state youth committee for promotional work. Any further expenses should be taken care of by the state executive committee.

RESOLUTIONS

1. WHEREAS, it is the expressed opinion of many of our North Carolina women and other supporters of the Anna Phillips Loan Fund that the interests of North Carolina Free Will Baptist work will best be served by limiting loans to select students, and,

WHEREAS, the Anna Phillips Loan Fund has suffered serious setbacks because of delinquent notes and the lack of sufficient funds.

BE IT RESOLVED: that henceforth, until such time as circumstances will afford further modifications, money will be loaned only to students entering schools within the state of North Carolina.

2. WHEREAS, the Anna Phillips Loan Fund Committee seeks to help as many students as possible through prescribed loans to these qualified students, and,

WHEREAS, there are a number of delinquent notes on previous loans which are long past due and that this money is needed badly in order to assist worthy and qualified students, and,

WHEREAS, the Anna Phillips Loan Fund Committee has decreed that all delinquent notes are to be paid by January 1, 1963, and that if these delinquent notes are paid in their entirety by May 15, 1962, no additional interest shall accrue, and that each student owing past due notes shall be privileged to make satisfactory monthly payments or pay their account in full, but if monthly payments are desired rather than full payment, such monthly payments shall be determined by the amount on note due plus interest, therefore,

BE IT RESOLVED: that this convention now in session endorse and approve the actions of the Anna Phillips Loan Fund Committee in setting up these arrangements for the collecting of delinquent notes.

3. WHEREAS, the North Carolina State Convention of Free Will Baptists in a recent called session terminated its relationship with the National Association of Free Will Baptists until such time as the two bodies function harmoniously on a mutually accepted basis, and

WHEREAS, the North Carolina Woman's Auxiliary Convention is a part of and subordinate to its parent body, the North Carolina State Convention of Free Will Baptists, and

WHEREAS, we wish for our North Carolina Woman's Auxiliary Con-

vention to remain a part of and loyal to accepted and established practices, usages, and customs of Original Free Will Baptists of North Carolina, therefore,

BE IT RESOLVED: that the North Carolina Woman's Auxiliary does here and now look with approval upon and give sanction to the action of the State Convention in withdrawing from the National Association of Free Will Baptists, and that we pledge our unqualified support to the program of activity now being formulated by the State Convention of Original Free Will Baptists in the interest of Kingdom extension.

4. WHEREAS, because of existing strained relationships between the State Convention of Original Free Will Baptists of North Carolina, and because this convention has pledged its support of and allegiance to its parent body,

BE IT RESOLVED: that all per capita dues remain the same this year and be retained in our treasury for promotional work.

5. WHEREAS, due to repeated requests for literature for our youth auxiliaries (Y. P. A., G. T. A., and Missionary Midgets),

BE IT RESOLVED, that this literature be made available for those desiring to use it (including manual and programs) and any other necessary literature.

WOMAN'S CRAGMONT CONFERENCE OF 1961

There were 85 (62 registrants, six staff members, one house guest and 16 visitors) attendance in August of 1961. These were from seven districts in North Carolina, Virginia and Mississippi. Among these were Mrs. J. C. Moye, state auxiliary convention president, and WNAC vice-president, Mrs. D. W. Hansley, state study course chairman, Mrs. H. L. Spivey, auxiliary pin chairman, and Mrs. Carl Dudley, state field worker. Mrs. Dudley served in the capacity of co-director leading the early devotions and teaching a course on auxiliary ideas to create more interest and teaching us how we could do more to promote work in general. Mrs. Charlotte Gray, a seven year graduate of the Bible Memory Association, was there.

Of course Mrs. Alice E. Lupton, the mother of the auxiliary, was there as conference guest. (Mrs. Lupton went to be with the Lord January 14, 1962. She will be greatly missed in the conferences.) Mrs. Lupton impressively conducted the memorial service for Mrs. Mae Rouse, Mrs. C. E. Brame and Mrs. E. B. Deans.

Rev. Harold Pitts of Canton, N. C., brought soul stirring missionary messages. The Holy Spirit used his messages to make each one aware of their personal responsibility to give forth the gospel. HEROINES OF THE CROSS—TRIBUTE TO MRS. ALICE E. LUPTON

\$ 42.01

For Christ the Cross He bore was borne alone and was God's expression of love for us.

For us the cross we bear is borne with Him sharing the load and is our expression of gratitude for His love.

When Christ died on the Cross, love reached its zenith and opened the direct channel through which all mankind can come to know God, Saviour and Lord.

For Christ the Cross was the crown of His redemptive work, for He said, "It is finished." It becomes the crown of life to all, who accept this. If there had been no Cross, there could have been no crown. This is true for us today.

As we pause for a moment to honor the women of our state who have run the race, let us remember the death was the gate through which they have entered to receive their crown. In Revelation 2:10, "... be thou faithful unto death, and I will give thee a crown of life." Paul had the assurance of his crown when he wrote these words to Timothy "Henceforth there is laid up for me a crown—not for me only but to all them that love His appearing." Doubtless there are many gems or stars glowing in the crowns of our heroines of the Cross who have gone to be with the Lord. At their death they received the crown of life made possible through the Cross. Somehow I think it was a very special occasion when each of them reached home. Psalm 116:15 says, "Precious in the sight of the LORD is the death of his saints."

As we think of and offer thanksgiving for those who received the faith and lived by it, thus meriting the crown of life, let us examine our own hearts and lives in the presence of God today, to find if we have that faith and are living by it so that we too may be worthy to receive the crown of life.

We pay this tribute first to Mother Lupton. To you who did not know her, this is just another name, but to those of us who knew her and loved her, this name has special distinction.

We honor her first because she was our royal kindred through the blood of Christ. She walked with Christ from a very early age. We did not know her then, but her life was commendable through the years, by those who knew her then. She was outstanding in her earlier years for her vision of the place young people and women could fill in the service of the Lord. She worked in the city of New Bern with other Protestant groups. In Free Will Baptist ranks she has been proudly designated as "The First Lady" of the Woman's Auxiliary and F. W. B. League. She was the first president of the national, state and district auxiliary conventions, thus this title rightfully belonged to her, for her vision prompted her to work with, organize and promote these organizations. At first, this was no easy task and would have gone on the rocks, if a less devout and dedicated person had undertaken it. In those days men felt that the gospel was to be propagated only by them because in God's word, men were most prominent in God's plan. She believed that they belonged in this position as leaders, but she searched the Scriptures and found God also included in His plan for women and young people. In order to convince the masses in our churches she spent much time in prayer, study and in education of men and women and young people that God needed all mankind. She made many sacrifices in order to succeed. Here I would like to pay tribute to her late husband and family, who co-operated with her in making it possible for her to achieve success in her undertakings. Because she was not easily discouraged; so today we have woman's auxiliaries and Free Will Baptist leagues wherever Free Will Baptists are witnessing for the Lord Jesus. Whenever we are prone to be weary and discouraged, let us remember Mother Lupton, who worked tirelessly for the Lord until January 24, 1962, when she went to her reward at the age of 86.

Mother Lupton was not only capable in her field of organization and executive ability, but she had a most coveted talent for writing. Through this she was a great blessing to her local church by articles she wrote keeping the activities before the public and writing for The Free Will Baptist in prose and poetry brought blessings to many. She served as editor of the woman's page in The Free Will Baptist for many years. This page in our paper encouraged auxiliaries to write about their activities and thus challenging others for all endeavors. She also freely wrote for our year book of programs for the Woman's National Auxiliary. For all these services she never received any remuneration. She wrote one book, "Foot Prints of Jesus," which has been widely used not only by woman's auxiliaries but ministers as well in their pre-Easter observations. For this she received a very small gratuity.

One of Mother Lupton's favorite Bible verses was Proverbs 25:11, "A word fitly spoken is like apples of gold in pictures of silver." Through the years it was my rare privilege to know her intimately, especially during the years I served as director of religious education in her church, St. Mary's. Never once was her conversation unbecoming as a Christian. She had high and lofty ideals and tried to encourage others to pursue them. I have heard her witness to the unsaved as well as to counsel those who needed spiritual help. She was active in the Alice Lupton Circle and the Sunday school class, which she taught as long as she was physically able. Even on her death bed she witnessed to the saving grace of the Lord Jesus.

At the woman's conference at Cragmont Assembly, she was an outstanding figure except one year since its beginning in 1946. Her alert mind and captivating personality made the younger women seek her out for fellowship and advice. She had greater physical stamina even then than many younger women. She never grew old as many do—forgetting to encourage younger women. The women meant so much to her and she meant so much to the women. To the last mile of the way she kept urging them to keep looking up and out—that the Kingdom of God might abound to the ends of the earth.

We shall long miss her presence, but the beauty of her life will live on and on in our lives who follow in her wake.

Books could be written about Mother Lupton and yet not describe the nobility of her life, so we humbly bow our hearts in sincere thanksgiving that God placed her in our ranks.

The tribute paid Mrs. Lupton doubtless belongs in a great measure to all our women throughout North Carolina who have gone to their rewards from these districts: Albemarle, Blue Ridge, Cape Fear, Central, Eastern, Pee Dee, Piedmont and Western.
