Copy of resolutions passed at a business meeting of the board of trustees of the Centerville Church March 19th 1903

"Whereas during the last two years it has been impossible to raise sufficient funds to maintain preaching & that neither the present or the future presents any encouragement of ever being able to maintain our organization as a church and whereas the church building is in a dilapidated condition & fast going to decay so that at the present time it could not be used without a large outlay, for church purposes, therefore Resolved that acting under the authority vested in us we do hereby turn over to the Neb Y.M.C. Board of Free Baptist the church building known as the Centerville Church situated in the south west corner of the S.W. Cor. of Sec. 31 Center precinct Cass Co. Neb. together with the furniture belonging or in any wise appertaining thereto, hereby giving unto the said Board full power & authority to sell the said building and furniture belonging to the same and to apply the proceeds as in the judgment of the said Board may seem best for the advancement of the interests of our denomination in the state

To the members of the Executive Board - and Delegates of the
Nebraska Yearly Meeting of Free Baptists - Greeting
1902 - 1903.

With gratitude to God for past leading and blessing - I come
once again with my annual report -

The year has been one of opportunity and also one full of
perplexing problems.

The, Centerville, Buster Co. and Thompson interests have demanded
the most careful and prayerful attention.

Since last Yearly Meeting Bro Willisford has come on the
field at Lincoln and with his characterized energy is
grappling with the problems there.

Sister Marks, whom God has called into the ministry, located
at Smithfield and God has wonderfully blessed her efforts.

The other churches will be reported by their respective
I. M. Clerks.

After completing my 5th year as your chairman, I want to
restate, with stronger emphasis, that which I urged last year -
The almost impossibility of one man doing well the work as
local pastor and chairman. It will break any man down
if he is at all faithful.

Your chairman is not oblivious to the sympathy and hearty
cooperation extended to him by every member of churches
throughout the State so far as he knows. I could wish for
my success no greater cooperation than that which has
been given to me.

The first work needing attention was the seemingly open
door in Adams. I was called there to consult with Brother
Gurner and the Brethren as to the advisability of entering
that open door. It was decided that such a move was
wise. Nothing of permanence was done until after my return
to Grand View last fall.

In November I was urged so strongly by the Adams

people, that regular services be held, that from that time to the present we have held meetings every two weeks in Wolford's Hall with excellent attendance.

And on March 27th (with the help of Bros. Williford, Dodge, and Branch a church was organized with eleven members, and a week later named the Capp Memorial Free Baptist Church.

A house of worship has been built and we have the evidence that every dollar will be paid on dedication day, Aug 23^d. A pastor will be located on this field. To better plan for the work in Kansas and Nebraska your chairman was invited to meet with the North Kansas G.M. in session at the Summit church.

We believe that much good will eventually come out of that meeting.

Our needs and opportunities are alike and there is no reason why we should not unite in carrying on the work for the West.

Not to unite as one G.M. but simply our forces.

By solicitation of the remaining members of the Centerville church, I made two trips to that place.

At the first meeting a legal meeting of the church was held to take action as to the prospects of continuing the organization. The following resolution was adopted: Resolved that the trustees be and are hereby instructed that if in their judgement after a full investigation of the conditions there is no prospect of reviving an interest in the church, that they turn over to the State Board the church building and furniture belonging to the same to be used by them as may seem to promote the interest of our denomination in the State.

Later the trustees met and voted that in their judgement there was no possibility of ever reviving the interest and thus voted that the property be turned over to the Board, and recommended that it be sold at public sale, which was done April 7th for \$111.²⁵ which with the furniture was voted by the Board to the Adams Church.

I spent a little time in attendance at the Hastings L.M. held in Geneva April 25th at which time I sat on a council to examine Bro W. S. Rooker for primary licence.

The Northern Nebraska Y. M. being solicitous for a more
permanent organization urged me to come to Bonsteel
South Dakota. and meet with them in the annual
meeting June 24-27.

An executive Board was elected similar to ours and
the Y. M., with the Board is now incorporated.

It is the desire of all I believe, that all hindering
causes to growth in our state be removed.

To advance as we might a few hindering things
must be removed -

- 1st A lack of appreciation of the great work for us here
in the West and the closed eyes to the many open doors
- 2nd That of being ashamed of the name "Free Baptist"
Thus many calling themselves simply "Baptists"
- 3^d The decrease in liberality in proportion to the increase
in wealth

- 4th Failure to observe the "State Day" and an entire,
in some cases, failure to raise the 25 ¢ per resident
member asked by our Y. M.
- During the past year your chairman, in order to
keep the West and its needs before our people outside
of our State, has furnished weekly outlines for the
Young Peoples topics and bi-weekly "headlights" in
the Star which has created no small interest throughout
the denomination.

He has been called upon several times to furnish
letters upon the "West and its needs" for their
gatherings.

Recommendations

- 1st That a campaign be commenced immediately in the interest of the mid week prayer meeting.
- 2nd That the organization and building of the Coppe memorial Free Baptist church in Adams receive the hearty sanction of this Board and Yearly Meeting.
- 3^d Notwithstanding the failure to make any appropriation by our General conference, I would strongly recommend that Kansas and Nebraska carry out the spirit, if not the letter, of the plans for "Cooperation".
- 4th More and more are we convinced that God has a great work for us in India through Bro and Sister H. R. Murphy.
Resolved that we pledge our hearty support to them for the coming year.
- 5th That we appropriate \$150 to our Lincoln church to be paid monthly beginning Sep 1st 1903 continuing 12 months.
- 6th That it be kept continually before the minds of our people that largely the life of our work depends upon the churches observing "State Day," and an other extra day, and the other three special days of our denomination.
- 7th That we pledge to raise 25¢ pr resident member, besides the offering on State Day, and that this be collected within six months from this yearly meeting.
- 8th That a thorough canvas be made to place the Morning Star or Free Baptist in every home of our people, and that our Sunday School literature be more widely used.

- 9th That something be planned whereby the chairman have time and means to carry on the work the coming year.
- 10th That we make some definite provision for the Guster Co. and Thompson interest;
- 11th If possible, financially, that these recommendations with any others be printed in leaflet form for use in our Churches.
- 12th That all means possible be used to seek out and encourage young men and women for the Gospel Ministry, to supply the churches already organized, and to plant more.
