 Y. M. of Free Will Baptists Met in Annual Session
 at the Grand View church in Sage County
 Members present W & Myers - J H Wolfe - and Mrs Fuller
 Absent Russel Fleming and John W Fink
 The record dating from Aug 18-1911 read and
 voted approved

Chairmans report and recommendations read and
 voted approved which are as follows - (viz -

To the members of the Executive Board and the
 Brethren of the Nebraska yearly Meeting.

Another year has come and gone into eternity, what has
 been accomplished for the Kingdom the great Book of life,
 kept by the Angel of God. Will reveal.

Circumscribed: conditions in the Yearly Meeting, over which
 your chairman had no control, and illness, have
 made it impossible for him to have taken hold of as
 much of the work as he would have liked.

We feel that there is still a great work for Free Baptists to do in
 Nebraska:

The building up of the work already started, and the
 reaching out into the regions beyond.

The new fields opening up farther West invites us to a
 still larger work for Free Baptists whose doctrines
 are always acceptable.

Your chairman has made a few trips looking after the work,
 to strengthen the stake wherever possible.

Thompson has had the services of Bro Savine whom we feel
 has done a good work in that field.

Geneva has located Bro Wheeler who is the right man in
 the right place.

The work up in the central and out in the West part of
 the state need evangelistic work done and the pastors
 settled in those fields.

We have sold the Lincoln lot for Thirty two hundred & thir-
 ty five dollars (\$3,225) which has been added to the perma-
 nent fund.

Revivals have been held in the Long Branch and Grandview
 churches under Rev J L Meads with good success.

Recommendations:-

1. That we raise at least one dollar per member for state work and as much more as possible, and that this be collected as soon as possible after this session of the Yearly Meeting.
2. That we favor evangelistic work, ^{not only} in the churches now established but in new fields. That the Yearly Meeting will place the evangelist on the field and when there the churches raise the money for the service rendered, but whatever work may be done in new fields, the support come from the Yearly Meeting fund all to be under the direction of the Board.
3. That we center on one or two churches for material aid thus fully strengthening a few points rather than scattering what little aid that might be given.
4. That we still stand loyal to the ^{Nebraska} Yearly Meeting of Free Will Baptists, thus keeping a united front for work for Christ and the Church.
