Moved & Carried - to recess until 5 P.M.

Conference opened at 5 P.M. with scriptures reading by Rev. Amos Richardson and prayer by Rev. Lester Porter

Moved and Carried - That Brother Grover Mc Carter be called before the Council for examination. He passed the examination of the Council, which was conducted by Rev. A. C. Childers. And was ordained by the laying on of hands and prayer. Rev. Elzo Bluan prayed the ordaining prayer, Rev. James K Childers gave the Charge, and Bro. Sidney Sturgill presented the Bible.

Moved & Carried That Rev. John Johnson preach the introductory sermon at the next Conference and Rev. Amos Richardson be his alternate.

Moved & Carried, that the money ~~with~~ with the letters from the Churches be divided between the moderator and Conference treasury.

Moved & Carried, that the just read minutes be accepted as the work of this Conference, and the clerk is to record the same in the minute book.

Moved and Carried, that the Conference adjourn until the next regular session.
