CE Board Report-given by Rev Aaron Dawson. A questionnaire will be handed out to each church represented to see what the CE Board can do to assist the sister churches. He recorded that the by-laws be adjusted so that the CE Board can do accordingly. MMS&C

Presbytery Comm report- Rev Dennis Reeves, Rev Kenneth Terry, Rev Henry Shellman and Bro Ron McCraney gave the following report: Request for ordination made for Bro Wayne Overton of First FWB Hackleburg to be ordained at his church at a future date. Rev Rick Cash gave the report from the Ex Office. Acts 1:8 giving is up from the first 3 mos of 2011. Bay City FWB just celebrated the 5<sup>th</sup> Anniv of the church with 122 in attendance. Rev Tim Riggs, pastor, reported 153 on Easter. Let's rejoice in what God is doing. 4 have recently been baptized at the new church in Oxford, where Rev Len Blanchard is ministering. Also asked for prayer for the camps in Russia and the Russian ministers. The Executive Office is bricked and have \$9000 in construction funds. Thanked N Al for giving \$3,601.56.
