

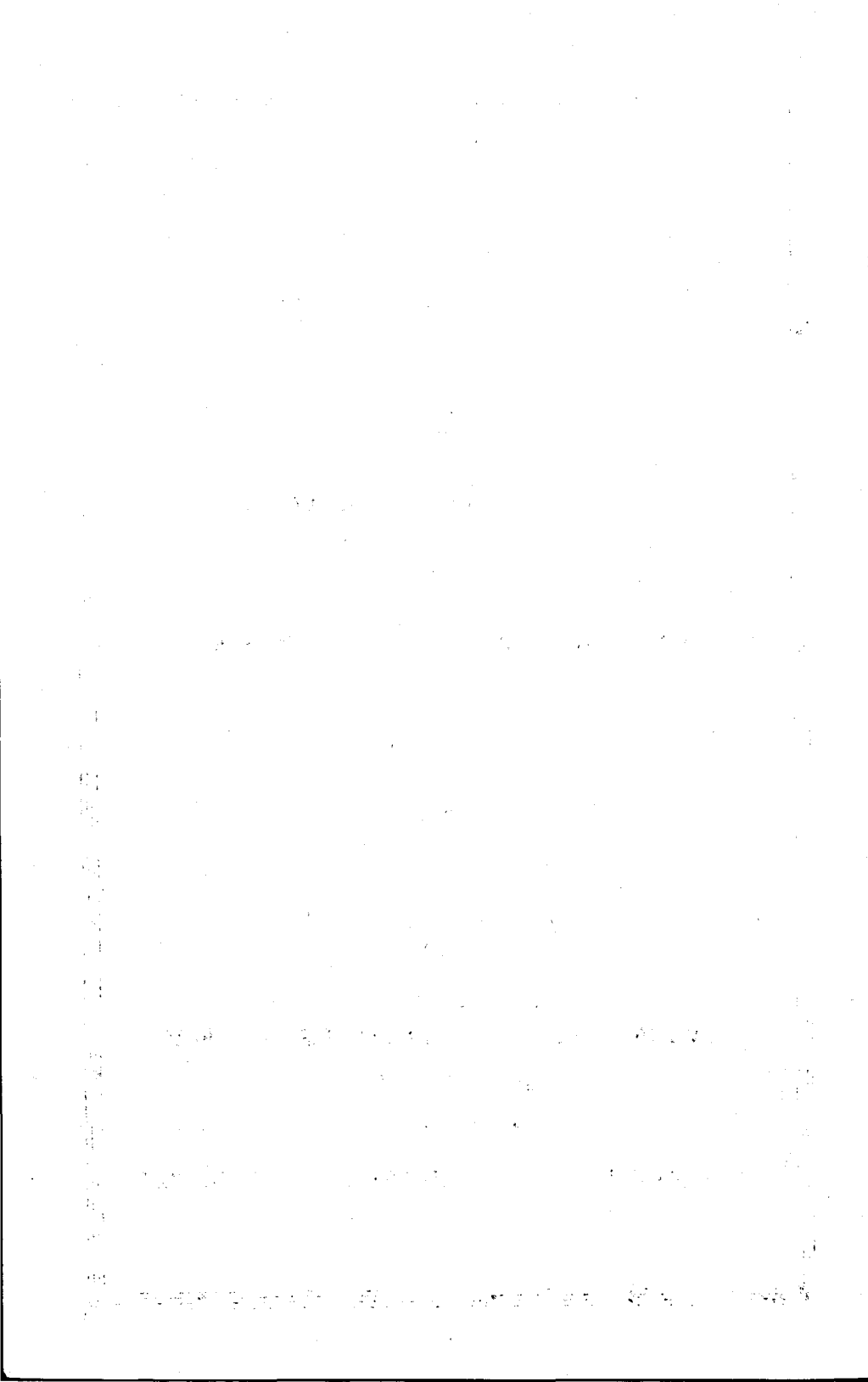

**MINUTES OF THE SECOND ANNUAL
SESSION OF THE NORTH CAROLINA
ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS**

MEETING—The Swannanoa Free Will Baptist Church,
Swannanoa, N. C. Date—May 4, 5, 6, 1964

MONDAY EVENING MAY 4

The Monday evening services opened with Rev. Roy Rikard presiding. Rev. Eugene Waddell led the congregational singing. The host pastor, Rev. Milton Hollifield, gave the overflow congregation a warm welcome. Brother Owen Thomas of Smithfield, responded with sincere appreciation for the gracious hospitality extended to the Association for this session.

The entire worship service was under the direction of Dr. L. C. Johnson, President of Free Will Baptist Bible College and the Bible College Choir. Dr. Johnson was introduced by Rev. Rikard and he in turn introduced the members of the Bible College staff who were traveling with the thirty-three member choir.

The Bible College choir, under the direction of Mr. Don Clark, rendered several superb arrangements of hymns and gospel songs. The Hallelujah Chorus from Handel's "The Messiah" as sung by the choir was a very special blessing to the congregation. The choir also featured soloist, Fred Hall, a men's quartet, and the girls' sextet. The acapello renditions were superbly sung.

Dr. L. C. Johnson brought the message of the hour. Using John 6:28-29 and I Corinthians 13. Dr. Johnson spoke on the subject, "Exalting Christ through Education". Reminding the Association that no religious denomination had continued to exist without a strong Christian education program as its fountain head, he challenged us to support liberally and sacrificially our Free Will Baptist Bible College. He pointed out that in America today the only schools of higher learning that keep the Bible in the center of its educational program are the small, so-called unknown Bible Colleges. The Association appreciated the message and the Biblical principles and high standards of morality which our Bible College holds.

A special offering for the College was taken in the amount of \$196.68.

Moderator Wayne Smith gave the benediction.

TUESDAY MORNING MAY 5

The session opened with Rev. T. O. Terry presiding. Rev. Conrad Williford led the Association in congregational singing. Rev. Herbert Bryan led in prayer.

Rev. G. Y. Burgin brought the devotional thought from Jude. Rev. Kermit Childress invoked God's blessings upon this session.

The Association was officially declared in session by the Clerk. Moderator Smith recognized the host pastor who greeted the congregation and welcomed us to Swannanoa.

The Moderator appointed the credentials committee consisting of Revs. Adam Scott, Eugene Hales, and Alton Hines.

The Moderator brought his message by reminding the Association of the importance of this session. He commended the Executive Board for their services for the past two years.

He admonished members of the Association that when they shall be elected to various positions and offices that they should determine to serve or refuse the office.

Using Amos Chapter 3, verses 1-8, Moderator Smith spoke on the subject, "The Cause of Unity". He warned our Association that we should be united as Free Will Baptists in that we beware of:

1. Professional ambition.
2. And that Free Will Baptists have a clear doctrinal point of demarcation with other denominations and that we may continue our unique place as a denomination and maintain our identity.

An offering for the Association was received. The offertory prayer was given by Rev. Carey Watkins.

The messenger of the hour, Rev. Don Pegram, was introduced by Bro. McQuage.

Bro. Pegram brought the message from Revelation 2:1 using the Ephesian church as an example, he applied the message to our State Association. The message was heartily received and all recognized that the message came from the Holy Spirit who used Brother Pegram.

A prayer of dedication was offered at the close of the message. Moderator Smith recessed. We all had lunch.

TUESDAY AFTERNOON MAY 5

The session opened with Rev. W. H. Calvert presiding. Rev. Eugene Waddell led the congregational singing. The devotional thought was brought by Evangelist Owen Ganey, using I Kings chapter 18 and Chronicles 7:14. Bro. Ganey closed the devotion with prayer.

Moderator Wayne Smith presided over the business sessions for the afternoon.

The report of the Executive Board was given by the Clerk, Rev. Carey Watkins. The proposed constitutional amendments were read and the proposed amendments to the By-Laws.

M. S. C.—to lay the proposed amendments on the table until tomorrow.

Report of the State Mission Board and their financial report was given by Rev. Chester Phillips.

M. S. C.—to adopt the Report and Financial Statement.

Report of the Free Will Baptist "Witness" was given by Rev. Eugene Waddell the editor. Bro. Waddell reported that now they have a circulation of more than 2,500. However he challenged the Association to get every local church to adopt the family plan in order for the "Witness" to go to every home.

M. S. C.—To accept the report.

Report of the Sunday School Dept. of the National Association was given by the director of that dept., Rev. Roger Reeds. Rev. Reeds reported that 139 churches in N. C. are using the National Association literature.

Report of the Orphanage Board was presented by Rev. Ronald Creech. The treasurer's report was given by Rev. W. H. Calvert.

M. S. C.—To adopt the reports.

Rev. Bobby Abrams spoke briefly concerning his work with the "Witness" and his proposed work as editor of the "Witness."

M. S. C.—To allow the Orphanage Board to loan sufficient funds to Rev. Bobby Abrams to transact the Vacation Bible School literature business on a cash basis. The loan to be repaid as soon as possible at the rate of 6% interest.

M. S. C.—to instruct the former treasurer Rev. W. H. Calvert, to handle the transaction with Rev. Abrams today.

Rev. Billy Walker spoke briefly informing us that the National Association will be held in Raleigh in July, 1965.

M. S. C.—to elect Rev. Walker to head the committee to host the National Association and allow him the privilege to appoint assistants as he deems necessary.

M. S. C.—to give Brother Jack Green and Milton Hollifield a rising vote of thanks for their work concerning the orphanage property.

M. S. C.—to recess until the evening sessions.

TUESDAY NIGHT MAY 5

The missionary service of the Association was under the direction of the N. C. State Missions Board, Rev. T. O. Terry presiding.

The choir of the host church under the direction of Mr. Louis Metcalfe rendered special music for the service.

Rev. Eugene Waddell led the congregational singing.

Rev. A. C. Morgan spoke concerning his missions work at Enfield, N. C. Rev. Morgan related the method of the beginning and growth of the church at Enfield under the sponsorship of the Mt. Calvary-Free Will Baptist Church, at Hookerton, N. C.

Rev. Frank Davenport introduced the missionary at Greensboro, N. C., Rev. James Denton. Rev. Denton related the method of the beginning and growth of the missions at Greensboro under the sponsorship of a group of interested pastors from the General Conference.

Rev. Reford Wilson, General Director of the Foreign Missions Board of the National Association reported on the Foreign

Missions program. He reported that our Foreign Missions family had now grown to sixty-seven.

Rev. Jerry Ballard, editor of "Heartbeat" reported on the literature program of the Foreign Missions Department.

Rev. Mark Vandivort of the Home Missions Department of the National Association reported on the program of that department in its work in North America.

Rev. Chester Phillips, chairman of the State Missions Board, introduced the messenger for the hour, Rev. L. D. Creech, our state missionary in Fayetteville. Rev. Creech introduced Mrs. Creech who attended the services with him. Rev. Creech used the Scripture from Matt. 28:19-20, Mark 15:16, Acts 1:8, and spoke on the "Great Commission." He challenged the Association to be in one accord concerning missionaries and missions.

A special offering for missions was received after prayer by our Moderator, Rev. Wayne Smith. Benediction by Rev. J. Reford Wilson.

WEDNESDAY MORNING MAY 6

The sessions opened with Rev. Al Davis presiding. Rev. John Floyd, Jr. led the congregational singing. Rev. Jerry Williams invoked God's blessings on this session. Rev. Edward Swartz brought the devotional thought. Moderator Wayne Smith presided over the session.

Report of the Leah Waddell Memorial Fund was given by Rev. Herman Hersey.

M.S.C.—to adopt the report.

M. S.C.—to take the proposal constitutional amendments off the table and consider these one by one. The amendments were adopted as presented.

M.S.C.—to instruct the Board of Superannuation and the Board of Child Care and Aged meet in joint session and prepare by-laws not in conflict with their specific work.

Report of the Nominating Committee was given by Rev. T. O. Terry.

M. S. C.—to receive the report.

Privilege was given for nominations for the various positions and offices: Nominated for:

Assistant-Moderator from floor—Rev. Frank Davenport and Rev. Cecil Campbell. Rev. Campbell was elected as Assistant-Moderator.

Rev. Herbert Bryan declined to serve as member at large on the Executive Board. Nominated from the floor Rev. Frank Davenport, who declined. Rev. Wayne Smith was also nominated. Rev. Smith was elected.

Rev. Bill Robinson declined the nomination to the Missions Board. The Rev. Frank Davenport was elected from the floor.

The other nominations as presented by the nominating committee were elected.

Report of the League Board of the National Association was presented by Mr. Sam Johnson, director of that Department.

M. S. C.—that the Board of Care for Children and the Aged be entrusted with the disposition of the Hensley property.

Substitution motion by Rev. Herman Hersey for Board of Care for Children and the Aged meet and prepare a set of by-laws to govern them and to explore different avenues of use and/or disposition of the Henseley property. To formulate plans for the establishment of a home for the aged. We further instruct this Board to ask the Executive Committee to call a special session of this Association to consider these plans.

M. S. C.—to adopt the substitute motion.

Report of the Resolutions Committee was given by Rev. Billy Walker.

M. S. C.—to receive the report and act upon them one by one. The resolutions as presented were adopted.

M. S. C.—To appoint a committee to study the time of the annual meeting of the Association. Rev. Billy Walker appointed as chairman of this committee and he is to select two members to help him in this study and report at the next annual session.

2. That Article IV, Section 6, be amended in that the title and listing of the Board read Board of Care for Children and the Aged.
3. That Article IV, Section 3 of the Constitution entitled Executive Board be amended by adding "They shall direct the work of the Free Will Baptist Witness. They shall employ an Editor and Director of information whose salary shall be approved by the association in its budget. They may appoint such other assistants as may be necessary."

The Executive Board may advise and assist other boards of the Association.

The Executive Board is not authorized to act as the Association when it is not in session except as provided for in this Constitution and by-laws or specifically directed by this Association.

4. That the By-Laws amended by adding the following article. Article 5,—All officers, board members, and employees of this Association shall be reimbursed at the rate of 6c per mile when traveling to duly called board meetings or attending to the business of any board. That the present Article 5, be renumbered Article 6.

ORPHANAGE BOARD REPORT

May 5, 1964

Your Orphanage Board wishes to submit the following report:

Jesus said, "Suffer the little children to come unto me and forbid them not for of such is the kingdom of God."

The Psalmist said, "When my father and my mother forsake me, then the Lord will take me up."

We have a tract of land near Burnsville. We have built a road into this property. We urge all of you to go over to see this great gift to our association.

Your board has done very little. To be perfectly frank, some of us are ashamed of our inactivity.

We want to mention several possibilities and then make some recommendations:

1. We have not been contacted by any North Carolina family about orphan children. In fact, an officer of the North Carolina Department of Welfare and Child Care Institutions tells us that there are no demands anymore for orphanages. He said that good homes are waiting to adopt any and all North Carolina orphans.

2. Contact has been made with the Free Will Baptist Home for Children in Greenville, Tennessee about the possibility of placing any orphans which we may have responsibility for in the future in their home. We are told that this probably can happen and that we can have a member on their board of directors in such a case.

3. There is a strong feeling on the part of many in our state that we should direct our attention to a home for the aged. The same officer in the North Carolina State Welfare Department tells us that this is a real need.

4. Some feel that we should have this tract of land surveyed and sell lots to develop this property as soon as possible.

5. There is a Free Will Baptist lady in Burnsville who operates a Home for the Aged and has blue prints ready to build a new one. She says she will go 50-50 with our State Association and make this a Free Will Baptist Home for the Aged. She says she will work with us any way we want her to. We do not know about this yet. It should be pursued further as to its feasibility from a business standpoint. She is delaying construction until she hears from us.

6. We just do not know what to do. We can't know without meeting and working on it.

In the light of these six possibilities, we recommend the following:

1. That the present Orphanage Board be dissolved and that a new board be elected at this session to take this thing and go with it.

2. That the chairman be from this area, if possible.

REPORT OF THE LEAH WADDELL LOAN FUND COMMITTEE

We recommend:

1. That we establish a fund to be known as the "The Leah Waddell Memorial Scholarship Fund," to be awarded annually to a North Carolina student attending the Free Will Bible College selected by the Administration of the Bible College.

2. That the amount of the scholarship be set at \$75.00.

3. That an appropriate certificate be prepared to be given to the recipient of the scholarship.

4. That Trustees of this scholarship fund be elected, consisting of 3 men, elected for 3 years, the term of 1 expiring year. It shall be the duty of these trustees to place the funds in a savings account, to solicit donations to the fund and work with the Administration of the Free Will Baptist College in awarding these scholarships. It is understood that this association may

amend the scholarship amount and/or provisions at any subsequent session.

CONSTITUTION

of the

North Carolina Association of Original Free Will Baptists

Article I—Name and Purpose

This organization shall be known as the North Carolina Association of Original Free Will Baptists.

The purpose of this organization shall be the establishment and maintenance of a voluntary association of autonomous Original Free Will Baptist churches, quarterly meetings (or any other meetings) district association or conferences—or any and all additional organizations—areal, district or state-wide that may be deemed essential to the prosecution and promotion of the general purpose and program of this association. Included, also in the purpose of this association is affiliation with the National Association of Original Free Will Baptists and co-operation in its world wide ministry. This association holds unswerving loyalty to the inspired word of God as our infallable rule of faith and practice.

Article II Composition

This association shall be composed of its officers; members of standing boards; ordained and licensed ministers who are in good standing with a conference or an association affiliated with this body; together with three (3) delegates elected from each conference or Association; and one (1) delegate for every fifty (50) members or fraction thereof from each local church. (Note: this also includes any other church who wishes to be affiliated with the National Association).

Article III. Meetings

This Association shall meet annually at seven-thirty o'clock (7:30 P. M.) on the first Monday of May and will adjourn at the option of the body.

Article IV Officers and Board

The officers of this Association shall be Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board, Board of Trustees, Board of Missions, Board of Care for Children and Aged, Board of Superannuation, and Board of Youth Relations.

Section 1. ELECTIONS

All officers shall be elected by the body. A nominating committee shall be elected at the beginning of each session. After

their report is presented, additional nominations for any office may be made from the floor. The General officers shall be elected for a period of two (2) years. No person shall serve in more than one (1) elected position in the Association at the same time, and no one having served a full term shall be elected to succeed himself.

Section 2. DUTIES.

A. The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the association; to appoint temporary committees; and the moderator shall serve as an advisor to all standing boards and as chairman of the Executive Board.

B. The duties of the Assistant Moderator shall be those of the moderator when the latter shall so direct or when he is absent.

C. The clerk shall record the proceedings of all sessions of the Association and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual session of the association; hold in trust all documents not otherwise preserved, and surrender same at the direction of the association; and conduct the official correspondence and sign such documents and instruments as require his signature. He shall also serve as secretary of the Executive Board.

D. The Treasurer shall hold in trust all money that belongs to the Association and disburse same by order of the association, the executive board, or any standing board or subordinate general organization invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and disbursed and make an annual report to the association.

Section 3. EXECUTIVE BOARD

The Executive Board shall be composed of the general officers and three (3) members elected at large. The members elected at large shall hold office for three (3) years, the term of one expiring each year. The Executive Board shall arrange the program for the annual sessions of the Association. They shall fill vacancies which may occur in any office until the session of the association. It shall be their duty to promote the work of the association. They shall direct the work of the **Free Will Baptist Witness**. They shall employ an Editor and Director of Information whose salary shall be approved by the association in its budget. They may appoint such other assistants as may be necessary.

The Executive Board may advise and assist other boards of of the Association.

The Executive Board is not authorized to act as the Association when it is not in session except as provided for in this Constitution and by-laws or specifically directed by this Association.

Section 4. BOARD OF TRUSTEES

The Board of Trustees shall consist of three (3) men elected for three (3) years, the term of one expiring each year. They shall hold in trust all real and personal property of the Association and shall convey such property as the Association may direct.

Section 5. BOARD OF MISSIONS.

The Board of Missions shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 6. BOARD OF CARE FOR CHILDREN AND THE AGED.

The Board of Care for Children and the Aged shall be composed of six (6) members elected for three (3) years the term of two (2) expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 7. BOARD OF SUPERANNUATION.

The Board of Superannuation shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 8. BOARD OF YOUTH RELATIONS.

The Board of Youth Relations shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Article V Independence of the Local Church

This Association has no judicial or appellate powers conflicting with the independence of the local church.

Article VI Amendments

This Constitution may be amended by a two-thirds (2/3) majority vote providing such amendment be read to the body and laid on the table until the following day.

BY-LAWS

1. All meetings shall be opened by singing, reading a portion of God's Word and prayer; and shall be closed with prayer.

2. All business, except routine, shall be brought before the body by committee, but should a committee fail or refuse to present a matter of business, the business shall be brought from the floor.

3. In parliamentary procedure, Robert's Rule of Order shall be used as a guide.

4. The offices of Moderator and Assistant Moderator shall be filled on an alternating basis, from the eastern and western part of the state; Durham shall be the dividing line, When the Moderator is elected from one section, his assistant shall be elected from the other.

5. All officers, board members, and employees of this Association shall be reimbursed at the rate of 6c per mile when traveling to duly called board meetings or attending to the business of any board.

6. These by-laws may be amended or changed at any regular session of this association by a majority vote.
