#### CONSTITUTION

#### of the compation to basis order of

#### North Carolina Association of Original Free Will Baptists

#### Article I-Name and Purpose

This organization shall be known as the North Carolina Association of Original Free Will Baptists.

The purpose of this organization shall be the establishment and maintenance of a voluntary association of autonomous Original Free Will Baptist churches, quarterly meetings (or any other meetings) district association or conferences—or any and all additional organizations —area, district or state-wide that may be deemed essential to the prosecution and promotion of the general purpose and program of this association. Included, also in the purpose of this association is affiliation with the National Association of Original Free Will Baptists and cooperation in its world wide ministry. This association holds unswerving loyalty to the inspired word of God as our infallable rule of faith and practice.

#### Article II Composition

This association shall be composed of its officers; members of standing boards; ordained and licensed ministers who are in good standing with a conference or an association affiliated with this body; together with three (3) delegates elected from each conference or Association; and one (1) delegate for every fifty (50) members or fraction thereof from each local church. (Note: this also includes any other church who wishes to be affiliated with the National Association).

# Article III Meetings

This Association shall meet annually at seven-thirty o'clock (7:30 P.M.) on the first Monday of May and will adjourn at the option of the body.

#### Article IV Officers and Board

The officers of this Association shall be Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board, Board of Trustees, Board of Missions, Board of Care for Children and Aged, Board of Superannuation, and Board of Youth Relations.

#### Section 1. ELECTIONS

All officers shall be elected by the body. A nominating committee shall be elected at the beginning of each session. After their report is presented, additional nominations for any office may be made from the floor. The General officers shall be elected for a period of two (2) years. No person shall serve in more than one (1) elected position in the Association at the same time, and no one having served a full term shall be elected to succeed himself.

Section 2. DUTIES.

A. The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the association; to appoint temporary committees; and the moderator shall serve as an advisor to all standing boards and as chairman of the Executive Board.

B: The duties of the Assistant Moderator shall be those of the moderator when the latter shall so direct or when he is absent:

C: The clerk shall record the proceedings of all sessions of the Association and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual session of the association; hold in trust all documents not other wise preserved, and surrender same at the direction of the association; and conduct the official correspondence and sign such documents and instruments as require his signature. He shall also serve as secretary of the Executive Board.

D. The Treasurer shall hold in trust all money that belongs to the Association and disburse same by order of the association, the executive board, or any standing board or subordinate general organization invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and disbursed and make an annual report to the association.

The Executive Board shall be composed of the general officers and three (3) members elected at large. The members elected at large shall hold office for three (3) years, the term of one expiring, each year. The Executive Board shall arrange the program for the annual sessions of the Association. They shall fill vancies which may occur in any office until the session of the association. It shall be their duty to promote the work of the association. They shall direct the work of the Free Will Baptist Witness: They shall employ an Editor and Director of Information whose salary shall be approved by the association in its budget. They may appoint such other assistants as may be necessary.

The Executive Board is not authorized to act as the Association when it is not in session except as provided for in this Constitution and by-laws or specifically directed by this Association.

#### Section 4. BOARD OF TRUSTEES AN ADDATE SHE BOARD OF TRUSTEES AN ADDATE SHE BALL

The Board of Trustees shall consist of three (3) men elected for three (3) years, the term of one expiring each year. They shall hold in trust, all real and personal property of the Association and shall convey such property as the Association may direct.

They may prepare by-laws to govern them in their work providing such bylaws are presented to the Association for approval. #### Section 6. BOARD OF CARE FOR CHILDREN AND THE AGED

The Board of Care for Children and the Aged shall be composed of six (6) members elected for three (3) years the term of two (2) expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Section 7. BOARD OF SUPERANNUATION.

The Board of Superannuation shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such bylaws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### BOARD OF YOUTH RELATIONS. Section 8.

The Board of Youth Relations shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such bylaws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Article V- Independence of the Local Church

This Association has no judicial or appelate powers conflicting with the independence of the local church.

#### Article VI Amendments

This Constitution may be amended by a two-thirds (2/3) majority vote providing such amendment be read to the body and laid on the table until the following day.

#### **BY-LAWS**

1. All meetings shall be opened by singing, reading a portion of God's Word and prayer; and shall be closed with prayer.

2. All business, except routine, shall be brought before the body by committee, but should a committee fail or refuse to present a matter of business, the business shall be brought from the floor.

3. In parliamentary procedure, Robert's Rule of Order shall be used as a auide.

4. The offices of Moderator and Assistant Moderator shall be filled on an alternating basis, from the eastern and western part of the state; Durham shall be the dividing line. When the Moderator is elected from one section, his assistant shall be elected from the other.

5. All officers, board members, and employees of this Association shall be reimbursed at the rate of 6c per mile when traveling to duly called board meetings or attending to the business of any board.

6. These by-laws may be amended or changed at any regular session of this association by a majority vote.

### MINUTES OF THE FIFTH ANNUAL

#### SESSION OF THE NORTH CAROLINA

#### ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS

When convened with Cramerton Free Wil Baptist Church, Cramerton, North Carolina—May 1, 2, 3, 1967.

#### MONDAY EVENING, MAY 1

The Monday evening session opened with Rev. W. L. Kell presiding and reading from Psalms 25:1-2. The opening prayer was by Rev. Sherman Branch. Rev. Fred Hall led in the singing of the hymns "Sade, Saved," "Such Love", and "Glorious Freedom". The host Pastor, Rev. Roy Rikard, extended a welcome to the congregation. Either party may terminate the contract upon a 90 day notice. However, upon sufficient evidence of unsound doctrine or immoral character the termination may be immediate. Unchristian practice may also cause immediate termination.

Furthermore, it is clearly to be understood that he is to have no official or ex-officio status with any of the Boards or Committees of the State Association, except as invited or directed.

### STATE EVANGELIST'S REPORT

Last year was a real important year in my life, I feel. At last year's session, you elected me to be your Moderator. I must admit, even though I always attended the sessions of our State Association, I was not as interested and involved in the business affairs as I should have been.

Right after our meeting last May, I agreed to serve as Editor of the WITNESS on a temporary basis until we could get someone permanently, Brother Ronnie Peele had just resigned. I have always been interested in our magazine but here again not as concerned over her financial status as I should have been. I would help raise money to bail the WITNESS out when it got into deep debt. Last March (1966) we faced some \$3,000 in debts and we all met at Liberty Church, Durham, to see what could be done. You remember. But not I was in a position where I had to help look at the financial picture constantly.

For instance, at the State Association last year the report showed that we owed \$1,488.07 in unpaid bills. You responded well in your letters to the Association and in your offerings at the Association which helped greatly to relieve the pressure of these debts. Also as Editor, I attended every Association and Conference that I possibly could last summer and fall and literally begged for money for the WITNESS and gathered subscriptions. You responded well in your different Associations and Conferences for which I am grateful to God.

Then on over in the summer, the Lord began dealing with my heart that we needed our work systematically promoted. This promotional man could also be Editor of our FREE WILL BAPTIST WITNESS. Too, if he could be the State Evangelist, he could help raise his own salary by conducting revivals. To make a long story short, I was hired as your State Evangelist on August 29, 1966. I have never been more sure of God's leadership in anything than the fact that God led me into this work.

One of the things uppermost in my heart during this interim period, between resigning my pastorate and beginning with the WITNESS full-time, was to see this WITNESS debt completely erased. By God's grace and your wonderful response in November every debt of the FREE WILL BAPTIST WITNESS was paid. So far as I know, this was the first time since the WITNESS was started over 4 years ago that she was completely debt-free.

I am indebted to the men who have gone before—Brothers Eugene Waddell, Bobby Abrams, Frank Davenport, and Ronnie Peele who have worked hard and tirelessly during these struggling years of the WITNESS. I do not mean that the struggling years are over but maybe the WITNESS during these years has established itself as a permanent fixture of our State Association and we hope will be regularly supported by our people.

My last service as pastor of Liberty Church was December 4, 1966. I then became your full-time worker. I am happy to report that I have drawn a salary each week since the first one. That in itself is a praise worthy item—considering the fact that our State started this full-time venture in the middle of the winter (which is always the hardest time of the year financially). Too, we had no surplus of money to cushion us through the hard winter months. Then too, this was something new for us. Free Will Baptists had their start in North Carolina in 1727 and for 240 years had never had a fulltime promotional man.

The response of you dear people to this new ministry has been the most gratifying experience of my life. I will be forever grateful to you.

Now, to some specifics. After closing out my ministry at Liberty Church on December 4th, I immediately began a revival the next night-December 5th. God has blessed in these revival meetings. From December 5 until this State Association, I have conducted 11 revivals with 147 decisions (44 saved, 103 rededications). The total offerings have been \$1948.03. (\$42 subscriptions to WITNESS, \$406.78 Book Store sales, and \$1499.25 love offerings). These love offerings, of course, go into the State Association treasury to help pay my salary, WITNESS bills, etc. Also since December 4th, I have had 19 one service meetings, like just Sunday morning or Sunday night or Wednesday night services or Conference meetings. The offerings have been \$626.91 (\$74 subscriptions, \$189.30 Book Store, \$363.61 love offerings). I have also during this time attended various conferences or associational meetings. There have been 2 decisions. In all these meetings and revivals, I have gathered \$116 in subscriptions to the WITNESS, have sold \$596.08 worth of Book Store items, have received \$1862.86 in love offerings, have seen 149 decisions, and traveled a total of 7631 miles. Thank you for your very generous response which has far surpassed my fondest expectations.

Now to the WITNESS. I am convinced that one of the most powerful voices in the world is the printed page. The Communists and Cults know this. We are late learning it. In March we mailed out 1785 copies. In June we are planning a special issue. We have a picture of the first session of the National Association for the front cover, a picture of the preachers attending that session, pictures of Tecumseh College in Oklahoma and its first faculty, etc.

Our Ladies Auxiliaries in our State are in a Campaign to get us 500 new subscriptions now. I had a letter before I left home from an Auxiliary with 25 subscriptions in it. Praise God! Our Executive Committee voted to send the WITNESS without charge to every family in any church giving as much as \$25 per month to the WITNESS. Continue to pray for the WITNESS.

The Witness Book Store has not had a chance. Nearly all the profit she has made has had to be used to help the WITNESS. Now, we are hoping to put the profit it makes right back into stock. I am real pleased at the response of our people to buy the items taken to the various meetings. Whatever your church needs in the line of church supplies, order from the WITNESS BOOK STORE. The address is in the WITNESS each month. If we do not have it in stock, we can get it. Brother Peele established credit with some 80 different publishers when he set up the Book Store. We can get it for you so please buy from your own Book Store.

As usual, our big item each year is D.V.B.S. literature. We increased both our Gospel Light and Scripture Press orders by 10% over last year. We have already had to re-order Gospel Light and will soon have to re-order Scripture Press. Praise the Lord and thank you for getting your V.B.S. literature from your own store.

As best I can determine, there are 127 churches that are members of our State Association. There are some 133 not members. There are some 178 preachers that are members and some 181 that are not. I have been privileged to have services in some of these churches and have fellowship with the preachers and laymen not officially members of our State Association. Pray for me as I visit all the churches that I possibly can.

I am glad to be your servant. I do want to do a good job. Please remember me. "The Lord hath done great things for us; whereof we are glad." Psalms 126:3.

A. That we the N. C. Association of Original Free Wil Baptists go on record as urging each Pastor to go back to his Church with the determination of selection some theme adaptable to his congregation which would carry forth the spirit and urgency of the challenge given to us by the message.

B. That we co-ordinate our efforts in community-wide evangelistic endeavors. (Be it therefore understood that these efforts include only those who basis of fellowship is centered around the person and work of Christ and the fundamentals of the faith.)

C. That in the light of the dire need for establishing New Testament, Soul-winning churches and whereas there is great need for general, consistent support of our State Missions Board, that each pastor bring this urgency before his people with prayerful consideration.

II. Whereas we believe that our denomination and State Association has been called of God for this period of time and whereas the various enterprises of our Association are worthy of our prayerful and consistent support, Therefore be it resolved:

A. That the men of these various boards be commended for their faithful and untiring efforts in performing their various duties.

III. Whereas, there is a present effort to unite all religious bodies into an organic super world church under the guise of Christian unity known as the ecumenical movement, and

Whereas, this attempt to unite all religious faiths into an organic entity ignores the New Testament teaching of the church as the mystical body of Christ and the spiritual bond of Christ's Kingdom, and

Whereas, the historic doctrines of Fundamental Christianity are compromised in attaining this unscriptural unity, and

Whereas, the Roman Catholic Church is fostering co-operation and merger as a scheme to bring all Christendom under the control of Rome, and

Whereas, the Bible plainly forbids us to "Be un-equally yoked together with unbelievers" (II Corinthians 6:14) and that we are to "come out from among them and be ye separate saith the Lord" (II Corinthians 6:17), and that we are commanded plainly in II John 10, 11 "If there come any unto you, and bring not this doctrine, receive him not into your house, neither bid him God speed: For he that biddeth him God speed is partaker of his evil deeds", and

Whereas, these plain Scriptural commands have been misinterpreted in evangelical Christian circles today in so-called "Co-operation Evangelism" which allows any and all churchmen, regardless of their doctronal position or attitude to Christ and the Bible, to take active parts in such evangelistic efforts, and

Whereas, this tendency is contrary to the historic position of Free Will Baptists, and

Whereas, this 1967 session of the North Carolina Association of Original Free Will Baptists wishes to make its position abundantly clear,

Therefore, Be It Resolved:

1.1.1

- That we go on record as being-unalterably opposed to the ecumenical movement.
- That this Association has never, does not now, and by God's grace, never will be in favor of yoking up with modernists, liberals, Jews, Catholics, cults, etc. in a one-world church, but believe we should obey God.
- 3. That we do not to any degree approve of any type of cooperative evangelism with modernists, liberals, Catholics, Jews, etc., which brings all theological persuasions together, and after the campaign turns decision cards over to and new converts back into liberalistic and modernistic churches.
- 4. That we are firmly against, and strictly opposed to the Neo-Evangelical Movement, which seeks to build a bridge between the fundamentalists and the liberals, and modernists by flirting with, having dialogue with, and tolerating liberals and modernists, when Almighty God has plainly said, "and have no fellowship with the unfruitful works of darkness but rather reprove them." (Ephesians 5:11).
- 5. That copies of this resolution be spread on the pages of our Associational Minutes, and that copies be sent to our Free Will Baptist publications.
- IV. Be it resolved that we give a rising vote of thanks to the Cramerton Free Will Baptist Church and the Piedmont Bible Institute for their generous hospitality shown to this State Association.

#### PROCEEDINGS

Minutes of the fifth Annual Session of the Woman's Auxiliary of the N. C. Association of Original F. W. B., convening with the Cramerton F. W. B. Church of Cramerton, N. C., May 1, 1967.

Theme: "Behold the Fields"

Watchword: John 4:35, "Behold, I say unto you, lift up your eyes, and look on the fields; for they are white already to harvest."

Song director for the day was Mrs. Alvin Davis assisted by Mrs. John Moran, with Mrs. William Calvert, as pianist, and Mrs. Leo Fox as organist.

The song opening the devotional time was "To the Regions Beyond," after which Miss Volena Wilson brought us an inspiring devotion from Mark 1:41.

Mrs. Willie Ervin extended a warm welcome to which Mrs. Eleanor Parker responded.

The convention was called to order by the President, Mrs. Edwin Hill. She recognized the Ministers, delegates, and visitors that were present; and also our Missionary, Miss Volena Wilson.

The minutes of the Executive committee meetings of July 28, 1966, January 12, 1967, and February 7, 1967 were read and approved with one correction (that \$1250 for the Bill Phipps be changed to \$1250 for the Brazil Bible Institute).

We voted unanimously to accept the Western Piedmont District Woman's Auxiliary's written petition for membership into our State Woman's Auxiliary.

Moved, seconded, and carried to adopt the following recomended changes in our Constitution and By-Laws:

1. That we change Article III, OFFICERS AND EXECUTIVE COM-MITTEE to read as follows:

The officers of this Convention shall be a President, Vice President, who shall serve as Enlistment Chairman, Recording Secretary, Assistant Recording Secretary, Corresponding Secretary, Treasurer, Field Worker, Study Course Chairman, Stewardship-Prayer Chairman, Personal Service-Evangelism Chairman, and Missions Chairman. These shall constitute the State Executive Committee, six of whom shall be a quorum for the transaction of business. 2. That Article IV, MEMBERSHIP be changed to read: This Convention shall be composed of the officers of the Convention together with District President and ten delegates (duly accredited by the Credentials Committee) from each District Convention, and President and four delegates from local auxiliaries.

3. That we delete the words "the election of officers and" from Article V, MEETINGS.

4. That Section 4 under Article I be Assistant Recording Secretary, and that Section 5 under Article I be Corresponding Secretary.

5. That section 5 become Section 6, that Section 6 become Section 7, that Section 7 become Section 8, that Section 8 become Section 9, that Section 9 become Section 10, and that Section 10 become Section 11, and that Section 11 become Section 12.

6. That Article V Committees, Section 1, Nominating Committee read as follows: The Nominating Committee shall be composed of one member from each district. This nomination shall be submitted with the District's annual report, giving the name and address of the nominee, the year prior to election. The President shall select the chairman from the district nominees, who shall call the Committee together before the annual meeting when elections are to be held.

7. That article VI-FEES be changed to read: Seventy-five cents (75c) per active member shall be paid yearly to the WNAC for membership and convention representation fee.

Also moved, seconded, and carried to adopt these further recommendations of our Executive Committee:

1. That our local and District Auxiliaries elect a Historian, and that Mrs. Owen Thomas be contacted to be our State Historian.

2. That our State Project for 1967-1968 be \$1250.00 for the Free Will Baptist Bible College and \$1250.00 for the Brazil Bible Institute, with allocations as follows: Coastal, \$225.00; General, \$1000.00; Piedmont, \$200.00; Western Piedmont, \$600.00; and Blue Ridge, \$475.00.

3. That 250 envelopes be ordered for auxiliary use with auxiliary return printed on them.

4. That a three-day Woman's camp be held, August 15-18 from 2 p.m., Tuesday until 2 p.m., Friday.

5. That \$50.00 be alloted from our State Treasury to go toward Camp expenses.

6. That Carolyn Adams be elected to fill the office of Assistant Recording Secretary.

7. That each local auxiliary bring, if possible, at least a \$3.00 offering to the State Meeting and each District bring at least a \$10.00 offering.

8. That the President appoint ten delegates and three alternates to represent our State Auxiliary at the WNAC in July.

9. That Mrs. Alvin Davis be elected as our State Mission Chairman.

10. That nominations be made for the State Nominating Committee, one from each District, and that they meet during the year and bring a recommended slate of officers to the annual meeting next year.

11. That Mrs. Roy Rikard be nominated from our State to serve on the National Nominating committee, with Mrs. T. O. Terry as alternate.
