#### CONSTITUTION

#### of the

#### North Carolina Association of Original Free Will Baptists

#### Article I-Name and Purpose

This organization shall be known as the North Carolina Association of Original Free Will Baptists.

The purpose of this organization shall be the establishment and maintenance of a voluntary association of autonomous Original Free Will Baptist churches, quarterly meetings (or any other meetings) district association or conferences—or any and all additional organizations—area, district or state-wide that may be deemed essential to the prosecution and promotion of the general purpose and program of this association. Included, also in the purpose of this association is affiliation with the National Association of Original Free Will Baptists and cooperation in its world wide ministry. This association holds unswerving loyalty to the inspired word of God as our infallible rule of faith and practice.

#### Article II-Composition

This association shall be composed of its officers; members of standing boards; ordained and licensed ministers who are in good standing with a conference or an association affiliated with this body; together with three (3) delegates elected from each conference or Association; and one (1) delegate for every fifty (50) members or fraction thereof from each local church. (Note: This also includes any other church who wishes to be affiliated with the National Association.)

#### Article III-Meetings

This Association shall meet annually at seven-thirty o'clock (7:30 P.M.) on the first Monday of May and will adjourn at the option of the body.

#### Article IV-Officers and Boards

The officers of this Association shall be Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board, Board of Trustees, Board of Missions, Board of Care for the Aged, Board of Superannuation, and Board of Youth Relations.

#### Section 1. ELECTIONS.

All officers shall be elected by the body. A nominating committee shall be elected at the beginning of each session. After their report is presented, additional nominations for any office may be made from the floor. The General officers shall be elected for a period of two (2) years. No person shall serve in more than one (1) elected position in the Association at the same time, and no one having served a full term shall be elected to succeed himself.

#### Section 2. DUTIES.

A. The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the association; to appoint temporary committees; and the moderator shall serve as an advisor to all standing boards and as chairman of the Executive Board.

B. The duties of the Assistant Moderator shall be those of the moderator when the latter shall so direct or when he is absent.

C. The clerk shall record the proceedings of all sessions of the Association and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual session of the association; hold in trust all documents not otherwise preserved, and surrender same at the direction of the association; and conduct the official correspondence and sign such documents and instruments as require his signature. He shall also serve as secretary of the Executive Board.

D. The Treasurer shall hold in trust all money that belongs to the Association and disburse same by order of the association, the executive board, or any standing board or subordinate general organization invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and disbursed and make an annual report to the association.

#### Section 3. EXECUTIVE BOARD.

The Executive Board shall be composed of the general officers and three (3) members elected at large. The members elected at large shall hold office for three (3) years, the term of one expiring each year. The Executive Board shall arrange the program for the annual sessions of the Association. They shall fill vacancies which may occur in any office until the session of the association. It shall be their duty to promote the work of the association. They shall direct the work of the Free Will Baptist Witness. They shall employ an Editor and Director of Information whose salary shall be approved by the association in its budget. They may appoint such other assistants as may be necessary.

The Executive Board may advise and assist other boards of the Association.

The Executive Board is not authorized to act as the Association when it is not in session except as provided for in this Constitution and by-laws or specifically directed by this Association.

#### Section 4. BOARD OF TRUSTEES.

The Board of Trustees shall consist of three (3) men elected for three (3) years, the term of one expiring each year. They shall hold in trust all real and personal property of the association and shall convey such property as the Association may direct.

#### Section 5. BOARD OF MISSIONS.

The Board of Missions shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Section 6. BOARD OF CARE FOR THE AGED.

The Board of Care for the Aged shall be composed of six (6) members elected for three (3) years the term of two (2) expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Section 7. BOARD OF SUPERANNUATION.

The Board of Superannuation shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Section 8. BOARD OF YOUTH RELATIONS.

The Board of Youth Relations shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

#### Article V—Independence of the Local Church

This Association has no judicial or appellate powers conflicting with the independence of the local church.

#### Article VI-Amendments

This Constitution may be amended by a two-thirds (2/3) majority vote providing such amendment be read to the body and laid on the table until the following day.

#### **BY-LAWS**

 All meetings shall be opened by singing, reading a portion of God's Word and prayer; and shall be closed with prayer.

2. All business, except routine, shall be brought before the body by committee, but should a committee fail or refuse to present a matter of business, the business shall be brought from the floor.

3. In parliamentary procedure, Robert's Rule of Order shall be used as a guide.

4. The offices of Moderator and Assistant Moderator shall be filled on an alternating basis, from the eastern and western part of the state; Durham shall be the dividing line. When the Moderator is elected from one section, his assistant shall be elected from the other.

5. All officers and board members of this association shall be reimbursed at the rate of 6c per mile when traveling to duly called board meetings or attending to the business of any board. The State Evangelist is to be reimbursed at the rate of 7c per mile.

6. These by-laws may be amended or changed at any regular session of this association by a majority vote.

#### MINUTES OF THE SEVENTH ANNUAL

#### SESSION OF THE NORTH CAROLINA

### ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS

When convened with Canton Free Will Baptist Church, Canton, North Carolina—May 5, 6, 7, 1969.

#### MONDAY EVENING, MAY 5

Rev. Fred Hall presided over the Monday evening session which was opened by singing "Redeemed" and "When the Roll is Called Up Yonder." Prayer was led by Rev. Edwin Hill. The host pastor, Rev. Harold Pitts, extended a warm welcome to the congregation, after which Rev. Herman Hersey gave a response of appreciation for their hospitality.

Rev. Fred Hall introduced the winners in the afternoon youth competitive activities.

The congregation sang the hymn, "When I See the Blood." The evening offering was received.

Rev. Gordon Sebastian brought the keynote message on the subject, "Time Is Running Out," using as a text Romans 13:10-14. In his heartstirring message Bro. Sebastian emphasized that it is High Time for Jesus' Return, High Time to Wake Up, and High Time to Put on Christ.

The following Credentials Committee was appointed by the moderator: Rev. Edwin Hill, Chairman; Rev. J. P. Langley, and Rev. Alton L. Hines.

Announcements were made by the moderator after which we were dismissed in prayer by Rev. Wayne Smith.

#### TUESDAY MORNING, MAY 6

The session was opened by singing "Where We'll Never Grow Old," led by Rev. Robert Hagler who presided over the morning session. We were led in prayer by Rev. L. D. Creech. Rev. Hagler read a scripture lesson from I John 1:7-10, and introduced the clerk.

The clerk, Rev. Galen F. Dunbar, called the Seventh Annual Session of the North Carolina Association of Original Free Will Baptists to order and introduced the moderator, Rev. W. H. Calvert. Bro. Calvert made challenging remarks based on Matthew 16:13-18, pointing out things

which we need to stay free from as well as some characteristics we need to keep, such as Christ-centered services and convictions.

Motion carried that we accept the partial report of the Credentials Committee and seat the delegates from the following associations: Western Piedmont, General Conference, Piedmont, Yadkin Valley and fifty-three (53) churches reporting by letter.

Motion carried to adopt the program for the State Meeting as prepared by the Executive Committee.

The association elected the following Nominating Committee to serve at this session: Rev. Herman Hersey, Chairman, Rev. Harold Pitts, and Rev. Billy Gene Outland.

The moderator appointed the following committees:

- A. Finance Committee: Rev. Roy Rikard, Chairman, Rev. Albert Bell, and Rev. Alvin Davis
- B. Resolutions Committee: Rev. L. R. Ennis, Chairman, Rev. Milton Hollifield, and Rev. Richard Adams
- C. Education Committee: Rev. Benny Turner, Chairman, Rev. Ronald Howland, and Rev., Robert Rose.

The clerk read the minutes of the Executive Committee's meetings during the year. The clerk read the resolutions sent by North Carolina representatives to the Treatise Study Committee of the National Association. Motion carried to receive the report of the Executive Committee as read.

Motion carried to accept the resignation of Rev. T. O. Terry as Assistant Moderator since he is leaving the state. Motion carried to ask the nominating committee to nominate someone to serve in this capacity the remainder of this session.

Motion carried that the Highland Pines Free Will Baptist Church in Hamlet, North Carolina be dropped from the roll of churches of our state (by a written request from the church desiring such action).

A number of visitors to our State Association were recognized by the moderator, including Mr. Samuel Johnson (Church Training Service Board), Rev. Harold Harrison (Sunday School Department), and Rev. Paul Ketteman (Free Will Baptist Bible College) from Nashville, Tennessee. Rev. Ralph Staten and Rev. Seldon Bullard from East Tennessee, and several brethren from the Beaver Creek Association in South Carolina. Rev. Robert Hagler continued to preside over the morning worship service and led us in singing the hymn, "Send the Light." After prayer by Rev. Roy Rikard an offering was received as we sang "When I See the Blood." Rev. James Childers brought the message on "The Pulpit in Days of Crises," and using as his text Isaiah 53:1-12. He emphasized Jesus as the Lamb who filled the pulpit and was our example, and challenged our hearts to fill our pulpit with the Lamb.

Closing prayer was led by Rev. Ralph Staten.

#### TUESDAY AFTERNOON, MAY 6

The afternoon session opened with singing the hymn "Glory To His Name" led by Rev. M. T. Sparks who also presided. Scripture reading by Rev. Howard Messer was chosen from Ephesians 6:10-18.

Greetings were brought from the National Sunday School Department by Rev. Harold Harrison.

Motion carried to receive a partial report from the Credentials Committee and seat the following delegates: Blue Ridge Association, Mt. Mitchell Association, and 8 additional churches reporting by letter.

The nominating committee recommended Rev. Gordon Sebastian to serve as assistant moderator to serve the remainder of this session of the State Association. Elected by acclamation by the body.

Motion carried to receive the report of the State Evangelist and the Book Store. (See reports).

Motion carried to receive the report of the Missions Board and adopt the proposed budget for the coming year. Included in their report was the good news that the church at Rocky Mount had become self-supporting and the church at Clinton had come under the jurisdiction of the mission board. Rev. L. D. Creech has already moved there to begin the work. Words of testimony were heard from Rev. Bronco West from the mission at Winston-Salem and Rev. L. D. Creech from Clinton.

Two new ministers in our state were welcomed into our fellowship. These were Rev. Barry Hampton at Fayetteville from Missouri and Rev. Jerry Rackley at Ahoskie also from Missouri.

Motion carried that the report of the Board of Care by Rev. Jason Salyer be received and adopted with the proposed budgets and recommendations. An amendment was made to the motion that we delete the proposed budget concerning immediate development of the mountain property. Rev. Paul Ketteman gave a report of the Free Will Baptist Bible College in Nashville, Tennessee.

Mr. Samuel Johnson brought greetings from the National C.T.S. Department and announced some of the plans for the youth at the National Association in St. Louis, Missouri in July.

The meeting was adjourned with prayer by Rev. Homer Arrowood.

#### **TUESDAY NIGHT, MAY 6**

Mr. Lorenza Stox presided over the evening service and led in the singing of "He Keeps Me Singing" after which we were lead in prayer by Rev. A. C. Morgan. We sang the hymn "Since Jesus Came Into My Heart." Rev. Charles Keith led in the offertory prayer and the offering was received while Rev. Herman Hersey played a hymn arrangement of "Happy Day." A testimony time was enjoyed by all.

Mr. Lorenza Stox blessed our hearts with a solo "'Til the Storm Passes By." Prayer was offered by Rev. Harold Pitts.

An appeal was made to the churches to receive a special offering to send our state winners in the youth competitive activities to St. Louis, Missouri for National competition.

In the absence of Rev. Joseph Ange the treasurer's report was given by Rev. Galen F. Dunbar. Motion carried to receive the report.

The Education Committee report was given by Rev. Ronald Howland. Motion carried to receive the report.

The Resolutions Committee report was given by Rev. Milton Hollifield and the resolutions approved as amended. (See resolutions under Reports)

Motion carried that copies of Resolutions No. 1 and No. 2 be sent the National Association of Free Will Baptists as information.

The report of the finance committee was given and received.

Motion carried that along with the letter sent to the President of the United States that we commend him for what he has already done.

The report of the Leah Waddell Scholarship Fund was received.

The report of the North Carolina Woman's Auxiliary Convention was given by Mrs. Betty Hill. Motion carried to receive the report as information.

A letter of greeting was read from our Foreign Missions Office in Nashville, Tennessee.

The final report of the Executive Committee was read and accepted by voting on the recommendations one by one.

Motion carried to adopt Item No. 1. Motion carried to adopt Item No. 2. Motion carried to adopt Item No. 3. Motion carried to adopt Item No. 4.

Motion carried that we approve the action of the Study Commission on the Treatise of our National Association.

Motion carried that our moderator appoint delegates to the National Association meeting in St. Louis, Missouri, July 14-17, 1969, with the understanding that if these cannot attend the moderator be authorized to appoint others to take their places. The five delegates are: Mrs. Jack Moran, Mrs. Flora Morgan, Mrs. Barbara Dunbar, Mrs. Roy Rikard, Mrs. Johnny Floyd, Sr. The following will serve as alternates: Mrs. Georgia Calvert, Mrs. Betty Hill, Mrs. Harold Pitts.

Motion carried that the Executive Committee approve the minutes of this meeting for publication.

The clerk was instructed to write a letter of thanks to the Canton Enterprise for their coverage of this session and to Mr. Guy Ward in appreciation for his providing the musical instruments used during this meeting.

Motion carried to give an "amen" vote to the local auxiliary for the lovely flowers placed in the church for this meeting.

Motion carried to rescind the part of the report of the Board of Care for the Aged that deals with number of members on the Board of Development.

Motion carried to accept the resignation of L. D. Creech from the Missions Board.

Motion carried that because Rev. Billy Walker has moved out of the state we declare the office vacant on the Leah Waddell Student Scholarship Fund Commission. The report of the Nominating Committee was given. Motion carried to receive the report and that we elect the slate of officers as nominated.

Motion carried that along with the motion to adjourn that we include commendations to the speakers in the four services for their fine messages.

We were adjourned and dismissed in prayer.

## **REPORT OF THE STATE EVANGELIST**

#### 1969

For all the prayers that have gone up on my behalf and in behalf of our work, I am deeply grateful. This has been a blessed year. The lowest valley, I ever walked through was this year, yet the highest peak of joy that has ever been mine has been this year. God is so good. I am so very unworthy of His goodness and mercy.

One year ago, this week, I had to report to you that our Promotional Department was in the red to the tune of \$2,893.61. That was a most distressing and depressing thing to do. Today, I am so very happy to report to you that all our bills are paid and we have a little money in the bank.

In addition to that, we have \$1,318.82 in the savings account on our Book Store Station Wagon.

I did not, nor could I make possible this report. You, our people in North Carolina, have made this good report possible and I am so thankful to you for it and to our wonderful Lord who gave us all the strength to carry on.

#### PROMOTION

This year, I have spent more time getting into as many of our churches as possible—Sunday mornings, Sunday nights, and Wednesday nights. It has proven profitable, both from the stand point of better promotion of our work as well as increased financial support.

Our pastors have been very cordial to me. I do not want to be in the way nor do I want to be a nuisance to our pastors. They are busy men, with lots on their minds and if I cannot help them and be a blessing to them, I certainly do not want to hurt them in their ministry. If they have enjoyed my coming just half as much as I have enjoyed coming around, then I am happy over it.

Five Free Will Baptist Associations in our State are not yet affiliated with our State Association. I have visited all of these this year and can honestly say that these Associations are some of the finest people I have ever met. They have treated me warmly and brotherly. I have not pushed them to join our State Association. Some may eventually. Some may never, but if they never do, they are still my Free Will Baptist brothers and sisters and I plan to attend their meetings as long as they will let me. If and when they join us, I want it to be their decision.

They have been so good to me. They have let me preach for them, stay in their homes, buy from our Book Store, etc. Some of them are at this meeting and I am so glad they are. I hope they like us.

There are 119 churches in these Associations and 178 preachers. They are our brothers and sisters. Lets pray for them.

We have seven Associations that are members of our State Association comprising 142 churches and 204 preachers.

I did not attend the National Promotional Director's meeting in Nashville this year. I really did not feel we could afford it but I plan to attend the next one.

#### WITNESS

Last year we were printing 2,500 copies of the WITNESS monthly. The May issue was 5500. I hope this paper can get into every Free Will Baptist home in our state. I really hope too that before long we can publish twice a month instead of once. Please pray about that. Our paper is accomplishing much for unity.
