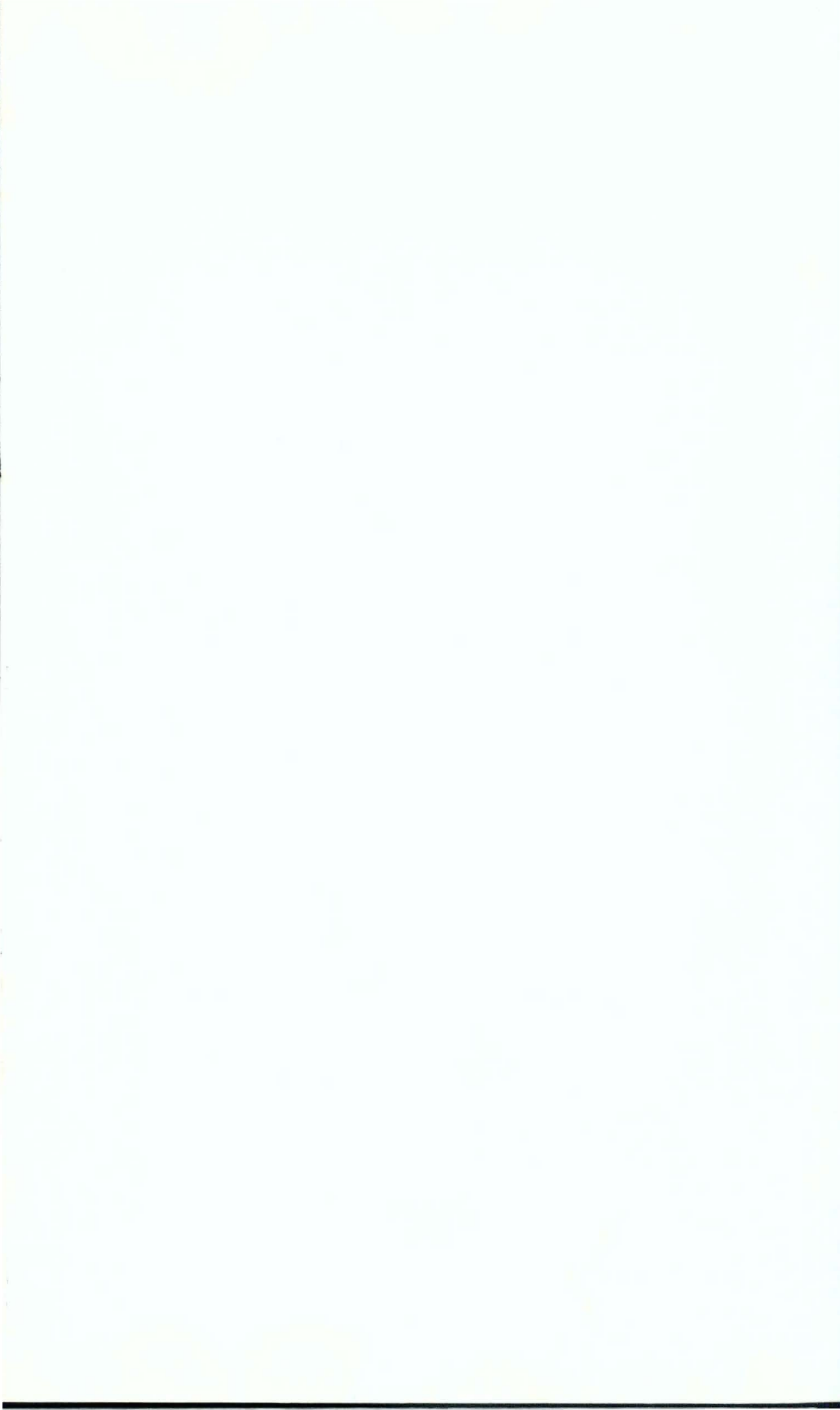

CONSTITUTION

of the

North Carolina Association of Original Free Will Baptists

Article I—Name and Purpose

This organization shall be known as the North Carolina Association of Original Free Will Baptists.

The purpose of this organization shall be the establishment and maintenance of a voluntary association of autonomous Original Free Will Baptist churches, quarterly meetings (or any other meetings) district association or conferences—or any and all additional organizations—area, district or state-wide that may be deemed essential to the prosecution and promotion of the general purpose and program of this association. Included, also in the purpose of this association is affiliation with the National Association of Original Free Will Baptists and cooperation in its world wide ministry. This association holds unswerving loyalty to the inspired word of God as our infallible rule of faith and practice.

Article II—Composition

This association shall be composed of its officers; members of standing boards; ordained and licensed ministers who are in good standing with a conference or an association affiliated with this body; together with three (3) delegates elected from each conference or Association; and one (1) delegate for every fifty (50) members or fraction thereof from each local church. (Note: This also includes any other church who wishes to be affiliated with the National Association.)

Article III—Meetings

This Association shall meet annually at seven-thirty o'clock (7:30 P.M.) on the first Monday of May and will adjourn at the option of the body.

Article IV—Officers and Boards

The officers of this Association shall be Moderator, Assistant Moderator, Clerk, Treasurer, Executive Board, Board of Trustees, Board of Missions, Board of Care for the Aged, Board of Superannuation, and Board of Youth Relations.

Section 1. ELECTIONS.

All officers shall be elected by the body. A nominating committee shall be elected at the beginning of each session. After their report is presented, additional nominations for any office may be made from the floor. The General officers shall be elected for a period of two (2) years. No person shall serve in more than one (1) elected position in the Association at the same time, and no one having served a full term shall be elected to succeed himself.

Section 2. DUTIES.

A. The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the association; to appoint temporary committees; and the moderator shall serve as an advisor to all standing boards and as chairman of the Executive Board.

B. The duties of the Assistant Moderator shall be those of the moderator when the latter shall so direct or when he is absent.

C. The clerk shall record the proceedings of all sessions of the Association and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual session of the association; hold in trust all documents not otherwise preserved, and surrender same at the direction of the association; and conduct the official correspondence and sign such documents and instruments as require his signature. He shall also serve as secretary of the Executive Board.

D. The Treasurer shall hold in trust all money that belongs to the Association and disburse same by order of the association, the executive board, or any standing board or subordinate general organization invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and disbursed and make an annual report to the association.

Section 3. EXECUTIVE BOARD.

The Executive Board shall be composed of the general officers and three (3) members elected at large. The members elected at large shall hold office for three (3) years, the term of one expiring each year. The Executive Board shall arrange the program for the annual sessions of the Association. They shall fill vacancies which may occur in any office until the session of the association. It shall be their duty to promote the work of the association. They shall direct the work of the *Free Will Baptist*

Witness. They shall employ an Editor and Director of Information whose salary shall be approved by the association in its budget. They may appoint such other assistants as may be necessary.

The Executive Board may advise and assist other boards of the Association.

The Executive Board is not authorized to act as the Association when it is not in session except as provided for in this Constitution and by-laws or specifically directed by this Association.

Section 4. BOARD OF TRUSTEES.

The Board of Trustees shall consist of three (3) men elected for three (3) years, the term of one expiring each year. They shall hold in trust all real and personal property of the association and shall convey such property as the Association may direct.

Section 5. BOARD OF MISSIONS.

The Board of Missions shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 6. BOARD OF CARE FOR THE AGED.

The Board of Care for the Aged shall be composed of six (6) members elected for three (3) years the term of two (2) expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 7. BOARD OF SUPERANNUATION.

The Board of Superannuation shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Section 8. BOARD OF YOUTH RELATIONS.

The Board of Youth Relations shall be composed of five (5) members elected for five (5) years, the term of one expiring each year. They may

prepare by-laws to govern them in their work providing such by-laws are presented to the Association for approval. They shall make an annual report of their accomplishments to the Association.

Article V—Independence of the Local Church

nis Association has no judicial or appellate powers conflicting with independence of the local church.

Article VI—Amendments

This Constitution may be amended by a two-thirds (2/3) majority vote providing such amendment be read to the body and laid on the table until the following day.

BY-LAWS

1. All meetings shall be opened by singing, reading a portion of God's Word and prayer; and shall be closed with prayer.

2. All business, except routine, shall be brought before the body by committee, but should a committee fail or refuse to present a matter of business, the business shall be brought from the floor.

3. In parliamentary procedure, Robert's Rule of Order shall be used as a guide.

4. The offices of Moderator and Assistant Moderator shall be filled on an alternating basis, from the eastern and western part of the state; Durham shall be the dividing line. When the Moderator is elected from one section, his assistant shall be elected from the other.

5. All officers and board members of this Association shall be reimbursed at the rate of 8c per mile when traveling to duly called board meetings or attending to the business of any board. The State Evangelist is to be reimbursed at the rate of 9c per mile.

6. These by-laws may be amended or changed at any regular session of this Association by a majority vote.

**MINUTES OF THE EIGHTH ANNUAL
SESSION OF THE CAROLINA
ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS**

When convened with College Lakes Free Will Baptist Church, Fayetteville,
North Carolina — May 4, 5, 6, 1970.

MONDAY EVENING, MAY 4

Rev. Milton Hollifield presided over the Monday evening session which was opened by singing, "Glory to His Name" led by Rev. Gordon Johnson. Prayer was led by Rev. Sherman Branch. Rev. Barry Hampton, the host pastor, extended a warm welcome to the congregation, after which we sang "Victory in Jesus." An offering was received with prayer by Rev. Milton Hollifield.

A ladies trio from the College Lakes Church sang "Precious Hiding Place."

Rev. Herman Hersey brought the keynote message on the subject "The Issues We Face," using as a text II Samuel 23:11-12. Bro. Hersey pointed out that "issues" change from generation to generation, and whatever the issues are that we face we must: I. See the issues, II. Stand on God's side of the issues, and III. There is a time to act. There are many issues facing us today as a nation and as Free Will Baptists. TUESDAY MORNING, MAY 5

The session was opened by Rev. L. D. Creech leading the hymns, "The Solid Rock" and "At the Cross." Prayer was led by Rev. Jackie Creech who was visiting from South Carolina. The College Lakes ladies trio sang "Give Me Thy Heart."

The clerk, Rev. Galen F. Dunbar, called the Eighth Annual Session of the North Carolina Association of Original Free Will Baptists to order and introduced the Moderator, Rev. W. H. Calvert. Bro. Calvert read from Romans 13:11-14 and Ephesians 5:14-17, challenging us to "awake out of sleep." We have the potential: the message, the preachers, and the churches. It is time for us to wake up, clean up, dress up in the whole armor, look up, and be ready to go up.

Motion carried to accept the partial report of the Credentials Committee and seat the delegates from the Blue Ridge, Coastal, Mt. Mitchell, and Western Piedmont districts, and 35 churches reporting by letter.

The following visitors were recognized by the Moderator: Dr. Robert Picirilli (Moderator of the National Association), Rev. N. R. Smith (National Sunday School Department), Samuel Johnson (Church Training Service Board), Bobby Henson (Randall Book Store), Rev. Homer Willis (Home Missions Department), Mrs. Mabel Willey (Missionary), Rev. Rufus Coffey (Executive Secretary), and the following from South Carolina: Rev. and Mrs. Adam Scott, Rev. Jakie Creech, Rev. Wilburn Beasley, Rev. Lewis Campbell, and Mr. A. C. Allen.

The association elected the following to serve as the Nominating Committee for this session: Rev. James K. Childers, Chairman, Rev. Freeman Edwards, and Rev. Dean Dobbs.

The Moderator appointed the following committees:

A. Finance Committee: Mr. Owen Thomas, Chairman, Rev. Sherman Branch, and Rev. Broncho West.

B. Resolutions Committee: Rev. Gene Parish, Chairman, Rev. Billy Allen, and Rev. Howard Messer.

C. Education Committee: Mr. Jack Forlines, Chairman, Rev. Richard Adams, and Rev. Homer Arrowood.

The clerk read the minutes of the Executive Committee meetings which were held during the year. Motion carried to receive the report of the Executive Committee and vote on the recommendations one by one.

A motion was made to adopt the budget as recommended. A motion carried to table this motion until we act on an anticipated change in Article 5 of the By-Laws.

A motion was made and carried to change Article 5 of the By-Laws to read as follows: "The State Evangelist is to be reimbursed at the rate of 9c per mile."

Motion carried to take from the table the matter of the budget. Motion carried to amend the budget by increasing the salary of the State Evangelist from \$6,500 to \$7,020.00. A motion carried to adopt the budget as amended.

Rev. Alvis Harris presided over the worship service and led the congregation in singing "Praise Him! Praise Him!" Rev. Tom Lilly led in prayer, after which the congregation sang, "His Way with Thee." An offering was received with prayer by Rev. Gene Outland. The College Lakes ladies trio sang, "Love Is Why."

Rev. Jason Salyer brought the message on the subject, "The Abiding Authority of the Word of God," using as his text, Psalm 119:89. Bro. Salyer pointed out: It is *all* the Very Word of God and that from the very beginning we can see through His Word how perfect His authority was and still is — the abiding authority.

Closing prayer was led by Rev. Lonnie Graves.

TUESDAY AFTERNOON, MAY 5

Rev. James Denton presided over the afternoon session and led the congregation in singing "Nothing But the Blood" and "On Jordan's Stormy Banks." Rev. A. C. Morgan read from II Chronicles 7 and led in prayer.

The recommendations of the Executive Committee were continued.

It was recommended and carried that the percentage of allocations to the various departments remain as they were last year which is as follows:

A motion carried to amend Article 5 of the By-Laws to read: "All officers and board members of this Association shall be reimbursed at the rate of 8c per mile" instead of 6c per mile.

The report of our State Evangelist, Rev. Ronald Creech, was given calling special attention to the future of our work. A motion carried to accept the report and give a rising vote of thanks to our State Evangelist and his wife. The rising vote was given to Rev. and Mrs. Creech.

Rev. Rufus Coffey, the Executive Secretary of our National Association, brought greetings.

Rev. Gene Parisher gave the report of the State Mission Board. Motion carried to accept the report and adopt the recommended budget which has an increase of approximately \$4,000 over last year.

Motion carried to receive the report of the Board of Care for the Aged and adopt the budget, and receive the report of the Board of Development of the mountain property which is a function of the Board of Care for the Aged.

Rev. Joseph Ange gave a report from the National Foreign Missions Board. North Carolina gave over \$76,000 to Foreign Missions last year, and \$15,000 in the telethon in April.

Brother Joseph Ange gave an announcement and some information concerning the chartered flight to the National Association in Fresno, California.

A motion carried to receive the report of the Superannuation Board and adopt the budget of \$1,500.00 which is the same as last year.

Motion carried to receive the report of the Board of Youth Relations. No budget was suggested but a plea was given for \$1,800 to send our representatives to Fresno, California. Several men made observations and pleaded with the pastors of these teen-agers to see that they go decently dressed to represent us.

Motion carried to adjourn. We were dismissed in prayer by Rev. Lloyd D. Gray.

TUESDAY EVENING, MAY 5

The service was opened by singing the hymn, "When the Roll is Called Up Yonder" led by Rev. Ronnie Peele. Rev. Dean Dobbs presided over this session. Prayer was led by Mr. Jack Forlines. The congregation sang, "Who-soever Meaneth Me," after which we had a brief testimony time. The congregation sang, "Leaning On the Everlasting Arms." An offering was received and the prayer was led by Rev. Gene Parisher. Rev. Herman Hersey played an arrangement of hymns.

Rev. and Mrs. Barry Hampton sang, "He Touched Me."

Dr. Robert Picirilli gave a report from the Free Will Baptist Bible College and in the report noted that North Carolina gave \$92,000.00 last year, and has 47 students.

Dr. Picirilli brought a challenging message on "Fellowship Without Christ," using two passages of scripture signifying a positive approach (I John 1:3-7) and a negative approach (II Corinthians 6:14-18). We have a tendency to measure things by our own experiences but we must have the Word of God as our measuring standard. Dr. Picirilli concluded with the challenge to be faithful to God. The hymn was sung, "I Surrender All." We were dismissed in prayer by Rev. L. R. Ennis.

WEDNESDAY MORNING, MAY 6

The service opened by singing, "Bring Them In." We were then led in prayer by Rev. Jack P. Langley, Sr. The scripture reading was by Jack Langley, Jr. who also led in prayer.

A motion carried to accept the final report of the Credentials Committee given by Rev. Wayne Smith. The total registration for this State Association was 218 and of those registered 81 were ministers, 53 were delegates, 75 were visitors, and 8 were from out of the state.

A motion carried to receive the treasurer's report given by Rev. Joseph Ange along with a partial report of offerings at this meeting. The morning offering to be received would complete the report.

Mr. Samuel Johnson gave a report from the National Church Training Service office.

Rev. N. R. Smith gave a report from the National Sunday School Department.

The report of the Education Committee was given by Mr. Jack Forlines. Motion carried to lay the matter of the report on the table temporarily so that the committee could include another item in the report.

Mr. Jack Forlines gave a report on the Sunday School campaign, "Dollars from the Scholars," for the Free Will Baptist Bible College.

The report of the Resolutions Committee was given, and the resolutions approved item by item.

Motion carried to adopt Item No. 1 as amended.

Motion carried to adopt Item No. 2.

Motion carried to adopt Item No. 3.

Motion carried to adopt Item No. 4.

An additional report from the State Evangelist was given regarding the State Program and also the financial report of the Witness Book Store.

A motion carried to receive the report of the Leah Waddell Student Loan Fund as given by Rev. Nathan Eason. The balance in this fund is \$118.72.

A motion carried to accept the invitation from the First Free Will Baptist Church in Gastonia for the 1971 State Association meeting.

The Ladies Auxiliary report was given by Mrs. Flora Morgan. There were 197 in attendance this year which was the best ever.

Motion carried to take the Education Committee's report from the table. The report was adopted.

Rev. Frank Davenport gave a report from the National Home Missions Department.

A motion carried that the Moderator appoint the delegates from North Carolina to the National Association meeting in Fresno, California.

The report of the Nominating Committee was given. Motion carried to receive the report and that we elect the officers one at a time. (See Report of the Nominating Committee for the list of officers who were elected.)

Motion carried that we declare vacant the office that Rev. Eddie Dollar holds on the Mission Board since he has left the state.

Motion carried to accept the resignation of Rev. Dean Dobbs from the Superannuation Board. Rev. Ronald Niebruegge was elected to fill this place.

Motion carried to declare the office of Rev. Fred Hall on the Board of Youth Relations vacant since he has left the state. Ronald Christ was elected to fill the unexpired term.

Motion carried to give a rising vote of thanks to the outgoing officers and that a letter be sent to Rev. Gene Hales and the newspaper reporter for the Fayetteville Observer for their interest in our meeting

Motion carried to accept the resignation of Mr. Jack Forlines from the Executive Committee as a member-at-large.

Motion to adjourn the business session and enter the worship service was carried.

Rev. Howard Messer presided over the worship service and led in singing, "Revive Us Again" and "O Worship the King." Prayer was led by Rev. Billy Allen. The offering was received after prayer was led by Rev. Ronald Niebruegge. Rev. Joseph Ange brought the message on, "The Judgment Seat of Christ," using as a text I Corinthians 3:11-15. Brother Ange stressed the burning of our works if they are not founded on Christ. If any man's work abides after the burning there will be a reward which we will gladly give to Jesus. He challenged us to be faithful in our service.

REPORT OF THE DEVELOPMENT COMMITTEE

We had some plans on development of the mountain property and were making some progress when Mr. Banks died. Since we did not have a right-of-way to the property we decided not to do anything for the time being. However, we have some plans in the making. We have contacted a man who is coming to plot out our property and tell us where is the best place to build our buildings, lake, etc. We had a meeting with a man from Timberlodge Builders Association. He gave us some prices on California Redwood buildings. These seem to be the most economical. These buildings are so constructed that anyone can put them together in three or four days. We can get a building 24' x 48' for \$6,800.00 plus an additional 4 feet for \$391.00. This does not include floor, plumbing, and wiring. We plan to build one building as soon as we get the right-of-way, plans, etc., and then add a building as we can. We have a number of people who are wanting to buy some land for \$100.00 per acre as soon as we get the right-of-way and the land surveyed.

REPORT OF THE STATE EVANGELIST

1970

REFLECTIONS

When you elected me as your Moderator in the 1966 session at Liberty Church in Durham, little did I dream nor realize that God's will for my life would lead in this direction.

After being elected, I conscientiously tried to analyze our Free Will Baptist situation and possibilities in the state. There had never been an analysis occasion for me before. I had never served on one of our boards. I think I was interested in our work — at least I attended all of our meetings. Now, it was different. You had elected me as your moderator. I could not just attend the meetings. Now I must try to give some constructive suggestions and leadership in our future course.

After three or four months of reflection and study and analysis of our total setup in the state, I became burdened that we needed a full-time promotional man. The night that I lay in bed, after my family had long since gone to sleep, with State Minutes in my hands, I thought and prayed. I became really scared as God burdened me that we needed such a ministry and that I was the one to promote our work. Would it make sense to resign a big church that loved me and paid me well and offer myself to work for our State Association, which had no money to pay me? Was it fair to my family? Was it even fair to my State to seek to lead them into such a gigantic venture of faith? Was it even ethical to say that I felt I was the man? Would my brethren think I was off my rocker and was promoting myself or was I sincerely wanting to promote our state work? Would our state rally? Would my brother preachers help me? Would I make a big fool out of myself?

That night — late, on my bed at 303 N. Hyde Park Avenue, Durham, the conviction crystalized in my heart. Yes, I would tell it to some of my closest friends first to see what their reaction was. I opened my heart to Billy Morris, Joe Ange, Frank Davenport, and Herman Hersey first. Then, I told our State Executive Committee about my burden. We decided to call a special meeting of all the personnel of our five departments and get their counsel. We met at Unity Church in Smithfield. The concensus was to call a special session of our State Association and recommend the step of faith. We met at Faith Church, Goldsboro. With much fear and trembling we launched out. You remember!

Now it has been three full years and four months since we launched out full-time. Am I sorry? No, a thousand times no! Have there been hard times? Yes, a thousand times yes! But many, many more blessings than heartaches!

Are you sorry? I do not know. I really do not think so. You have rallied to this venture of faith. You have supported the work. It is *your* work — not *mine*. You have made the good reports possible! I thank you a thousand times! God bless you for it. I love you for it with all my heart. You have had faith in me and our other men when it really looked dark. I am so glad. God has rewarded the faith of us all.

Our work now, I feel, is well established and we are really ready to do a noble work for our God in North Carolina. The next years, if Jesus tarries, we will see things happening that will awe and astound us all, I feel. It is so exciting just to think of the possibilities, I can hardly stand it. To God be all the glory! To all of you, our North Carolina Free Will Baptist people, we say, "God bless you and thank you."

Now I have not followed my outline for the preparation of this report at all. I had been making notes for two months of things I wanted to include in this annual report, but when I sat down tonight to write it, the Lord, I believe, led me a different way. If we can all be reminded that God *has really led us* and that we are on course, then to God be the glory. Our future looks as bright as the promises of God.

THE FUTURE

There are great things in the future for us, I feel. All five of our departments are making important plans for our state. I have some dreams for us too.

Oh, I would love to see us have a nice tent, hold revivals and at the end organize us a good Free Will Baptist Church. A dream of mine is for us to have a first-class radio ministry to cover our state from Murphy to Manteo. My heart burns for us to get to the place where we could publish pamphlets and paper back books by the thousands and also some hard backs. Just some of my dreams.

THE WITNESS

The Witness is having an effective ministry. Our people like it, I am convinced. We now print 5,700 copies per month.

C. C. B. INC.

Capital Church Bonds, Inc., has now conducted programs totaling \$233,000 — right at the quarter million mark — since we began. We are so glad for churches that have used the services of our own North Carolina Bond Company. We now have three of our men helping us in the field.

I am anxious to see us develop a "package building plan" for our churches. I mean a turn key job including financing, architectural, contractor, materials, furnishings and equipment, etc. We can save our churches thousands of dollars and make some money for our state too. It is now in the talking and planning stage.

BOOK STORE

The Book Store continues to grow. Our Executive Committee has authorized a committee to look for a building in a business district. We are deeply grateful to you, our people, for patronizing your own Free Will Baptist book store.

We now have excellent arrangements to supply you with pews, folding chairs, tables, desks, office and school equipment, baptistries, steeples, stained-glass windows, carpet, tile, hard wood floor finishing, commercial ceilings, pianos and organs, hymn books (any kind), baptistry scene paintings, flags, etc. Prospects look good, in the near future, for brick, steel, folding doors, outdoor church signs, laminated beams, etc. No matter what you want, give our Free Will Baptist Book Store a chance to get it for you.

SOUL-WINNING

One of my dreams has been to cover our state with One Day Soul-Winning and Sunday School Building Institutes — one for each district, once or twice each year. Some of our strongest leaders have already told me they are available for such meetings. Praise God! We hope to start soon! Watch for the announcement for your district.

SUPPORT

I hope to see the day that every church in our state is giving something to our work — whether a large gift or a small one, we want each church giving each month. Remember now, we handle no National money. We urge all of our churches to send their money for National causes directly to Nashville. What you see in these reports is what our people have given to our North Carolina causes — a total of \$44,426.91. Now add to that

figure \$138,892.76 and you will see our total North Carolina giving picture — \$183,319.67. That is not all we *could* do, but it is *fair*, I think, don't you?

The Associations in our state, not yet members of this Association, have been extremely nice to me. I visit them all. They welcome me, buy from our store, some support our work, etc. God bless them. We have an Association of Indian Free Will Baptists down near Lumberton. I have visited with them. God bless them too.

Last year we cut the State Program allocation to the Promotional Department by 2%. It was added to the Missions Department. I hope we can go another step in this direction this year. Not much, you say? I think it is significant that we are *cutting* at least rather than *adding* some.

Now, State Program giving is only about 15% of our total giving picture in the state. Eighty-five percent (85%) of our money goes direct from the churches to the agency that spends it.

GROWTH

We are growing. A lady is helping us with some typing part time. Our Executive Committee voted to use the double entry bookkeeping system and has employed a bookkeeper to keep the books for us, make our tax reports, etc. This will greatly help us and allow us to do some things that we just have not been able to get to do up until now. He is working on his first month's invoices.

Thank God we are growing — no one wants us to stand still. But the more we grow, the more money will be required. God will supply. He will do it, however, through us.

STATE EVANGELIST

I am your editor, book store manager, director of Capital Church Bonds, Inc., treasurer of the State Program and the State Evangelist. That sounds big and important. However, when I cross your mind, I do not want you to think first of me as editor, manager, director or treasurer but think of me as a *preacher*, an *evangelist*. I want to be known as a warmhearted preacher who loves your souls and the souls of lost people and who by all means wants to win some to Jesus. As Paul said, ". . . I am made all things to all men, that I might by all means save some." I Cor. 9:22

This year I have traveled 35,657 miles.

REPORT OF RESOLUTIONS COMMITTEE

1. Be it resolved that this Association extend a rising vote of thanks to College Lakes Free Will Baptist Church and the host Pastor, Rev. Barry Hampton, along with the musicians and the Church Trio, for the gracious hospitality extended this Eighth Annual Session of the North Carolina Association of Original Free Will Baptists.
2. WHEREAS, the issue of Sex Education in our schools and pornographic materials that are being made available throughout the land are an abomination before God and a source of corruption of the morals of our young people, and

WHEREAS, God calls His ministers to be "Watchmen on the wall, and sends them to warn people of these things that war against the soul. BE IT RESOLVED: That we re-emphasize our opposition to the SIECUS Program in our schools and the filthy literature being made accessible to our Youth, and,

BE IT RESOLVED: That we urge our ministers to cry out as never before against these sins and encourage their people to speak out against these things both at the polls and by writing the proper authorities stating their opposition in no uncertain terms.

3. WHEREAS, the Bible says in I Timothy 2:8, 9, 10, "I will therefore that men pray everywhere, lifting up holy hands, without wrath and doubting. In like manner also, the women adorn themselves in modest apparel, with shamefacedness and sobriety; not with broidered hair, or gold, or pearls, or costly array; But (which becometh women professing godliness) with good works." And

WHEREAS, the Bible says in James 1:14-15, "But every man is tempted, when he is drawn away of his own lust, and enticed. Then when lust hath conceived, it bringeth forth sin: and sin, when it is finished, bringeth forth death." And

WHEREAS, the miniskirt and other immodest clothing causes men and women to be guilty of sins recorded in Matthew 5:27, 28, "Ye have heard that it was said by them of old time, thou shalt not commit adultery: But I say unto you, that whosoever looketh on a woman to lust after her hath committed adultery with her already in his heart." And WHEREAS, women in our public offices in our cities, counties, and state are wearing this type apparel and causing a breakdown of efficiency in the jobs that we as taxpayers are paying for and,

WHEREAS, the public school teachers and students are wearing this type of apparel and causing a breakdown of moral character throughout our country,

BE IT RESOLVED: As Christian people we prayerfully petition, (1) The pastors of our churches to cry aloud against the sin of immodesty (Isaiah 58:1); (2) The designers to improve this immoral condition in our country by designing clothes that are modest; and (3) Our Legislators to enact laws to protect us against those who would be immodest and impose their immodesty upon the public.

4. WHEREAS, New Evangelicalism is a deadly and subtle attack upon the Word of God and a theological and moral compromise of the worst sort, and

WHEREAS, no more serious issue has faced the church since the days of the Protestant Reformation, and

WHEREAS, The New Evangelicalism advocates toleration of error and is exerting tremendous pressure upon believers to forget the Biblical principle of separation, to join hands with the enemies of the Lord, and to minimize the spiritual distinctives which separate God's people from unbelievers, and

WHEREAS, the New Evangelicalism mood of toleration toward heretics is leading them into the "soft line" of appeasement rather than the "hard line" of repudiation; and in dealing with these heretics, it is no longer the doctrine of God but the law of love. And

WHEREAS, in *World Vision Magazine* for October, 1968, Dr. Paul Rees writes an editorial reporting the meeting of the World Council at Uppsala and seems eager for evangelicals to have part in the blasphemous testimony of the World Council. He said, "Furthermore, whether we have formal connections with the World Council or not, we are obliged to acknowledge that we have Christian brothers whose denominations are in the Council and who themselves are active participants in Council affairs . . . They have been sitting in this assembly hall and I, though not a delegate, have been unashamedly sitting with them. A few seats away from me is Dr. David Hubbard, President of Fuller Theological Seminary . . . Behind me sat the Rev. John Stott, senior minister at All Souls' Church (Church of England) in London . . . In the same bank of seats with us was Dr. Leighton Ford, associate evangelist and vice-president of the Billy Graham Evangelistic Association."

In another editorial in the same issue of "World Vision" Dr. Rees writes: "Uppsala for Dr. Hubbard, confirmed his belief that participation in theological councils of the Church by Conservative evangelicals is essential" and

WHEREAS, the Rev. W. S. Mooneyham's ministry and time is devoted to working and promoting World Vision, and

WHEREAS, we believe that his organization is detrimental to the cause of fundamental Christianity because of its active role in promotion of New Evangelicalism, and

WHEREAS, we do not believe that a man who is working and promoting New Evangelicalism, as Dr. Mooneyham seems to be, should be given the recognition or honor of speaking at the Missions service of our National Association.

BE IT RESOLVED that this State Association hereby petition the Executive Committee of the National Association of Free Will Baptists to withdraw their invitation to Dr. Stan Mooneyham as speaker for the Missions service of the 1970 Session of our National Association.

- C. Education in Christian educational institutions.

Within the above areas the committee recommends the following:

- A. In the local church
 - 1. Place greater emphasis on training and grounding new converts in the faith.
 - 2. Thoroughly teach our Free Will Baptist doctrines.
 - 3. Hold institutes to train workers to be more effective.

B. In the home

1. Provide a daily devotional guide for each family.
1. Provide the *Free Will Baptist Witness* for each family.
3. Provide *Contact* to each family on the "every family plan" or encourage each family to subscribe.
4. Suggest and encourage the use of other Christian literature.
5. See that each family is on the mailing lists to receive *Heartbeat*, *Missiongrams*, and the *Free Will Baptist Bible College Bulletin*.

C. Christian educational institutions

1. Recommend Free Will Baptist Bible College and Piedmont Bible Institute to all persons seeking to further their education regardless of whether or not they plan on full time Christian service.
2. Warn people of the dangers in attending secular colleges and universities.
3. Recommend that parents strongly consider sending their children to Christian day schools when such schools are available.

The committee recommends that each Sunday School and CTS use the literature prepared by and for Free Will Baptists and supplied through the National Sunday School and GTS departments.

The committee recommends that each church give regular financial support to both the general fund and expansion program of Free Will Baptist Bible College.
